All stakes are Walking and open to all AKC Registerable pointing breeds. Bitches in season may compete in Amateur Ltd Walking Gun Dog – Retrieving, Open Walking Derby and Amateur Walking Derby only. Open Derby will run 30 minutes, Amateur Derby will run 20 minutes. Open and Amateur Puppy will run 15 minutes. AKC approved tracking collars may be used per AKC Regulations.

Entries limited to the number of dogs that can be run during daylight hours. Entries will close when this limit is reached. No more than 50% of the entries in any stake may be handled by the same handler.

OWP and AWP will be a single course without bird field, no birds released. No firing of blank cartridges in puppy stakes. OWD, AWD, OWGD, AWGD, ALGD-Ret. will be single course without bird field. ALGD-Ret. will be call back for retrieve. Bring you BLAZE ORANGE. Horseback handling will not be permitted in any stake. Shotguns with blank shells will not be permitted. Bobwhite quail, and/or chukar, and/or pheasant will be released.

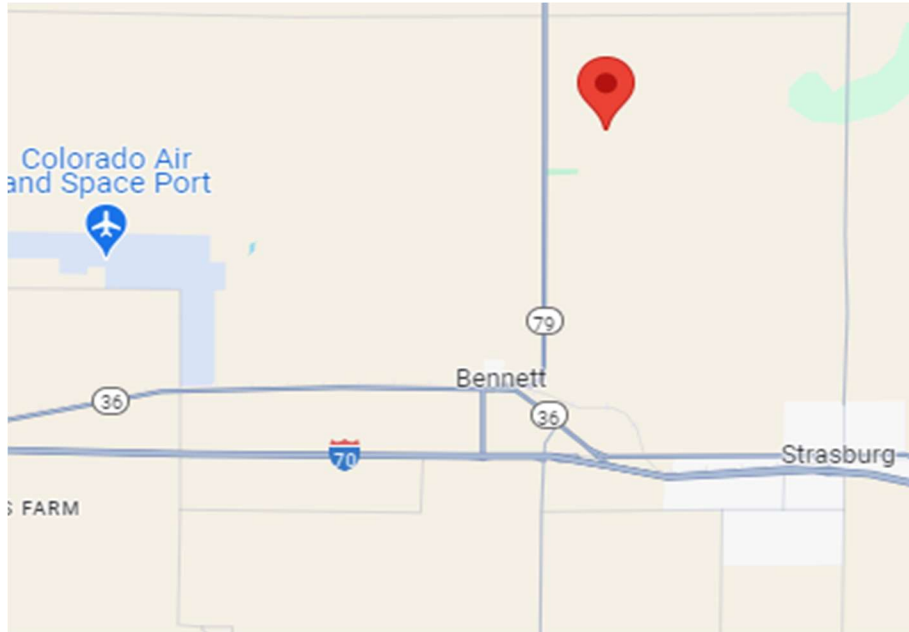

In consideration of and as a condition of \_\_\_\_\_ being allowed to participate in field trials/hunt tests/dog training activity on certain land in Adams County, Colorado located at 51550 E. 72<sup>nd</sup> Avenue, Bennett, CO 80102 owned and operated by David A. Lincoln, Joyce E. Lincoln and David A. Lincoln Jr. (collectively known as the "Lincoln Property"), the undersigned acknowledges, represents and agrees that:

1. Participating in field trials and related activities, including riding horses, are inherently dangerous activities that can result in seriously injuries or death caused by myself or other people who are present or participating in such activities. I hereby expressly agree to assume all risks, both known and unknown, and I understand that I may be seriously injured or killed through my acts or the accidental or negligent acts of others.

Participating in field trials also includes an inherent risk of serious injury or death caused by conditions of the land, including both defects in or improvements thereto, or natural conditions including animals, insects, or hazardous water crossings. The "Lincoln Property" owners have not made any representations or warranties, express or implied, that the conditions of the property are suitable for field trials or that the property is free from defects, including any roads, buildings, structures, gates, creek crossings, or any other possible dangerous or hazardous condition. Further, I acknowledge that I will be solely responsible for safety and condition of any and all horses and equipment utilized by me.

I acknowledge that in allowing me to participate in a field trial/hunt test/dog training activity on the "Lincoln Property", the "Lincoln Property" owners or their representatives, owe me no duty to supervise or control the activities or the actions of the persons present or participating in such activities.
