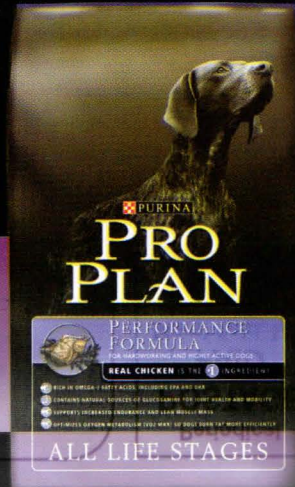

The ABC Chukar Classic/Championship was held April 21st & 22nd, 2009 at BLM Goose Butte Management Unit located outside of Ritzville, WA. A special thanks to our sponsors, Purina and Tri-Tronics for their continued support of this Championship. Thank you to our Judges, Dan Hoke, Professional Dog Trainer from Cheney, WA and Dennis Leis, Brittany enthusiast from Oregon City, Oregon. Our trophies were custom designed and crafted by Brittany enthusiast and artist, Dave Roe, of Ritzville, WA. Breakfast and lunch were provided by the host club, Washington Brittany Club with Julie Templin of Sharon's Drive-in coming out to the grounds to cook hamburgers for all of us. Judges' dinners were held in town after the chores were finished and enjoyed by all in attendance. Although it was a small Championship this year, all participants and attendees pitched in with the multitude of tasks involved in running a trial. Thanks to everyone.

THE WINNERS – TERRA'S CABO WABO (Sammy) ran a true all-age race setting the standard for all. TJ'S SINGLE SHOT OF SCIPIO (Emme) coming in as Runner-Up, both Champion and Runner-Up doing a bang-up job for amateur handler, Tom White. Congratulations Tom. Third place being awarded to QUAIL ROCK TOUGH ENOUGH (King) with Paul Doiron handling and fourth place going to CEDAR CREEK SURGEON (Cutter) with Joe Waitman at the whistle. Congratulations to all.

THE RUNNING – DAY ONE

Brace One: SAN-DEE'S BLAZING SHANE - Paul Doiron and MTB EMME'S CABO DE SCIPIO - Tom White. Day one started out with a beautiful morning, sky was clear and the sun was shining strong, kicking off our first brace. Both dogs broke away very nicely, first dog on point was Shane with nice

bird work between first and second gate, Cabo was running wide and forward, second find for Shane across the creek at $\frac{3}{4}$ mark, held steady and finished in front. Cabo was picked up by handler shortly across the creek.

Brace Two: CEDAR CREEK SURGEON - Joe Waitman and QUAIL ROCK TOUGH ENOUGH - Paul Doiron. Brace breakaway was nice at 69.5 degree's already with the temperature rising. First find was Cutter past the first gate, "nice job" comment from Judge Dan Hoke. King on point up front before the second gate, Paul went to look for bird only to see a coyote run off close by, King held point, relocated with no find produced. Coyotes were abundant at this trial and the dogs had to work hard to find a live bird. Second find was King, half way past the second gate, nice point, Cutter came up for a nice back. Off and running again, Cutter has a nice find before the creek. Crossing the creek below the rim rocks, Cutter has another find. Crossing the creek, King is up on top the cliffs and running strong. Lost him for 4-5 minutes to find him down off cliffs and up front holding point. At $\frac{3}{4}$ mark King is out front and on point. Nice job on both dogs during this brace. Judge Dennis Leis calls time as Cutter goes on point, Joe walks up on dog to see he has a great find!!! A nice bold-face calf hiding in the sage brush, now that's what I call a Dual Dog!

Brace Three: SHADY'S TIA MARIA - RJ Marquart and MVP REDLINE'S HIGH OCTANE - Paul Doiron. Nice start on both dogs, first find with Tiger on a hawk kill, handler relocates dog, nothing produced and then off running out front. As we all know, our dogs, no matter their titles, are allowed an "off day", handler, RJ chooses to pick Tia up. Tiger is out front and running strong to finish at time holding point on that cute baldy calf hiding in the

brush ... hey, another Dual Dog!

Brace Four: MEGASMOKE LIMITED EDITION - Tom White and CEDAR CREEK ZEB - Joe Waitman. Both dogs took off fast and forward, first find went to Zeb way left of the first gate. Zeb also found on second find just above the creek. Both dogs running nice. Judges commented disappointment that Ted went birdless because he was a good powerful all age dog. Both dogs finished out front.

Brace Five: MEGASMOKE GRAND FINALE - Paul Doiron and TERRA'S CABO WABO - Tom White. Both dogs took off fast and furious, one to the left, the other to the right. Sammy has first find just before the second gate, is relocated and does a nice job. Sammy is running big, found on point on top of hill before the creek. Gallery truly enjoyed Tom's ballot through the brush chasing the chukar as Sammy held steady. Personally, I think he need a little more work in his arm movements! Crossing the creek Al is found on point, no ballot from Paul. Both judges liking the strong fast run on Sammy. Sammy is gone for awhile and found at the 42 minute mark on point with Al backing.

THE RUNNING - DAY TWO

Sixth Brace: TJ'S SINGLE SHOT OF SCIPIO - Tom White and TRAVELER'S NEW TWIST - Paul Doiron. This brace started off our second day, the weather totally opposite the day before, where the temperature reached 85 degrees easy, now it was windy and chilly. Traveler, was running well and coming up on finds only to be hawk kills twice, on his third find (which was live) he broke and was picked up by Paul. Emme has first find at 8:21, this gal is running big and forward. Judges rate her high on style and intensity and she has a great finish.

Seventh Brace: MTB CABORITA DE SCIPIO - Tom White and HIDEAWAY RED'S BESS BET - Roger Borine. Both dogs take off great, but all good things must come to an end. Both dogs were found running under the same bird.

I truly enjoyed riding each brace and seeing all the wildlife, cows calving, the horn owl in it's nest on the side of the cliff near camp. Most of all wishing I didn't forget my camera when we spotted the coyote a few feet from a chukar on the ridge watching us and the chukar watching the coyote. Needless to say, the coyote was run off and the chukar was saved for awhile longer for the bird dogs. As I end, I would like to say kudos' to the scouts and thanks to all of you who pitched in and helped make this trial a success. Until next time, train well and ride easy. (Oh yeah, Thanks Tom!)

An Active Public Education Program The Public Education Program must document significant activity. For example, Youth programs (4-H, Scouting Groups, or active Canine Ambassador Programs) or Public Education Programs at community functions, civic organizations, public library programs, support of an AKC Veterinary Outreach activity, a canine legislation representative, AKC Responsible Dog Ownership Day event, or participate in other community activities within 10 miles of the club territory. Documentation of PECs, Canine Ambassadors, and suitable educational activities will be submitted to:

Any on-going activity promoting purebred dogs or your particular breed including performance demonstrations to influence legislative decisions or land-use for events would satisfy this activity.

Other Educational or Outreach Programs Other club outreach or educational activities may be used to satisfy this requirement if the club receives advanced approval from AKC Event Operations. In order to have an activity approved, the club must submit a description of the activity, the intended audience, and the location of the activity. *Should none of the listed "Major Activities" be feasible for your club, present your proposed activity that promotes purebred dogs or your breed and we will approve any reasonable outreach program.*

Conformation and/or Obedience/Rally, or Agility Training Classes Training classes that meet this requirement are those involving obedience, agility, or conformation and are open to the public. *Single breed handling classes are acceptable.*

Breeder Referral Service The key to a meaningful breeder referral lies in making it known to the public that this information is readily available. The club must indicate how it advertises the referral service to the public. (i.e. on a club website, show catalog, the local Yellow Pages or advertises in local newspapers etc.). *Single breed referral is acceptable.*

Public Educational Programs or Formal Judges Education Clubs hold regular meetings and some of these meetings should involve educational programs that are of interest to the membership and the public. If the club is fulfilling this requirement, it should specify the dates of its educational meetings and give a summary of the programs for these meetings. Clubs are encouraged to invite the public to these meetings. Specialty clubs can satisfy this requirement by offering breed specific judges education programs including ringside mentoring, or on-line presentations. (i.e. On-line video, Power Point, or similar presentations) *Single breed educational presentations are an excellent tool to attract new exhibitors/members.*

Dog Show Tours (May be conducted at events held outside the club territory) Dog shows tours help spectators understand the classes, ring procedure, championship points system, dog show etiquette, and promotes the sport of purebred dogs. A formal educational plan and schedule of tours conducted should be submitted to document this activity. *This can be an informal introduction to inexperienced spectators at specialties. Spectators may be attracted with an understanding of the event.*

Registered Handler Seminars or Workshops (May be conducted at events held outside the club territory) Clubs that provide AKC Registered Handler seminars that educate new exhibitors and/or junior handlers encourage new exhibitors and promote the sport of dogs. *Promoting these seminars/workshops for members to attend these events through news letters or other club materials would satisfy this option.*

New Exhibitor Briefing (May be conducted at events held outside the club territory) New exhibitor briefings should help new exhibitors understand the dog show and feel more comfortable with the sport. The briefing must be publicized in the judging program and should include scheduled times. The briefing should explain the duties of the superintendent or show secretary, the AKC Executive Field Staff, the event committee, the ring steward, ring location, exercise areas, and assist with grooming space. An explanation of dog show classes, points computation, and verification of placements (judges book tear sheets). The club must document the briefing in the show report submitted for the event. *This can be an informal introduction to new exhibitors presented by club members at specialties.*

Compliance Requirements for Specialty Clubs

As of 2009, specialty clubs are required to comply with the *Eligibility Requirements to Hold Future Dog Shows*. As with all-breed clubs, specialty clubs often have smaller entries at their events and suffer from shrinking club membership. The intent of these "requirements" is to assist clubs in determining activities that will serve the public within their licensed territory and attract both exhibitors and club members. Although the listed activities may seem applicable to all-breed clubs, specialty clubs can also use these activities as explained below.

Info for All Exhibitors in 2010 and Beyond! Exhibitor Rule Changes

Chapter 11, Section 1.

No dog shall be exhibited in a licensed or member dog show, except for dogs entered in the Miscellaneous Class unless it is either individually registered in the AKC Stud Book, or individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration. A dog with an AKC limited Registration shall be ineligible to be entered in a breed competition in a licensed or member dog show.

An unregistered dog with an acceptable foreign registration that is individually registered with a foreign registry organization whose pedigrees are acceptable for AKC registration may, without special AKC approval, be exhibited in licensed or member dog shows that are held not later than 30 days after the date of the first licensed or member dog show in which the dog was exhibited, but only provided that the individual foreign registration and name of the country of birth, are shown on the entry form; and provided further that the same name (which in the case of a foreign-registered dog must be the name on the foreign registrations) is used for the dog each time.

No dog that has not been individually registered with The American Kennel Club when first exhibited in a licensed or member dog show shall be eligible to be exhibited in any licensed or member dog show that is held more than 30 days after the date of the first licensed or member dog show in which it was exhibited, unless the dog's individual AKC registration number is shown on the entry form, or unless the owner has received from The American Kennel Club an extension notice in writing authorizing further entries of the dog for a specified time with its individual foreign registration number. No such extension will be granted unless the owner can clearly demonstrate, in a letter addressed to the Show Records Department of The American Kennel Club requesting such extension, that the delay in registration is due to circumstances for which he is not responsible.

Such extension notice will be void upon registration of the dog or upon expiration of the period for which the extension has been granted if that occurs earlier, but upon application further extensions may be granted.

For complete details see Rules Applying to Dog Shows, Chapter 11, Section 1.

FAQs

Q: Why change the requirements?

A: The change was made to encourage exhibitors to register all puppies eligible for AKC registration.

Q: Must the dog have individual AKC registration prior to the closing date of the event?

A: Although it is best to register the dog well before the event, the registration must only be processed by AKC prior to the starting date of the event.

Q: Are Puppy Classes affected?

A: Yes, even dogs in puppy classes must now be individually registered. Dogs may not be exhibited on litter registration at licensed or member events.

Q: Do Foundation Stock Service (FSS) breeds and Miscellaneous Class breeds have to be individually registered to compete as well?

A: Yes, all dogs, including Foundation Stock Service breeds & Miscellaneous Class breeds must enrolled in the AKC Foundation Stock Service® prior to the day of the event to compete.

Q: Are all AKC sports affected?

A: Yes, all dogs competing in AKC performance events, companion events and conformation shows are required to be individually registered before competing in the event.

Q: May dogs with foreign registration compete?

A: Dogs individually registered with an AKC recognized registry (see: http://www.akc.org/rules/special_registry_services.cfm) may exhibit for up to 30 days after the date of the first AKC event in which it was exhibited. After 30 days time the dog must have received AKC registration or have applied for and been granted an extension from AKC Event Operations in order to continue exhibiting at AKC events.

Q: May dogs with Limited Registration exhibit?

A: Dogs with AKC limited registration are not permitted to exhibit in conformation shows (except in Junior Showmanship Classes) but may exhibit in all Companion and Performance Events.

Friendly Reminders

In the rush to complete event registrations, submit applications, judging panels, and show results, or deal with the multitude of issues that are involved with hosting an event, it is easy to forget a few things. Below are some friendly reminders regarding some common misunderstandings or misconceptions that the Event Operations department sees on a regular basis.

- There is a great deal of confusion about the handling of problems at trials related to aggressive dogs. Event committees must understand the "Disqualification by Event Committee" procedure, as well as the procedure for "Dealing with Misconduct." The two are regularly confused. Disqualification relates to a dog and issues of misconduct relate to a person. Action must be taken, regardless of whether or not someone insists.
- Event applications must be signed by an officer (President, Vice President, Secretary, or Treasurer) of the club, not the Show Chair(s), Board Directors, or Regional Secretaries in order to be valid.
- When using the Online Plans tools remember that your application should be submitted prior to submitting your Judges Panels just as is done when submitting these via hard copy.
- There is no application fee for clubs that have less than a 30 dog entry at the previous years show.

Event Committee Corner

Event hearings are one of the many tasks that an Event Committee must prepared for. Everyone on the Event Committee should understand the club's responsibility concerning misconduct at their event. The AKC publication *Dealing with Misconduct* defines the Event Committee's duties in Section II.

It is the duty of the committee, not of the AKC, to deal initially with acts of alleged prejudicial conduct which occur during or in connection with a club's event. The phrase "in connection with" means any incident where the parties involved are there because of the event; for example, at a dinner connected with the event, in a parking lot adjacent to the event grounds, at a hotel facility, or abuse of a hotel facility. Incidents occurring while traveling to, from and between events are not considered to be in connection with an event. While a club can hope that no problem of this nature will arise, its committee must be prepared to deal with such incidents in a creditable manner should they occur. The AKC will support a committee which properly executes its powers, but when a committee fails to fulfill its obligations in this respect, serious questions arise as to whether the club should be allowed to hold future events under AKC rules. In situations where the club fails to meet its obligations, the Board of Directors of the AKC, after review, may impose a fine or withhold approval of events, or both.

As you see from the excerpt above, a committee's failure to fulfill its obligations can have serious consequences for the club! Fortunately, there is help available. The Executive Field Representative is available at nearly all all-breed shows to provide guidance for procedural matters and the show chair can obtain advice from the phone number that is listed for the *Weekend Club Hotline* in the Show/Trial Manual(800) 252-7894. This number is staffed 24/7 by the AKC Companion Animal Recovery (CAR) staff who will route your call to the appropriate department to deal with your questions.

The Dakota Prairie Championship got underway Monday, September 21 and concluded Friday, September 25 on the Dave Tech ranch northeast of the small, friendly town Bonesteel, South Dakota. The ranch was lush and green after a cool and rainy summer, the Missouri Breaks country resplendent with cover, and the bird population thriving. All the ingredients were there for a great trial, well conditioned dogs, top handlers, and world class judges. Even the weather co-operated for the most part. So what could go wrong?...

For thirteen years now, I have been going to South Dakota for about ten days in late September to watch some of the nation's best all age dogs compete, an event I look forward to with great relish. Some years, the Ringneck club holds the ABC Pheasant championship. Alternate years they hold the Dakota championship, but every year, they put on a class event on some of the finest prairie grounds to be found. Sad to say, it may have come to an end this year.

The Ringneck Brittany Club weekend trial also hosts a weekend trial, as well as an Amateur championship, namely the Region 19 Amateur All Age Brittany Championship just prior to the Dakota championship. As usual, we had a good turn out of amateurs and professional trainers from across the United States, as well as me from Canada. The Region 19 championship is run continuous course, with each brace releasing where the last picks up.

As usual, the Dave Tech ranch served as the headquarters. But in addition to the Tech ranch, the club utilizes the land of the Selles ranch and the land of the Varlick ranch, with the Selles ranch being the middle portion of the courses. A few years ago, Jim Selles signed an agreement with the state of South Dakota to open his land to use for walk-in hunts. When the four wheeler that we use as a dog wagon met up with a game warden mid afternoon on Sunday, and driver was given a warning ticket, the writing was on the wall. The powers that be decided that we could not run dogs, ride horses, release birds or drive a 4 wheeler across the walk-in designated areas. We had only two choices, cancel the championship or make an alternate course using only Dave Tech's land. We chose the later-with Randy Walth and Chad Holman mapping out the course Sunday evening while Ken Seivert and I handled the draw.

There was about one hour and fifty minutes of running room in our new land allotment, instead of three full hour courses. The first course begins at camp, just as it has for many years, crossing a little dam, winding through the feedstrips, through the first two fields with no changes until we pass through the second gate. Instead of proceeding past the large pond as we have in the past, the new course turns sharply left, down a hill, up another into a pasture, and then weaves you through several pastures all with their own little ponds, and all with their own steep hills. We exit this part of the course at the shale canyon, which was part of the old second course, and turn into the Tech hay meadow. This is where the second brace would break away under normal circumstances. After traversing the hayfields, and crossing back through the dairy cow field, it heads back to the feedstrips as well as the brushy draws that border the fields, and eventually turn again at that second gate to finish up in the more hilly area. Everyone was happy that we were able to hold the championship at all, and cowboied up to the fact that while the it was far from ideal, it was what could be done under the circumstances. There was still beautiful scenery, ideal habitat for pheasants and sharptails, as well as few prairie chicken, and weather was not as extreme as it has been some years.

Many people were sad to think that we may never again gather together to enjoy the challenge that this trial provides to prove the best hour Brittanys.

Our judges were Gary Cowell and Garvin Collins, both native to Missouri, from the competitive world of pointers, with many championships judged and excellent reputations. They were very compatible in views, comfortable in the saddle and appeared to enjoy

watching the dogs. I enjoyed meeting them and learning their thoughts on bird dogs.

The winning dog, Trademark's Iceman came out of the 26th (second to last) brace. "Timmy" as he is called, is coming into the prime of his life, and entered this trial having won the 2009 American Brittany Club Chicken Championship the prior week. Timmy is owned by Ed and Donna Janulius, and handled by Chad Holman, all Illinois natives. Timmy began his bid first brace out on Friday morning, on the most challenging part of the course. Timmy was strong on the ground and very obviously looking for birds. As we passed the second gate, Timmy was posed intently down the fenceline to the right. Chad flushed a pheasant here, with all in order. He worked the hilly portion of the course, and when we came up to the hay meadows, Chad was able to point out a still strong Timmy going away in the valley below. At 55, Timmy styled up on a hill in the hay meadow, with several sharptails being flushed. A hard act to follow, but the last brace had a strong challenger in Hanging Jaze Howlewya Amen, handled by Ed Tillson. "Slick", as the Jake and JoJo Schroeder owned dog is called, claimed the runner up spot, with a limb find on sharptails, a pheasant find late in the hour, and finishing with power to spare. Two strong challenges came from "Chug"-Jerry McGee's Ru-Jem's A Touch of Bourbon with 4 class finds and smooth handling race, and TM's Tennessee Twister-"Sway", Timmy's littermate, handled by Tom Tracy, co-owned by Brook Caviness and Lisa Pollock. Sway put in an hour with sustained all age prairie casts and two good pheasant finds. No one envied the judges the job of choosing from several top performances to come up with champion and runner up.

As always our club membership, small in numbers, came up big to take care of the work that needed doing. Thanks to all the help goes to Craig Nelson, Ron and Randy Walth, Kenny Seivert, Leslie Andreas and new member, Chad Holman.

Purina was our sponsor, and as usual, greatly appreciated for their monetary contributions, as well as donating bags of their fine Pro Plan line product for the winners. They have given so much to the sport of field trialing, and have done much to ensure that the one hour stakes continue to thrive.

2009 Dakota Championship Running

We broke away to cool temperatures, light rain and 35 mile per hour winds.

Brace 1# CEDAR VALLEY BANDIT (Tracy) & HI POINT'S BET'N HE'LL ROCK "Ozzie" (Holman). Each dog scored a separate find in the heavily brushed steep draw by the first gate. Ozzie on the west side, Bandit on the east side, two different birds, manners good all the way around. Ozzie had a mishap on a wild flushing sharptail at 40. Bandit handled a sharptail find at 55, birds rising sporadically.

Brace 2# TM'S TENNESSEE TWISTER "Sway" (Tracy) & SANDY PINE'S CHASE THE WIND "Chavy" (Holman). Sway got on the task immediately with big all age swings on the left hand side of the course. She was wide and fast, yet handled with ease. Her first find came in a brushy draw, with a running bird that was seen but not flushed, although the handler did a fine face plant trying. Her second find was in a small feed plot, again a running bird. This one flushed with Sway showing great intensity throughout. She continued to apply herself for the entire hour, with a strong finish mounted on the steep hills. Chavy is a young dog, and was not as forward as might be desired. He suffered two non-productive stands and was picked up.

Brace 3# DOWNTOWN LUCAS BROWN (Garrow) & CHEYENNE WIND DANCER (Cross). This pair of liver dogs got off to a somewhat slow start, taking awhile to get their acts together. Both dogs stopped correctly when a large covey of sharptail departed quickly in the wind and were fired over. In one of the grassy fingers, Dan was steady to flush on a fawn. At 56, Dan pointed with Lucas backing, and a pheasant was produced.

Brace 4# BLACK CREEK TIM (Holman) & BRETON'S CASTLE ROCKET (John). Tim pointed

at 2 just off the breakaway. Even with a long relocation, no birds were produced. Rocket pointed across the top of the dam moments later, and moved in when handler arrived, to be picked up. Tim chased a bird at 5, making this a short brace.

Brace 5# DIAMOND HILL'S RECKLESS ENDEAVOR "Rex" (Tracy) & ODYSSEY'S ACE OF HEARTS (Holman). Both were to go around the course with decent ground races, but no defined bird work. There were a lot of sharptails flushing from a hill top with both dogs in the area, but nothing definitive seen. Ace had a couple non-productives. Rex had one non-productive. After time was called, Rex handled a bird properly, but it was too late to count.

Brace 6# ROUSTABOUT'S SNIKOSH SADIE (Tracy) & SHADOW'S TEQUILA TWISTER "Gator" (Tillson). Neither dog challenged today and both handlers elected to pick up after about 12 minutes.

Brace 7# T.J.'S PRAIRIE BLIZZARD (Tillson) & RAMBLIN' MAN "Randy" (Garrow). Blizzard would not go the direction of the course, which made it easy for Ed to put him in the dog wagon. Randy went on alone for about 10 minutes, but was not extending himself and joined his brace mate.

Posted after the first days running, Cedar Valley Bandit and TM's Tennessee Twister. Our second day was again cold, windy with a light rain falling off and on all day.

Brace 8# SHAQ ATTACK (Tracy) & LANE'S END HAVE MERCY (Holman). Shaq required gathering early in the hour to make the turn, at which point he lined out and went to the front with speed. By the big pond, he stopped at the flight of a wild flushing bird. He would have a non-productive at 47 in an area that several deer had just exited. Mercy hunted with vigor through the feed strips only to run up and chase a pheasant at the first gate.

Brace 9# TEQUILA WITH A TWIST "Taryn" (Tillson) & BLACK CREEK DEACON "Dee" (Holman). Taryn put in a very competitive race, but had the misfortune to have nervous birds flush on their own on each of three finds outside of judicial observation. Dee also had a very nice ground effort going. Chicken were seen to leave on their own atop a large hill. Moments later, Dee pointed in the same area. Three more chicken flew when Chad was flushing. Dee continued to search, and pointed in the hay meadow, without result. My horse took the opportunity to run away with me at this time, and I did not really observe the rest of Dee's effort. When we caught up, Dee was on a rope after roading in a bit on a stop to flush. Thanks to Jim John for helping reset the curb chain and collect my goofy horse.

Brace 10# SHAMROCK SIRIUS (Holman) & SHADY WAY RED TAIL HAWK "Beau" (John). Si got us off to a good start with an excellent find at the edge of a feed strip. Only moments later, he again swirled to a stop, but took a step and put the bird up. Beau was fun to watch as he cruised through the hilly portion of the course with great enthusiasm. At 49 he was chasing a deer, when a pheasant got up he switched to chasing it.

Brace 11# CEDAR VALLEY UNCLE KRACKER (Tracy) & KD'S SLIP AND SLIDE "Splash" (Tillson). Kracker had a non-productive early and was not pleasing his handler, so he was up early. Splash was quartering at the start, but got lined out and into a better pattern eventually. At 15, he pointed in a very small grassy patch, and to everyone's surprise, three huge pheasants were flushed in an area no larger than they were with dog showing good manners as they rocketed past his face. At 56, Splash met his Waterloo on a pheasant.

Brace 12# THE ROCK II (Tracy) & FARTHER OUT KID AIMEE (Garrow). Rock was putting down a real all age effort, but at the end of the hour, could not be shown. Aimee, a grey headed veteran, also ran her heart out. After a long absence, her handler called for the tracker. She was found far to the front.

Brace 13# TRADEMARK'S ATM "Cash" (Holman) & CROSSLAND'S CHARLIE (John). Cash had his directions mixed up right off the line. Charlie showed his youth in immature pattern. Everyone had had enough of riding around in the rain, and this brace ended early.

No dogs were posted on Day 2#. A heavy fog delayed our start for 2 hours. Once it cleared a bit we enjoyed nice, overcast and cool weather.

Brace 14# MARJO'S RED RUM "Johnnie" (Luisi) & KINWASHKLY DAKOTA MOLESTER (John). Lester was seen taking the lines above the dam with speed right off the breakaway, and a distant flash of white that was Johnnie was briefly seen. When we had reached the second gate with no dogs in front of us, we held up. Joe Luisi called for his tracker. (Johnnie was found near the town of Fairfax several hours later, tired and happy.) A distant call of point behind us came when scout Ken Seivert found Lester standing on a feedstrip. A bird was produced right in front of the dog. Lester got back on course and was looking good as he dropped into the deep draw to the left. As we turned into a gate above a steep hill, Lester was seen on point at the bottom of the hill. When he had everyone's attention, he moved up and took out the hen pheasant.

Brace 15# CORREDOR DORADO "Dex" (Tracy) & WOLF RIVER'S WINNING TICKET "Cash" (Garrow). Dex is a 2 year old, who stretched out well in the early going, but got less and less responsive to the handler as the hour went on, and eventually faded over a hill and would not come back on course under judgement. Cash also had a mind of his own, and Al got tired of trying to fight him.

Brace 16# HI PROOF WHIZKI (Garrow) & RUJEM'S A TOUCH OF BOURBON "Chug" (McGee). Whizki put in an interesting hour, going hard and fast the whole time. He was a handful! At 21, we heard the call of point, a call of "there they go", and a shot. This was Whizki's only find. Chug had a little problem tackling the cattle herds at the beginning of the course, but got to hunting once past them. At 21, scout called point for him in a grassy area to the right of feedstrips. No bird was produced, but at 24 when Chug was getting back on course, he slammed into a tight coil. Two pheasants were produced as the result of this stand. He scored again at 40, in a feedstrip with birds running everywhere, including under the dog, with no movement whatsoever from the dog. Chug added another stylish find at 44. At 46, the course had looped back to where he had the non-productive at 21, and he pointed in nearly the same place. This time, birds were flushed. As always, Chug looked great on point. Chug was going hard at time to cap a good hour.

Brace 17# CEDAR VALLEY AYSA (Tracy) & MIGHT AS WELL BE THE GUNNER (Kolinas). Aysa chose to hunt to the right of the course at medium range. Gunner took in some rough country, and established point with high head and tail near the top of a hill. Aysa came upon the scene and failed to back. Gunner remained composed and a large rooster was flushed. Later on, Gunner succumbed to temptation on what started out to be a stop to flush.

Brace 18# SOVEREIGN'S GIT R DUN "Larry" (Tillson) & GRAND JUNCTION JAKE (Holman).

At 5 Larry had a point on the edge of a feedstrip, waved off as he moved on. He would be credited with a find at 13, and a stop to flush at 27. He finished up the hour a little wound up and doing his own thing. Jake started out like a challenger to the title. He scored a pretty find at 3, stopped to flush at 13 on a hillside parallel to the gallery, added another stylish find at 18, all with class and manners. About two thirds around the course, the hills started to take their toll, and he was struggling to keep going. At 49, he pointed again with high head and tail and had a nice pheasant find recorded for him. At 58, he had a stop to flush on a bird that the judge rode up.

Brace 19# EARLY TIMES (Tracy) & THUNDER (John). Earl went places no one else did as he took in huge portions of land to the front. He made a swing far to the right and around the dairy pasture and ended up on the other side of the Dave Tech home place. This allowed him to point the flight pens where hundreds of pheasants were sunning themselves! It took some riding to get Earl back on course, but he had everyone watching him, sitting up to catch a glimpse of him. As he came down the left fence edge that goes through a brushy draw, several pheasant were seen in the air. And then Earl was seen, slowly following them, like he was planning on pinning them when they landed. Thunder had a somewhat erratic race. He did hunt and may have connected with birds a couple of times when gallery or scouts rode up birds with him standing in the areas, but no definitive bird work. He added a non-productive to his score, and was picked up short of the hour.

RuJem's A Touch of Bourbon was posted on Day 3. Day four began with another heavy fog. It delayed our start by two and a half hours. Once it cleared, we had sunny and humid conditions.

Brace 20# KINWASHKLY FRENCH VELOUR "Val" (Andreas) & DAKOTA ALLEY CAT "Tiger" (Tracy). Val was very busy with bird work galore, but did not reach out to all age range. Thanks to my scout, Ed Tillson for firing for me when I ran out of bullets. Tiger started a bit slow, but moved out well in the later portions of the course. He ended up having a stylish limb find at time, buried in a deep draw far over a high hill to the right.

Brace 21# DIAMOND HILL'S DEUCES GONE WILD "Cooter" (Tracy) & BOUNCIN' BETTY (Garrow). Cooter scored a remarkable find at 6. Initially the handler could not find the bird, moved the dog up and tried again. When he decided to take the dog on, a bird rocketed out from right under the dog. Cooter stood steady. At 12, Betty had a class find on a hill with a pair of pheasants going out at the flush. Both dogs were taking in a lot of real estate. Betty was more to the front. Cooter scored another find at 28 followed with a find where sharptail were seen by handler but not the judge. Cooter wanted to bend to the left and ended up close to the gun dog course. Betty had point called for her in the end of a grassy finger with handler calling quail, but no birds were observed by the judge. She had a very strong first 45 minutes, slowing but still moving out the last 15 minutes as she cast along a fence taking it all the way to the end. A commendable hour for a young up and coming dog and an old veteran.

Brace 22# SHADOW ATTACK (Tillson) & LINVEL'S ACE OF HEARTS (Tracy). Tack had a mishap on a bird near the big pond. Ace took off deep on the left hand side of the course, but at 20 his handler decided he was not happy and Ace went on the dog wagon.

Brace 23# JAYHAWK'S GEORGIA GIRL "Gigi" (Tracy) & ACE'S DI (Garrow). Gigi made a big swing threw a high meadow, and had a stunningly beautiful find silhouetted with a high stance against the sky along the fenceline atop a high ridge, with all in order. She continued in good form for about half an hour, but began to shut down and was picked up. Di was having her own kind of fun hunting the draws, and was seen in the area of a flushing pheasant. She, too, tired early.

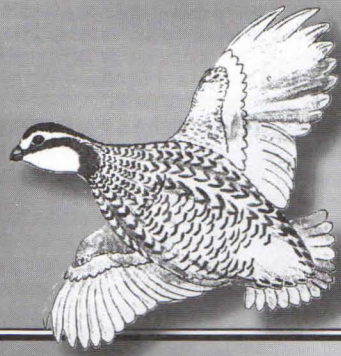
Brace 24# BRITTMONT THE HAWK "Hogan" (Garrow) & ACE'S PATCH (Holman). Hogan put in some nice moves but was not changing anything. He did not go the hour. Patch started out like a house afire. He made for the front with power and speed. We watched him fade onto the horizon, and eventually the tracker came out for him.

Brace 25# PRIME TIME OUTLAW JOHNNIE "Cash" (Kolinas) & ELET'S COLORADO BLUE (Tracy). This pair was quickly swallowed up by the feedstrips. At 10 point was called for Blue, and while the scout rode up a bird a long way from the dog, it proved to be non-productive. Blue again disappeared into the heavy jungle of feedstrips, with no farther action to his credit. Cash was finally produced after a long absence. He pointed on the brim of a hill, with no bird produced. Released, he ran to the next ridge and was seen under a rooster to end his chance.

Two dogs were added to those posted, Diamond Hill Deuces Gone Wild and Bouncin' Betty. The last day was bluebird perfect dog running weather, as we headed out for the last two braces.

Brace 26# MODAN BELIEVER "Buddy" (Cross) & TRADEMARK'S ICEMAN "Timmy" (Holman). At 5 Timmy was on point at the end of a feedstrip with Buddy honoring. No bird was flushed, and Buddy released himself away from the action before it was appropriate. Judges informed Cross that Buddy would not be used, but he could leave him down. At 10 Buddy scored a good find, but when we ran across the dog wagon at the top of the dairy cow pasture, he was put on the dog wagon. Timmy, meanwhile, was putting in a hard charging, hunting effort. At 14 he was styled up along the fence to the right when we approached the big pond. Chad flushed a big rooster here, with all in order. Timmy continued to check all likely cover with intelligence. As we climbed out of the hills, Timmy was sighted far down the bottom, going away to the front. At 55, he pointed on a small hilltop in the hayfield, with two sharptail moved. Timmy finished well.

Brace 27# OAK HILL'S TIME TO BURN (Holman) & HANGING JAZE HOWLEWEYA AMEN "Slick" (Tillson). Our last brace had two contenders to the end. Bernie had a stop to flush at 6, followed by a chicken find, a second find where two pheasants were flushed, and a third find on a running pheasant in a feedstrip. Bernie finished the hour with a deep cast in a long draw, hunting hard. Slick was strong, forward and going to the right places. At 22, he scored a limb find on a steep hillside across a fence. I was glad to be the reporter not the judge as I watched Ed and Gary walk to the stylish dog waiting for them in the distant yonder, where a sharptail was flushed. At 48, Slick pointed outside the fence draw, facing into the top of it, with a pheasant flushed and all in order. Slick had a lot of drive left to make a strong finish and gave the judges lots to think about.

Congratulations to the young participants – including Thomas Swanson who handled his Brittany Mc's Fred Bear O'Dee MH to a pass. St Croix Valley Brittany Club also had a HT judge apprentice both days.

The Double Hunt Test venue allowed the clubs to leverage purchasing birds, grounds, and lunch. Committee members had several planning meetings, coordinated the running orders and sent out joint club messages to participants. Saturday was a cool, dry long day with approximately 16 Junior Hunter braces and 16 Master/Senior braces for each club the evaluating of hours continued into the evening hours. Sunday morning greeted the crowd with several inches of snow on the ground, which quickly melted by mid-morning. Like the actual hunting season, everyone was dressed in blaze orange. There were participants and volunteers of all ages.

CONDITIONS AND RULES



- American Brittany Futurities shall be open to every purebred Brittany bitch and her progeny whelped during the calendar year of January 1 - December 31 and whose litters have been enrolled with The American Brittany Club.
- Bitch must be owned or leased by an American Brittany club member.
- All dams nominated and all sires bred to must be registered or eligible for registration.
- Nominations of dams must be made within 30 days after the bitches have whelped.** A sum of \$30.00 must be paid at this time. This payment will entitle each puppy of this particular litter to be entered in the ABC Futurities (Field and/or Bench) after the dog has been properly registered in a recognized stud book.

- Late litter nominations will be accepted with the following current fee schedule:** Late fees are: \$30.00 for 31-60 days, \$60.00 for 61-90 days, and \$100.00 for any nomination received more than 90 days after whelping. No nominations will be accepted past 180 days of whelping. Additional late fees may be imposed from time to time by the ABC Board of Directors. The postmark will determine the fee for late nominations.
- Dogs will be eligible to run in the designated futurity to be held in the Spring of the second year following the year of whelping.
- A final nomination fee will be due by September 15th of the year following whelping. Entry fees will be paid by the owner of the puppy for each Sectional Futurity field or bench event the dog enters.
