Ken Windom, our sweepstakes judge was very pleased with his entry and felt he had many quality dogs to choose from.

Regular and non-regular classes were judged by Linda More:

Here are her comments about her judging experience:

Sunday evening after the Brittany specialty, I was leafing through the catalog/yearbook and realizing what a wonderful time I had had. It wasn't the show site – though this is hardly the first time a club has had to “make do” with temporary arrangements. It was the dogs that had made it such

an enjoyable experience – many of them attractive, athletic, functional, friendly, with appealing heads, eyes and expression. It was such a pleasure to judge them, and I thank all the exhibitors for the opportunity.

General remarks: I thought that overall, the quality in dogs went deeper than that in the bitches, in this entry at least. Some entries in both sexes that I liked very well in many respects did not go higher on the day due to less than good feet. And I was happy to see, when I was able to read the catalog, how many of the dual titled dogs were handsome Brittneys that fit the standard nicely. More than in any other Sporting breed, Brittany breeders appear to be producing dogs that “can do” in both conformation and the field, something to be very proud of.

As to the BB and BOS winners: when I walked down the line of very nice dogs in the National Field Qualifier class, I was attracted right away by the upstanding dog at the end of the line, for his balance and square proportion, structure and bone, handsome head and soft expression. Upon moving him, it appeared that he simply could not put a foot down wrong, whether down and back or from the side, and he went with wonderful ease and extension. He had good feet, too. Added to that he was in very good muscle tone; not a lot of coat but what was there was of decent quality. Throughout a very nice Best of Breed entry this dog held up in all the things I was looking for and for me, it was his day to be king. I was delighted to learn afterwards that he was a Dual Champion, and interested to be told that I had given him points some years before.

The Best of Opposite bitch is simply one of the prettiest Brittneys I have ever seen. She is beautiful in outline and proportion, mature body, head and expression, quality of coat, and extension on the move. She stood out immediately when the bitches entered the ring, and was a pleasure to go over. On that day, though, the Best of Breed dog had the edge with his lovely muscle tone and his consistent excellence in movement. I was very happy to have seen and judged both of them, and was very pleased also with the quality of the Award of Merit winners and numerous others. This speciality definitely enhanced my appreciation of the breed.

Remembering Harold Green

Both ABC and the Missouri Brittany Club have lost one of the breed's great supporters. Harold Green died suddenly in January while helping his son-in-law and children cope with the death of his daughter in Cape Coral, FL. Harold served as President of the Missouri Brittany Club for over 15 years, easily one of longest terms in the history of the club. Harold presided over a club "in transition" as landscape changes came from a variety of sources similar to those facing all of our ABC affiliated clubs.

Harold first joined MBC in 1973 when he acquired a young Brittany from Herman Bonine. He became friends with Rosco Staton and was a fairly active member. At one time he had a well-bred field trial prospect, which was stolen before he could get it started in competition. At that time the MBC, like most Brittany clubs, was a field trial club exclusively with a good bit of show dog interests. Harold believed in the Dual Dog concept to a tee. By the time Harold assumed his role as president he had already seen the signs of change. He stayed in tune as the club kept moving grounds from James A Reed, to Hillsdale Lake to Pony Express Lake and one time to private grounds in north central Missouri. Even though he didn't run field trial dogs, he often drove the dog wagon at our trials. As many field trialers began to exit the sport Harold tried to broaden the appeal to bird hunters at large. One of his ideas was to upgrade the fairly primitive MBC Internet web site. To that end he managed to get the club to invest in "DREAMWEAVER". He passed before his vision was realized but as anyone who has visited the new MBC site will see, Harold would be proud of his club.

Another of Harold's passions was fly-fishing. He served his local fishing club with the same enthusiasm as with all of his varied interests.

There was another lesser-known talent others might not have known of, Harold was a world-class BBQ competitor, having won a Championship at the world famous American Royal BBQ competition in Kansas City. One year, as the club was planning our spring field trial, the subject of food service for our guests/participants. Harold piped up and said he could cater brisket, ham, beans etc. and probably do a better feed than anybody in the area, and HE DID. He got rave reviews from everyone who attended!

Harold Green will be missed.

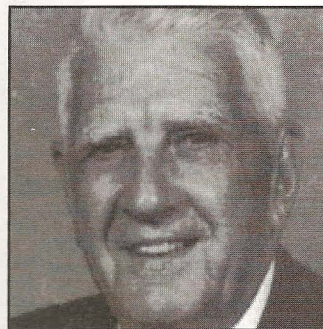

SUSQUEHANNA York Pointer Setter Club Wellsville, PA Oct. 2-4, 2009

The Susquehanna Brittany Club held our fall field trial over the long time grounds of the York Pointer and Setter Club in Rossville, PA. The grounds just having completed the first stages of a major improvements program with some clear cut timbering to open up about 20 acres of woods on the grounds. Although the clear cut presented some extra care needs, when handling and scouting, the grounds were in great shape and the new cutting made for some very nice performances by the dogs.

We began our fall trial on Friday, October 2nd, 2009 with the Open Limited Gun Dog stake. We saw lots of dogs run over the freshly timbered course and do well. It was a hard stake to judge as there were several dogs with great bird work and ground races enhanced with the ability to see more across the wider open fields. There was also some great work on the ground and not the bird work wanted and some great bird work but just not the ground work hoped for. We have to remember these are just dogs and not machines. No matter how old a dog, some days they are just puppies in their own minds. This day Spring Hill Pancho Del Prado for owner Steve Lauterbach came and ran our pants off with sharp, crisp bird work. Steve has brought "Pancho" back to a form that we are all eager to watch. Jim Wilkerson and Paul Snyder's Poison Ivy was on her game also and did a fine job with lots of ground speed and some good bird work to earn the red in this well contested stake. Chris Rider brought both his dogs ready to point birds with class and style but just a bit less ground work then needed to beat the other two dogs ahead in this stake.

The Open Puppy followed the Limited Gun Dog Friday afternoon. This meant there were birds out and the grounds in good shape to see some puppies run and cover and hunt the course. This stake provided one of THE FIRSTS for us at this trial. A brand new club member, handling his just turned 8 month old pup came to run his dog for the first time at a field trial. He was very worried about being new and afraid that without thirty years experience he might mess his dog up and his brace mate with something an older more experienced handler might avoid. After lots of coaching and the lending of a horse from Barb Youngs, whistle and blank pistol from Bob, advice from trial chairman Dan Rein, Troy Hoverter got on the horse and road into the setting sun with his puppy handling and covering some nice chunks of ground. Handler's first time to handle and pup's first blue ribbon. As we told him, "the hook is now set deep".

The Open All Age was held up on Saturday morning with a fog delay of almost two hours but we got all run with a new Field Champion earning the blue ribbon here. Jogger's Reserve owned by Dan Rein and Bob Youngs handled birds and ran to the front in this new cut over groomed set of grounds to win. It was a hard day on dogs as scenting was tough at times. The winner had four finds and a forward, strong race. It was a very nice win for all concerned with Toby.

Following the finish of the Open All Age, the Amateur Gun picked up with keen competition and again, lots of good work. Weather and grounds changes as well as temps that climbed made bird work that was excellent hard to come by. Many good dogs made derby mistakes and yet there were dogs that rose to the top that had great performances. Bruce Conover's This Bud's 4 You came through for the blue with a strong race and good

bird work. Steve Tubach handled a dog for Brian and Helen Wriggle called The King of Pop's to the second spot with a forward ground race and several nice finds. Chris Rider handled Barton Hollow Bear to third with more of that excellent style on birds and a forward race. Dan Rein with his Jack, Bourbon Straight Up, had excellent ground work and three well spaced finds to bring in the white ribbon for his owner.

Following Saturday's running we all enjoyed a great pot luck dinner prepared by Jo, Barb, Marilyn, Joan and Dennis that featured four different kinds of roast pork with all of the "fix'ns". About 45 people stayed and ate and enjoyed the meal along with placements. Judges were thanked and given brand new bridles or roading harnesses of their choice made by the Amish for us as judges' gifts.

We began on Sunday morning without the fog of Saturday. The temps were cool and breezy but not cold. A small fire in the wood stove at 5 a.m. had the club house warm and toasty as judges and club members and others ate breakfast inside. The day was great for running dogs with lots of sunshine and dew on the grass that lay heavy and wet. A light breeze prevailed all day. The derby stake was small but Brian Wriggle's Wild Mtn Let Her Rip, did a fine job on the ground running strong and pointed a several birds with lots of style. New club member Troy Hoverter ran his puppy Max for his second time handling at a trial. Max showed lots of good ground effort but just could not get birds pointed today. First place was awarded to Brian's Wild Mtn Let Her Rip with all other placements being withheld.

Dan Rein and others were out planting birds following the last brace of Derby and the Open Gun was off and running. This large entry showed lots of great dog performances by. Les Casselberry came with DC/AFC Scirocco Del Prado needing a win to qualify for the National Gun Dog Championships next month and came away with the blue ribbon for his owners. Les was quite excited as Club President Bob Youngs reminded folks that last year Brian Hendrickson came here with the same need, won here, the same stake Les won and then went to win the National Gun Dog Championship at Ionia. Close behind Les was Bruce Conover again with Bud. He's in the money almost every week and doing a good job. Bruce was back with Flyboy for third. This was a close stake and just one small piece of action can change so much in the placements as in any stake. His speed and style are a part of every performance he puts down and today was no exception.

A club is always lucky to have members that come to work and this weekend we had not only the regulars like Marilyn Fenicle, Barb Youngs, Dennis Green, Dan Rein, Lou Palazzolo and Wil Smeltz we also had new member Troy Hoverter helping on Friday and Sunday to plant birds with guidance from Bob Youngs and Dan Rein. Our club is truly blessed to have this many workers that come to plant birds, give up their horses and time riding to work in the kitchen and cook and serve all those guests of the club that come to run dogs. Some club members spend two or three days just rounding up folks to be "on the line" so the judges don't have to wait around for folks to get to the line. We have a club that does much and will do more as long as we have good folks like we have working with us now. In addition we are lucky as we see other clubs represented at our trial and all are willing to help and lend a hand. As memberships run low in some areas we find that folks are joining more then one club so they can work at both clubs functions! This is something that many don't see unless it is pointed out that not all of the folks are completely local. We do appreciate every chore, every task done and every offer given.

Last but not least we can't write about the trial and not thank the judges that come and ride and give their honest opinions. We may or may not agree all of the time but that's the great part of this sport. The different perspectives of those that we ask to watch our dogs keep us all up in our saddles. Each person see's each situation a little different. Yet we see so much the same. Experience is something that tempers much of what we see in placements and it's great to see judges like we had this weekend all smiling at the end of each stake and knowing that two people came, watched and agreed on placements, agreed on how and why they looked at the dogs and even if we presented great or not so great they watched and judged on total performances and not some book that gives a few sentences of what to look for.



On a side note this weekend, for the writer and his wife, was one of sadness and joy at the same time. In the Open All Age an old dog made her final field trial appearance (sadness). Joan Warshefski's SoSueMe was retired for her final time as she and another first time handler at this trial made his appearance. Mason Viehman, 9 year old grandson of Barb and Bob Youngs handled Sue in the final brace of the Open All Age as a bye dog (great joy) shown above. She was handled well as Mason rode "Grammy's" horse and took Sue around the course with a find at pickup. Mason sang to his dog, blew his whistle and road to Sue at pickup to call point. He flushed birds with the help of Pappy and fired the gun. Later he remarked that when you shoot the gun yourself it is much louder then when you sit in the gallery. Judges Wil Smeltz and Howard Shultz were two fine gentlemen helping this young boy as he handled the dog. We are looking forward to more of these first time handlers like we had this weekend as that will better the future of our sport.

Thank you to all that came, entered dogs or just came to watch. Thank you to club members, judges our field trial secretary, Joan Warshefski, for all she does before and after the field trial, Dan Rein as Committee Chairman for all he does getting judges and setting up the workers so that all runs smooth and for keeping our "guests" feeling welcome, and the field trial committee members for all of their work to make this trial such a success.

American Brittany Club Futurities

CONDITIONS AND RULES



- American Brittany Futurities shall be open to every purebred Brittany bitch and her progeny whelped during the calendar year of January 1 - December 31 and whose litters have been enrolled with The American Brittany Club.
- Bitch must be owned or leased by an American Brittany club member.
- All dams nominated and all sires bred to must be registered or eligible for registration.
- **Nominations of dams must be made within 30 days after the bitches have whelped.** A sum of \$30.00 must be paid at this time. This payment will entitle each puppy of this particular litter to be entered in the ABC Futurities (Field and/or Bench) after the dog has been properly registered in a recognized stud book.

- **Late litter nominations will be accepted with the following current fee schedule:** Late fees are: \$30.00 for 31-60 days, \$60.00 for 61-90 days, and \$100.00 for any nomination received more than 90 days after whelping. No nominations will be accepted past 180 days of whelping. Additional late fees may be imposed from time to time by the ABC Board of Directors. The postmark will determine the fee for late nominations.
- Dogs will be eligible to run in the designated futurity to be held in the Spring of the second year following the year of whelping.
- A final nomination fee will be due by September 15th of the year following whelping. Entry fees will be paid by the owner of the puppy for each Sectional Futurity field or bench event the dog enters.

THE AMERICAN BRITTANY CLUB 64th ANNUAL FIELD & 49th ANNUAL SHOW FUTURITY Trial and Show to be run Spring of 2012

For all purebred Brittany bitches whelping a litter on January 1 thru December 31st, 2010, who are owned or leased by a member of The American Brittany Club.

Nomination must be made within 30 days of whelping or subject to a late penalty fees • NOMINATING FEE: \$30.00

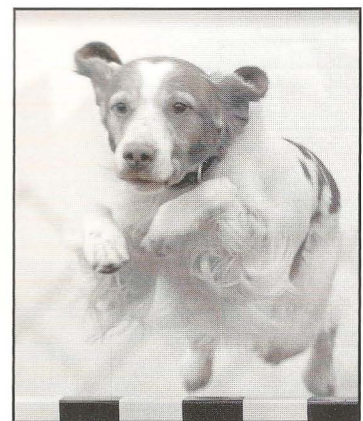
