

## **Obedience/Agility/Rally**

#### NAVIGATING BY NOSE



My dogs bark as we approach their favorite hunting ground. Regardless of the route we take, they know when we're approaching. I've always wondered exactly how they find their way. Safe to say that olfaction is involved, in this real-life situation, as well as in dogsports such as tracking or hunting. But while we know more now about canine olfaction than ever before, the dog's sense of smell is so much more powerful than ours, it's difficult for us to clearly imagine how it works.

James Walker, former director of the Sensory Research Institute at Florida State University, estimated that a dog's sense of smell is anywhere from 10,000 - 100,000 times as acute as a human's sense of smell (http://www.appliedanimalbehaviour.com/article/S0168-1591(05)00219-4/abstract). Let's conservatively assume it's 10,000 times better. Walker elaborates "If you make the analogy to vision, what you and I can see at a third of a mile, a dog could see more than 3,000 miles away and still see as well".

Alexandra Horowitz, a dog-cognition researcher at Barnard College noted that while a human might notice a teaspoon of sugar added to his coffee, a dog can detect a teaspoon of sugar in a million gallons of water, enough to fill 2 Olympic size swimming pools.

One study by Wells and Hepper, from the Animal Behaviour Centre at Queen's University Belfast, Ireland, brought tracking dogs to a trail recently walked by a person and showed the dogs could determine the direction the person walked from only 5 steps. The dogs' scent discrimination was so strong that they could smell that the first step had a less odor than the fifth step (since odor molecules diffuse into the surrounding air over time). Amazing.

Investigating navigation in other non-human animals may further deepen our understanding of scent in dogs. For example, birds migrate using many tools, including detection of the earth's magnetic field, an internal compass, stars in the night sky (during nocturnal migration), sunset and lighting cues, vision (detection of landmarks such as mountains and rivers) and of course scent (http://www.birds.cornell.edu/AllAboutBirds/studying/migration/navigation).

In one bird experiment, Manx Shearwaters were removed from their nesting island in Britain and flown by plane to unfamiliar distant locations. Half were flown by plane to Boston and the other half were flown to Venice. Both groups returned to Britain in 14 days, covering approximately 250 miles per day.

Scientists estimate that homing pigeons use an olfactory map to assist in navigation, at least in the 300 miles closest to home. Imagine a pigeon at home amidst the scent of pine trees from one direction and an onion farm in the other. When the bird moves closer to the pine trees, the scent of onions weakens. If the pigeon is flown by plane 300 miles away, it can fly towards the precise location where pine and onion scent indicate they're home by using a combination of olfaction, as well as its other tools.

Turtles also use both the magnetic field and the sense of smell to find their way to their nesting grounds. In one study, a group of turtles was caught and released away from their nesting grounds and their return was monitored using GPS tracking. Before release, the researchers attached a strong magnet to half of the turtles, which disrupted their magnetic field. But despite the handicap, all turtles made it back to their nesting grounds. Since the magnetic field of some was disrupted, it is postulated that those turtles used both the ability to sense location using the magnetic field as well as their sense of smell (http://www.cbc.ca/natureofthings/episodes/when-north-goes-south).

Dogs also navigate by using their noses, along with the other tools available to them. A study by Mary Cablk, from the Divisions of Earth and Ecosystem Sciences in Nevada, recruited and trained dogs to detect live tortoises. When their handlers took them out into a large area with tethered tortoises and strict monitoring, their GPS coordinates were recorded every second. The GPS readings showed the path that the dog's followed to detect the turtle odor and follow it to the source (the tethered turtle). They mapped the dog's "head snap", the moment where the dog makes a sudden sharp change in direction, and tracked it directly to the source (http://www.mdpi.com/1424-8220/8/4/2208). The distance from the initial detection/head snap to the source ranged from 0.5 m to 62 m, under those set of environmental conditions (humidity, wind speed, terrain, etc). Further, the wind data suggested that, of 184 tortoises detected, 21 were first detected by sight (while upwind) and the other 63 were first noticed through olfaction.

In summary, dogs certainly navigate by using their amazing sense of smell, but may also draw on an arsenal of less obvious tools to navigate our world. To date, dogs detect odors better than humans equipped with the best mechanical chemoreceptors available. We're only beginning to truly understand the workings of the complex world of canine olfaction and navigation. We have a lot more to learn from man's best friend.

## TRAININ' DOGS

### with Rick Smith

### Sight Pointing

A dog's nose is an amazing and wonderful thing. However, if we take the human hunter out of the equation and go back a few thousand years to a time when a dog had to hunt by itself or with a pack of other dogs, things change dramatically. Back then, dogs had to scent the game, point it, and then carefully stalk it; and in order to catch it in the end, the dog had to see it. The purpose of pointing was to freeze on scent so as to not scare away the prey, and then the dog would carefully work its way close enough to catch it.

Young dogs learned quickly that getting too close too soon meant going hungry.

In modern times, dogs no longer need to hunt for food, but the instinct is still there. We provide the dog's food, which puts us in a position to take leadership of the dog. The trick is that we still have to be the leader; it's not a position automatically conferred on us. In our modern hunting scenario, hunting is still a team effort just like it would be in a wild pack. However, now each member of the modern "pack" has a strictly defined role. The dog's job is to locate the game, and the human's job is to kill it. The ideal way for this team to work is for the dog to lock up on point at the first scent of game. This gives the hunter the best chance at getting a good shooting opportunity.

We don't have anything remotely close to our dog's scenting capability, so it's natural to want to see the bird when the dog is on point when training. We tend to assume that the dog has to be close enough to see it, when in actuality the dog shouldn't. Remember,

if the dog can see the bird, the bird can see the dog! And in most cases that also means that bird will be long gone before we can get a shot. It's important to let go of our human limitation and trust the dog to find and hold the birds using its nose.

Developing a dog to work as an

effective part of the team starts when the dog is young. It's important to encourage a puppy to use its nose. At an early age, you'll often see puppies sight point. They tend to freeze and then stalk anything that moves, from leaves to grasshoppers to songbirds. And with a young puppy, that's okay for the first three or four months. During this time, they're developing their hunting and stalking skills and exploring the world in general. Everything is new, and they need to figure out what it is and what to do with it.

One thing that's often done with puppies is the "wing on a string." A bird wing or bunch of feathers is attached to a pole via a long string, and the puppy is encouraged to point it. This can be cute and fun for both the puppy and the owner, and the temptation to show off the puppy's skill at pointing a wing is great. While this is fun, be forewarned: It is also teaching the puppy to point on sight rather than scent. Does that mean the wing and string shouldn't be used? Not at all. But once a puppy starts pointing it on sight, it's time for that game to be permanently put away, or you run the risk of teaching the dog it is supposed to point on sight rather than scent. Of course the feathers have scent and the puppy can smell the feathers, but as long as it can also see the wing, it is sight pointing. Be careful not to turn a fun game into a bad habit.

In the backyard or the field, if a puppy sight points butterflies or turtles or songbirds, don't pay any attention to them. Don't acknowledge the behavior or praise or do anything else to encourage it. Just keep walking. This lets the pup know that we aren't impressed and won't be rewarding that behavior.

The very best way to help a dog learn to point on scent rather than sight is with wild birds and lots of them. Wild birds are spooky and will not hold if the dog gets in too close, and the dog will quickly learn to stop on scent. Planted pen-raised birds, on the other hand, can often be caught and can encourage a dog to

"Ōkav." you say, "but there aren't any wild birds I have access to." There's a way around this dilemma. You c a n plant pigeons or pen-raised birds and then checkcord the dog in toward the bird, always making sure you come from

sight point.

Here's a dog's-eye view of a bird, sight pointed. This quail is on high alert and ready to get out of there, which means a missed shot opportunity

downwind. Watch your dog carefully for any sign that it has scented a bird and stop immediately once it does. A dog will usually act more excited, with head up and tail wagging fast and try to locate the source of that wonderful smell. You should use the checkcord to stop the dog from getting in close enough to see the bird. Be careful to stop the dog gently rather than with a hard jerk on the checkcord. If the dog's focus turns to you, you've used too much pressure. We want the dog to remain intently focused on the bird scent. If you have a helper, you can stay with the dog and support it while your helper walks in to flush the bird.

Even better, a remote bird releaser/launcher can be a big help for a dog that has already developed the habit of sight pointing. The first thing to do is use the launcher to teach the dog to stop to the flush. Don't worry about pointing at this stage. If the dog gets excited at the scent and starts moving in toward the bird, you can push the button and get the bird into the air. If the dog gets to within 20 feet of the bird, launch it. Make sure the dog is looking in the general direction of the launcher when you release the bird. This teaches the dog that getting closer after scenting will scare the bird away, and the beauty is that you don't need a checkcord to do it. It won't take long to see a difference in the dog.


After a few repetitions of the bird flushing when the dog ignores scent and wants to sight point, you'll notice your dog becoming more careful and slowing down when it gets wind of a bird, and it won't be long before the dog is pointing on scent. It's not uncommon for dogs to want to chase the bird when it's released;

that goes on to whoa training and steadiness, which comes later when the dog has learned to stop on scent. Don't worry about that while you're teaching the dog to point on scent – stick with training one step at a time.

When planting your birds, even in launchers, always have them in heavy enough cover so that the dog can't see them. Make sure no part is visible so the dog has no recourse except to use its nose. Set up every training session to maximize your dog's success. Pay close attention to wind direction and scent conditions. Damp cover holds scent better than dry, and strong, gusty winds make scent difficult. Try to time your training sessions with the best scent conditions to give your dog every opportunity to succeed.

On wild birds, it is uncommon for a dog to point birds by sight. And over the course of a lifetime, its nose will find many, many more birds than its eyes will. The more birds a dog points via scent, the more shots you'll get, and the more you'll want to take your dog hunting.


The meeting was then opened to the membership to bring up questions or ask for discussion on concerns or topics of interest.

ABC is a member of the Chic Program. Over 200 Brittanys have submitted information to be recorded. They record all information whether it has received a pass or fail on hips, eves, elbows, etc. We are proud to say we have a very healthy breed. This gives us a database of good information on dogs to use in one's breeding program. She thanked Dr. Margaret Horstmeyer for helping ABC to get this program started. She will be doing a complete program on this organization at 3:00 PM at the show site.

Margaret Horstmeyer said the ABC health and genetics committee would be doing a survey next year...probably online. Just wanted













people to know this will be coming up.

Ray Trimble asked if Pres. Rankin would give us an outlook for future trialing at Conway and Blue Mt. He discussed the pre-release programs at Blue Mt. both in the spring and fall of about 1000 birds. The new plan passed for Conway says the state will no longer buy the birds. The state will give the dog wagon at Blue Mt. to the clubs, but we will have to provide the dog wagon driver in the future. The state will not be doing as much mowing but more burning for habitat management. The Blue Mt. Plan should be passed this coming spring. The state is not interested in us hiring someone to mow but they would do necessary/appropriate mowing. Not much having will be done. Clubs will continue to pay the fee to the state for running here on a per day basis. We may have to increase entry fees to pay Blue Mt. Association to buy birds for the pre-releases. Tom Milam listed the different breeds that run on these grounds. Several addressed talking to the local tourism, Chamber of Commerce, and governmental groups to help us when the Management Plan comes up for a vote. Joe Gower felt that we needed to concentrate on these local groups who have cultural and political impact that could help us. They will not be rebuilding the club house at Conway destroyed by a tornado. A bathroom will be put in the new barn. Conway is also forming an association like the Blue Mt. Association which has been around for many years.

Hearing no other questions or topics from the membership, the meeting was adjourned at 8:50 PM.

### **BAKED STRADA**

6 English muffins, split and quartered

- 9 eggs
- 1 cup milk

1 - 4 <sup>1</sup>/<sub>2</sub> ounce can diced green chile peppers, drained

<sup>1</sup>/<sub>4</sub> teaspoon salt

<sup>1</sup>/<sub>4</sub> teaspoon ground black pepper

1 cup diced cooked ham (about 5 ounces)

4 green onions, finely chopped (1/2 cup)

1 - 2  $\frac{1}{2}$  ounce can sliced pitted ripe olives, drained

1 - 7 ounce jar roasted red sweet peppers, drained and cut into strips

1 ½ cups shredded provolone cheese (6 ounces)

<sup>1</sup>/<sub>2</sub> cup shredded cheddar cheese (2 ounces)

1. Arrange English muffin quarters in a single layer in a greased 3-quart rectangular baking dish. Set aside.

2. In a large bowl, beat together eggs, milk, chile peppers, salt, and black pepper with a rotary beater or whisk until well mixed. Pour egg mixture over muffin quarters; sprinkle with ham, green onions, and olives. Top with roasted sweet pepper, provolone cheese, and cheddar cheese.

3. Preheat oven to 350 degrees F. Bake, uncovered, about 35 minutes or until a knife inserted near the center comes out clean. Let stand for 10 minutes before serving.

### **BREAKFAST CUPS**

12 links breakfast sausage (Can also use 1 lb of bacon)

3 cups frozen country style shredded hash brown potatoes, thawed

3 tablespoons butter, melted

1/8 teaspoon salt

1/8 teaspoon pepper

6 eggs, lightly beaten

2 cups shredded 4-cheese Mexican blend cheese

1/4 cup chopped red bell pepper

Chopped, fresh chives or green onion

1. Prepare sausage (or bacon) according to package directions. Cool slightly and cut into 1/2-inch pieces; set aside.

2. In a bowl, combine hash browns, butter, salt and pepper; divide evenly into 12 greased muffin cups. Press mixture onto sides and bottom of muffin cups.

3. Bake at 400F for 12 minutes or until lightly browned. Remove from oven, divide sausage pieces into muffin cups.

4. In a bowl, combine eggs, cheese and bell pepper. Spoon mixture evenly into muffin cups. Sprinkle with chives or onion. Return to oven and bake 13-15 minutes or until set. Serves 12

## **Laryngeal Paralysis**

There is a growing awareness of a breathing problem seen in many older Brittanys. As a Brittany owner and veterinarian, I have watched several of my own and friends' dogs suffer from this problem. While our breed is not listed as being predisposed, I believe, based on my own observations and conversations with colleagues and other Brittany owners, that our wonderful breed does suffer an increased incidence of laryngeal paralysis. I could speculate as to why; genetics, training methods that result in trauma to the neck or our wonderful breed's dislike of walking on a loose leash! The signs of this disorder are insidious in onset and many times attributed to other disorders. I believe that many veterinarians don't have a high index of suspicion for this disease and think of it more often in larger breed dogs. Even when it is suspected, because the signs are subtle and slowly progressive, owners and veterinarians are not quick to pursue a definitive diagnosis. Unfortunately, as I discuss below; when a crisis occurs, the prognosis for survival AND good quality of life is poor without rapid accurate diagnosis and aggressive treatment. While it is important to understand the risk of surgery and postsurgical complications, it is equally important to understand that doing nothing will result in a poor quality of life for your dog and the inevitable crisis will lead to a heart rending decision on your part and/or an unpleasant death for your dog. Surgery when done by an experienced veterinary surgeon with the expertise AND facility/staff to manage and avoid complications can lead to a good quality of life for your older dog. There are NO medical treatments that will allow your dog to breathe comfortably once this disease has advanced to the point where the airway opening is significantly affected.

**So what exactly is the larynx?** The larynx is a structure that is located at the top of the throat, just in front of the tubes that lead into the lungs (i.e., trachea) and stomach (i.e., esophagus). When the larynx is fully open, air can pass freely into and out of the lungs. When closed, as is the case when an animal swallows, the larynx prevents food, water, or other substances, including air, from entering the trachea. The larynx also houses the vocal chords and other structures. The larynx is a box primarily made out of cartilage and soft tissues. In the middle is an oblong opening that is oriented vertically. Laryngeal muscles contract and relax to open and close the larynx depending on whether an individual needs to breathe or swallow.

**What is Laryngeal paralysis?** The opening to the trachea ("wind pipe") normally is pulled open on two sides when breathing in, and relaxes when breathing out. In dogs and cats with laryngeal paralysis, the muscles that normally pull the airway open do not function properly. When an affected pet breathes in, the walls of the airway do not pull open—rather, they are sucked into the opening, or in severe cases sucked shut. It is like breathing through a straw. Early in the condition, this creates increased noise when they breathe; later, it can completely obstruct their airway, and they can suffocate.

The early signs of laryngeal paralysis can be quite subtle. You may notice harshness in their panting, increased panting or panting when cool and calm, a hoarse or raspy-sounding bark, noisy respiration and a high-pitched sound when breathing in (most common), occasional coughing/gagging especially after drinking or eating, reduced activity, exercise intolerance and elevated rectal temperature (especially during warm weather months). Owners report that they see their pet working harder to breathe; their facial expression is a bit anxious, their eyes are prominent and their chest is vigorously expanding. The pet may also look like they are "smiling" when they pant, with their lips pulled way back and tongue hanging out. Dogs will seem to tire more easily during activities such as walking.

Because animals use their breathing as a means to cool themselves naturally, pets with laryngeal paralysis are more prone to overheating under conditions that would not make a normal dog hot. This may be a simple walk outside on a sunny day or vigorous play on a cool day.

When the paralysis is quite pronounced, it is very obvious that the dog or cat is really working to breathe. The extra noise they create with each breath is harsh and easy to hear. Their tongue may be a darker red or purple in color; they do not want to be touched or restrained. They are in "respiratory distress" and need medical assistance. If laryngeal paralysis is not treated, a respiratory crisis can emerge. In this situation, the patient

attempts to breathe deeply and simply cannot, creating a vicious cycle of anxiety and respiratory attempts. The laryngeal folds become swollen making the obstruction in the throat still worse. The patient's gums become bluish in color from lack of oxygen and the patient begins to overheat. The patient must be sedated, intubated and cooled down with water in order to survive. As soon as intubation is done, the patient can breathe normally, oxygen can be administered and the crisis can be curtailed if it has not progressed too far. With this brief but effective therapy, most patients will rest comfortably and return to their pre-crisis state. Unfortunately, most patients that have reached a crisis point will continue to suffer these breathing episodes because their airway is ineffective.

If your veterinarian suspects this disorder, they may recommend some or all of the following diagnostic tests: blood tests, chest x-rays, neurologic examination and sedated examination of your pet's throat. In order to determine if a dog has laryngeal paralysis, the larynx must be examined and this requires sedation. The level of sedation must be heavy enough to allow the larynx to be visualized but light enough for the patient to be taking some deep breaths. In a normal larynx, the arytenoids cartilages are seen to open and close widely. In a paralyzed larynx they just sit there limply while the patient breathes deeply. Obviously, it is best to pursue this diagnosis before a crisis occurs.

What is the most effective treatment? Many different approaches have been used to surgically treat laryngeal paralysis. Over the years and through the monitoring of many post-operative patients, one technique has remained at the top of the list of procedures with good success and few complications, the Unilateral Arytenoid Lateralization or "Tieback". In the tieback procedure, a suture is used to permanently pull the wall of the airway open on one side of the larynx. To minimize the chance of fluids or food entering the airway, only one side is pulled open enough to prevent airway compromise and future breathing crises.

In the hands of an experienced veterinary surgeon, this is typically a relatively straight-forward, **minimally invasive surgical procedure**. The incision is only 3-4 inches on one side of the neck and well-planned pain management can reduce or eliminate post-operative pain directly associated with surgery.

Most small animal veterinarians have not done enough of these surgeries to be comfortable with the technique and more importantly, lack the staff and facility to prevent and monitor for complications. They will likely refer you to a board certified surgeon with a 24 hour care facility.

Restrictions following surgery include use of a harness rather than a neck collar (this should be done immediately if you suspect your dog may have this problem), minimize barking for 6 weeks, pre-form meals into meatballs to minimize the chance of the food being sucked into the windpipe, consider an elevated feeding station or a bowl designed to slow your pet down while eating, avoid swimming and implement a weight loss program if needed.

Minor post-surgical complications can include: incision infection, seroma (an accumulation of fluid under the incision), loss of voice (usually already gone with laryngeal paralysis), coughing during or following eating and drinking (usually tapers off over time).


Major post-surgical complications can include aspiration of regurgitated stomach contents into the lungs resulting in mild to severe pneumonia and breakdown of suture/cartilage connection that results in pre-surgical breathing status requiring re-operation. The surgeon that did my dog's surgery has a specific fasting and drug protocol he uses that decreases the risk of aspiration immediately post op.

While laryngeal paralysis and its post-operative complications can be quite severe, the majority of families living through this with their dogs are happy with the quality of life that is restored with surgery. It is less and less common for aspiration pneumonia to be fatal, and dogs can make a full recovery even in severe cases. Most dogs do not suffer these complications and go on to live well with the ease of breathing restored.

## A SPORTSMAN'S RAMBLINGS

Lots of outdoors persons, here and elsewhere, enjoy horses and horseback activities. And so do we. But, as in any exercise involving the outdoors, accidents are part of the game, and working with half-ton animals presents risks that are pretty specific to that activity.

A couple of weeks ago at a field trial held on the historic English Setter Club grounds in Medford, New Jersey, about a half hour from Philadelphia, a surprising number of accidents took place over the course of only a few days. Having so many mishaps in such a short time was unusual. At mid-week, during a fast paced stake, one experienced handler tried to turn his horse rather sharply; when the animal stumbled, he went over the top and landed on his collarbone, breaking it in the process. Over the weekend, two more riders went down when their horses fell; one bailed off just in time, the other suffered a fractured finger and a few bruises. To round things out, another experienced rider with a newly purchased horse failed to notice how much air the animal had blown out while riding and didn't cinch up in time. During dismounting, the saddle assembly slipped off, depositing the rider, butt-first, on hard, dry soil. Badly bruised, that rider was also through riding for the weekend.

A couple of wags commented that this had something to do with bad karma, running a big field trial during Holy Week (with Passover in the mix as well), but a very well-known dog trainer, who also spent her youth "breaking in" quarter horses, confided that she'd long ago stopped counting cracked and broken bones accumulated while riding horses!

As we've explained in previous essays, most of us get into horseback activities from the periphery. If you go into the Rockies with guides to set up a hunting or fishing trip, you ride in a pack train, horses and burros, or you just don't go. If you compete seriously with pointing dogs in any trials other than walking trials on grouse and woodcock, sooner or later, you'll be in the saddle, handling, judging, or simply observing those dogs.

After only a few rides, you get the feeling that there's more to this game than simply plopping your butt into a comfortable saddle and using reins or legs, especially if you're called upon to ride off by yourself on a steed from the wrangler's string. Horses have a terrific sense of who's a "tenderfoot" or "greenhorn" and who's not, and "rental" horses are notorious for taking advantage of such situations. Now maybe you'll want to get serious about riding lessons, and buy proper riding apparel, designed specifically for the riding you'll do. Riding jeans, proper riding boots, chaps, and certainly a good helmet are starters, and you may quickly find that your very own saddle will serve you well over several seasons.

If you get serious about any horseback-related games, you eventually come to the conclusion that you'll do a lot better with your own horse. Here the story takes a new turn, similar to the anglers who commit to offshore fishing and progress from skiff to cruiser. Horses (We say plural, because they need companions.) require pasture, barn, or boarding, plus trailers and haul vehicles. Now you're really hooked, and so are your life savings!

But, back to the "safety" theme. Even when beginning to ride, you should know about tying lines, adjusting stirrups, saddling and bridling the animals properly in case the wranger misses something, setting up your rental ride. You're the person most affected. A loose saddle for a rider is like a poorly tied knot for an angler. Stirrups too long? No control! Too short? Cramps or balance issues! If you begin to work around horses, you realize how much lifting has to be done---everything from dragging heavy bales of hay and six gallon Jerry cans of water to supporting horses' feet and cleaning hooves. I've never used a lumbar support so often in any other outdoor activity!

But, again, like all outdoor endeavors, when things come together, it's something else. Late on the Sunday of the Medford, New Jersey, trial, I was called upon to run a dog in place of one of the injured handlers. While I judge quite a bit and help out handers as a "scout" when dogs go a.w.o.l., I seldom carry responsibility for steering a wide ranging field dog around a big course. But the dog knew its mission and, within a few minutes, I found myself watching her two fields ahead, swinging along a long edge, searching for game birds. Then the veteran judge cantered up alongside and asked me to turn at the end of the cast. As I called and swung the horse, the dog spotted me and swung 90 degrees at the far end of the field, just the maneuver we wanted.

And this is why we ride!

## GARMIN 2014 American Brittany Club National Amateur All-Age Championship

Stomach butterflies, vertigo, tachycardia....an instantaneous cocktail of medical maladies ignited by a truck horn blast.....placements! Contestants stroll toward the origin of the sound with zombie-like ambulation, hoping they really didn't hear it yet some invisible tractor beam is pulling them there. It really didn't bother either of them; they were not going to hear the names of any of their dogs. The 1999 Chicken Championship had not gone as planned; the dogs hadn't performed well over the expansive sandhills of the Taylor Ranch. This was their second group of trial dogs, the first crop including a National Amateur Champion, set an awfully high standard. In order to put the week behind them, they headed to Montana with hopes some hunting would put a little spark in the string of mostly young dogs. She was particularly fond of the two year old, but admittedly, he had his quirks. He suffered from a canine compulsive disorder of licking his flank and when he wasn't pointing cows, he got pretty good at pinning Montana Hungarian partridge. The string of contenders benefitted from the two weeks of low pressure training but an early snow had them hastily retreating to a Missouri weekend trial. They had one qualified for Booneville with hopes of getting another one in before the fall deadline. Her 2 year old won the AAA stake and qualified. As the auctioneer barked out a cadence in the Booneville clubhouse calcutta, you could have bought him for the price of a happy meal.... no one in attendance having any knowledge of this young dog...but Charlie and Doris Johnson had a calcutta strategy that worked them, they ignored the name of the dog and listened for the name of the handler. From where they sat, this handler was hardly a gamble.

At 2:15pm, on Tuesday, November 23, 1999....just across the Petit Jean River bridge on course 2, JoJo Schroeder released her favorite...quirky.... 2 year old, Hanging Jaze HardTack Mack. The gallery seemed disinterested....no one had the brace circled on the brace sheet.... no one.... but for the next hour, Mack was the poster child for "every dog has his day" and my-oh-my did he pick the right day. He handled, as if on a string, at great distance with 3 flawless finds holding everyone's undivided attention. At time, near the bridge... Jake, with astonished expression, sat astride the grey gelding as JoJo pulled the roading harness over Mack's head.....Charlie and Doris Johnson leapt, like teenagers, from the dog wagon singing "We're in the money!" When Mack was announced the winner, Jake and JoJo exchanged glances thinking one would tell the other, this was all just a dream.

Every amateur arrives at Blue Mountain with dreams... hope....and visions of a winning hour in their head. Most leave disappointed, occasionally happy, but rarely shocked.... like... lottery winner shocked. Jake Schroeder had never given a second thought to Mack's possibilities of winning the 1999 National Amateur Championship but the trophy is proudly displayed in his Arizona home. The following year, at the party held in Mack's honor, JoJo read the handwritten notes Jake had made while she drove across the vast expanse of West Texas, destination Booneville. It started with thanks to Larry McAnally for the grounds conditions and the fact that there were no cows on course 2....it concluded with a short and honest admission that he never saw it coming but it had taught him one of the richest lesson in the sport.....have a plan and never give up! After all, championships aren't won on reputation, paper, or in the parking lot....he had the trophy to prove it!

This stake is the first of a twin bill affair conducted by the American Brittany Club leading to the naming of the National Amateur and Open Champions for 2014. Fittingly, the decade. They handled all the other tasks needing attention when entertaining a group of this size. They performed flawlessly always having dogs available while keeping the

amateurs go first creating great anticipation and excitement around both events. The daylight hours are for competition with evenings full of scheduled social events honoring past champions, notable breed patrons, and club business. The 2013 National Amateur Champion, Wimberly Rowdy Bo-Dandy, was honored on Tuesday night with guests enjoying a prime rib dinner by Judy Button. Owners John and Ginger Gay had the clubhouse decorated in festive fashion with a hand embroidered sign over the fireplace reading "Enjoy our sport, have a ROWDY good time!" John gave a moving speech

as to what the sport and friendships had meant to him and Ginger, along with the important role Scott Johnson played in getting their dogs ready for national level competition. Terri and the Executives played deep into the night with all in attendance enjoying the libations and camaraderie.

National events of this magnitude take months of planning, generous sponsors, quality grounds, and excellent judges. The months of planning are directed by many of the club's stalwarts...Bob Rankin, ABC President; Tom Robin, ABC 1st VP; Field Trial Secretary, Steve Ralph; and Mary Jo Trimble, ABC Executive Secretary. The stake was executed flawlessly by Stake Manager Joe Gower with help from the field trial committee of Frank Pride, Jessica Carlson,

Kent Patterson, and Steve Ralph. Course Marshall Frank Pride was always on the spot to assist handlers or gallery members over the course of the week as glorious weather had the gallery and dog wagon full of spectators.

Purina, Garmin, and Heskett Saddleworks generously supported this championship with dog food, electronic gear and a saddle. These fine sponsors manufacture quality products known throughout the field trial community as products that assist in producing champions. I doubt there was a handler or owner at this year's championship that doesn't utilize one or all of these trusted manufacturers. Purina and Garmin/Tri-Tronics sponsor the annual 1 hour awards for all age and shooting dogs.

Quality grounds are essential for the credibility of a title of this caliber and there should be no

argument that the J. Perry Mikle grounds can separate the field in quick order. Brian Enfield, Brad Wells, and Clyde "Red" Bailey had the facilities and grounds in the best condition many of the competitors could recall in the last



dog wagon gallery in view of the action.

The judicial panel of Wade Haines and Stan Noble has experience at all levels of the sport as trainers, trialers, breeders, hunters, and judges. Each has a lifetime commitment to bird dogs and recognizes quality when they see it. They were attentive to all handlers with high standards for the dogs they used. They were quick in their decisions and fair with all participants. It was a pleasure to ride with these fine gentlemen.

#### THE WINNERS

Champion - TLM Frequent Flyer – h,Tom Milam; owners Harlan Gerardy, Tom & Linda Milam. If national placements were given to those having invested the most sweat equity in Booneville, Tom Milam would take every placement, every year. He's been stake manager, 1st VP, representative for the ABC on the Blue Mtn field trial committee, and scouted more dogs in the Nationals than anyone....ever. Yet, over the years, the stars had never aligned to grant him a placement with one of his dogs. Co-owner, Harlan Gerardy just wanted a good hunting dog. Tom, wife Linda, and Harlan arrived in Booneville brimming with confidence.... this was the dog and the year. TLM Frequent Flyer (Jack) had put the field on notice in September



by winning ABC's only true wild bird championship over the Sandhills of north central Nebraska....The Chicken Championship. Jack is a handsome, leggy, mahogany and white specimen that is a credit to the breed and to Tom and Linda's breeding program. Harlan ran the pup one day on his Texas quail lease and Tom happened to see him. Tom couldn't get to the next trial fast enough....won the puppy stake..... took 2nd in the derby....won the puppy stake again the next weekend. Harlan was now hooked. Jack's hour started at the same place that Mack's 1999 hour started....course 2 near the Petit Jean River Bridge. He was standing on hind feet and straining against the scout to get started. He was fast, wide, and forward over the early portions of the course building steam to the old 109 crossing where he made the eastern swing around the big bowl. Coming out of the

big move, he switched sides and started a championship cast in front of the dog wagon gallery. He smoked the feed strips to the north then swung in full view on a distant edge where he slid to a regal stop. Tom flushed a big covey and the concussion of the 32 caliber chased them to the west. We entered the back loop where Jack did a tremendous job of hanging....rimming....showing....and flowing. He pinned a nice covey in heavy cover on the right as we came back out into the Parish field. Taken on, he was stopped in a feed strip on the elevated edge of the Parrish field. An extended flushing and relocation did not produce. He was ahead and building as time was called short of the bridge.

Runner-up -- MTB Cabo Rita De Scipio – h, Tom White; owners Margaret Horstmeyer & Tom White. Rita is no stranger to the National Amateur pedestal. She won the title in 2012, with runner-up laurels in 2011 and now 2014. She stays busy, consistently forward, and finds birds. She was away on course 1 after lunch where afternoon temps had climbed to comfortable levels requiring only a light jacket. Tom waved off a point for her at the top of the hill around 5 then found her standing with style in a mott on the next hill at 12 to the right of the course. He flushed a small group with all manners in order. She was forward through Lick Creek and went further east to the tree line as we headed to the S curve. She moved well over the series of fields leading to the old corral area. As we neared the chute leading to the double gates, she pointed on a feed strip with Tom flushing birds toward Hwy 109. Reaching the river bottom she stretched out with speed to the river bottom and met Tom as we neared the tree line opening. She rimmed cover on the right of the course and finished strong near the bridge.

3rd Place -- The Ace Of Spade(Spade) – h, Tim Self; owners Tim Self & Dave Capstick. We left under another "chamber of commerce" morning with Spade seen sparingly over the early portions of the course. At 15, as he made the cast down a feed strip, he froze. Tim flushed birds that went back over him with Spade swapping ends on flush. Spade hunted well to Lick Creek and credited with a stop-to-flush at 23 as we approached the S curve. Birds lifted all around him. He handled it well and upon release went 10 yards into a clump of cover and pointed again, handler called point out of the sight of judges and informed them a bird had already left. He flushed briefly, fired, and we went on. He used both sides of the course over the remainder of the hour with a big move near the old corral and a solid finish.



4th Place—Uncle Kracker—h, Bo Ackerman; owners Bo and Renae Ackerman. Kracker was released to course at 9:14, he was forward and across the buzzard roost dam continuing on to make the big swing in the broom sedge field on the other side. He was seen cresting the hill as the congregation surged to the first 109 crossing. He was flashy and forward as we crossed old 109 for the first time and missing as we went into the Parish Field. After an extended wait, the call of point came in the distance with Kracker found standing in a mott of cover to the north. A big covey was pushed out with all in order. Upon release, he disappeared around the end of the same cover and it took some time to pull him out. In the back loop, point was called in the southeast corner of a space just past the gas pad. Bo wasn't able to produce any game. He finished ahead and on course before we got back out in the Parish field.

#### THE RUNNING

**BRACE 1: KINWASHKLY FAT BASTARD(FATZ)** - **BO ACKERMAN; WOLF RIVER'S WINNING TICKET(CASH)** – **RAY TRIMBLE**. We were away at 7:55 on a cloudless, 40 degree morning. Fatz and Cash were happy to be loose as they streaked down the hill and across the service road. Bo pointed Fatz along the tree line on the right of the course as we head to the Lick Creek crossing. At 15, Cash returned near the creek after an extended absence. At 25, Cash shot to the left edge as Fatz was last seen headed toward Mario's Hill. Both worked each side of the course to the double gate as the gallery surged into the river bottom with Fatz taking the river's edge and Cash hunting cover to the right. At time, Fatz was on the river's edge and Cash standing on a feed strip near the bridge as Ray flushed and fired with all in order.

BRACE 2: TNT'S BLAZING SHOSHONI SHAKE N' BAKE(BUBBA) – TOMMY THOMAS; SPANISH CORRAL'S SONNY PATCH(PATCH) – JOE GOWER. At 9:05 Tommy and Joe blew their whistles over Bubba and Patch. We crossed the dam with both dogs and turned toward Old 109 as Patch went out the front, Bubba seen to the west. As we neared 109, a deer flushed from tall cover near the crossing and both handlers did a great job of keeping the dogs on course. Crossing 109, Bubba headed to the eastern tree

line to make the bowl swing as Patch headed straight down course toward the Parish Field. Patch regained the front as we went down into the back loop with all parties showing well near the gas pad. Both dogs were birdy on a feed strip as we came back out into the Parish field but nothing got pointed. At 55, point was called for Patch but birds lifted with Patch moving to end his time. As Tommy was riding a feed strip after the 2nd 109 crossing a large covey lifted and flew across the road with Bubba not involved. The brace ended with Bubba having no birdwork.

#### BRACE 3: REDROCK'S SIESMIC SHIKSOH(MICKEY) – DAVID LINCOLN; ROUSTABOUT'S FLAT OUT(HANK) – TOMMY THOMAS. After a break for coffee and donuts, we started at 10:25 on course 3 with Mickey and Hank.. At 6, Mickey was stopped with tremendous style along cover near the river but it proved non-productive. Hank made a nice move on the right side of the course and spun to a stop near the old corral. Tommy flushed extensively with no luck. As he tapped Hank on the head, he went into the cover and a bird flushed from

behind the original pointing location. Tommy fired his gun and we went on. At 30, we reached the Pavilion with Mickey ahead of us and Tommy trying to pull Hank off course 1. Gas well hill found the gallery riding under soaring red tail hawk's with sun on their back. At 50, Dave called for the tracker as we had not seen Mickey since the Pavilion field. Hank finished up front concluding the morning braces.

BRACE 4: SPANISH CORRAL'S SUNDANCE KID(SONNY) – JOE GOWER; JO-LOCKAPEK DARK ROUX GUMBO(ROUX) – DAVID LINCOLN. After a fine Judy Button lunch, Sonny and Roux dropped off breakaway hill at 12:55. Both dogs worked either side of the course interchangeably as we moved toward Lick creek. They began to stretch their legs a bit as we crossed the series of field leading to the old corral. They were watered and seen up near Hwy 109 as we transitioned through the chute leading to the vast river bottom, where Dave pointed Roux out headed down along the river's edge. Both dogs worked the center of the course to the bridge where the brace ended.

#### BRACE 5: TLM FREQUENT FLYER(JACK) – TOM MILAM; MEGASMOKE GRAND FINALE(TED) – JOE GOWER.

Jack and Ted were straining against the ropes wanting to get going on course 2. Both were fast and forward over the early portions of the course with Jack building steam at the old 109 crossing making the eastern swing around the big bowl. Ted was a handful as we turned north as Jack started a championship cast in front of the dog wagon gallery. He smoked the feed strips to the north then swung in full view on a distant edge where he spun and slid with regal style. Ted came in and pointed as the gallery arrived. Tom flushed a big covey and the 32 caliber chased them to the west. At release, Ted had a delayed chase to end his day. We entered the back loop where Jack did a tremendous job of hanging.... rimming....showing....and flowing. He pinned a nice covey on the right as we came back out in the Parish field in heavy cover. Taken on, he was found standing in a feed strip on the elevated edge of the Parrish field. An extended flushing and relocation did not produce. He was ahead and moving as time was called short of the bridge.

#### BRACE 6: ONE OFF MOJITO MIKE(MIKE) – KENT PATTERSON; JOKER'S JACKPOT(JACK) – STEVE RALPH.

The last brace of day 1 was away at 3:25 after a coffee break at the bridge. Mike and Jack attacked the early portions of the course with handlers working to get them into the chute leading toward Mario's Hill. Jack worked the left edge quickly with Mike standing at 12 just off to the right of the course. Handler picked up a fresh hawk kill quail and pitched it to the course marshall. Both were a handful toward Mario's Hill where Mike swung wide to the north with Jack in parts unknown. Jack was found to the front and moving on the western edge of the pavilion field as Mike was found standing at 25 in a feed strip. Birds flushed all around him as he maintained great composure. We had dogs gaining momentum over gas well hill with both showing well on a long feed strip down the hill. Jack crossed out front with Mike not seen until the distant cry from his scout, Harlan Gerardy, brought the party to a point deep into the corner of the field. An extended flush and relocation produced no game. Mike made big moves in the fields on the right leading to the beaver dam, while Jack stayed left and seen intermittently up front. Across the beaver dam, Mike jumped down to an edge leading south where he was on point at time,

no game was produced for his 2nd nonproductive. Jack was up front and building at time with no birdwork to his credit.

### BRACE 7: MISS ABBY MEADOWS(ABBY) – JOE MARLATT; K NINE'S ON THE LOOSE(LUCY) – JOE GOWER.

Another cold and cloudless morning greeted all in attendance on breakaway hill for day 2 of the amateur championship. We had two Joe's handling two ladies in Abby and Lucy. Both dogs were at moderate range and working each side of the course as we headed to the Lick Creek crossing. Abby came out of the Lick Creek cover with blood all over her face....Joe looked it over and decided it wasn't serious enough to stop the proceedings. Lucy made a nice move along the old corral and into the chute. We ended short of the bridge with neither dog having birdwork.

### BRACE 8: MTB ZIPNSON VENI VIDI VICI(VENI) – JOE GOWER; UNCLE KRACKER(KRACKER) – BO ACKERMAN.

We were away at 9:14 with Veni and Kracker. Each was forward and across the buzzard roost dam with Kracker making the big swing in the broom sedge field on the other side. Veni was seen briefly down in the far end of the same field and not seen again as Joe asked for the tracker at 25 in the Parish field. Kracker was flashy and forward as we crossed old 109 for the first time and missing as we went into the Parish Field. After an extended wait, the call of point came in the distance with Kracker found standing in a mott of cover to the north. A big covey was pushed out with all in order. Upon release, he disappeared around the end of the same cover and it took some time to pull him out. In the back loop, point was called in the southeast corner of a space just past gas pad. Bo wasn't able to produce any game. He finished on course before we got back out in the Parish field.

**BRACE 9: WIMBERLY ROWDY BO-DANDY(ROWDY) – DAVID LINCOLN; SHADY'S DESERT KNIGHT(KNIGHT) – TOM MILAM**. A welcomed cup of hot coffee and donuts were passed out in the Parish field break. Good thing the handlers had orange and green collars on these dogs as it was very hard to tell these two liver males apart. Rowdy is the current National Amateur Champion with Dave and scout Tommy Thomas trying to repeat last year's hour. Both dogs were extremely fast and flashy back to the Petit Jean River Bridge. They continued the pace up to Mario's Hill with Knight having a non-productive on a push pile below the Pavilion. Both dogs were moving well at time in the bottom below gas well hill with no birdwork to their credit.

**BRACE 10: MTB CABO RITA DE SCIPIO(RITA)** - TOM WHITE; MARJO'S MAGIC BULLET OF HOPE(HOPE) - JOE LUISI. Rita and Hope were away for the afternoon where temps had climbed to comfortable levels that required only a light jacket. Tom waved off a point for Rita at the top of the hill as Joe pointed out Hope crossing the course at the bottom of the hill. Rita was standing with style at 12 in a mott just east of the course. Tom flushed a small group with all manners in order. Hope took the left edge with Rita going further east to the tree line as we headed to the S curve. Both moved well over the series of fields leading the old corral area. Joe raised his cap for Hope on a feed strip near the chute...then waved it off as she came out. Rita had come into the same area from the west and pointed with Hope then backing. Tom flushed birds from the milo strip and both handlers fired. Each dog spent time down in the corner of the

river bottom that took some time to pull them out. Rita took the river's edge down to a strip that leads back to the tree line on course. She was pointed out across the service road at time with Hope working a nearby feed strip.

#### BRACE 11: BONY BUD(BUD) – DAVID LINCOLN; RU-JEM'S "LAST" PENNY(PENNY) – TOMMY THOMAS.

Bud and Penny were away at 2:14 on course 2. Both were busy and fast over the first quarter hour. Each made the showy cast as we made the first 109 crossing and remained forward as we dropped into the back loop. It took some time to pull Bud through the woods and back on course near the gas pad but he made it out and rimmed the southern edge of the field leads back to the course. At 48, Dave elected to pick Bud up. Penny continued at moderate range in the series of fields leading back to the bridge.

#### BRACE 12: RUSTY RIDGE LUCKY STRIKE(RED) – CLAUDE KILPATRICK; MEGASMOKE MOON CHIP(CHIP) - JOE GOWER.

Chip was a handful early with Joe attempting to get him lined out on course 2. Red got separated from his handler and was checking each horse in the area for a familiar face. As we neared the chute both dogs had gotten their bearings and things had settled down a bit. Both were watered at 16. Red and Chip were standing near each other on a feed strip near Mario's Hill with a nice covey moved and both handlers firing. The string broke between Joe and Chip near gas well hill at 45. Red was lost at time near the beaver dam at 55.

#### Posted Dogs: Uncle Kracker, MTB Cabo Rita De Scipio BRACE 13: THE ACE OF SPADE(SPADE) – TIM SELF; MARJO'S JOHNNIE WALKER(JOHNNIE) – JOE LUISI.

Judges would have no problem telling these dogs apart as Spade is liver and white...Johnnie white and orange. We left under another "chamber of commerce" morning with both dogs seen sparingly over the first 5 minutes. As Spade made the cast down a feed strip at 15, he froze. Tim flushed birds that went right back over him with Spade swapping ends on flush. Joe hadn't seen Johnnie as we crossed northwest of Mario's Hill and asked for the tracker. Spade had hunted well to Lick Creek and credited with a stop-to-flush at 20 as we were headed to the S curve. Birds lifted all around him. He handled it well and upon release went only 10 yards into a clump of cover and pointed, handler called point out of our sight of judges and informed them a bird had already left. He flushed briefly, fired, and we went on. He used both sides of the course over the remainder of the hour with a big move near the old corral and a solid finish.

BRACE 14: CHANCEY'S FROZEN ASSET(MAGGIE) – JACK ALEXANDER; JJ'S TASMANIAN DEVIL(TAZ) – JOE WILLIAMS. Over the first 15 minutes of this brace, Maggie lit up course 2. Birds were seen lifting at 8 from a feed strip to the left of the course. When the judges arrived on the scene, she was standing, Jack flushed briefly and fired. She was given credit for a stop-to-flush. Taz was returning to Booneville from his 3rd place honors the prior year and struggled to duplicate that performance. He made several nice casts but got behind at times as we crossed old 109. He finished the hour with no birdwork. Maggie continue to be strong through the back loop where she had a nonproductive and was absent over the last 10-15 minutes of the brace before returning up front right at time.

### BRACE 15: MO-KAN DURAMAX(MAX) – MIKE BOYDSTON; MTB CAN AM FORMULA FUN(FRANI)

- TOM WHITE. Max and Frani were away from the bridge on course 3. Both were animated and excited over the first rise in the course. Frani was standing at 4 on a small island of cover to the right of the course. Max was in the area and backed initially, but then moved in closer to end his day. No birds were produced for Frani. She remained fast and forward leading toward Mario's Hill with a single find at 14 on the left margin of the course. At 30, she was pointed on a strip of cover below the pavilion. A large group of birds lifted and sailed into the nearby woods with all manners in order. Frani was released toward gas well hill and it would be the last we would see of her with Tom asking for the tracker at 47 near the fork in the road.

### BRACE 16: WAYSIDE'S BLUERIDGE RUNNER(BLUE) – TOM LONGFELLOW; MTB SCIPIO'S HOT SHOT OF WHIZKI(CALI) – TOM

**WHITE.** 12:50 saw the last brace of the championship released with Cali taking the left edge of the course and Blue working the right over the first 10 minutes of the course. The wind had picked up with fall leaves and hawks sailing on the breeze. We had all parties as we crossed west of Mario's Hill with Cali seen dropping off the shelf at the S curve and remained missing until we reached the double gates. Blue was at moderate range over the series of fields leading to the river bottom and was standing at 50 to the left of the course. No birds were produced. Point was called for Cali in a feed strip along the service road with no game put to flight. The brace ended just short of the bridge.



## None Held Back and Other Bird Dog Stories

#### Part Four Good and Evil

#### A Little Dispute

I hadn't seen physical violence at a field trial in years. But when this fight erupted, it seemed as senseless and

ugly as all the others. Yet this one didn't leave me depressed, as all the others had.

We were gathered at Mossy Swamp Plantation in south Alabama for the old Wingfield Club's spring trial the first weekend in March. For the lead-off derby stake, the entry was light—just a dozen—but high on quality, or so we thought. The favorites were two pointers vying for Derby of The Year, Bill Stone's Whiparound

Willie and Bob Brame's Toastmaster. Both derbies had carded a half dozen placements since their debuts on the prairies of Saskatchewan the August before. Through the long season their handlers had met nearly every week at a trial on the major circuit, coming down through South Dakota, Kansas, Oklahoma, Texas, up to Kentucky for Thanksgiving weekend, then to Georgia, Alabama, Mississippi for the mid-winter series. So far as I knew there was no bad blood between them—fierce rivals, of course, a little suspicious of one another when the scouts were out of sight, but no more tension between them than always exists between two competitors near the top of the standings—like with drivers on the Winston Cup Series or pitchers in a pennant race.

At the drawing in the old clubhouse, beneath the gaze of Osthaus setters and pointers, Willie and Toastmaster drew the last brace. When the other ten derbies had run their races, my fellow judge and I faced a dilemma—we had only one decent performance from which to choose. We could use that for first, but the other nine were below mediocre, with little to separate them. So when Willie and Toastmaster came to the line, we were praying for two good performances to elevate the stake and save from difficult decisions.

> The gallery swelled for the two favorites; expectation filled the air as we set the stopwatch and I said, "Let 'em go." For the first half Willie was my job to watch; then I would switch to Toastmaster, and my fellow judge would take Willie. The heat started routinely enough, both dogs running prettily out front on the field edges.

Occasionally, peals of laughter drifted forward from the gallery. Ahead the two handlers rode slowly, singing to their dogs, now and then lifting an arm to point out a dog. "We've got him" my fellow judge or I would respond. The sun warmed our backs as the course turned east, and a feeling of well-being enveloped the whole field-trial party as we rode through the towering long-leaf pines on a carpet of wiregrass.

Then Wills and Toastmaster left a bean-field edge and entered swampy woods. We expected to see them reappear on the edge in a moment, but they did not. Soon handlers and scouts were scouring the woods in search of their charges, each praying to find his dog on point. I was keeping in touch with Stone and my fellow judge was monitoring Brame—as best we could and still stay near the course path as the rules required. The midway point of the heat came and passed, but the judges were too far separated to switch dogs. Soon both dogs would have been judicially unseen for a third of the heat time, and we would have to declare them out of judgment and ineligible to place. We were not anxious to do that, for these two derbies had, to their point of disappearance, run the best races we had seen. We hoped against hope the derbies would reappear on course, but they did not. As the distant calls of the handlers echoed through the pinewoods, I looked up my fellow judge, and we agreed we had no choice but to call time; we told the gallery, which turned back for the clubhouse, leaving a cloud of dust behind them.

Then an eight-point buck bounded from the cover, with Toastmaster in hot pursuit. Instinctively, I spurred my horse after them. The dog ignored my calls of "whoa"; soon my horse was losing ground. The deer was headed straight for a four-lane highway a mile away; all morning we had heard the whine of truck tires coming from that road. Just then Bill Stone saw me and joined the chase. "See if you can catch that dog, Bill. If you don't the buck is going to take him to the road and get him killed." Bill soon had his rival's derby in hand. When I caught up, Bill was dismounted, holding Toastmaster by the collar, his horse blowing nearby.

"Shall I turn him loose now Judge," Bill Asked politely.

"No, Bill. Both dogs are out of judgment, gone too long. Road him out to the course if you will please, and I'll take him, and you can go look up your dog."

Just as Bill emerged from the woods at the field edge, Bob Brame emerged a hundred yards north, searching vainly for his dog. He saw Toastmaster, then he saw Bill Stone, then he saw the rope that connected the two. (He had not seen me yet, for I was still in the woods). Brame assumed that Stone had caught his dog while still in judgment and was about to turn it loose again to hide the crime. In a rage, Brame rode at Stone at full gallop and tackled him from his horse. The two young men were all fists and elbows when I rode out of the woods and yelled for an armistice. They ignored me until I fired a blank from the pistol I always carried when judging. Then I told Brame when the rope was on his dog, that I had asked Stone to catch him, that this dog would probably be dead on the highway now but for Stone's act of kindness. Brame was ashamed of himself, apologized to Stone and to me, and looked like a whipped pup.

"You know the Club's rules about fighting," I said. Brame faced a lifelong ban from Mossey Swamp for his fit of temper. A minute of silence passed as Brame stared at the ground. Then Bill Stone spoke.

"How about if we just forget this happened, Judge? If I'd seen Bob with my dog on his rope, I'd have probably done the same thing—no harm's been done, just the three of us know what happened."

I looked down from my horse on the disheveled young men, their dog food promotion caps now picked up and held in hand, dust of battle coating their faces, shirts, chaps. I'd know them both since they were little boys, seen them ride on the pommels of their fathers' saddles, watched them grow up in the field-trial sport as apprentices to their fathers, retired now, proud of the sons who had followed in their footsteps. I let a few minutes of silent suspense pass, and then I said, as seriously as I could, "OK, but what happened here has got to remain our secret, or all our reputations will be shot." They grinned at me, swung easily into their saddles and rode off in search of the still missing Willie. I roaded Toastmaster back to the clubhouse, put him in an empty run, and fixed myself a bourbon and branch. Then my fellow judge and I picked the winners and the club secretary announced the results.

Out of everyone's hearing, my fellow judge said, "That's about the dullest stake I ever judge."

"Oh, it had its moments," I replied.
