On behalf of the Brittany Field Trial Hall of Fame (BFTHF), we are asking you to participate in the BFTHF nomination process. The BFTHF is part of the Bird Dog Foundation, Grand Junction, TN.

Purpose

The purpose of the BFTHF is to recognize and honor Brittanys and Brittany owners that have made significant contributions to the Sport of Field Trialing. To date, 75 Brittanys and 47 Brittany enthusiasts have been inducted and pictures of these dogs and people are displayed in the Hall of Fame.

Nominations

You are a member of the nominating committee and your support is needed. We want you to nominate those you believe are **Outstanding** Brittanys and **Distinguished** Brittany people.

Outstanding dogs are recognized by their entire competitive career, field trial performance record (championship wins) and production record. They must be deceased at least one year prior to opening of nominations March 1. These are the same dogs you would like to find in the pedigree of that good pup you just bought!

Distinguished people have rendered exemplary service to the sport of field trialing both locally and nationally <u>for a long period of time</u>. These contributions may be as a judge, a breeder, a field trial official, a reporter, a patron or any combination thereof. The sport is better because of these people who are givers, not takers or self promoters.

Nominations Process

A nominator should prepare a bio with facts that outline a dog or person's worthiness to be a member of the BFTHF. Support letters should be sent to mail@BrittanyFieldTrialHallOfFame.com by anyone wishing to add support for a nominee.

Election and Induction

After the nomination period has closed, the BFTHF Election Committee will vote using the bios submitted for each nominee. Normally, no more than two worthy dogs and persons will be elected in any calendar year. Induction ceremonies are held in early February of the following year.

#### THE WINNERS:

THE CHAMPION FROM BRACE 5, HIGH HOPES LITTLE ANN. A) HIGH HOPES LITTLE ANN (ANNIE) – DAN RIEDL AND B) MAGNUM HIGH VELOCITY (GAUGE) – VINCE ANDERSON. Both dogs broke away after the button hole. Annie scored at seven with Gauge backing. At 10 Annie scored again. Gauge scored at 14 with Annie backing. Both dogs were out to the front rimming the far field. Annie and Gauge hunted the grounds strategically. At 41, both dogs had finds on separate sides of the field, shots were fired for Gauge, Annie had an unproductive. Both dogs finished forward.

THE RUNNER-UP CHAMPION CAME FROM BRACE 11, PRIME TIME TEBOW. A) PRIME TIME TEBOW (TEBOW) — KENT CANTRELL AND B) BGD'S OUTLAW JOSEY WALES (JOSEY) — DAVE JOHNSON. As both dogs were released, Josey hit point and scored. Tebow scored at four. At 14 Tebow had a nice find with plenty of style. As Josey came by, she failed to back and was up. Tebow continued with good ground application, hunting forward with finds at 56, 58 and finished with another stylish Tebow find at 59.

FROM BRACE 3 THIRD PLACE WAS NOTHIN' BUT TROUBLE. A) NOTHIN' BUT TROUBLE (TROUBLE) — JIM CARTER AND B) RINGO RASCAL (RINGO) — RODGER FIORITO. Both dogs took the front immediately. Trouble was anything but trouble. At 21 Trouble scored with a nice find; Ringo was up due to a backing indiscretion. Trouble scored again at 25 and rabbits at 30. Another nice find at 45 as Trouble moved smoothly through the course. Both the handler and dog were finishing strong. As time was called, Trouble disappeared and was out of sight. As we were all scanning the field hoping to spot Trouble, the scout found him tucked down in the treeline standing on point.

AWARDED FOURTH PLACE FROM BRACE 8 WAS TURNINGPTS LANDSLIDE. A) TURNINGPTS LANDSLIDE (MACK) – JON ST. CLAIR AND B) RYLEE'S ROLLING THUNDER OF COOS (THUNDER) – RAY GORMAN. Mack scored at 10 and 33. He had a nice application on the ground with very nice bird work. Thunder was working the course hard but the birds eluded him. As Mack held tight to the edges, point was called at 51, heading down the treeline, he finished with a nice find and was released to the front.

Day 1 – Sunday, October 25, 2016 following the Shooting Dog Derby Invitational

BRACE 1 A) GUNN'S-A-BLAZ'N (ANNIE) – JIM CARTER AND B) KIP'S BAY DARK N' STORMY MISS MADDIE (MADDIE) – JOHN KIPP. At 5 Maddie had a stop to flush and Annie backed. Maddie had an unproductive at 12, then a dead bird and feathers at 22. Annie scored at 28, then an unproductive at 34. Maddie was up with a second unproductive at 48. At 53 minutes Jim picked up Annie.

BRACE 2 A) LACEY MTN'S B CAMPBELL LITTLE JESTER (LOKI) – BEN CAMPBELL AND B) EMMA TAYSHON – JIM CARTER. At 15 Lacey was pointing a bird on a branch, after the flush the temptation was too much. Emma scored at 16 with relocation. At 30 and 39 Emma scored again, looking nice. She finished to the front.

#### Day 2 - Monday, October 26, 2016

BRACE 4 A) WOODLAND'S MONEY PIT (CHLOE) – KAREN SCHRAMM AND B) BARK RIVER QUEEN OF DIAMONDS (DAISY) – JEFF STANTON. Daisy scored first at five. Chloe had an unproductive at six after relocating. Daisy was cruising around the field and had another find at 15 as Chloe came out of the brush with a stop to flush. At 20 both had separate finds. At 25 both dogs hit point again. Daisy had a good forward race and scored again at 35. Both dogs were standing at time with no bird produced.

BRACE 6 A) BLAZIN SHADOWS BAMA JAMA (JAMMIE) – ROGER STOWELL AND B) HIGHPOINTS SUMMER TIME (SUMMER) – AL CROPEK. Both dogs hit the ground running. Summer had finds at 6, 10 and then feathers at 16. Roger picked up Jammie at 23 and Summer chased at 25.

BRACE 7 A) LOST CREEK A SHOT OF BOURBON (STREAK) – SUSAN JANUSCHKA AND B) ALDER'S SOPHIE BROOK (SOPHIE) – DAN CAMPBELL. Both dogs worked the cover. Streak had a unproductive at 14. There was a divided find at 33. Streak went for the chase at 36 and was up. Sophie scored at 44 and 50, finishing with a nice run.

#### Day 3- Tuesday, October 27, 2016

BRACE 9 A) HIT'S SHOWTIME (BRANDY) – JOHN PERRY AND B) HY STEPPIN LIBBY'S LIEBLING (LIBBY) – CHRIS SENNOTT. These two handlers hit the ground moving along with their dogs. Both dogs had a nice forward race. Libby scored at 7, 12, 32, 43 and 46 with good bird work. Brandy scored at 11, 20 and 42. Both dogs were well

matched as were the handlers. Good times and sportsmanship was

BRACE 10 A) WRIGLEY'S BODEMEISTER (BODE) – BARRY STEINMETZ AND B) GAMBLERS KNOWS WHEN TO RUN (TUCKER) – JAMES STEVENS. This was a short brace as both dogs chased on their first contact with birds.

BRACE 12 A) SUEMAC'S SKY KING (SKY) – RAY GORMAN AND B) HIGH HOPES DARK NITE (JOE) – AL CROPEK. Five minutes in and Joe was looking very birdy. As suspected, he was on the chase which end his brace quickly. Sky was working the cover in very close range with bird work at five and six. He had a nonproductive at 17. Sky was looking a bit tired as the temperatures were close to 70o. Sky hit point at 27 and had a covey find at 40.

BRACE 13 A) RUNNIN ON FAITH (FAITH) – KENT CANTRELL AND B) ST. CLAIR'S PRINCE ROCCO VULCANO LEO (ROCCO) – JON ST. CLAIR. Faith scored first at 11. Rocco decided that day was for chasing and was up at 15. At 20 and 22 Faith had more bird work and the handler decided call it a day and pick Faith up early.

BRACE 14 A) AJAX JAROS JOSEY WALES (JOSEY) — RICH JAROSINSKI AND BYE. This was the first time for Josey and her handler at the Gun Dog Nationals. At two minutes Josey had a find and handled it well. Josey and her handler worked the cover as the temperature was starting to rise. At 30 minutes her handler decided to pick her up as she kept going in and out of the woods. We will see this pair again next year.



The 53rd running of the American Brittany Club prestigious Prairie Chicken Classic commenced September 19, 2016. The venue of Rock County landowners consisting of Butch Fischer, Curtis Luther, Wade Dearmont and Ted Morton again allowed this event to be run across their ranches. We are greatly in their debt for their generosity.

From a field of 39 entries JJ's Levi The Lionheart emerged the winner. Levi ran in the 17th brace handled by his owner Dr. Joe Williams of Hillard, Ohio. Levi is an early 2013 model white and orange well-built male. He was sired by Spanish Corral's Sundance Kid X Sandbank Rose. Levi's race was fluid, forward and pleasing to watch with rock solid bird work. Runner-up was Georgia's Texas Two Step handled by Tom Tracy of Nebraska for owners Travis and Clayton Tangen of Georgia. Georgi is an eight-year-old female and no stranger to the hour stakes. She was sired by Dakota Alleycat X JB's Georgian Amber Blaze.

Third place was awarded to Jagoub's Buzz'N Bayou owned by Tom and Debbie Jagielski of Illinois and handled by Tom Tracy. Skeeter is an eight-year-old male who is out of R&J's Buzz Cut X Jagoub's Jambalaya. Brendi Brooks Cowboy Up also Tracy handled for new owners Ray and Mary Jo Trimble of Illinois.

The prairie chicken cannot be caged and released to supplement the population for an event. The first ABC Prairie Chicken Classic Was held at Buena Vista Grasslands Area near Plover, Wisconsin in 1964. In 1975 it began to rotate between there and Nebraska. The last event in Wisconsin was held in 2000. The sand hills have been its' home since that time.

The committee would like to thank everyone who participated and helped with the work. New comers this year were Dr. Joe Williams of Hillard, Ohio and Kevin and Joey Rogers of Vail, Arizona. As "newbie's" gate opening and closing is the initiation. Joey did a fine job as did the others who helped. Our committee consisted of Stan and Claudia Truksa at the helm doing pretrial details and set-up along with Jerry McGee

and Ed Tillson. Ray Trimble transported the coffee and donuts every morning that were provided by Jeanna Harmon of the Corral Bar in nearby Bassett. On Tuesday evening participants were treated to a steak dinner by the club at the Corral Bar. On Wednesday, the local VFW has a steak feed at the Legion Club which was well attended by field trailers. #### The Running

**DAKOTA GUNRUNNER'S BUCKSHOT, TRACY AND TEQUILA SCORCHER, TILLSON.** Both dogs started strong. At 12 Buck had a stop to flush. They traveled across the pastures reaching. Lincoln was wide on some turns making him lateral at times. At 37 Buck had a non productive. They finished without defined bird work. Bird count by gallery 2 coveys.

JAC'S OVER ACES, HOLMAN AND THE CRASH SCENE, TRACY. Dan pointed at 9 but nothing could be produced. Crash made a wide swing past the windmill and was out of pocket, upon return he was leashed. Dan continued to hunt the course and was up at 35'. We could not use the "honeyhole" this year, needing to bypass because of cattle being pastured.

JAGOUB'S BUZZ'N BAYOU, TRACY AND MAXWELL'S LEGAL TENDER, ROGERS. Skeeter started by making strong moves. Cash was methodical in his pattern, hunting the terrain. At 40 Skeeter had a nonproductive, released, he continued to reach the limits of our visual. Cash had shortened and was up at 35. Nearing the end of the hour Skeeter was wide over the knobs at time, we looked for handler and dog to the north. Then point was called well into the grace period with

all in order. Bird Count this brace by gallery 2 large coveys.

TLM PETE NOCONA, MILAM AND BLACK CREEK BLAZE, **HOLMAN**. The afternoon conditions were hot and dry. Pete made a concerted effort to cover country but was up midway in the hour. Blaze was wide early to the north. He was credited with a stop to flush at 43. Water revived Blaze and he finished the hour.

PINEY RUN JAKE, PATTERSON AND CEDAR VALLEY SPIDER, TRACY. Hot and dry for these dogs. Jake worked some of the likely areas. He pointed but moved on. He had a nonproductive at 49 finishing the hour without defined bird work. Spider tried hard to run but to no avail and was up at 20. Bird count by gallery was 2 coveys.

TLM TALL TAIL, TRACY AND ALAR'S DIRTY DANCER, TILLSON. Sam had a stop to flush at 3 with another bird lifting after handler shot. At 18 Sam had a nonproductive along the edge of a cattail slough. He was up at 40. Dani made some good moves during the hour. At 47 pointed but nothing could be found. She finished the hour without bird contact.

ROUSTABOUT EUSTACE, CAPSTICK AND PINEY RUN IT'S A SMOOTH RIDE, PATTERSON. This morning we had very windy conditions from the south. Both dogs made an opening cast running into the wind. Rider did not get untracked and was up in the second pasture. Eustace made some strong moves in his time on the ground. He had 2 non productives and was up at 50.

GLADE RUN IRISH, TRACY AND KOKOMO JOSEY JO, GORROW. The wind is still 15-20 mph out of the south. Irish was showing us some prairie casts. Jo headed south into the hills at 21. Scout dispatched, called point. Handler could only produce a box turtle. At 45 Irish had a find on a covey with good manners. At 50 he pointed, a single left and he took to many steps forward. Jo finished without any bird contact.

WHIZKI'S STING, HOLMAN AND CVK'S SPARTAN KING, TRACY. Holly pointed at 8 with nothing produced. She slowed her application and was up midway in the hour. Leo made some wide casts, but in consistent in application. At 42 he pointed near the bunge gate but nothing was produced. He finished the hour without bird contact.

BLACK CREEK DEACON, HOLMAN AND GEORGIA'S TEXAS TWO STEP, TRACY. Few clouds, still windy as we breakaway to the northeast. Dee started wide to the north as we headed east. At 36 we were at the far east side of the course where Dee went wide, out of pocket, was not returned to judgment. Georgi made some reaching casts in her hour. Georgi 's find was by the book. Point was called when she stopped off in the distance. Ridden to, handler flushed a covey, fired and she stood mannerly through-out. Later in the hour she was credited with another find finishing the hour forward.

### **2016 Membership Survey**



This past fall, 2<sup>nd</sup> Vice President Sandy Malloy sent a survey to the membership of ABC to obtain feedback on subjects related to membership and retention.

Delivering an electronic survey to the full membership proved to be a challenge, because many members did not have an email address in the database, or the email address was no longer valid. In the end, a total of 1515 electronic surveys were delivered and copies sent to each Regional Secretary. Despite the difficulty in delivering the survey, the response was surprisingly strong, with a total of 768 surveys completed and analyzed.

#### **RESULTS**

The demographic data accurately reflected the size and distribution of members across the country by region, giving us confidence that the survey results were a true representation of the ABC membership. The survey revealed that our youth and young adult population is quite small, suggesting a need to market ourselves better to youth, families, and adults under 45.


ABC members reported that they actively competed in field trials, conformation and hunt tests, with other members competing in agility, obedience, barn hunt and other venues. Many members added comments to their responses for that question to add NSTRA, NAVHDA, flyball and hunting with their Brittanys. Approximately 20% of our existing members did not compete in any events over the last 12 months.

The survey found that most ABC members initially joined to support the breed, meet other Brittany owners, and belong to a Regional Club. Members renewing continued to express "To Support the Breed" as their #1 priority, with #2 being "Remain in a Regional Club" and #3 "To Receive the ABC Magazine."

Most members approved of the concept of a Breeders Directory on the website, with 83.44% expressing support. Members also demonstrated a willingness to support other technology, with 87% already

The survey comments provided many constructive suggestions for positive change and membership growth. The most common comment was that ABC and Regional Clubs should be "more inclusive" to reach out to and engage members who participate in events other than Field Trials or Conformation, or who do not participate in events at all. This comment was also made by members who hunt with their Brittanys but do not compete.

A subsequent survey sent to individuals whose memberships had expired over the previous 15 months yielded similar results. Individuals who did not renew their memberships participated renewing their membership online or willing to do so in the future; as well as 89% who use the ABC website "Sometimes" or "Often," and 59% who already subscribe to the ABC Facebook page.

The survey results of the magazine readership show 30% of members "Always" read the magazine thoroughly, with 24% reporting that they "Often" read the entire magazine.

Finally, the survey showed that our members tend to be active in their Regional Clubs, with 83% reporting that they participate in Regional Club activities, yet 55% of members wished that their Regional Clubs were larger, and 86% reported that their Regional Clubs would benefit by attracting more members.

in fewer competitive events, suggesting that we did not retain members who are not actively competing with their Brittanys. Alternatively, it is possible that we failed to engage new members and/ or help them become involved in competitive events. Finally, the survey indicated that many members were not aware that their membership was due to expire, and this contributed to their failure to renew.

I would like to thank all members who took the time to respond to the survey and provide valuable comments. The survey results have given ABC constructive feedback from its members about the issues that matter to them. In response, the Membership Promotion Committee is seeking additional members who would be interested in helping evaluate survey results and proposing positive changes for membership growth and retention. These events take team work, Larry Hagedorn and his crew consisting of Terry Gowin, Matt Harris, Herb Rea, Scott Johnson, Mike Lager and Francis Clasen took care of the necessary duties. The weather went from hot and windy to cool and typical of an October day in Kansas. We also would like to thank the ladies who made the side dishes for the steak feed on Saturday night, no one went away hungry.

Again, the club and participants are grateful for the grounds and facility that Bill and Marylynn make available for our bird dog events. It is always a joy to ride across this ranch.

#### THE RUNNING

Castaway Wilson, Tracy and Tequila Scorcher, Tillson. Cover is very heavy in most places so you don't take your eye off the dogs. Wilson hunted the cover and at 27 in the ditch line he knocked a bird and was leashed. Lincoln searched the country for game but was not rewarded with any birds.

Crescent City Girl, Tillson and CVK's Spartan King, Tracy. Nola had a hard time maintaining the front in this cover. She was leashed at 20. Leo had a non productive at 7. At 17 in the canyon he pointed near a stand of pines, relocated, handler said the birds flew. He was fired over and taken on. At 29 he was working the brambles near a feeder, around the mott came a small covey followed by the dog to end his time on the ground.

Ru-Jem's "Last" Penny, Tracy and Firestarter's Crossed The Line, Tillson. We came off the plateau and into the "bowl". Ty was running the fence line. Judge saw the dog point at 16. Extensive flushing and relocation couldn't produce any game. At 23 Penny pointed in tall grass, extensive flushing and a relocation produced a small covey which she pointed very stylishly. At 35 Ty pointed beneath a cluster of bois d'arc

trees. Handler did extensive flushing but nothing was produced and Ty was leashed. Penny continued on course through the red gate and across the plateau, past the "Custer Battlefield" sign. At 53 she pointed in the bottom of a small canyon near some hedge trees. Birds were flushed with all in order. She ended her hour with a long cast to the front.

Kinwashkly Fat Bastard, Tracy and Ezechial of Hunters Pride, Johnson. Both dogs started at moderate range. At 23 Zeke had a non productive near an old dead tree. Fatz dug into the cover. At 43 he had a non productive along the creek in the big draw up from the water shed lake. Zeke shortened in the middle and went into hunting mode and was up near the end of the hour. Fatz pointed near the base of some pines at 55', flushing produced nothing. He was relocated and knocked a small covey and was leashed.

Dakota Gunrunner's Buckshot, Tracy and Wimberley Rowdy Bo-Dandy, Johnson. Buck tried to maneuver the cover but it was hard for him to maintain the front. He was up at 25. Rowdy was lateral in the cover. At 16 he stood in a creek bottom when the handler approached he observed that Rowdy failed to maintain a horizontal posture and was leashed.

MK's Magnificent Bandito, Johnson Roustabout's Far Out, Tracy. At 16 Hank had undefined bird work. At 23 he had a stop to flush with Chico coming in to back. Hank dug into the long draw that headed toward the cabin. He was out of pocket and not returned to judgment. Beyond the red gate, along the same draw Chico was lateral. In the windmill canyon he was absent and out of judgment at the end of the hour.

Kashmir, Tracy and Red Rocks Seismic Sniksoh, Lincoln. Both dogs were fast off the breakaway. Kashmir settled into moderate range for the hour. Mickie remained a distant vision showing at the second gate and was off again. She was out of pocket and the tracker was called for at 45. Kashmir had no bird work during his hour.

Carpe Diem, Lincoln and TLM Tall Tail, Tracy. Carp was wide off the breakaway then showing at the appropriate time. Sam had two non productives at 27 and 48. At 35 handler indicated point, said bird left before the judge could get there, moved the dog up, flushed and shot. Judge stated undefined bird work. Carp had been out of pocket and the tracker was pulled at 35.

SS Rig's Colorado Gunrunner, Tracy and JJ's Diablo With Rusty Tears, Williams. Fresh off the breakaway Rigs pointed at 1.5 minutes. Rusty was in high gear passing Rigs failing to back and was leashed. A small covey was flushed with all in order. At 12 Rigs had a stop to flush near a bois d'arc tree when the

handler flushed the rest of the covey lifted. At 49, as we approach the rim, Rigs had a stop to flush in the tall grass. He finished the hour as he started laterally and at moderate range.

Jagoub's Buzz'N Bayou, Tracy and Shady's Desert Knight, Johnson. After lunch the skies were sunny and low 70's with a light breeze. We left the gate, both dogs were forward. Skeeter had a hard time maintaining the front and was leashed at 25. Knight hit the cover but suffered two non productives at 29 and 34 to end this brace.

Cedar Valley Spider, Tracy and JJ's Tasmanian Devil, Williams. We broke from the high gate, down the wall into the bowl. Taz and Spider worked the edge of the wall going forward. Taz had a breech of manners on quail at 4 and was leashed. Spider pointed at 12 near the base of a small deadfall, relocated but nothing could be produced. He continued at moderate range and was up at 55.

Georgia's Texas Two Step, Tracy and JJ's Alabaster Angel "Angie", Williams. Angie pointed on our left across the long draw at 5 but no game was produced. At 30 Georgi encountered birds under the bois d'arc grove just before the red gate. Her bird work was all in order. At 29 Angie pointed in the bottom, nothing was produced and she was leashed. Georgi continued on at moderate range. She had a find at 52 in the bottom of the windmill canyon with good manners. The hour ended across the next draw with Georgi well to the front.

Maxwell's Show Time, John and Glade Run Irish, Tracy. Time for most of the hour was forward at moderate range without any bird contact. Irish was lateral at moderate range. He had a non productive at 57 to end his hour.

Smarteyes-Joker's EZ Ace, John and Uncle Kracker, Tracy. Both dogs started strong. At 22 Ace had a covey find in the draw above the water shed lake. He stood with intensity through flush and shot. Kracker got wider and wider until the string broke and the tracker was pulled at 30. At 34 Ace had a non productive. We came across the bottom of the bowl and at 54 point was called for Ace as he stood in tall cover. He was relocated and worked the area and finally pinned a single out of the cover to end his hour.

Dakota Sun, Carrington and JJ's Levi The Lionheart, Williams. Both dogs worked the cover, Levi had a non productive at 16. At 32 he pointed a pair for quail standing high and tight. Levi continued to punch the cover going forward. Sunny was having a hard time with the cover and was up at 45. Just before we go thru the gate Levi pointed birds near a feeder, standing staunchly through flush and shot. His hour ended well forward going up the hill toward camp.

Checote. Carrington and Kanza Sun, Lager. Both of these dogs were off in a flourish. They hit the cover with ease. We would see them from time to time. At 31 Coco had a find in the ditch before the high gate with all in order. We

saw Slim and then he was gone again. The tracker was called for at the high gate. Coco continued to sickle through the cover. At our loop toward the big draw, north of the water shed, she disappeared and was not returned to judgment.

Tempo crossed the creek in the big draw and pointed in a deadfall/pine tangle at 36. This was a barren stand. He continued his search but was not rewarded in the hour.

Driving Miss Daisy II, Tracy and Sparky's Prairie Wind Gypsy, John. We left the plateau southwest of the red gate after a coffee break. Both dogs were forward in the cover. We went down into the windmill canvon where at 14 Daisy pointed near a large bois d'arc tree. Nothing was produced and the handler collared her forward, releasing her and headed to his horse, Daisy ran about 20 feet and swapped ends standing like a statue. Handler approached and flushed a large covey of young birds (their peeping and wing noise made the gallery ooh!) while Daisy stood rock solid throughout all. Meanwhile down the draw Gypsy had a very stylish find at 15. She stood at the top edge overlooking the creek below. The birds were flushed from under the overhang while she stood staunchly through flush and shot. At 36 just off the horse track, Daisy pointed, a single flushed as the handler approached the dog, she went forward and another bird was up to end her time on the ground, Gypsy came across the front and pointed in a gully. handler flushed, then relocated her. She worked to her right but nothing was pointed. Handler sent her on and started to mount when a single popped under the reporter's horse. Gypsy honored with fine manners. She was sent forward finishing to the front thru the gate in the bottom. We returned to

### CHEESY BACON PULL-APART BREAD

GARNISH, IF DESIRED

1 LARGE LOAF OF FRENCH, ITALIAN OR
SOURDOUGH BREAD
½ CUP MELTED BUTTER
2 CLOVES GARLIC, MINCED
8 STRIPS COOKED BACON, CHOPPED
4 GREEN ONIONS, CHOPPED
3 CUPS SHREDDED GOUDA CHEESE
ADDITIONAL CHOPPED GREEN ONIONS, FOR

PREHEAT THE OVEN TO 400°F. USE A SERRATED KNIFE TO CUT A CROSS-HATCH PATTERN INTO THE BREAD, SLICE 1/2-INCH GRID LINES INTO THE BREAD BY SLICING IT LENGTHWISE THEN WIDTHWISE WITHOUT CUTTING ALL THE WAY THROUGH THE BOTTOM CRUST, YOU WANT THE BREAD TO STAY TOGETHER. COMBINE THE MELTED BUTTER AND GARLIC. GENTLY SEPARATE THE BREAD WITH YOUR FINGERS AND DRIZZLE THE MELTED GARLIC BUTTER MIXTURE IN BETWEEN THE CUTS. MAKE SURE THE ENTIRE LOAF GETS DRIZZLED WITH THE BUTTER MIXTURE. PLACE THE LOAF OF BREAD ON A PIECE OF ALUMINUM FOIL THAT HAS BEEN SPRAYED WITH NON-STICK COOKING SPRAY. WRAP THE BREAD HALF WAY UP. COVER THE TOP WITH A SEPARATE PIECE OF UNGREASED

FOIL. PLACE ON A LARGE BAKING SHEET AND PUT IN THE OVEN. BAKE FOR 10 MINUTES. REMOVE THE BREAD FROM THE OVEN AND TAKE OFF THE TOP PIECE OF FOIL. GENTLY PRY APART THE BREAD AND STUFF THE BACON INTO THE CREVICES. NEXT, STUFF THE SHREDDED CHEESE INTO THE CREVICES. MAKING SURE ALL OF THE BREAD IS EVENLY STUFFED WITH BACON AND CHEESE. THERE IS A LOT OF CHEESE, BUT KEEP STUFFING! IT WILL ALL FIT. SPRINKLE THE GREEN ONIONS OVER THE TOP. PUSHING THEM GENTLY INTO THE BREAD. PLACE THE BREAD BACK IN THE OVEN, UNCOVERED, AND BAKE FOR 15-20 MINUTES OR UNTIL THE CHEESE IS MELTED. REMOVE FROM THE OVEN AND SPRINKLE WITH ADDITIONAL GREEN ONIONS, IF DESIRED. REMOVE THE BOTTOM PIECE OF FOIL AND SERVE WARM.

- 1 CUP BEEF BROTH


2 TABLESPOONS SEASONED SALT

- 1 TEASPOON DRIED OREGANO

### **Versatile Brittanys in Action**

Abominable Loser vs. Well-Mannered Winner By Carla Simon

Some people have a knack for winning well and never becoming an abominable loser. I've had the pleasure of competing against people who are classy in how they accept their results, whatever they

are. Over time, whether winning or losing, I've learned from watching.

No matter the dogsport, you just can't control everything that happens at a canine competition. You train, prepare and strategize, but the results are influenced by whatever chance throws at you on any given day. Sometimes you are unprepared for the challenges that occur, making mistakes and failing as a result. Sometimes you surpass your own expectations in the face of intense challenges, and achieve a personal best.

Losing can be painful, given that it's accompanied by emotions such as disappointment, anger, frustration, confusion or surprise.

Nobody wins every competition. Sometimes you have a crummy day, lose focus, have a health emergency at the worst time. Judges and volunteers make mistakes too. There is no perfect dog, or person. The life cycle of competition generally entails training an unknown puppy, gelling with that unique dog, gaining experience and mastery, then growing old when health is declining and you just aren't as fast as you used to be. That's life. We'd rather be growing younger, but we grow older anyway. Complaining about the judging or gossiping about rivals will do little to change the reality.

I vividly recall when a conformation judge noted that one professional handler never burned her bridges. Even when she lost, she was gracious, never rude, maintaining her relationships with judges, colleagues, newbies and her dogs. That constituted an advantage in the future, whether that was her intention or not. She's still a class act, now on her way to becoming a judge herself.

Contrast her attitude with a famous agility handler, who left the ring in a huff when his dog made a mistake at a large, televised international competition. Many viewers recognized his enviable skills and his phenomenal canine, but his crude reaction to that loss can never be erased from cyberspace or public perceptions. If he had continued, excelled in the remainder of the course, then smiled and waved as he left, he could have become a legend. Staying to observe the conclusion and congratulating the winners would have been good for a few karma points too.

Considerate winners are delighted to win, and don't need to put anyone down to make themselves feel better. They enjoy the moment, with the realization that the next competition might be another story. When congratulated, they smile and are happy to accept. When people compliment aspects of their performance, they simply say "thank you", without any self-deprecating remarks about their shortcomings: without arrogance or entitlement.

Opponents that I appreciate don't wish that everyone else fails. They don't focus on how much they want the ribbon or prize either. They focus on the job they have to do: obstacle by obstacle, step by step, trusting their training and their canine partner, and going with the flow based on what actually happens in that competition.

Sometimes all factors meld into a perfect performance. What a thrill! Sometimes performance is ugly and clumsy and still results in a win. At best, bloopers merit a chuckle. Returning the focus to your bond with your dog is one sure-fire approach to keeping wins and losses in the proper perspective.

As 2017 approaches, I wish you the best in all of your competitions in the year to come. May your wins be many, and well deserved. May you lose as well as your dog, and approach the next event with no loss of enthusiasm.



### TRAININ' DOGS

#### with Rick Smith

### The Release Cue

Training is something that happens all the time, whether we realize it or plan it or not. It doesn't automatically start when we say, "Okay, let's go train," and end when we put the dog away (or let him back up on the couch) after a session.

Every contact with a dog is training it to respond in a certain way to whatever we're doing, and it happens most often via our body language. Each and every one of those small, daily interactions is a chance to shape behavior, develop good habits, and teach the dog. It doesn't matter if your dog lives in the house, outside, or a combination of both. There are a multitude of things that happen in those places with your dog every singe day, that can be shaped and molded into consistent responses and be made very useful in the field as well. The one we're going to focus on right now is the release cue or command.

What is a release cue? It's a signal that tells the dog it is free to go. Pretty simple, right? It certainly should be simple; but it often gets far too complicated. We're firm believers in keeping things consistent and as easy as possible, and that means using one command for the same behavior instead of two or three or more.

To break that down, let's think about the times we tell our dogs they are free to go, and what the dogs hear. For the sake of simplicity, we'll use what we most often hear, although there are several others used. Dog coming out of a crate or kennel: "Okay." Dog being turned loose to hunt: "Hunt 'em up!" Dog coming back into the house after being outside: We usually hear nothing that tells the dog it is free to go. Interspersed with these, we hear a lot of, "C'mon!" and, "Let's go!" in addition to the initial words, as more of an encouragement.

The more we talk, the more dogs tune us out. And as we've mentioned in past columns, most of the stuff we say to our dogs verbally is more for our benefit than for theirs. So, in the interest of simplifying things and helping our dogs focus on what really counts, the first thing we're going to suggest is to eliminate the additional words given after the first release command.

No more, "C'mon," or, "Let's go," or anything else. It's not needed and doesn't do anything except cause confusion.

The next thing we're going to do is suggest you pick just one word to use

as a release cue. Why? Again – simplicity. Make it easy for the dog. Now we know there are some of you scratching your heads and, saying, "But I use 'okay' around the house and, 'hunt 'em up' when we're hunting or training because I want the dog to know the difference between just loose at home and hunting or working on birds." Trust us when we say that your dog know when you're hunting versus just hanging around at home. You don't need two different words to differentiate between turning loose at home and hunting. Stick to one and it will make things a whole lot less complicated. A release command or cue just means the dog is free to go. It makes no difference if it's free to go out into the yard or into the field to hunt. The cue is the same.

What word should you use, and how to you train a good release command? Choosing a release command isn't hard. Pick one word – one that is easy to say and remember – and make it a word you don't use much in normal conversation. For example, while "okay" can work, we also say, "Okay" a lot in talking, and end up inadvertently telling our dog it's free to go when we didn't intend to. One that works well is a long, drawn out "alright" ("Aaahhhhrright," with the "L" missing). It really doesn't matter what word you want to use, as long as you say it consistently and it's not something you use in conversation that will accidentally release your dog. You can say, "Linoleum" if you want. It doesn't matter, since the dog doesn't know the meaning in English – it simply recognizes the sound as meaning, "Go!" Just keep it short and simple. (In the old days, the word "charge" was often used as a command to lie down.)

When doing field training, we like to add a whistle cue as a remote release cue. The whistle carries far better than the voice, and it is also far less emotional. One short tweet of the whistle means, "Go." This is useful in situations where your dog is on point, you're a good distance away, and the dog needs to relocate on a bird that may have run. It's useful anytime a dog is stopped a distance away from you and you need it to release it from that spot. If you want, you can also use a whistle when releasing a dog from your side as well. We like to place a trained dog on "whoa," take the lead off, and let it stand while we walk a few feet away and then release on the whistle. This helps solidify the concept of being released from somewhere other than your side and helps with more distant, remote release later on.

How do we teach the release cue? First, the dog must be close by your side. You can start this with puppies, too. Take the lead off and lightly hold the collar, not so much that you're pulling or putting any pressure on it, but just enough to be able to prevent your dog from leaving on its own. Say your release word as you let go of the collar, and walk away. Puppies are likely to follow you, as will some adult dogs when learning this. Say nothing and just keep moving away from the dog. They will eventually venture out away from you. Being in some sort of interesting area with tall grass or cover can help, since most dogs want to take off and explore. It doesn't take many repetitions for the dog to figure out the cue means, "Go!" It's important to remember that if you have called your dog to come to you, it must stay put again until you give the release command again. Don't let it self-release.

You can also do this around the house. When you go to the door to let the dog out, or open the crate or kennel door, use your release word. However, we'd like to add a caveat to this: When you open a kennel or crate door, or vehicle door, don't step back and just give the release cue. Have the dog wait with the door open and then come out of the crate or kennel or vehicle on your command, whether on a lead or verbal if the dog is trained to it, and have it stand next to you first. This will help the dog in a couple of ways: First, it won't learn to bolt out of a crate or kennel or vehicle as soon as the door is opened; and second, it reminds

the dog that you're the one in charge.

Something else to keep in mind as you train this step: Dogs are experts at reading body language. They know what you're going to do before you actually do it, as a rule, because your body language tells them. One good example that fits in here very nicely is using the whistle as the release cue. Once the dog has learned the cue, it starts watching for you to reach for the whistle and anticipates the release. Make sure you teach the dog to wait for the sound rather than the action. You may have to make the dog stand while you reach for your lanyard and whistle, then touch it and drop it a few times, and then bring the whistle to your mouth and drop it without blowing it. Make the dog wait for your actual command.

Having a solid release cue is great. And keeping it simple by using one consistent word for all situations make it easier for both you and your dog. That's always the goal: Make learning simple. Plus, it adds to your dog's training, which in turn enhances your time in the field.

I love you, Robert.



Many hold a specialty (conformation) show and hunting tests. The Regional Clubs hold meetings to discuss mutual problems, fun trials, training sessions and other events of interest to their members.




