


I've been fortunate to witness many of their performances and recall some special moments as I ride over the beautiful Ionia grounds. Little did I know as this championship began that this one would hold some of the most treasured memories for me going forward. No matter the future for this event, Ionia and the championships over the past 20+ years will live on in the wonderful recollections of those that have competed here.

Well before the championship begins the work starts to make it happen. Our thanks to 4th VP Bob Burchett, and his wife Valerie, trial secretary, Mike Poehler and their committee for pulling it all together for us! We must also thank the awesome "Michigan crew" for all their efforts on behalf of the ABC. Diana Kubitz & Deb Smeltz (hospitality), Eileen (food) & Carlos Gust (grounds), Dick Lipski (bird planter), Chuck Langstaff (dog wagon driver), Terri DeBarr (finances) and Will Langley (wrangler) were busy during both the open and amateur championship providing for all those in attendance. Ron Gulembo and the Ionia Grounds committee work throughout the year to maintain this wonderful facility. How very fortunate the ABC and those in Michigan and the surrounding area are to have such a great place to run bird dogs!

Our thanks as well to our amazing sponsors Purina, Garmin/Tritronics and The Saddle Guy for their continued support of the American Brittany Club championships. All those reading this can express their appreciation of our sponsors by purchasing and recommending their great products!

All the above helped to make this championship come together but I think all will agree that what makes any field trial very special are birds,

judges and (of course) dogs! The birds for this year's championships were outstanding! Thank you so very much to Clifford Weaver for making a second trip to Ionia from Missouri to bring birds for the amateur championship. The coveys flushed during the running were spectacular.

Our judges Marc Rittner from San Dimas, CA and Tony Giovinale from Montville, OH both commented about the great dogs they saw and were obviously having a good time watching our Brittanys do what they love. They both have over 30 years of experience in Brittanys including competing in field trials as well as judging many pointing dog trials. They were looking for a forward running dog that pointed with style and handled kindly which was obvious in their choices. It was a pleasure to ride behind judges that were positive and enjoying themselves.

There was a delicious welcome dinner on Saturday evening followed by



the amateur Calcutta. Thank you to our auctioneer, Scott Johnson, and all those who placed bids making it a very successful evening.

### THE RUNNING

The amateur championship began on a cool Sunday morning under cloudy skies with a few raindrops starting to fall at 8:37.

Brace 1: Thomas' Dixie, h Dr. Jim Carter, DVM and High Hope's Dark Nite, h Al Cropek. These two were away quickly and over the hill and soon both scouts were out. Dixie was never spotted again in judgement and Jim pulled his tracker at 22. Joe was spotted along the fence a Hires field from which he worked his way back to his first find at 18. Joe carded his second at 38 on the edge before descending the hill and his third going down the hill on the left where Al had difficulty getting small coveys to fly on both. Joe's last find was at the bottom of the hill where he had difficulty pinning running birds. Time was called at the top of cardiac hill. Following his big breakaway Joe settled into an attractive forward sweeping pattern.

Brace 2: Hit's a Red Rock Girl, h Marcia Rupnow and Kdel's Eagle's Chance to Soar, JH, h Ken DeLong. At 9:44 the second brace broke from the bottom of cardiac hill. They headed forward and at 6 Ruby was spotted slowing along the treeline just into the derby course. When she stopped it was discovered that she was honoring Chancey's point. Chancey had made a nice move deep into the derby course to this find. After the birds were flushed with all in order the dogs moved forward to a divided find at 10. At 15 Ruby backed Chancey again on what proved to be a non-productive. Chancey shot forward to a big cast along the far edge heading toward the creek. Across from the gun dog parking lot at 24 Chancey pushed up a bird and jumped to attempt a retrieve to end his day. Just into the gun dog course Ruby pointed at 25 and following a lengthy flushing attempt and relocation the birds were flushed. Ruby turned on the speed heading to the big oaks and scored again at 40 where Marcia flushed a covey. She finished the hour in the shoot above the swamp.

Brace 3: Legacy's Pine Bandit, h Delmar McCallister and Alder All Tundra Devil Tuktu, h Robert Puerner. Beginning at the lower side of the orchard this brace was down to business quickly with a point by Bandit at 3 with Tucker executing a stylish back. Following a flushing attempt, Delmar elected to take a non-productive. Tucker ducked into the lower end of the course and point was called by his scout at 8. Tucker chased and was up. Bandit scored at 10, where the birds flushed as Delmar walked in front, and again at 21, and 26. At 28 Bandit was ahead on another stylish point but the weather was turning ugly as Delmar flushed another covey. The bad weather meant that my recorder got wet and then quit but Bandit seemed to be enjoying the tough conditions as he continued to find birds at the top of the derby course. However, a covey that was difficult to flush proved his undoing as he sunk to the ground on a point with only 5 minutes left in the hour.

Due to bad weather, the running was cancelled on Sunday afternoon. Posted, day 1: High Hopes Dark Nite

Monday morning proved to be great field trial weather with the temperature in the 40's, cloudy and dry as we started the day, at 8:33.

Brace 4: Spring Hill's Red Hot Performance, h John Bell and Remchester's Amazing Grace, h Bill White. Gracie was off and forward and Red flew to the front and disappeared into the trees at the top of the hill. At 6 point was called by the scout on Red on the opposite side of the treeline on the flat. He stayed tight as Gracie came around the corner and executed a nice back without cautioning and John waited for Bill to get to his dog. Working across the top, Red scored again at 14. Gracie came around the corner but this time got in front of Red and flushed the birds in front of a staunch Red and was ordered up. She showed nice speed









and application prior to her mistake. Red reached forward where he was sighted by his scout standing stylishly along the line below Hires field at 22 and John lifted small coveys there and on the edge at 24 and again at 29. Entering the big fields before descending the hill Red turned on the jets, flying along the edge and fading into the cover forward. John sent his scout to search the tree lines as he walked ahead, getting a little anxious. We waited as Dan searched but John walked forward and we soon heard "OUT FRONT" from a relieved John. When we next saw Red he was standing again to the left on the hill side at 47 and a large covey was flushed. As we approached the bridge, Red dug into the trees and pinned another covey for his 7th and last find. He then sped forward hugging the left edge, surging up the hill and racing forward as time was called.

Brace 5: Turning Pts Landslide DJ, h Jon St. Clair and Georgie Drive By, h Burton McCandless. The second brace of the day started at 9:41 at the bottom of cardiac hill. Both dogs were away fast and forward and at 2 Drive By was on point with Mack backing. Burton needed to relocate Drive By and Mack went ahead. Birds were flushed cleanly for Drive By. At 12 Mack seemed unsure but pointed and birds were flushed with all in order. At 15 the dogs were striking to see pointing and backing in the tall grass ahead and at 22 Mack scored again with Drive By honoring. As we passed the Riverside Drive parking lot it was Drive By's turn to card the find and Mac with the honor. Drive By suffered a non—productive at the end of the orchard then backed with style on Mac's points at 46 & 55. This was an enjoyable brace to watch with two mannerly dogs and plenty of birds and bird work! Drive By ran faster and wider through much of the brace but both dogs slowed as we neared time.

Brace 6: BDG's Outlaw Josey Wales, h Dave Johnson and Spring Hill's Salida Del Prado, h John Bell. Sally & Josey broke away on the far side of the shoot at 11:01 and at 11:02 Sally was seen pointing ahead where John flushed over her stylish point. Then at 6 it was Josey's find where Sally came in to honor. At 14 John's scout called point on Sally just across from the Riverside Drive parking lot. She stayed in place when Josey cam in to investigate and ran around the pointing dog to end her bid. Sally continued with 6 more high & tight points throughout the hour however her speed & range weren't up to the competition.

Brace 7: Kip's Bay Dark N' Stormy Miss Maddie, h John Kipp and St. Clair's Prince Rocco Vulcan Leo, h Jon St. Clair. Right off the breakaway Rocco was impressive dashing forward and hitting the edges where he ran with excellent speed. Maddie worked forward at moderate range. Along the trees below Hires Rocco hit a stylish point and Maddie came in for a perfect back. As we traveled across the flat Maddie handled a stop to flush but Rocco came into the area and got under the bird. Maddie couldn't resist the temptation and moved with the bird and both dogs were ordered up.

Brace 8: Shiloh's Sailing The West Wind, h Ted Foster and Sanbar's Legendary Evening, h Wayne Pepin. From the start Zephyrus went the wrong way and in spite of work by the scout and handler he was never back onto course going in the correct direction. Running on what had proven to be the section of course with plenty of birds, Hershey seemed to find them all! Each point was picture perfect and handled with outstanding manners. Hershey didn't make any big moves but he stayed forward and finished the hour.

Brace 9: Nothing But Trouble, h Dr. Jim Carter, DVM, Bye. Trouble was released as we approached the parking lot at Riverside Drive. She reached forward to her first find in the tree island before the orchard. Working fast and forward through the orchard, she was standing tall again along the rock wall at the end. Trouble would score again in the big oaks where she stayed planted as Jim flushed a large covey and









birds flew into her face! After we passed through the shoot, she would be tested with a bird in the path but she was up to the test. As we again passed the parking lot she made a nice cast on the right above the swamp and though the creek. Trouble stopped at the hedgerow on the other side of the creek but Jim elected not to flush when she didn't appear sure. A couple minutes later Trouble hit her last find in a clump of trees and Jim flushed a woodcock. After having to avoid an encounter with a woman walking a couple vizslas, time was called at the edge of the derby course to complete a fast and stylish performance.

Posted, day 2: Spring Hill's Red Hot Performance, Turning Pts Landslide DJ, Georgia Drive By, Nothin' But Trouble.

Brace 10: Gambler's Knows When to Run, h Jim Stevens and Alder's Sophie Brook, h Daniel Campbell. The last morning of the championship was again cool but dry. We were underway at 8:34 with the first pair flying fast and forward onto the course. Tucker had everyone's attention as he zoomed over the large fields but pointed and chased to finish his day. Sophie's first point was buried in the treeline at 6 where Dan had some work to get the birds flushed. She was rewarded with finds again at 14 and 17 where a covey was difficult to flush. Sophie had us standing up in our saddles as she dug deep into the course and cruised along the edges as we traveled across the top approaching Hires. At 26 she hit point again and then made a classy move along the trees to her find at 33. Her final find was as we descended the hill and then she continued forward until time was called. A strong performance from the dog from the far west.

Brace 11: Hopes Chief of Crosscreek, h Wayne Pepin and Magnum High Velocity, h Vince Anderson. Beginning at the bottom of cardiac hill, no one was surprised to see this pair off quickly and well into the derby course where Chief was on point at 8 to the left and Gauge at 11 on the parallel tree line beyond and both dogs were stylish and mannerly. Gauge went forward and disappeared into the high grass where he was found standing by his scout. Vince had difficulty locating the birds and, feeling the pressure, Gauge sunk to the ground and was done for the day. Following his first point, Chief crossed the field and honored Gauges first point. He reached forward and was standing again on the hedgerow before the creek. After working the birds cleanly, he crossed the creek, hugged the left edge above the swamp and disappeared forward. We proceeded through the orchard with no sign of Chief. Once we reached the gun range Wayne begin to get concerned and went back looking. At 38 Wayne pulled his tracker and we were ready to start the final brace of the championship.

Brace 12: Bark River Queen of Diamonds, h Jeff Stanton and Autumn's Pumpkin Spice, h Bill White. Breakaway was at 10:45 at the shooting range. The dogs went forward to the big oaks and were both standing. The judges called it a divided find. When a large covey flushed Pumpkin broke and chased but Daisy stayed solid looking good. Once Pumpkin was leashed, Daisy headed ahead toward the shoot but then turned back to point just below the original find. She pushed up the bird and we were done for the day.

Riding back to the parking lot following the completion of the last brace I thought back on some of the most memorable moments of the 2018 National Amateur Championship. Two beautiful Brittanys pointing & backing in the high grass, a large covey lifting and flying into the face of a staunch dog, a stunning liver & white dog silhouetted along the trees, swans and sand hill cranes flying overhead as we ride under blue skies but, for me, the most vivid memory will always be of that one "red hot performance".

This year's winner and runner—up came from Brace 4, characterized by lots of action from both dogs; both exhibited great speed, style and

application superior to the rest of the field. Both of these dogs should have long and distinguished careers ahead of them!

Our winner, Whizki on Diamonds handled by Scott Johnson, grew in speed and application as the hour progressed with a slightly stronger finish than her brace mate. Tracy, a white & orange female, had 8 finds with her last being a large covey near the shotgun range just before the western levy and the lone oak parking lot. This was the first time Tracy had been handled by Scott Johnson as well.

Runner—up, Osage Fork Slick, handled by Bob Burchett, was making huge moves early on and through most of the hour, using the wind and flying around the course having 8 finds. Slick and Tracy slowed some at the 40 minute mark with Slick having less in the tank at the end. Slick's scout Tommy Thomas repeated his Superman imitation by flying off and under his horse in a familiar spot early in the hour; thankfully he wasn't seriously injured and finished the hour as well.

The Running:

Brace 1: Kala's Thunder & Lightning of Shortbarrels (Boomer), Christnagel and Sniksoh Diamond Jack (Jack), Burchett. Jack disappeared to the front upon break—away being spied again on the interior line of Hire's field heading south with speed until his first

# Introduction to the Brittany: April 2013 – Walking Your Pup

A while back a new puppy owner asked me what he should do to start his pup. I suggested he take his pup to the field and go for a walk. Walking your pup is one of the best ways to develop the bird dog instincts your pup inherits from his parents. These instincts include the instinct to hunt, to point and to be part of a team. The best time to develop these instincts is between the ages of three and six months. By six months of age, many pups are becoming independent and some may stop going with you.

There is an art to walking pups and to do it well you need to understand the difference between developing a pup and training him. Training involves teaching your pup to do something. Developing him involves creating situations where he can learn on his own. For example, when I was five years old my father who had been a competitive swimmer took me to the pool and threw me in the water. At first I flailed around, but then I discovered I already knew how to swim. My father didn't have to teach me. I was born with the instinct to swim and all my father did was put me in a situation where I could learn on my own. While my father's method was a bit extreme, you do the same thing with your pup every time you take him to the field and expose him to situations where he can learn on his own what he was bred to do.

When you walk your pup, let him run free and investigate the world on his terms, and as he runs around, you want to basically ignore him. You may need to give an occasional, "Hey" to get his attention, but don't offer words of encouragement or correction. Instead, try to stay out of the way as much as possible. Your job is to create specific situations where your pup can discover on his own that he is a bird dog. There are many situations you can create. Here are two of my favorites.

• When I start walking a pup in the field, I set a slow and steady pace. Anytime the pup putters

- or gets behind, I ignore him and continue walking so he has to run to catch up. I never say a word. As he runs to catch up, his instinct to be forward is awakened, and it isn't long before he is paying attention to where I am and trying to stay in front of me.
- After a couple of weeks of walking a pup in the field and he is confident on the ground, I am ready to plant quail to develop his instinct to hunt and to point. I continue to walk at a slow and steady pace and try to approach the planted birds from downwind so he can smell them and begin using his nose to find them. Anytime he starts to make game, I stay back. By not being in the picture, I keep it between him and the bird. Each pup is different and some take more time to develop than others. As he learns to use his nose, he becomes skilled at finding birds and when he finds them he begins to stalk them. Eventually, the stalk turns into a point.

There are many different situations you can create for your pup, but the key to being successful is to understand the difference between developing and training. The way to develop your pup doesn't involve controlling him or putting pressure on him. Instead, you let him learn to be a bird dog the same way I learned to swim—by awakening the instincts he was born with. You don't have to teach him what to do; you simply set the stage, take him for a walk, ignore him and let him teach himself.



# Versatile Brittanys in Action

When there is no wind or air flow, scent disperses outwards equally, in all directions. The picture shows scent spreading out in approximately a cone shape, called a "scent cone" or "scent plume". (Brighter green represents stronger odor, lighter green represents weaker odor and in the black areas, there is no scent.)

### **AGEING**

The longer you leave the scent (known as ageing aka soak time), the more widely the scent disperses into the environment, until it reaches equilibrium. Once a dog's nose encounters the scent cone, he can follow it back to source.

If target odor is secured inside a box next to a hole, when the dog's nose is in the hole, he's "at source". Source is the highest concentration of scent, and we want the dog to find its precise location. Depending on the test organization, teams are expected to have a degree of precision in identifying the source's location, ranging anywhere from 2 inches to several feet.

### **AIRFLOW & WIND**

While visualising scent plumes is helpful for human understanding, it's a simplification of the complex, changing environments dogs navigate in real life. There is almost always wind, or smaller air currents, even indoors. Wind and air currents shape how scent travels, messing up the tidy cone shape of the scent plume.

The scent plume isn't static: it is constantly changing. Outdoors, wind gusts may cause chaotic, erratic,

unpredictable changes to the path scent travels, including swirling in circles and even changing or reversing direction mid-search! Indoor, every time you breathe, take a step, or open a door, the scent plume is being altered accordingly. Scent is a moving target, and no two searches are identical.

Falling back on the foremost human sense of vision, envision how smoke from a bonfire dances upward in unpredictable shapes, dropping ash some distance from the fire when it's windy. Those shifting shapes are closer to how your dog "sees" scent patterns with his amazing nose, as he figures out complex puzzles.



ABC Futurity Rules can be found on the ABC Website and in the ABC Policy Book CONDITIONS AND RULES FOR FUTURITY ELIGIBILITY

- The 2021 American Brittany Futurity shall be open to every Brittany bitch and her
  progeny whelped during the calendar year of January 1 December 31, 2019, who
  is owned or leased by a member of The American Brittany Club, and whose litters
  have been Futurity nominated with The American Brittany Club. Sires do not
  necessarily have to be owned/leased by an American Brittany Club member. All
  dams nominated and all sires bred to must be registered with AKC, CKC, or FDSB.
- The nominating breeder needs to be a current full member in Good Standing of the ABC when the litter is nominated and the closing dates of the of the Sectional Futurities in which puppies from their nominated litter compete. They must sign the Litter Nomination form, and any breeder purse checks will be paid to this designated nominated breeder. If their membership has lapsed at the time of the Sectional Futurity, the purse will revert back to the ABC Futurity Administrative Fees.
- Nominations of dams must be made within 60 days after a bitch has whelped, and a Nomination Fee of \$40.00 ("First Forfeit") must be paid at this time. This payment will entitle each puppy of the nominated litter to be entered in the ABC Futurities (Field and/or Show) after the puppy has been properly registered with AKC or FDSB. Nomination Fees are set by the ABC Board of Directors.
- Late litter nominations will be accepted with the following current fee schedule: In addition to the Nomination Fee of \$40.00, late fees are \$60.00 for 61-90 days, and \$100.00 for 91-180 days. Nominations after 180 days will be accepted at the discretion and decision of the ABC Futurity Committee. The postmark will determine the fee for late nominations. The ABC Board of Directors may impose additional late fees from time to time.
- A Final Forfeit Fee, to be eligible to compete in the Sectional Futurities
  (Western/Central/Eastern), is due by October 1, 2020, and is submitted by
  the owner of the eligible puppy. Futurity Entry Fees will also be paid prior to
  2021 Sectional Futurity events by the owner of the eligible puppy for each
  Sectional Futurity event in which the eligible puppy is entered. Final Forfeit
  Fees as well as Sectional Futurity Entry Fees are set by the ABC Board of
  Directors and subject to change.

# 2018 American Brittany Club Quail Classic/Championship By Burton Wice

The 2018 American Brittany Club Quail Classic/Championship was hosted by the Greater Saint Louis Brittany Club and run from November 12-16 at Sportsmen's Association Field Trial Grounds in Grovespring, Missouri. These private grounds are groomed and maintained solely for field trials. In addition to birds planted each day, these grounds hold numerous large coveys of prereleased quail which allow dogs to really show their skills. In addition, kennels are available for dogs, electric hook-ups are available for trailers, and the clubhouse has facilities for cooking, eating, and sleeping. To limit pressure on the birds, 3 braces were run on the 3-hour continuous course in the morning and another 3 in the afternoon. Thus, coveys of pre-released birds were found in nearly all braces regardless of when the dogs ran.

Many people and Sponsors helped make this event possible. Dave Capstick, Tim Self, Ed Janulis and Jerry McGee planted birds on the continuous course. The club provided meals and snacks for all of the attendees. Sharon Wice prepared hard boiled eggs for morning coffee breaks at the dog wagon between braces. Burton Wice prepared dinners that were well received. Margaret Horstmeyer, Donna Janiulis, and Kathy Gulembo helped with kitchen duties. Valerie and Bob Burchett cooked a steak dinner one evening and kept the supplies stocked. Dave Capstick and Donna Janulis took turns driving the dog wagon. Purina donated small pouches of Pro Plan Sport dog food for all entrants as well as large bags for the winners. Garmin donated a Pro 550 advanced training system. Collectively, these folks helped make this year's Quail Classic/ Championship a huge success.

The quality of the stake is reflected by the fact that there were 54 entries including 9 of the top 15 dogs in contention for the Purina Award. Participants from Arizona, California, Idaho, Illinois, Kansas, Michigan, Missouri, Nebraska, Ohio, Oklahoma, Oregon, Tennessee, and Wisconsin attended and competed in this event which also served as a tune-up for the All-Age Nationals which started the following week. Stan Truksa of Firth Nebraska and John Hott of Hoopeston, Illinois spent five days in the saddle evaluating the dogs. The weather for this year's event was challenging for the dogs and everyone involved. The weather started out more like what might be expected in January rather than November. On the first morning, a light drizzle changed to snow which made it hard to see the dogs. It was decided not to run the afternoon three braces. The running continued on Tuesday morning with temperatures in the low teens which

only reached the low 20s in the heat of the day. The temperatures were just as cold on Wednesday. Temperatures finally started to warm up on Thursday and reached nearly 60 degrees as the stake was finishing on Friday afternoon.

The Champion of the 2018 Quail Championship was JJ's Levi The Lionheart (Levi) owned and handled by Joe Williams of Grovespring, Missouri. Nearly 6 years old. Levi ran in Brace 21 and showed that he is back after missing all of last spring while being treated for heartworms. Levi handled well, ran a smooth and forward race, and finished strong to the front. Levi had four finds spread over the hour which included two limb finds. Levi pointed all of his finds with excellent style.

The Runner-Up Champion was Glade Run Irish (Irish) who is owned by David Webb of Valencia, PA and was handled by Tom Tracy, Jr. Irish ran in Brace 12. This 8-year-old male showed why he is a perennial winner. Irish had excellent range, was forward and responsive to his handler, and hunted hard the entire time he was on the ground. He had four finds and finished strong.

Third place went to Whiskey's Little Tip (Tip), a 7-year-old male owned by Weston and Gaylord Jowett of Frankfort Michigan and handled by Bob Burchett, Tip ran in Brace 26, handled well, hunted hard, and had solid bird work on each of his three finds.

Fourth place went to HEHE's Slim Shipley (Slim), a 5-year-old male owned by Matt Healy of Birmingham, Michigan and handled by Bob Burchett. Slim ran in Brace 9, hunted hard and had good style on each of his three finds.

### **Understanding Canine Epilepsy**

### Introduction

Epilepsy is the most common neurological disorder seen in dogs, and has been estimated to affect approximately 0.75% of the canine population<sup>3</sup>. The term epilepsy refers to a heterogeneous disease that is characterized by the presence of recurrent, unprovoked seizures resulting from an abnormality of the brain. The condition can be inherited (genetic or idiopathic epilepsy), caused by structural problems in the brain (structural epilepsy), or stem from an unknown cause (epilepsy of unknown cause)<sup>1</sup>. Determination of an appropriate treatment regimen for canine epilepsy depends on an accurate diagnosis of the type and cause of seizures, only after which appropriate therapeutic options can be identified.

### **Diagnosing and Classifying Canine Seizures**

Although classification systems exist for human seizures, there is not yet a widely accepted classification system available for seizures in dogs<sup>1</sup>. While human systems are sometimes used to describe canine seizures, this can be problematic. Human classifications are not always clearly applicable to canines, and there is often confusion about the meaning of specific terminology in the veterinary setting. This is particularly true of those classification elements which require subjective reporting of symptoms. For example, while dog owners may notice a specific behavior that typically precedes a seizure and is indicative of a behavioral change, there is no direct way to determine the presence of a pre-seizure event as sometimes diagnosed in humans.

Recently, the International Veterinary Epilepsy Task Force proposed a classification scheme for veterinary seizures, which is similar but not identical to the current human classification system<sup>1</sup>. Using this system, a seizure is primarily classified according to where it begins in the brain, with specific features of the seizure used to further characterize the event.

### Seizure Classification

Seizure description is the most critical information needed for the diagnosis of canine epilepsies. There are two basic types of seizures, generalized and focal. Generalized seizures involve both sides of the brain at the onset, and are characterized by clinical signs apparent on both sides of the body. Most generalized seizures manifest as bilateral involuntary muscle movements or sudden losses or increases in muscle tone. During a generalized seizure, an individual's awareness of the environment is typically impaired, and salivation, urination and/or defecation can occur. Focal seizures originate in a discrete area of the brain, and are characterized by signs that affect a single side or specific part of the body. Focal seizures can present with abnormal motor activity (facial twitches, chewing movements, paddling of a limb), behavioral signs (fear, attention seeking), and/or changes in autonomic functions (pupil dilation, salivation, vomiting). Awareness may or may not be impaired during focal seizures. A focal seizure can spread to both sides of the brain and become generalized.



### **Commonly Used Terminology**

**Automatisms** – repetitive motor activity that resembles movement under voluntary control, such as lip smacking, licking or chewing

**Atonic seizure** – a sudden loss of muscle tone lasting several seconds or more, not following a tonic or myoclonic event

**Cluster seizures** – a group of seizures within a shorter than normal interval; clinically defined as 2 or more seizures within a 24-hour period

**Focal seizure** – seizures originating from only part of the brain and therefore also only affecting part of the body

**Generalized seizure** – seizures originating from both hemispheres of the brain

**Idiopathic epilepsy** – epilepsy without an identifiable structural cause, typically assumed to be genetic.

**Interictal period** – the time between seizures

Myoclonic seizure – sudden, brief contractions of a muscle or group of muscles

**Postictal period** – the time immediately following a seizure, where behavioral changes may be observed

**Refractory epilepsy** – seizures that occur even during treatment with therapeutic doses of antiepileptic medication, i.e. the medication stops being effective

**Status epilepticus** – a serious condition where seizures follow closely on one another without a break, or where a single seizure lasts more than 5 minutes

**Tonic seizure**— a sustained increase in muscle tone (i.e. stiffening) lasting up to several minutes

**Tonic-clonic seizure** – a seizure where the tonic phase is followed by shorter, clonic (jerking) movements

### **Describing Seizures**

When observing seizures, it is important for dog owners to keep a diary of detailed information including: 1) affected body parts 2) when seizures occur 3) how often seizures occur, and 4) how long they last (see attached diary template for record keeping). Veterinarians and owners should also pay close attention to how dogs behave immediately after a seizure. Although some animals will quickly return to normal, during the postictal period, others will experience difficulties standing or moving; blindness; sedation, anxiety or other changes in behavior. These symptoms may last for varying amounts of time, and can affect treatment choice.



In some cases, seizures can result from exposure to a specific stimulus, such as an illness, exposure to a toxin, or problems with metabolism (reactive seizures). Any potentially precipitating events should be brought to the attention of the attending veterinarian, as such reactive seizures are not generally treated with standard anti-epileptic drugs<sup>4</sup>. Reflex seizures, which are seizures that occur consistently after a particular exposure, such as to a loud noise, a flashing light, or a more complex movement or behavior, have also been reported in dogs<sup>5</sup>.

### **Types of Epilepsy in Dogs**

It is not always possible to identify the cause of seizures in dogs; however, canine epilepsies can generally be classified into one of three categories based on etiology. Idiopathic epilepsy is defined as epilepsy without an identifiable structural cause and having an assumed genetic origin. Repeated seizures in 1-5 year old dogs with a normal neurologic examination, where there are no known structural abnormalities of the brain, metabolic diseases, or toxin exposures, are often assumed to be a form of idiopathic epilepsy<sup>5</sup>. The designation of idiopathic epilepsy suggests that the exact cause of the seizures is unknown, although the condition is presumed to be inherited. However, the cause of such epilepsies can sometimes be determined, for example when seizures are the result of a specific genetic defect known to occur in certain breeds.

Structural epilepsy is the diagnosis for seizures that occur because of observable damage to or malformations of the brain. For example, structural epilepsy can occur after an inflammatory disease of the brain, growth of an intracranial tumor, or after trauma to the head. It can also be the result of congenital malformations or a vascular event, such as a stroke<sup>5</sup>. The brain abnormalities seen with structural epilepsies can sometimes be detected using an MRI or by analysis of cerebrospinal fluid. Testing for structural epilepsy may be indicated if a dog exhibits neurologic abnormalities between seizures or if the dog falls outside the typical age range of onset for idiopathic epilepsy. Interictal changes are less common in dogs with idiopathic epilepsy.

Epilepsy of unknown cause is used to describe a condition in which a structural cause is suspected, but has not been identified on diagnostic evaluation.

Reactive seizures, seizures which occur in response to specific stimuli (such as a metabolic derangement or a toxin), are not considered to be a form of epilepsy, because they are not caused by an abnormality of the brain.

### The Genetics of Canine Epilepsy

A large number of genetic mutations have been associated with epilepsy in both humans and mice. In humans, the inheritance of epilepsy is generally complex, meaning that it involves interactions of one or more genes with each other as well as potentially with environmental factors, and this is likely true of epilepsy in dogs as well. However, the extent of inbreeding within specific dog breeds has allowed the identification of certain animals that are at particularly high risk of seizure development. No fewer than 26 dog breeds have shown at least some evidence of heritable epilepsies.



Gene mutations have been identified, many of which include a group of diseases known as neuronal ceroid-lipofuscinoses. These are storage disorders where mutations lead to the abnormal accumulation and storage of a cellular product within cells, eventually leading to the dysfunction or death of neurons<sup>1</sup>. One gene for an inherited epilepsy has been identified in Lagotto Romagnolo dogs. That gene, *LGI2*, is similar to the previously identified human epilepsy gene *LGI1*, and scientists believe that a number of heritable epilepsies may have similar causes in humans and canines<sup>1</sup>. Research into potential similarities between dog and human epilepsies has also led to the identification of several candidate genes that may predict the effectiveness of anti-epileptic treatment in some breeds.

### The Etiology of Epilepsy

The specific biochemical mechanisms that cause seizures are not yet fully understood in either dogs or humans, although seizures are known to result from dysfunction in the brain's electrical activity. It is generally believed that epileptic seizures are caused by an imbalance between excitatory and inhibitory activity in specific areas of the brain, leading to either excessive brain activity or activity that is unusually depressed. However, in the absence of structural damage or metabolic insults, the causes of such dysfunction are not clear. There is some evidence suggesting that abnormal excitatory processes may be caused by functional abnormalities in neurons, specifically mutations in the ion channels that are essential to cells' electrical function<sup>7</sup>, but that explanation is likely to only apply to a subset of idiopathic epilepsies. Further research into the specific causes of various forms of epilepsy is still needed; current understanding is incomplete.

### **Medical Management Options**

The information provided below is for information purposes only and cannot replace the advice of your veterinarian. Do not give your dog any medications without a prescription from a veterinarian.

Anti-epileptic drugs (AED) work primarily by inhibiting the action of excitatory neurotransmitters, stimulating inhibitory pathways, or altering ion channel function in the brain. Not all drugs work equally well in all animals, and their safety profiles are somewhat variable. A single, isolated seizure is not usually seen as a reason to begin treatment with AEDs. Treatment with these drugs is usually indicated when multiple generalized seizures have occurred within a 24 hour period, a dog has had at least two seizures within a six month period, or a dog has unusual or severe signs during the postictal period<sup>9</sup>. Once treatment has been declared necessary, the process of choosing the right drug requires balancing effectiveness and tolerability. Although many short-term side effects can be managed by titrating medication dosages, some AEDs have the potential to cause significant adverse effects. Therefore, it is important for medications to be chosen and tested with care and to recognize that not all epilepsies are amenable to drug treatment.



### Anti-Epileptic Drugs

**Phenobarbital**, a first generation AED, is one of the drugs most used in veterinary patients, because it is effective, relatively inexpensive, well-tolerated, and easily dosed<sup>9</sup>. Serious side effects include blood cell loss (cytopenias) and liver toxicity. Other side effects include sedation, ataxia, and increased appetite and water consumption. Dogs can also develop tolerance to phenobarbital over time, and are susceptible to withdrawal effects as physical dependence can develop<sup>9</sup>.

**Potassium bromide**, or bromide, is another first generation AED that is often used to treat canine epilepsy. When used in combination with phenobarbital and other AEDs that are metabolized in the liver, dosages of those drugs can potentially be lowered to reduce the risk of liver damage. Bromide may also be useful in resolving some cases of epilepsy that do not respond to phenobarbital monotherapy<sup>9</sup>. Side effects of bromide include sedation, ataxia, vomiting and increased appetite and water consumption.

Second generation AEDs used in dogs include levetiracetam, zonisamide, felbamate, gabapentin, pregabalin, and topiramate. Of these, levetiracetam and zonisamide are used most frequently. **Levetiracetam** is considered to be a particularly safe treatment option with a wide range of dosages, however, its efficacy remains unclear<sup>9</sup>. Side effects are considered mild, with sedation and ataxia reported most commonly. Further, co-administration with phenobarbital can affect how long it remains in the bloodstream<sup>9</sup>. **Zonisamide** is metabolized by the liver and can cause liver toxicity, although this is infrequently observed. Other adverse effects include sedation, ataxia, vomiting and inappetance. It is well absorbed, works via multiple mechanisms, and has shown to be effective against a variety of seizure types in humans. Because it interacts with phenobarbital, zonisamide doses should be increased when the two drugs are used in combination<sup>9</sup>. The second generation human epilepsy drug lamotrigine is **not** recommended for use in dogs because it can cause heart arrhythmias<sup>8</sup>.

Several third generation AEDs have been marketed for human use within the last few years and may turn out to be useful in the treatment of canine epilepsy. **Lacosamide** has been shown to be well tolerated in people, and some canine-specific data exist to support its use in dogs<sup>8</sup>. **Rufinamide**, a novel AED that is unlike any existing AEDs on the market, may also have some potential for canine treatment<sup>8</sup>. Finally, several other types of drugs are also under investigation for epilepsy treatment, including drugs that decrease inflammation, alter the connections between neurons, and address other brain health concerns, but they are not yet ready for general use<sup>7</sup>.

### **Drug Dosing**

Determining the appropriate dose for an AED is an extended process. While initial dosing is determined by weight, different dogs metabolize these drugs in different ways. Therefore, a series of blood tests are often needed to evaluate serum drug levels over time in order to make certain that levels remain high enough to be therapeutic but low enough not to be toxic<sup>9</sup>. While measuring serum levels of AEDs is a useful monitoring tool, it is not a substitute for clinical assessment when determining the appropriate drug type and dose for any individual dog.



# 2018 ABC New England Brittany Championship

# PROPLAN

The New England Brittany Championship Association held the Open and Amateur Shooting Dog Championships on October 2–5 at the Flaherty Field Trial Area in East Windsor, CT. We appreciate the mowing and upkeep of the ground by the State of Connecticut DEEP. Also, without the support of Nestle—Purina we would not be able to run these championships. They provided bags of Purina Pro Plan 30/20 to the winning and placing dogs and small bags for each participant. NEBCA provided free lunches and dinners every day. On Tuesday night, dinner was served by Tom and Robin Maule in honor of last year's Open Shooting Dog Champion, Shailorville's Gunner. Wednesday night John and Joanne Perry provided dinner in honor of T J's Black Diamond, the 2017 Amateur Shooting Dog Champion. Thursday night, Mike Tiberii and Leslie Fleury presented a dinner in memory of Dave Marshall. Dave was a founding member of NEBCA. Everyone signed a ceramic platter in memory of Dave Marshall.



Also, thanks go to the committee: Chairman Bob Fleury, Reporter Sarah Conyngham, Bill and Fran Gorman, Rita Poland, Henry Wierzbicki, Mike Tiberii, and Secretary Leslie Jane Hunt. Thank you to Tom Wood for taking the week off from work, planting birds throughout the championship and Paul Shirley who took a day off to plant birds.

We were fortunate to have four respected judges, Kevin Stuart from Schenectady, NY and Dick Frawley from East Windsor, CT who judged the Open Championship and Howard Schultz from Bealsville, Maryland and Andrew Campbell from Northfield, MA who judged the Amateur Championship. We thank them for their wisdom, judgment, and kind manner.

### **Open Shooting Dog Championship**

The Open Shooting Dog Championship ran 23 dogs on October 2–3. FC Waypoint's Chancy Big White Cooper was named the 2018 New England Brittany Open Shooting Dog Champion owned by Joyce Roberts and Vic Williams and handled by Kyle Merrill. The Champion, aptly named Big White, and handler Merrill arrived in the last brace. Some dogs need

a bracemate but Big White did not. He covered the country intelligently and purposefully, scoring three well—spaced finds, each with manners befitting his placement. Though the paths had been furrowed by many before him, two of his finds were in locations in which no other dog had scored. In the last, the cover was so impenetrable, bird flushing seemed unlikely, yet the handler was unpredictably successful in making the bird fly. Big White concluded his hour gamely seeking distant objectives, but attentive to his handler.

Runner-Up Champion was FC Kinwashkly Midnight Rambler owned by Jodi Miller and handled by Kyle Merrill. In the sixth brace, the Runner-Up, Jack, with handler Merrill exemplified a smooth run. Jack was fast and forward scoring in the maples behind the pond despite a steady rain that burdened the entire hour. His bracemate Marjo's Fille De La Bretagne, owed by Robert Goldman and handled by John Perry, took third place. She was on a shopping spree carding finds below the pines, above the culvert, and at the creek west of the clubhouse in heavy cover. She had one nonproductive. At the creek and culvert on Dearborne's return loop, the two had a divided find. It was Jack's application and the pattern of his casts that put Jack in the driver's seat in this brace.

Fourth Place was FC Rainbow's Chik'N Mcnugget owned by Art Cohen and handled by Kyle Merrill. In the seventh brace Nugget, with handler Merrill, ran with Autie, with handler Lorenson. Their divided find was at the pond's maples, and two other finds had Autie in the backing position. At Dearborne, a divided find became a nonproductive for Autie while Nugget succeeded in a relocation. At the little creek crossing on the return loop, Nugget had scent, but no birds could be persuaded to leave an awful tangle of shrubs and roses. Her race while challenging to handle was impressive and exciting and she was rewarded. Autie ran a good, honest race.

**Brace 1: Haley-Perry and Misty-Merrill.** In a cool, light rain with no wind, the running started. Misty's find at the maples behind the pond started the ball rolling while Haley flew around the course, not to be spotted too often. A divided find on Tobacco Barn Hill showed Haley in the foreground. Misty was up at 20. Haley continued her long, loose run.

**Brace 2: Rusty-Lorenson and Gauge-Anderson.** Rusty was not with us long and the tracker was called for after a time. Gauge's race and early finds were sound and systematic. His relocation west of the clubhouse was textbook. Dearborne's southern edge held a nonproductive for him, while at the end of the loop he handled his birds with ease.

**Brace 3: Stuart–Pollack and Trooper–Lorenson.** The pond's maples saw the first find with Stuart pointing and Trooper backing. Trooper's turn was next in the trees above the culvert behind Fox Hill. At Tobacco Barn Hill, a bird ended Trooper's bid, while Stuart was picked up on the downhill side, not pleasing his handler.

**Brace 4:** Kali-Tiberii and Jib-Lorenson. Jib's gait was attractive and animated, but he seemed unsure of the course. Kali stood the birds at the pond and both dogs headed for Tobacco Barn Hill. At the top, Jib stood intently on point in the field to the right of the tree line while Kali approached with intent less noble. Kali was up and Jib clean. Jib had a good find at the end of Dearborne. His last find caused a small sensation because the dismounting handler put the birds to wing, but he

had a harder time finding the dog. In tall creek grass he stood obscured, his handler eventually locating him by logic.

**Brace 5: Gus-Lorenson and Gin-Pollack.** Gus's story ended quickly with a find and a disappearance. Gin had two finds in close succession at the near end of Tobacco Barn Hill. Her final find at Dearborne's midline on the return side followed.

Brace 6 & 7: Covered above.

**Brace 8: Gabe-Lorenson and Jet-DuBois.** Jet was interested in the forest and would not return to the course. Gabe ran hard and was not seen until the back stretch. A tracker was called for at 20

**Brace 9: Bye brace. Gunner–Lorenson.** Gunner streaked off and was found standing at an oak tree short of the islands. Bird up, shot fired, dog acceptable. The Tobacco Barn Hill yielded another find. Gunner was in the open and steady to wing and shot. The rest was a private affair, the tracker later activated.

**Brace 10: Eli-Merrill and Tucker-Lorenson.** The clouds thinned and the temperature swelled. Tucker didn't join us much, but Eli kept with us. At the culvert behind Fox Hill, both dogs stood, but seemed unsure. Eli was sent to relocate while Tucker backed. At Eli's stop, the birds take off. In the scattered trees below the clubhouse, Eli had contact again, all clean. Tucker stood in the distance at the end of Dearborne, holding his birds. His find was good and so was his scout on the next leg. The brace ended with a divided find on the steeply descending hill at the powerline.

**Brace 11: Denver–Merrill.** An attractive dog, Denver handled the course methodically finding a bird in the trees west of the clubhouse. Enthusiastic on his game, he acknowledged the approaching handler, finishing clean.

**Brace 12: Hooch–Merrill.** The sun was out and overbearing. Hooch had a stylish find at the maples behind the pond, but at 23, Hooch was picked up at Tobacco Barn Hill.

**Brace 13: Rex-Lorenson.** A forward dog, Rex had a ground eating pace. He suffered a nonproductive in the trees next to the pines and hit the edge to cover the north part of the course. At the top of the Tobacco barn Hill, Rex was pointing into hip high weeds in the overgrown

### Amateur Shooting Dog Championship

The Amateur Shooting Dog Championship ran 18 dogs on October 4-5. FC I'm You Man (Gus), owned by Frances Gorman and handled by Art Cohen, was named the 2018 New England Brittany Amateur Shooting Dog Champion. The winner appeared in the third brace, Gus with handler Cohen running with Coal with handler Perry. Gus reached to his first find at 10 am, locating birds on the islands after a relocation. Then we were pressed to keep pace as Gus swept to the front. His next find upgrade from the culvert saw him steady to birds overhead as the handle

flushed and fired. At the top of Tobacco Barn Hill, Gus again indicated the birds' exact location at a respectable distance. It's Coal's turn in the trees below the clubhouse with Gus having another clean find nearby. Coal powered up the treed midline at Dearborne, and Gus was seen at the end. Gus cast wide at the pines while his handler sang strongly. Coal had recovered connection with his handler. Gus resurfaced at the west power line bridge, later pointing on the hill that descended to the water ahead. His handler liberated a bird from heavy cover, bringing the exciting brace to a close.

Runner—Up Champion was FC/AFC Palmetto Point's Autumn Blazing Star (Autie) owned and handled by Tom Bass in Brace 4 with Gin handled by Pollack. Both dogs had the look of seasoned professionals as they crossed the water at the base of the pines. Gin searched the right edge and had her handler flush there. Gin was rewarded at the islands. Autie canvassed the course intelligently while Gin had an honest stop to flush on the near side of the culvert. Autie's first find occurred in the trees beyond. Gin pointed in the strips past the trees but did not find the birds that had been there the day before for her. At the top of Tobacco Barn Hill, Autie handled not one, but two finds. At the entrance of Dearborne, she did not come up with the birds she had pointed, even after a relocation.

but at the other end, she stood flawlessly for an extended flushing effort that did put birds int eh air. She seemed as honest as her run was long and graceful.

Third place was awarded to NGDC/GFC/FC/AFC Magnum High Velocity (Gauge), handled by Anderson who ran with Kali, handled by Tiberii in the second brace. Kali skated the course effortlessly. Gauge hit the course hard and came into view only on the backside. Above the culvert, Gauge found his first bird while Kali was cautioned, taking up a backing position. At the top of the big hill, Kali was taken up for an indiscretion around birds. Gauge's find there was clean. Under the trees below the clubhouse, Gauge relocated exactly as he had the day before to collect his third find. Gauge found again at Dearborne, pointing nearly one thousand or so blackbirds. The handler's flushing and a thorough relocation did not yield a game bird. Then Gauge stood near the wet draw to the west of the pines. Again, the birds were elusive. Undeterred, the dog and hander worked a full five minutes to produce a bird. Five minutes is not a long time in other context, but in this one, unbridled tenacity was required. And they were successful.

FC Rusty Nail of Coos was named fourth place in the 7th brace with Jack, handled by Cohen. The sun was hot at 3:39, but Rusty steamed up the edge and Jack was soon out of sight until the back stretch. Rusty found birds at the culvert hill, all neat and clean while Jack moved past. Rusty scored again on Tobacco Hill and twice in the trees and seep below the clubhouse. Jack failed to stop on a flush at 4:25. Rusty's devotion to the edge failed him at Dearborne, but he produced another clean find at the end of the loop and used the edge well on the return side. He finished acceptably.

**Brace 1: Trooper–Bass and Joey–Luisi** fired off the line at 7:42 am. Trooper, not pleasing the handler was taken up. Joey scoured likely spots after pointing beyond the culvert, culminating in a find. The handler harnessed him before time.

Braces 2, 3 and 4: Covered above.

**Brace 5: Remi-Perry and Nugget-Cohen.** Tobacco Barn Hill provided the cover for Nugget's find, which turned out to be a nonproductive, but was a terrible temptation for Remi. Remi soon succumbed to a later lapse in discipline and was up while Nugget had a

clean find at the end of the tree line. She was the hot little engine that could but chose not to, as the handler moved toward Dearborne and the Nuggett headed north. She changed her course soon enough and disappeared in the cuts and cover of Dearborne when the handler called for the tracker.

Brace 6:
Colby-Arcand and JibBass in one of the last autumn afternoons of hot sun. The two dogs pointed separately at the islands, Colby having a nonproductive, but soon committing to a clean find nearby. Colby has three more finds, two of which were in novel

spots though adjacent to the course. Jib is up for failure to stop. Colby disappears up the midline of Dearborne and had a long find at the end with two relocations, the bird finally spotted in the adjacent cornfield.

Brace 7: Covered above.

**Brace 8: Misty-Bass and Stuart-Pollack.** On the right edge of the fields after the pines Misty pointed a large covey while Stuart backed near the new pole path barricade. Stuart's find occurred on the hill above the culvert with Misty backing on the other side of the trees, all in order. Stuart stopped to flush on the way up the Hill and had a point, relocation, and find in the trees below the clubhouse. Misty enjoyed an unrelated clean find nearby.

**Brace 9: Maddie–Kipp and Cruzan–Luisi.** Both dogs moved well to the islands, where Maddie burst through one of the clumps, failing to honor Cruzan, and sending two birds up. Cruzan was released from her clean find only to stop again for a bird in the tall, marshy grass close by. The top of Tobacco Barn Hill held birds at its far end for Cruzan, all in order and her final find happened below the clubhouse in the dense cover around the road's seep. Her time ended at the turn in Dearborne.

# The Brittany Bites By Sheila Cordner Recipe Collection

### **Buffalo Chicken Lasagna**

1 tablespoon canola oil

1 ½ pounds ground chicken

1 small onion, chopped

1 celery rib, finely chopped

1 large carrot, grated

2 garlic cloves, minced

1 can (14 ½ ounces) diced tomatoes, drained

1 bottle (12 ounces) Buffalo wing sauce

½ cup water

1 ½ teaspoons Italian seasoning

½ teaspoon salt

¼ teaspoon pepper

9 lasagna noodles

1 carton (15 ounces) ricotta cheese

1 ¾ cups crumbled blue cheese, divided

½ cup minced Italian flat-leaf parsley

1 large egg, lightly beaten

3 cups shredded part-skim mozzarella cheese

2 cups shredded white cheddar cheese

In a Dutch oven, heat oil over medium heat. Add chicken, onion, celery and carrot; cook and stir until meat is no longer pink and vegetables are tender. Add garlic; cook 2 minutes longer. Stir in tomatoes, wing sauce, water, Italian seasoning, salt and pepper; bring to a boil. Reduce heat; cover and simmer 1 hour.

Meanwhile, cook noodles according to package directions; drain. In a small bowl, mix the ricotta cheese, ¾ cup blue cheese, parsley and egg. Preheat oven to 350°.

Spread 1 ½ cups sauce into a greased 13" x 9" baking dish. Layer with three noodles, 1 ½ cups sauce, ¾ cup ricotta mixture, 1 cup mozzarella cheese, ¾ cup cheddar cheese and ⅓ cup blue cheese. Repeat layers twice.

Bake, covered 20 minutes. Uncover; bake until bubbly and cheese is melted, 20-25 minutes. Let stand 10 minutes before serving. 12 Servings

### Jalapeño Popper Stuffed Chicken

- 2 slices center cut bacon, cooked & crumbled
- 3 jalapeños, chopped (remove seeds for milder)
- 3 oz 1/3 less fat cream cheese, softened
- 4 oz reduced fat shredded cheddar jack
- 2 tbsp chopped scallions
- 8 thin sliced skinless chicken breast cutlets, 3 oz each
- ½ cup Italian seasoned whole wheat breadcrumbs

1 ½ juicy limes, juice of 1 tbsp olive oil salt and fresh pepper olive oil non-stick spray

Wash and dry chicken cutlets, season with salt and pepper. Preheat oven to 450°F. Lightly spray a baking dish with non-stick spray. Combine cream cheese, cheddar, scallions, jalapeño and bacon crumbles in a medium bowl. Lay chicken cutlets on a working surface and spread 2 tbsp of cream cheese mixture on each cutlet. Loosely roll each one, secure the ends with toothpicks to prevent the cheese from oozing out. Place breadcrumbs in a bowl; in a second bowl combine olive oil, lime juice, salt and pepper. Dip chicken in lime-oil mixture, then in breadcrumbs and place seam side down on a baking dish. Repeat with the remaining chicken. When finished, lightly spray the top of the chicken with oil spray.
