

2019 ABC National Amateur Gun Dog Championship

December 9 -11, 2019

People from across the country gathered for this first year of the combined National Championships in Booneville, Arkansas. We saw a no real increase in Amateur entries; just a few new faces and some missing old ones; every dog qualified could have been entered and like the lottery, you can't win if you don't play! Amateurs Richard Beaver, Dan Doiron, Jon St. Clair, Jackie Hutwagner, Rodger Fiorito, Wayne Pepin, Bob West, Dawn Droel, John Perry, Lisa Pollock, Tommy Thomas, Rick Hastings, Vince Anderson and Frank Campbell were on hand to showcase their fine of dogs from across the country in pursuit of The American Brittany Club's 2019 National Amateur Gun Dog Championship; thanks for your support!

The grounds were in wonderful shape from a decreased growing season due to Spring and early Summer flooding and the wonderful mowing work by the J. Perry Mikles-Blue Mountain staff from the Arkansas Game & Fish Commission. We used all the courses and had bird contact on each one, frequency influenced by changing scenting conditions and pattern of the dogs. Three hundred fifty birds were released upon the completion of the Open Championship and fed according to the site's feeding program, allowing every dog the opportunity to have multiple finds on small groups of birds as well as large coveys throughout the event.

Corporate Sponsors Purina and Garmin provided their products as well as financial support for our event; Kevin Parrish "The Saddle Guy" provided a finely tooled trophy saddle for the winner. Purina food fuels our fine canine athletes and they provided a small bag for each dog running in the Championship, along with 375lbs of food to be split amongst the placing dogs. Garmin provided one of their 550 Plus, track & train units with the T5 Mini collar to the winner. We cannot thank these sponsors enough for their continued support and dedication to the pursuit of healthy nutrition, training,

safe recovery of our dogs, as well as the comfort of their trainers and handlers while doing their jobs. These companies make it easier and more efficient than ever to do the work necessary in preparation of a National caliber dog and we are grateful for their support.



Bob Burchett and I want to thank everyone who came to compete, watch, lent a helping hand and pitched in daily to make this National Amateur Championship a success. They sacrificed time away from family and the usual duties of preparation for the approaching Christmas/Hanukkah season. Stan Williams stayed over from the All-Age and took on Marshall duties for much of the Open Gun Dog and all of the Amateur – we greatly appreciated his help! Judi Tipton and her staff in the kitchen prepared 3 meals daily that were available to all to partake in for a very reasonable cost; not to mention their pleasantness to everyone they encountered! Robert returned to pilot the dog wagon saving the passengers from the exciting



rides of the All-Age Championship's pilot du jour program. Linda Thomas coordinated the Hospitality of the Dog Wagon with assistance from the kitchen staff and their homemade cookies which were outstanding! Brittany Pros Paul Doiron, Ed Tillson, Bob Burchett and Scott Johnson were on hand to assist with the multiple tasks of the Amateur Championship and we appreciate their attendance and support.

Our Judges were Mark Keegan, from Colorado and Rhonda Haukoos from lowa; they each have judged Championships and successfully handled multiple dogs of their own to Championship wins. We appreciate their attention to the performances of every dog and the positive manner in which they adjudicated this event. They were a pleasure to be around and enjoyed their time with us — without the willingness of others to give back by judging, these events would be nearly impossible to hold. Thank you for your time in the saddle watching our dogs, it is greatly appreciated!



Our 2019 National Amateur Gun Dog Champion came from brace 10b K Nine's Finale's Way To Go - (Allie) owned by Linda McDonald, handled by Tommy Thomas and scouted by Mike Poehler. One of the most stunning aspect of this Champion is that Allie met her handler for the first time, 30 mins. before being loaded on the dog wagon for the day; she met the scout at breakaway! Allie was fast during her entire hour with no let down. She made sweeping moves and was on a mission everywhere she went. Upon breakaway on Course 2, she hit the right side along the river and flew to the front and deep into the corner of the field past the Buzzard Roost. Her first find came at 12 mins. on a small covey where she was found standing with style near the dog wagon on the far left side of the course, near the exit of the third field. Her moves were ambitious to say the least, as evidenced when she swung out into the left side of the Parish Field and worked wide left, taking it way out then forward to the exit area of the Horseshoe Loop and across the front from left to right. She worked with Tommy on the far edges through the back section of the Horseshoe Loop and back out into the Parish Field. Taking the right edge of the Parish Field around to the Old 109 road grade where Allie was found beautifully pointed at 50 mins. on a covey. After her find, Allie shot South down Old 109 to be seen running the backside of the line south of the Buzzards Roost, heading towards the original breakaway within the grace period after time was called. Runner-up Champion came from brace 2b Saradac's Dangerous Diamond Caper – (Caper) handled by owner Lisa Pollock for co-owners Ed Kostka, Darlene Dow, & Paul Pollock. Caper had 5 very stylish finds and a run that grew as the hour progressed to be detailed below. Third place came from brace 10a Josey's Jazz Em Up Rascal – (Rascal) owned and handled by Rick Hastings. Rascal had 2 finds and a pleasing run as detailed below. Fourth place came from brace 12b Magnum High Velocity – (Gauge) owned and handled by Vince Anderson; Gauge's 2 finds, and consistent run are detailed below.



The Running:

Day One – We awoke after overnight rain to a cold and damp morning with temperatures in the mid 30's warming to the mid 40's with some sun; these conditions required more layers than usual and was the coldest weather since the Brittanys arrived in Booneville mid-November!



Brace 1: Second Amendment – Perry (Remmi) and Leona Valley's Sonny Red Side Up – Dan Doiron (Red). This pair broke away on Course 1 working independently of each other; Remmi showed lots of promise, but never warmed to the task at hand and without bird work, John elected to pick-up midway through the hour. Red rose to the occasion, growing in range and application as the hour progressed. His first find came at the 18 min. mark in the S/W corner opposite the Barking Dog House. He had a non-productive at 44 mins. with a relocation through some of the thickest briars I've seen here, in the tree line prior to turning towards the Double Gates. After the Double gates in the open field approaching the river, Red pointed with beautiful style and intensity on a large covey at 58 mins. and finished well.

Brace 2: Jazz Em Up Arrow – Hastings (Arrow) and Saradac's Dangerous Diamond Caper – Pollock (Caper) *Runner-up Champion*.

This pair broke away on Course 2 with Arrow driving forward on the right along the river and across the culvert. Caper ended up on the right side after the Buzzards Roost and had her 1st stylish find at 7 mins. midway along the right of the second field, with Arrow backing at Ricks direction. Caper had her 2nd find at the bump-out along the right edge of the second field with Rick and Arrow moving forward. She had a non-productive at 20 mins. before the Parish Field. Both dogs started to make nice moves and worked out into the Parish Field, taking the left side down to where the trees end with Caper pointed at 31 mins. with a lot of pressure by Arrow who ended his day failing to honor the find. Caper's 4th find came at 37 mins. on the right at the entrance to the Horseshoe Loop on a small covey after which, she made some of her nicest moves of the hour running the right edges and islands of trees in the swampy section. At 52 mins. she stood for her final time at the stand of pines just right of the second entrance to the Parish Field and finished her hour working across the Old 109 road grade.



Brace 3: High Velocity Copper Magnum – Anderson (Colt) and Hurricane Banjo – Fiorito (Banjo). The pair broke away with great speed on Course 3 with both dogs taking the right side doing a nice job through the first three fields. Banjo had a stop to flush at 13 mins. in the woods. Colt was found standing on the opposite side looking nice on point, but unfortunately went with the covey at the flush ending his time. Banjo ran with animation and was fun to watch as he moved on and had a find at 20 mins. near Mario's Hill. He hunted hard for the hour though a bit hesitant at times and finished well towards the end of the course.

Brace 4: TNT's Sirius Renegade Buddy Boy – Thomas (Buddy) and Campbell's Razz-Ma-Taz – Campbell (Razz). These dogs broke away on Course 1 working well for their handlers. Buddy had a find at 24 mins. on the left after crossing Lick Creek and Razz had his find at 28 mins. after crossing the road on the right edge at the cedar thicket. Both dogs moved well thru the next fields and at 35 mins. Buddy had a find on the left side half way down the line, 2 fields before the turn paralleling 109. Razz ended his day at the same time, running through a covey on the right. Buddy continued making nice moves at a moderate pace with very nice application and two more finds – at 40 mins. in the briar tangle encountered in the first brace, pinning the birds upon relocation on the opposite edge. His last find was on a large covey at 55 mins. near the river's edge after the Double Gates ending his hour going away.

Brace 5: Sonny's Hot Summer Breeze – Thomas (Breeze) and Coos Triple Six – Perry (Boomer). These dogs broke away with fluidity and speed on Course 2, working to the left edge with Boomer taking the

near side of the Buzzards Roost pond and Breeze continued to run the far edge, into the water and actually swam the line across the front! What started as an awe-inspiring move turned into a scary incident when her collar got hung on the brush she was swimming through requiring Tommy to ride into the deep water to pull her into the saddle and bring her back to land. Luckily, the pond was hard on the bottom! With the cold temperatures and the length of time she was swimming until Tommy pulled her out, we figured she'd shut down, but it didn't slow her one bit! She had a find at 21 mins. before the entrance of the Parish Field and Boomer a non-productive on the right as we approach the entrance to the Horseshoe section. Nearing the pond on the right of the Horseshoe, Breeze pointed with Boomer backing on a small covey. Boomer worked to the Old 109 crossing where he had a find at 55 mins. on a covey. Breeze really ran well for Tommy making nice moves deep into the Parish Field after the back section and forward working across the Old 109 road grade where she popped a single at the site of Boomers covey find, ending what was a serious challenge for the Championship. Boomer made some really nice moves during his hour and was fun to watch cover the ground, ending his hour three fields before the bridge crossing.



Brace 6: Sanbar's Legendary Evening – Hershey (Pepin) and A Trace of Bourbon With Diamonds – Hastings (Trace). Both dogs broke away on Course 3 taking a hard right down the river's edge requiring scouts to be dispatched. Both dogs were gone for a while with Hershey rejoining Wayne and making nice moves working wider right with each one; he disappeared again, requiring a call for the tracker to be found later on point. Trace returned to the front about the time Hershey went missing with his handler now being gone looking for him. Rick called it a day upon his return.

Day 1 Posted Dogs: 2b - Saradac's Dangerous Diamond Caper – Pollock, 3b - Hurricane Banjo – Fiorito, 4a - TNT's Sirius Renegade Buddy Boy – Thomas, 5b - Coos Triple Six – Perry.

Day 2 – We awoke to a heavy frost and temperatures near 30; given 2 injuries and a scratch altering the running order, the committee delayed break-away until 8:30 and only 5 braces were scheduled to run. Ice was on the ponds and the sun came out late morning to at least give the impression of warming things up.

Brace 7: Quail Rock Too Tough – Dan Doiron (Duke) and TJ's Black Diamond – Perry (Coal). A collision on breakaway put this pair off their game early, each warmed to the task before approaching the culvert crossing. Point was called at 15 mins. for Duke on the far side of the pine mot after the culvert with Dan flushing for a long time, including re-location with no birds produced. Duke made nice moves throughout the hour; he was bird-less for his efforts. Coal running fast and forward, was last seen crossing Lick Creek with John calling for the tracker at 40 mins.

Brace 8: Sovereign's Chasing Legends – Droel (Hobey) and St. Clair's Prince Rocco Vulcano Leo – St. Clair (Rocco). Hobey and Rocco broke away on Course 2 doing a nice job and shared a divided find at 10 mins. and Rocco had another at 15 mins. looking nice on point. At the 25 min. mark,

Rocco was pointed again with Jon flushing for a long time. Rocco decided that Jon had flushed long enough and ended his day early; he'd done some nice things up to that point. Hobey had a non-productive at the entrance to the back Horseshoe at 32 mins. and made some nice moves and had fun in the Parish Field and ran forward for Dawn until time was called.



Brace 9: Atos – Hutwagner (Atos) and Kid's Royal Casey – Heiter (Casey). This pair broke away after lunch on Course 1 with Casey standing at 8 mins. in right corner of second field with nice style and intensity; Bruce relocated him and produced the bird after a lengthy second effort. Casey stood again at 16 mins. with a high head and beautiful style in the briars near the dog wagon on a large covey after the culvert crossing. His third find was at 29 mins. on the tree line prior to the road crossing, requiring a well-executed relocation; an aggressive mark on the flight required cautioning. He had a stop to flush with Atos backing nicely at 42 mins. Casey made nice moves with a fluid running style; his pattern had some inconsistency. Atos had finds at 12 mins. near the large oak tree prior to the culvert crossing, at 26 mins. after the Lick Creek crossing on a small covey, and again at 50 mins. with Casey backing. Atos pointed with a high head and great intensity on all of his finds and ran with power and an energetic gait; his range and application growing throughout the hour. Both dogs finished strong as time expired.

Brace 10: Josey's Jazz Em Up Rascal – Hastings (Rascal) *3rd Place* and K Nine's Finale's Way To Go – Thomas (Allie) *Champion*. This pair broke away on Course 2 with speed; Allie's performance was detailed previously. Rascal ran with speed and fluidity carding his first find on a dead bird at 8 mins. on the right corner of the tree line, one field prior to the Old 109 bridge. He swung along the right edge fairly consistently from there until the entrance to the back Horseshoe area. He continued working on the right and carded his second classy find in the pine grove at 40 mins. at the second entrance to the Parish Field. Upon release Rascal pointed again around the corner of the Northern edge of the Parish Field ending in a non-productive. He and Rick continued working in a pleasing fashion until time, nearing the last field before the bridge crossing.

Brace 11: Marjo's Fille De La Bretagne – Perry (Brie) and Hopes Chief of Crosscreek – Pepin (Chief). Brie and Chief broke away with gusto on Course 3; Brie being fast and snappy, flying around and Chief worked in the manner befitting a seasoned veteran. Brie carded the first find at 12 mins. on the backside of the trees near the shortcut back to camp with high and tight style. Chief stood next at 14 mins. with picturesque style for Wayne. Brie's second find came at 22 mins. in the Pavilion Field. Chief pointed again at 28 mins., in a near impossible tangle of tree trimmings prior to Gas Well Hill requiring a precarious flushing attempt by Wayne who finally succeeded

in production of a single bird with all in order. At the large downhill field, John and Brie drifted off to work the right edge; Wayne let Chief naturally work the islands on the right. As Brie and John returned to the trail, Brie pointed again at 40 mins. with a small covey produced for her. Chief dug in hard right, pointing on the edge at 42 mins. right as John flushed and fired. While Wayne was dismounting, Chief decided to end his bid early with gusto. Brie's remaining time on the ground displayed nice moves and speed; she finished the hour pointed at time, with John electing to not work the bird.


Day 3 – Sunny and warmer, our last brace broke away to temperatures in the mid 40's.

Brace 12: Ricochet Gunsmokes Mr. Dillon - Thomas (Dillon) and Magnum High Velocity - Anderson (Gauge) *4th Place*. Both dogs broke away with determination and worked independently at a consistent pace with Gauge pointing with great style and intensity at 12 mins. on the far side of the clump after the culvert crossing. After a prolonged flushing effort, Vince produced a single for Gauge. While riding almost a ½ mile catching the front, Vince let Gauge work the left edge which he took around the entire way past the Barking Dog house, crossed Lick Creek and rejoined Dillon who was working well for Tommy up on the left edge. After crossing the road, Gauge dug in on the right and disappeared for a while. Tommy and Dillon worked ahead while Vince and Gauge thoroughly worked the trees. After a covey of deer jumped up out of the field near Vince at the end of the Plateau Field, Gauge pointed on the right edge at 30 mins. for another lengthy flushing effort and a relocation; a non-productive was carded. Gauge finally rejoined the front at the 42 min. mark close to the Double Gates. Dillon swung out on the left past the Double Gates towards the river and had a beautiful find on a large covey there at 47 mins. while Vince and Gauge headed to the right. This pair worked at a moderate pace towards the end of the course. Gauge worked forward to the trees from right to left towards the river's edge where he pointed for his 2nd find at 55 mins. After a lengthy flushing effort, Vince put a sizable covey to flight with the hour ending for Gauge near the bride crossing. Dillon worked on the left side of the course and crossed the bridge and ran the right edge along the river with time being called as he crossed the culvert of the Buzzard Roost.


2020 Lone Star Derby Classic

The judges for this year's event were Charlie Collier from Corsicana, Texas and Wesley Felt from Kaufman, Texas. These two judges were up to the task of two days of riding to select the dogs with the all age range, intensity on birds pointed, and the handling necessary to be named the Champion and Runner-up Champion. Thank you judges for giving of your time in the saddle.

We had twenty-three dogs run in this Championship. The Champion named for the 2020 Texas Open Brittany Championship was FC/AFC A Trace Of Bourbon With Diamonds, a five-year-old male owned by Rick D. Hastings and Becky J. Hastings and handled by his owner Rick D. Hastings. His sire is GFC/FC Touch Of Bourbon Little Chug and dam is FC Sniksoh Little Diamond. The Runner-up Champion was MK's Magnificent Bandito, an ten-year-old male owned by Bill Oliver and Mary Lynn Oliver and handled by Scott Johnson. His sire is Tee Bone and Dam is Chief's Nubbins My Lil's Lady.

Third place was awarded to Sparky's Prairie Wind Gypsy owned by Barry Koepke and Karen Fujikawa and handled by Scott Johnson. Fourth place was awarded to Sundance Kid's Rule Breaker owned and handled by Frank Campbell.

The Championship Running:

The weather for the two days was cold in the morning and unseasonable warm afternoons for the month of February in Oklahoma. The breeze in the afternoon kept it reasonable for the dogs to run. The previous weeks before the trials the grounds received tremendous amount of rain to make the grounds muddy and some of the course was modified for safety. The path chosen to run the course was new for this year and maybe in some ways better. The wet condition did not hurt the bird count as every dog had a chance at a bird and most had multiple finds.

Brace 1: A Trace Of Bourbon With Diamonds-Hastings and Chiefs Cross Plains Copper Breeze-Rucker. A Trace Of Bourbon With Diamonds broke away and was seen going over the hill to the southern route to the front. His southern route took him to his first successful find at 15. He was released and moved forward for a couple minutes when he locked up at 22. He was released and moved out and after a full edge line locked up in front where all could view at 25. He had two more finds at 45 and 50 and finished going away to the end of the hour. His performance was truly mature and fun to watch and was hard to beat as the judges awarded him the Champion of the Texas Open Brittany Championship. Chiefs Cross Plains Copper Breeze had an early bird bump and for his lack of manners was sent to the dog wagon.

Brace 2: Just Call Me Lucky Ned Pepper-

Campbell and Almaden's Under Lock And Key-Tilson. Just Call Me Lucky Ned Pepper was showing his forward drive early and at 18 had his first find. He had two more finds at 39 and 50 and was covering a lot of ground. He had a final point at 58 and on relocation bumped the bird and was taken to the dog wagon. Almaden's Under Lock And Key had an early bird contact and for his lack of manners was sent to the dog wagon.

Brace 3: Alar's Dirty Dancer-Tillson and Highpoint Spike's Southern Gal-Kuykendall. Alar's Dirty Dancer backed his bracemate at 5. He has his own bird finds at 25 and 32. He was found on point at 57 and at the completion of the relocation a bird was not produced. He finished the hour. Highpoint Spike's Southern Gal had a bird at 5 minutes. She handled a delicate flush from a tree limb. She was sent to the front and at 25 she failed to back her bracemate.

Brace 4: SS Rig's Colorado Gun Runner-Milam and Sparky's Prairie Wind Gypsy-Johnson. SS Rig's Colorado Gun Runner backed his bracemate at seven. The next time we saw him he was pointed next to his bracemate and both stood for the flush and shot. He was released and both dogs were to the front. At 25 his bracemate was already standing and he backed and then decided to pint even closer and was picked up for lace of manners. Sparky's Prairie Wind Gypsy had a bird at 7 and 14. We all watched as she was finishing the edge and slammed into point at 25. As we rode to the front, her bracemate came in front of her point while she maintained her picturesque pose. Handler flushed and shot and she was released to the front. She had two more finds at 42 and 45 and finished the hour at medium range. This performance was enjoyed by the judges and she was awarded third place.

Brace 5: Sundance Kid's Rule Breaker-Campbell and Firestarter's Crossed The Line-Tillson. Sundance Kid's Rule Breaker had a back at 38 and three finds at 44, 48 and 51 and finished the hour. This performance was enjoyed by the judges and he was awarded fourth place. Firestarter's Crossed The Line had a bird at 38, 48, and 51. Handler elected to pick her up before the hour.

Brace 6: MK's Magnificent Bandito-Johnson and Arrow's Tequila Rustler-Beaver. MK's Magnificent Bandito broke to the front and was seen next time on point at 20. His next find was at 35 and then showed his talents as an all age performer. He was found to the front at 58 and then again at 59. This performance was enjoyed by the judges as he was named the Runner-Up Champion of the Texas Open Brittany Championship. Arrow's Tequila Rustler was lost early as the handler asked for the tracker.

Brace 7: JB's Full Speed Ahead-Johnson and Tequila Scorcher-Tillson. JB's Full Speed Ahead chased a bird at six. Tequila Scorcher came in after his bracemate was on a check cord and pointed at the same tree. Handler flushed and shot with perfect manners. He had two more birds at 14 and 17. He

bumped a bird at 26 and was taken to the dog wagon.

Brace 8: Tejas One And Only-Carrington and Sinksoh Little Diamond-Johnson. Tejas One And Only was lost at 30. Sniksoh Little Diamond had a bird at 20 and 48. He finished the hour.

Brace 9: Willie Make It-Johnson and Rev'N Gunrunner's Tilly-Tillson. Willie Make It was moved down to 12 and Rev'N Gunrunner's Tilly was moved to 13 as she was season.


Brace 10: Wiyanna-Gowin and Tejas Blazing Sun-Carrington. Wiyanna had a bird at 35, 45, and 47 and finished the hour. Tejas Blazing Sun had a point at 14, however he did not wait for the handler to flush and was sent to the dog wagon.

Brace 12: Crescent City Girl-Tillson and from Brace 9 Willie Make It-Johnson. Crescent City Girl had a nice find at 15. She was forward for most of the first half and at 35 pointed and decided to chase. Willie Make It had not been seen for some time and at midway through the hour the handler requested the tracker.

Brace 13: From Brace 9 Rev's Gunrunner's Tilly-Tillson. Rev's Gunrunner's Tilly had not been seen for some time and at the midway through the hour the handler requested the tracker.

This concluded the running of the 2020 Texas Open Brittany Championship.

2020 Brittany Field Trial Hall of Fame Ceremonies

The Hall of Fame's purpose is to honor individuals, past and present, both human and canine, that have made significant contributions to the field trial sport and to preserve their legacies so that others can remember and be inspired.

Rick Smith & Bob Fleury had visited Barbara Rokas during the year as she had many more priceless items to donate to our wing. Our deepest appreciation and thanks to Barbara for making sure that our breed history is well documented and sustained by her generosity! Mere words of thanks can't do justice to Barbara's contribution to our Brittany Field Trial Hall of Fame.

We held our now "annual" happy hour at the Hampton Inn in Collierville, TN on the 7th of February. We are so grateful for their allowing us to usurp their entire dining area for our gathering and making all of us feel so welcome! Mary Crawford reserves a block of rooms for our group and I'm happy to report that she has to increase that number every year! It's always enjoyable to greet old friends and give everyone a chance to spend some money! Scott Johnson "volunteered" to be our auctioneer for evening and we made about \$2000.00 through his efforts. Mary Crawford kept Lisa Pollock apprised of the bid on items over their cell phones, thank you Lisa for your support!

The HOF inductions took place on February 8th and since our portion was after lunch, it gave visitors a chance to tour our wing. We had a few additional items with prices on them that were purchased by the Brittany community at that time. We'd like to thank everyone for their personal and club contributions throughout this past year; every penny goes into our endowment fund to ensure our breed history will always have a home! A fabulous lunch was served to everyone after the morning session! The luncheon was sponsored by Purina, Garmin, Ainley Kennels & Fabrication, and Avery.

We missed Dave Fletcher this year as he had to have surgery, but we'll look forward to having him back next year! Dave has been our master of ceremonies, our plaque presenter (which he makes!), and since he's a printer, he also prints the programs for the morning and afternoon sessions. Surgery didn't stop him from completing his tasks ahead of time and making sure everything was in Grand Junction on time! Rick Smith presided over the Brittany portion of the afternoon. The first plaque presented was a Patron Plaque for Marge Johnson, accepting was Scott Johnson as Marge had broken her arm and was unable to attend. We missed you, Marge & Lyle! The second plaque recipient was kept as a well-guarded secret! Rick asked Mary Crawford to come up and join him and then he asked me to come up and join them. As I was walking up, I glanced at the easel and there on the plaque was my picture! Gary said I had a "deer in the headlights" look! Mary started reading the plaque as I was trying to hold back the tears. Thank you, Mary & Willo Barfield, for this lovely surprise and to my sneaky husband for supplying Mary info on my "spa" days!

Our first HOF recipient was Ray Gorman from New Hampshire. Ray has been a supporter of the Brittany for 20 years as a field trialer, breeder, local club official and an ABC director for 12 years from 2000 - 2012. As a Director he served on several committees, including the nominating,

ethics and judges' committees. Ray worked hard for the National Gun Dog Championship and the grounds in Ionia, MI. His two main projects were the grounds and the fence fund. Ray supported the proposal to have an ABC National Amateur Gun Dog Championship and was instrumental in ensuring the ABC Classics and Championships were AKC and American Field sanctioned. While President of northern New Hampshire Brittany Club for 15 years he helped secure the Kilkenny trial grounds and took the lead in securing the Hill, NH grounds.

Ray judged many events for NE birddog clubs' trials and hunt tests. He judged the AKC Nat'l Pointing breed Gun Dogs at Branched Oak in 2004, the International Amt. Woodcock Championship in Moncton, NB in 2008 & 2009, the Grand Nat'l Grouse Invitational on 2010 and Grand National Futurity twice.

Ray and wife, Martha, have bred Brittanys for over 20 years and live in Coos County, hence their kennel name "Coos." They have finished and produced many AKC FC/AFC and FDSB Champions. Dogs owned or co-owned: 4XCH/4XRU/FC/AFC Suemac's Sky King, 1XCH/3XRU/FC/AFC Ray's Pride of COOS,1XRU/FC/AFC TBF's Hot Roddin Howser, and 3XCH/2XRU/FC/AFC Coos Rylee.

6XCH/6XRU/DC/AFC/NBOB Tequila with A Twist — is our first canine recipient this year. "Taryn" was owned & loved by Jessica Carlson and Ed Tilson, her trainer. Taryn was a "lucky find" for Jessica. She was sired by HOF/NFC/DC Tequila's Joker and Taryn changed Jessica's life in so many ways! She found a co-owner in Canada who had his friend Vern Brunen start her in the field. After he handled her to her juvenile points, Jessica was excited about her potential as a serious field trial competitor. When she came home at 11 months of age, Ed Tillson saw her for the first time and became a co-owner, trainer and handler. Together they won the 2004 Texas Derby Classic among others that spring. Ed trained and ran her in Open and Amateur stakes until turning pro in 2007, when Jessica became her sole owner and went on to run her in Amateur stakes. Taryn had breaks in her career for actinomyces treatment, 2 litters of puppies and a ligament injury in 2009 that ended her career.

Despite all this, she had 25 hour all age placements with 8 firsts. She placed in the Nat'l All Age Championship twice and was RU in the 2008 U S Open Championship. She finished 2nd in Purina Award points in 2008 & 2009 and is the #1 all-time female point earner for the Purina Award with 4488 lifetime points. Taryn received the 2007 Christy Feather Duster Award for highest placing female at the Nat'l All Age Championship, was BOB at the 2008 Nat'l Specialty Show and was the ABC Nat'l Dual Award Winner in 2005 & 2007.

Her 2 most accomplished progeny are 3XCH/1XRU/DC/AFC Tequila Tryst with 5-hour wins and 8XCH/DC/AFC Tequila Scorcher with 13-hour wins. She has kids and grandkids still out there getting it done! DC/AFC Grand Junction "Jake." Jake was owned and loved by Dick &

Carol Pulliam. In his derby season he only competed in hour stakes. He finished his career with 30 All age hour placements and was RU for the Purina Dog of the Year in 2011. Jake had a wonderful temperament and was an affectionate companion with impeccable manners, who lived in the house when not on the trial circuit.

Chad Holman, Jake's trainer, told Dick to "never look back" when running Jake in Amateur stakes, because he'd always be out front! Even as a young dog, Jake liked to stay out front on the edges, needing only a blast of the whistle and a horse turned in the right direction to keep him on course. Jake won the 2008 Chicken Championship in 90-degree heat over 74 dogs. John Kline, one of the judges, remarked that he was the biggest running dog he'd ever seen. Jake was 3rd in the Nat'l Open All Age in 2010 and again in 2012. He won the U S Open Brittany Championship in 2011, the ABC Prairie Chicken Championship in 2008 and was RU in 2009.

To date Jake has produced 12 young dogs with field placements. His most accomplished progeny is 4XFC/NAC/FC/AFC ANJ's Ohio Hellion! Hank won the 2018 ABC Nat'l Amt Championship with owner/handler Mike Poehler, trainer Bob Burchett (of Mike & Hank)! Hank likes the front just like his dad!

Pheasant and Wild Rice

1 can (10-3/4 ounces) condensed cream of mushroom soup, undiluted

- 2-2/3 cups water
- 3/4 cup chopped onion
- 2-1/2 teaspoons dried parsley flakes
- 2 teaspoons salt
- 2 teaspoons garlic powder
- 2 teaspoons dried oregano
- 1-1/2 teaspoons paprika
- 1 teaspoon pepper
- 1 tablespoon all-purpose flour
- 6 bacon strips, cut up
- 1 large oven roasting bag
- 2 cups uncooked wild rice
- 1/2 pound sliced fresh mushrooms
- 1 large pheasant, halved or two small pheasants (about 4 pounds)

In a large saucepan, combine first nine ingredients; bring to a boil.

Meanwhile, place flour in oven bag; shake to coat. Place oven bag in a 13x9-in. baking pan; add the bacon. Sprinkle rice and mushrooms over bacon. Add pheasant. Pour soup mixture into bag. Cut six 1/2-in. slits in top of bag; close bag with tie provided. Bake at 350° for 1 to 1-1/2 hours or until a thermometer reads 180°. Let stand for 10 minutes before carving. Serves 6-8

Asian Style Roasted Quail

6 quail

- 2 tbsp honey garlic BBQ sauce
- 2 tbsp sesame seeds
- 1 tbsp chili-garlic sauce
- 3 tbsp dark sesame oil
- 2 tbsp honey
- 3 cloves garlic, minced
- 1 tbsp fresh ginger, minced
- ¼ cup white wine
- 1/4 cup soy sauce
- 2 tbsp vegetable oil

Combine all ingredients, excluding quail and vegetable oil, in large heavyduty zip-top plastic bag and add quail. Seal and chill 30 minutes, turning occasionally.

Preheat oven to 375 °F.

In an oven proof large skillet or a dutch oven, heat the oil over medium to high heat. Sear the quail on all sides until brown. Be careful to turn often, since quails are so small they might burn quickly. Save left over marinade.

Roast quail in the oven uncovered for 20 to 30 minutes or until quail is done.

In the meantime, pour the marinade in a small pot and simmer over medium heat for 10 minutes, it should reduce a bit. Pour marinade sauce over quail and serve hot with your favorite side dish.

As I left, I noticed someone following me. It was one of the judges, John McMurry. John said the other dogs had a little more range and would probably make better field trialing dogs, but if he could take one home, it would be Skippy. I was so proud.

I thought, "This is one nice man to come to me like that, when four other dogs have beaten Skippy". He was the kind of man anyone would like as a friend, and after 64 years, we are still good friends.
