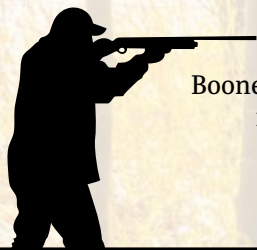

2019 ABC National Amateur Walking Gun Dog Championship

October 26 & 27, 2019

Ionia, Michigan

The inaugural running of this National Amateur Walking Championship was a quality, yet small event. With the move to Booneville being discussed, many were concerned with losing the walking National events and with AKC support, The Walking National Gun Dog Championships came into being. Multiple excuses and rationales have been bandied about for those who didn't come, but bottom line is that everyone with a Gun Dog qualified for Nationals were invited to come and compete; the quality of dogs was on par with every National Gun Dog Championship that I've attended since 2003.

We'd like to thank our judges, Al VanWeiren and Kent Merryman for their time in the saddle observing each and every dog with an attentive and positive eye to select the National Amateur Walking Gun Dog Champion. Several

people gave of their time and talents to assist in making this a quality National event. Dick Lipsky planted birds on each course the night before as well as daily during the mornings for our afternoon braces and took charge of feeding them on course. Deb Smelt and Diana Kubitz took on the large task of hospitality on the dog wagon and arranging great box lunches and organized dinners as well as our Calcutta handling the records and money for those bidding on dogs as well as our auction which was facilitated by Sue Lehosky. Eileen Gust donated homemade caramel rolls and cookies and Chuck and Theda Langstaff ran and drove the dog wagon for a full load of passengers each day. Will Langley was there to provide horses for rent for those desiring to ride and watch as well. Wayne Warners donated a large number of framed Brittany and wildlife prints and odds and ends from his private collection to the auction as well.

We also thank our corporate sponsors, Purina and Garmin for providing financial support as well as their fine products for participants, winners and placing dogs. Purina Pro Plan food will feed our winning dogs for months to come and a Garmin Pro 550 Plus collar will help track and train our Champion



well into the future.

The Ionia Grounds Committee did a wonderful job preparing the courses by mowing and clearing brush so that handlers were afforded a stellar canvas upon which to showcase their dog's performance in each and every brace. I've never seen the grounds in better shape than they were this year!

This year's National Amateur Walking Gun Dog Champion was NGDC GFC DC AFC Magnum High Velocity owned by Vince & Denise Anderson, from Pennsylvania and handled by Vince. Gauge ran in

brace 2b and had multiple finds, wasting no time getting to work. He stood beautifully at the 30 second mark and remained so while Vince flushed for nearly 4 mins. to produce the birds. Upon release, Gauge stood statuesque again at the 6 min. mark with the birds being produced in short order. Vince took Gauge on and released him further down the line to slam on point 30 seconds after release again for his third piece of bird work in 8 mins. Gauge continued with nice style, application and consistent race for the remainder of the hour to garner his Championship title.



Runner-up Champion was Spring Hill's Red Hot Performance with Red's run detailed below.

Third place was Sundance Kid's Rocky Mountain Renegade whose performance is described below.

Fourth place went to Bark River Queen of Diamonds, with Daisy's run detailed below.

The running:

Brace 1: Sundance Kid's Rocky – Jim Culler and Spring Hill's Red Hot Performance – John Bell. Rocky and Red broke away strong on course 1 with Rocky standing on his first covey at 7 min. with style and intensity. Rocky and Red were found pointed together, opposite the Horseman's Campground



staging area at 11 min. After the divided find, dogs and handlers separated with Rocky making some big moves to the point of being out of pocket for a brief time after being drawn towards camp by a wayward rider going in! Upon his return, Rocky picked up the tree line taking it to the end where he stood for his 3rd find on a covey at 25 min. at the end of the line separating the Dog Leg field and the last field after the Horseman's Day Use staging area. There was quite a bit of pressure put on Rocky with the birds running around in front of him, but he stood it well. Rocky ran strong for the remainder of the hour with 4 additional finds, a single at 30 min. in the short grass at the end of the Dog Leg field, and coveys at 42, 49, and 55 mins. respectively. Handled from a Quad and very well trained, Rocky earned 3rd place for his consistent, stylish finds and impressive run by a young California dog! Jim and Rocky should have many more years together competing at this level. Red had 6 finds and a stop to flush during his hour and put down a strong and consistent run to earn 2nd place for his efforts. His finds came at 8 mins. near the twin pond area north



of Hires Field, 13 min. south of the Horseman's Day Use Staging area on the line dividing it from Hires. Red stood again on the line dividing the two halves of Hires Field at the 17 min. mark and carded a stop to flush in the open north of there at 19 min. mark. On the long downhill section leading to the Boy Scout Bridge, Red rimmed the field counterclockwise and stood again at the 40 min. mark where he suffered a slight bobble keeping from the top of the podium on his 5th piece of bird work. Moving on from there, Red's final find came at 49 min. on the corner of the woodlot near the Boy Scout Bridge with beautiful style and intensity. Red was crossing the bridge past Cardiac Hill leading to the Derby Course as time expired.

Brace 2: Autumn's Pumpkin Spice – Bill White and Magnum High Velocity – Vince Anderson. Pumpkin and Gauge broke away to quick action with Gauge standing at 30 seconds and Pumpkin and Bill moving forward across the field where Pumpkin stood beautifully at the 6 min. mark with great intensity and style. Pumpkin was suppressing the urge to chase as the birds ran in front of her and was unable to contain herself going with the flight, ending her day early. The remainder of Gauge's run was detailed previously.



Brace 3: Gambler's Knows When to Run – Jim Stevens and Spring Hill's Fancy Wheels – John Bell. Tucker and Mags broke away together into a near impossible situation for a pair of dogs – a divided find at the 30 second mark. Both looked beautiful pointed together; one of them made a snide remark to the other, the birds, sensing growing conflict, flew off sending the dogs in hot pursuit to the dog wagon far too early.

Brace 4: Atos – Jackie Hutwagner and Diamond Hill Storm Cat – Mike String. This was a great brace to watch! Both of these dogs were flying around the course and pointed their game with style and intensity while making moves worthy of Champions. Cat had a find at the 7 min. mark looking beautiful. Atos moved on and was standing at 9 mins. with Jackie about to flush when Cat appeared without Mike even being close to the action. The judge appointed the reporter to stand with her through the bird work and all was in order and she was re-joined with Mike as both dogs moved forward. Atos had 3 finds and a beautiful back, Cat carded three of her own. As the brace started to



head toward the downhill section leading to the Boy Scout Bridge, Cat stood along the cut of one of the short fields and Atos who had been out of pocket, appeared again at the scene of Cat's last find. Atos decided to heed Jackie's call instead of backing and both dogs ended their day; a bird in the air and Cat going with it. It was an exciting and beautiful brace to watch while it lasted!

Brace 5: Sanbar's Legendary Evening and Bark River's Queen of Diamonds – Jeff Stanton. Hershey and Daisy broke away heading towards the Boy Scout Bridge with Daisy pointing at 5 mins. with Hershey failing to back which ended his day. Daisy had 7 additional finds with nice intensity and style on all of them. She stood at 15 mins. and 20 mins. before Cardiac Hill and was found standing again at 25 mins. on the Derby Course at a place she's stood in Gun Dog Nationals past with better results this time. Upon release, Daisy worked her way towards the Wooden Bridge and brought the edge around to the start of the Sumac Line where she stood at 30 mins. with a covey flushed. Crossing the Derby Creek, Daisy took the swamp edge forward to be found standing on the backside of the Levy Hills by the Gun Dog Parking Lot at 40

mins. Daisy had additional covey finds at the 45, 50 and 55 min. marks. She stood again at 57 mins. but running birds couldn't be produced so Jeff took a non-productive and Daisy finished her hour moving East toward the chute area after the Old Shotgun Range. Her pattern was very nice, though her pace slowed during the hour.

Brace 6: Remchester's Amazing Grace and Hope's Chief of Crosscreek. Grace and Chief broke away heading East towards the lower orchard area of the Gun Dog course with Chief having his first find at the 2 min. mark on a pair of birds with nice style and intensity. Chief was found standing again on the left at the 12 min. mark and Wayne produced the birds with ease as Chief stood tall for his 2nd find. He hunted well through the remainder of the Gun Dog Course taking the swamp edge from the Gun Dog Parking Lot levy across the Derby Creek crossing. Upon crossing the creek, Wayne and the Judge were divebombed by a terrified quail; Chief tried to defend them, but the bird was too nimble and ended Chief's bid at the 35 min. mark. Grace ran with spirit and enthusiasm for Bill through her time on the ground, covering available cover and objectives thoroughly for her handler. At the 8 min. mark, Grace stood for Bill in the open area of the lower Gun Dog Orchard area and succumbed to temptation on a quail in the open, ending her bid far too early; she's fun to watch and enjoys everything she does!

Brace 7: KDeI's Eagle's Chance to Soar and Diamond Hill Work Hard Play Harder. Chancey and Gin broke away into light rain, just past the Derby Orchard area with Chancey swinging the right edge all the way around up towards the direction of the wood lot area and brought the edge around to the tree lines heading towards Cardiac Hill. She continued strong along the edges of the Derby course taking the eastern edge of the woods deep into the South East corner, resulting in Ken calling for the tracker at the 17 min. mark when the scout couldn't return her to judgement. Gin ran a good race with stylish bird work, carding 4 very stylish finds; a slight breach of manners ended her day early on her 5th find near the 30 min. mark.

Congratulations to our winner, NGDC GFC DC AFC Magnum High Velocity owned by Vince & Denise Anderson, from Pennsylvania and handled by Vince. Gauge ran in the 2nd brace and had 7, quality finds and 1 non-productive. Gauge's hour had an efficient and flowing pattern, that found him taking edges to their completion and enduring several, lengthy flushing efforts by his handler. His multiple finds kept him and Vince from regaining the front during the hour, yet his style and intensity on birds along with his ground race and search of game, earned Gauge the win.



Second place was Gambler's Knows When to Run – Tucker's run is detailed below.

Third place was Atos, Atos' performance is detailed below.

Fourth place went to Spring Hill's Red Hot Performance – Red's run is detailed below.

Brace 1: Spring Hill's Red Hot Performance – John Bell (Red).

Red ran as a bye dog due to Eli being injured and unable to run. Red carded 7, nicely styled and intense finds during his hour; a lengthy flushing effort resulted in a bobble on Red's 6th find which effected his position on the podium. His pattern was very nice and his range grew after his 2nd find, with Red stretching in his search of game, and was rewarded with 4th place for his efforts.



Brace 2: Remchester's Amazing Grace – Dr. Bill White (Gracie) and Magnum High Velocity – Vince Anderson (Gauge).

Gracie is a very animated dog on the ground and carded 3, beautifully styled finds. Her first was at the Oak mot due west of the Gun Dog parking lot, the second at the western edge of the Gun Dog Orchard with her last being just before time on a large covey near the intersection of the four Oak lines near the old shotgun range. Bill and Gracie finished to the front with her pattern and application growing through the hour. (Gauge's winning run is detailed previously)

Brace 3: Bark River Queen of Diamonds – Jeff Stanton (Daisy) and Atos – Jackie Hutwagner (Atos).

Daisy and Atos broke away driving hard and forward with Daisy being last seen entering the chute area along the swamp to not been seen under judgement again. Atos had 7 finds and a stop to flush during his hour. He was fast, hunting hard and located his game accurately during his entire hour with a high head and intensity. Some mixed signals from his handler kept him just shy of a higher placement.



Brace 4: Sanbar's Legendary Evening – Bob West (Hershey) and Gambler's Knows When to Run – Jim Stevens (Tucker).

Hershey and Tucker broke away with speed and purpose; Hershey had a really



nice find then gave Bob the slip and wasn't returned to judgement. Tucker had finds at 8, 12, 15, 20 and finally at 43 with really nice style and made some very nice moves. He suffered from a little inconsistency and slowed a bit towards the end; he pushed the winner to earn 2nd place.



Brace 5: Spring Hill's Fancy Wheels – John Bell (Mags) and Hope's Chief of Crosscreek – Wayne Pepin (Chief). Mags and Chief broke away heading down Cardiac Hill, each with a pleasing gait and beautiful pattern. They each had finds on the Derby course with style and intensity. After crossing the Derby creek, Chief made a beautiful move along the edge of the swamp and was found standing at the end of that move on the edge of the Levy Road, standing on his toes, which he used to launch himself towards an early ride on the dog wagon. Mags continued on alone and did a very nice job, though showed some inconsistencies of youth – she will grow into a tough competitor as she matures.



Brace 6: Autumn's Pumpkin Spice – Dr. Bill White (Pumpkin) and Sundance Kid's Rocky – Dr. Jim Cullor (Rocky). Pumpkin and Rocky were fun to watch with different running styles; Rocky ran more



long lines and edges with Pumpkin busily working the assorted clumps of bushes and trees. Rocky's finds were at 12 exiting the Chute along the swamp, again below the Gun Dog Orchard area near the swamp at 16. He stood again at the N/S line of rocks near the Gun Dog Parking lot at 20 and at 35 in the Derby Orchard area. Pumpkin pointed very stylishly in the lower section of the Gun Dog Orchard near the swamp at 18 and again in the Derby Orchard area at 33, where her day ended when she helped Bill with the flushing effort. Rocky continued alone with Jim making nice moves and was found standing at 52 min. along the rock wall just West of the southern end of the Gun Dog Levy crossing. Jim had difficulty flushing and re-located Rocky who bumped the birds ending his run 5 mins. short of time.



Brace 7: KDel's Eagle's Chance to Soar – Ken DeLong (Chancy), bye. Chancy, being in season ran as a bye dog and made nice moves through most of her run, having 3 finds with style. Her day ended early when she carded her second non-productive near the 38 min. mark.

Their attentiveness and cooperation throughout the event were truly exceptional.

Purina once again provided Purina Pro Plan Sport dog food for the placing dogs and Sport Dog provided training collars and bark collars to those placing in the Championship and the Amateur stakes. This is the second year that Sport Dog has made such a considerable contribution. Our most sincere thanks to the folks at Sport Dog.

Given the severe weather conditions, this year's Championship would not have occurred without the cooperation and assistance of all those who came out to compete. Not only did everyone persevere under often miserable conditions, they also exercised great patience as the Committee worked through the changes necessary to proceed with the trials.

Thanks also to Bill and Fran Gorman who provided last year's Winner's Dinner. They provided a superb Traditional New England dinner. And a very special thanks to Jim Winnen who not only helped with bird planting but also prepared an absolutely fabulous walleye dinner.

Weather conditions being what they were, this year's report of the running will be limited. Due to the reporter's recording equipment being partially submerged during the heavy rains, most of the reporting was lost in the pools of water which accumulated in his jacket pockets. However, enough was recovered to report on the four placing dogs and handler.

I'm Your Man (Gus) owned by Bill and Fran Gorman and handled by Ben Lorenson captured the title of Champion for the second year in a row. Gus demonstrated exceptional power and a true willingness to handle kindly throughout the entire hour, accumulating six very stylish and off the grid finds along the way.

Just Call Me Eli, owned by Tom Ettinger and handled by Kyle Merrill was named Runner-Up with four finds and a quick and very snappy run to the front. With a stylish gait Eli cruised the course almost effortlessly, causing all who watched to sit high in their saddle.

Saradac's Dangerous Diamond Caper owned by Ed Kosta, Darlene Dow and Lisa Pollock and handled by Lisa Pollock captured the third spot with four stylish finds and a consistently forward 10 to 2 race. Capar handled with ease throughout the entire course, requiring little direction in the quest for game.

Coos Triple Six (Boomer), owned by Brent and Marcia Rupnow and handled by John Perry, rounded out the placements with two finds and a spirited race to the front. Braced with Eli, the Runner-Up, in the second brace of the state Boomer demonstrated a kindly nature and proved to be highly honorable.

2020 Region 3 Brittany Amateur Championship

There are multiple cities that claim the "Bird Dog Capital of the World" moniker. However, Waynesboro, Georgia is the only one with a 20ft tall English Setter on the south face of the city water tower. It is a comforting reminder of a community that supports the multitude of visitors that make the annual pilgrimage to this region of the country.

The Brittany faithful have made the late January trek to the piney woods of the DiLane Plantation for the last decade as the Georgia Brittany Club, Southern Open Brittany Championship Association and DiLane Plantation has hosted the Southern Open Brittany Championship series. The late January start is appealing to those of a more northern persuasion with New Jersey, Connecticut, Delaware, Pennsylvania, Ohio, New York, Illinois, Maine, Massachusetts and Tennessee represented.

Mike Blondin of Solon, OH and Charlie Gonzalez of Manorville, NY were in the saddle to look over the field. They were attentive to all contestants and judged the field in a positive manner. Many thanks to Purina for their sponsorship and support of this championship series.

Betty Morgan, Jim and Drew Carter, and Lisa Pollock along with all the club members do a great job of putting on this trial.

The Running

Day 1. A brisk 31 degree morning, it was cold in south Georgia as a quick moving front came through the first morning with heavy rain. We were delayed until 9:30 as clouds gave way to sunshine and a northerly breeze.

Brace 1: Atos-J. Hutwagner and Palmetto Pointe's Autumn Glazing Star-T. Bass. Atos and Autie were excited to get things started. Autie is a very animated female that is always busy with Atos maintaining the front and looking in all the right places. As time wore on, both settled into a moderate pace. Autie was pointed at 25 and took a few steps to end her bid. Atos was not pleasing John and he elected pick up at 34.

Brace 2: Diamond Hill Travelling Doc-L. Pollock and Piney run Three Sheets To The Wind-T. Bass. Doc and Jib worked the cover on each side of the course as the gallery headed north. Doc disappeared near the slew with Lisa electing to call for the tracker at Mary Mischief Road. Jib was eye-pleasing and standing at 22 with exquisite style. He is one magnificent animal on point. Birds were produced and he was handling kindly to 50 where there was bird contact that ended his day.

Brace 3: High Velocity Copper Magnum-V. Anderson and TJ's Black Diamond-J. Perry. Colt and Coal had a pleasing breakaway with Coal being the first to reconnect. Colt was the first to score with had a big covey find at 24 after a well-executed relocation. Coal was on point to the north of the course at 25 and after extensive flushing, birds were produced. Both dogs had settled into a hunting pace with Colt having a find at 57 along the tree line near the winter wheat fields. Coal had a nonproductive at time.

Brace 4: Saradac's Dangerous Diamond Caper-L. Pollock and Just Call Me Eli-K. Patterson. Caper and Eli were in and out of pocket over the early half of the course with both at moderate range. They stayed busy to the halfway mark where both sailed across Belle Star road and disappeared out the front. They were standing within 50 yards of each other at 40. Eli had birds all around him and took some steps when birds lifted behind him. Caper handled her birds in fine fashion and was take on. At 50, she wasn't pleasing to Lisa and got the rope.

Brace 5: M&M's Grouse Gunning Gracie-V. Williams and Piney Run Jake-K. Patterson. Gracie and Jake disappeared from breakaway with Gracie pointed at 14 west of the course. A large group of birds

lifted with her moving to end her bid. Jake was seen briefly near Mary Mischief road and the slew crossing. He was found standing at 24 north of the course but no birds were moved after a relocation. He promptly grabbed the north edge of the property and rimmed it to the big oak where he crossed and skimmed the long edge to the creek crossing. He was watered and healed to the top of the hill, where he sailed across Belle Star road and was seen far to the front on the hill. When the party arrived near where he was last seen, he was stylishly pointed on a big covey at 40. He shot away over the hill at 45 and it would be the last time he was seen.

Brace 6: Sniksoh Pattyann-C. Roberds and I'm Your Man-K. Patterson. Patty and Gus shot away from the line with Gus mostly interested in Patty over the first 200 yards of the hour. Chris elected to pick her up as it appeared she was in season. Gus got down to business and was running the front end in a pleasing manner, showing at key times. He displayed excellent style and composure at 20 on running birds. At 30, he was found buried in brooms-edge. He was watered and made the huge cast across Belle Star road, was seen briefly at 40, and found standing at 45 along the creek with birds well located. He shot up the hill and was not seen again until the party reached the winter wheat fields where he pinned a small covey at 55 in a tree line. Upon release, he sailed toward the slew and was going away as time was called.

Brace 7: Wichita Wild Woman-C. Roberds and Thomas's Dixie-J. Carter. Nicky and Dixie had their sneakers on early in the hour with Dixie not seen from breakaway until the 18 minute mark with a mannerly find to the left of the course at 20. Nicky topped the hill near the big oak and skimmed the edge along a bamboo stand that was holding birds that were a bit skittish. They lifted with Nicky not getting stopped in time to remain in contention. Dixie was starting to settle into a more moderate pace at the halfway mark. She had finds at 30, 40 and 52 finishing short of the winter wheat fields.

Brace 8: Piney Run Hilltop Blew-K. Patterson and Waypoint Chancey Big White Cooper V. Williams. Blew and Big White were away under partly cloudy skies with Blew disappearing out the front and Big White a bit confused as to his handler. Kyle Merrill is his pro handler, Kent Patterson handled him at the Amateur Nationals and Vic, his owner, was now in charge but nobody gave Big White a heads up. Each time Kent worked to show Blew, Big White responded. Blew was seen a couple of times and found standing at 21 in a plum thicket with birds running around on bare ground...too much for a 2-year-old. Once Blew was up and with only one handler left, Big White settled in to a much smoother application. He finished with three mannerly finds but the first 20 minutes were a bit too much to overcome.

Brace 8: Shailorville's Gunner-K. Patterson. Gunner was a bye dog in the last brace and was on a bird finding mission from the release. He was buried in

cover at 10 to the left of the course with a covey rising as the judge rode around to see him. Upon release, he disappeared out the front and was found standing at 18 with birds well located. He continued with finds at 22 and 38. Running birds on a side hill would be his undoing at 40.

Championship. We were fortunate to have David Walker and TK Smith sitting in the judges' seat to evaluate our dogs. Thank you to Purina for their continued support and for fueling many champions. The weather was cold and the skies were clear; good for running dogs.

Brace 2: Piney Run Hilltop Blew (Blew) – Kent Patterson and Sniksoh Pattyann (Patty) – Jamie Fountain. Blew's run was strong and forward. He went wide to the left and showed to the front. At 25 point was called for Blew and everything was in order. Blew took the pines wide to the right. Blew continued with wide forward sweeps to finish the hour. Patty's range was short as she hunted the grounds checking in with her handler. She had a find at 35 with a slight mark. Patty finished the hour.

Brace 3: Wichita Wild Woman (Nicki) – Jamie Fountain and I'm Your Man (Gus) – Ben Lorensen. With Gus scratched, Nicki ran in place as a bye dog. Nicki was hunting the cover to the front. The brace ended early at 27 with Nicki under a bird. Gus was scratched due to an injury.

Brace 4: Shailorville's Gunner (Gunner) – Ben Lorensen and M&M's Grouse Gunning Gracie (Gracie) – Kyle Merrill. Both dogs took to the front. At 7, Gracie scored with a covey. Point was called again at 20 for Gracie who was standing nicely. Kyle relocated Gracie then chose to move on with an unproductive. Gunner has been out of pocket since the breakaway and at 38 Ben requested the tracker. Gracie continued to take the fields effortlessly to the front and finished going away.

Brace 5: Sligo Sam (Sam) – Ben Lorensen and Waypoint Chancey Big White Cooper (Big White) – Kyle Merrill. Big White scored first at 20 with a nice find. He took to the front continuing with a forward run. At 26 Sam was up due to an indiscretion with birds at the woods edge. Big white cut to the front over the creek; heading up the hill to the left and point was called again as he scored with a covey. At 38 as we turned right at the crossroads, Big White scored with his third covey. Big White took the front and finished the hour with a strong forward race.

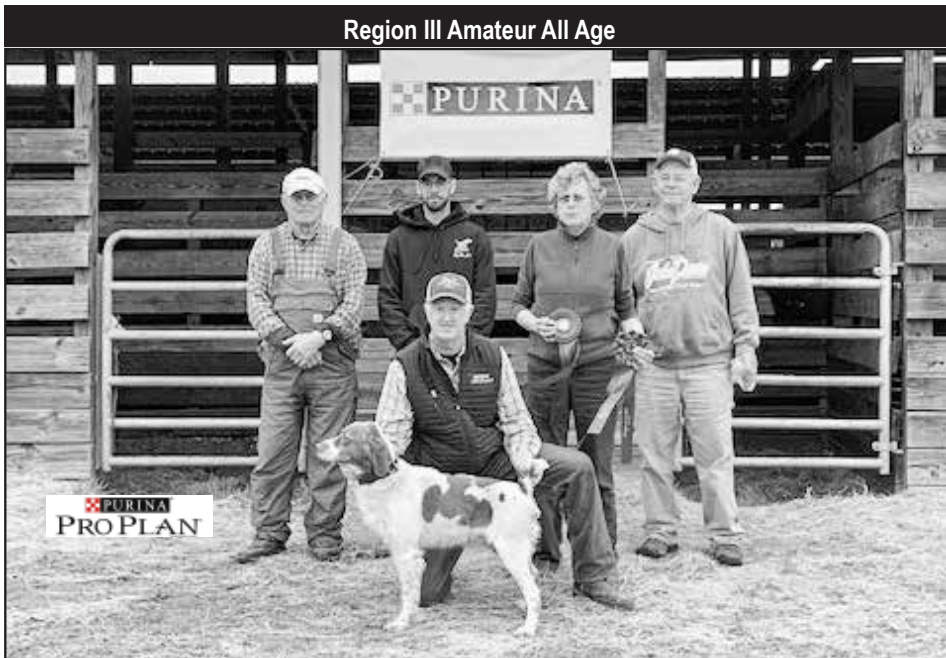

Western Brittany Open All Age Championship

The 2020 Western Brittany Open All Age Championship, which is sponsored every January by the Greater Phoenix Brittany Club, was held at the airstrip area of the Empire Ranch, near Sonoita,

Arizona. Our judges this year were two very experienced pointing breed judges: Tommy Negrete of Torreon, New Mexico, and Dave Garrett of Laveen, Arizona.

The Empire Ranch is a historic, working cattle ranch. The beauty of the landscape has earned it a place as a movie location in the past (1948 - Red River with John Wayne; 1976 - The Outlaw Josie Wales with Clint Eastwood, and many more). It is located southeast of Tucson, Arizona, and is about 10 miles north of Sonoita, Arizona. The scenery is spectacular, with purple mountain ranges surrounding the lush grasslands. Cienegas (marshlands) wind through the landscape, with an abundance of large oak trees along the dry washes, and cottonwoods in the areas with water present. Mesquite trees dot the grasslands, as well as saltbush, rabbit bush, and various desert type flora.

Hawks and kites are frequent visitors, as well as coyotes, jackrabbits, gray foxes, deer, and pronghorn herds. Javelina, raccoons, and coatimundi are here as well but rarely seen. Fortunately, no rattlesnakes showed up this year! Fair weather predominated, with temps down to the 20's at early morning to 60's in the afternoon. We were spared the usual windy conditions this year.

The 2020 Western Brittany Open All Age Champion was FC JT Copper Buckaroo (Buck), owned by Jeff Minch and handled by Paul Doiron. He was sired by FC Kiger Hills Louee x Lock and Load Daisy. Buck rocketed off the line and had a big, forward race over the grasslands and hills, and two finds. He was found standing on top of the first big hill, and handled his bird with style. His second bird was again handled with style and intensity. He ended his race with a huge cast back over the ravine and over the first hill.

The 2020 Runner Up was FC Blew Me Away (Bud), owned and handled by Norm Ahl. He was sired by NAFC/GFC/FC/AFC Spanish Corral's Sundance Kid x FC Blew By Yet?, and trained by Paul Doiron. Bud blasted off of the starting line and ran forward at all

times. He ran the left side of the course and was found on point at the edge of the ravine, but no bird could be produced. He had a second point in the bottom half of the race and stood with intensity and style as a chukar was produced. He finished with a strong race.

Third place went to NAGDC/DC K Nine Finale's Way To Go (Allie), owned by Linda McDonald and handled by Paul Doiron. She was sired by DC/AFC/3x Am. Fld. Ch. Megasmoke Grand Finale x FC/Am. Fld. Ch. K Nine's On The Loose. Allie took off with a big, forward race, and was rewarded with two finds on course. She handled her birds, as always, in a very intent and clean manner, and earned third place in the championship.

Fourth place went to FC/AFC Sonny's Hot Summer Breezy (Breezy), owned by Myra-Dawn Ellis and handled by Paul Doiron. She was sired by NAFC/GFC/FC/AFC Spanish Corral's Sundance Kid x FC Blew By Yet?. Breezy covered the territory in a forward race, though not quite as big a run as the champion

had. She had four finds, all handled with intensity and style, earning her fourth place in the championship.

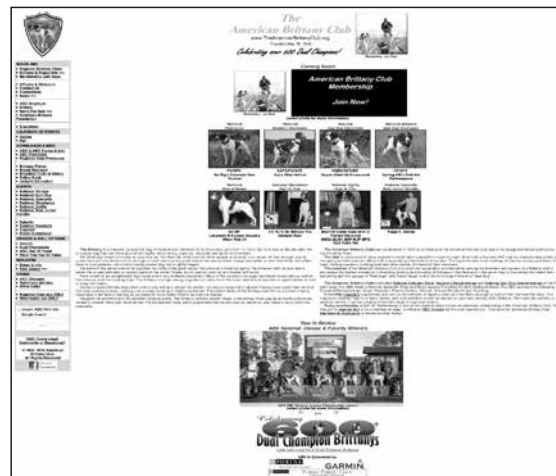

How to Weather-Proof Your Bird Dog's Off-Season Training



Weather extremes make it difficult to train and keep your bird dog sharp during the off-season. Just as you probably don't want to work in knee-deep snow, heavy rain or brutally hot, humid weather, neither does your dog.

However, just because the weather outside is frightful doesn't mean your sporting dog should become a couch potato until the next season. A dog that is bored becomes anxious and stressed. Regular conditioning and training, whether indoors or outdoors, will help to relieve stress and keep him or her healthy and fit.

Professional gun dog trainers Paul McGagh of Glencoe Farm & kennels in Bismarck, North Dakota, Clyde Vetter of Sharp Shooter's Kennel in New Richmond, Wisconsin, and Josh Miller of River Stone Kennels in New Richmond, Wisconsin, recommend short training sessions consisting of simple obedience drills to keep a dog tuned up year-round, even when outdoor training isn't an option.

"It is so important to train your dog every day, even if only for a few minutes," McGagh advises. "When you can't go outside, indoor training in a garage or workshop is a great substitute. A physically and mentally engaged dog is a happy, well-behaved dog."

Follow these simple, fun obedience drills straight from the pros that can be done indoors even with limited space to help keep your dog in tiptop mental and physical shape, regardless of the weather.

1 Out of the Box

McGagh trains his bird dogs on box drills using boxes or platforms he builds. "I call for the dog to sit or stand on the box. Then, I'll add a second box and whistle for him or her to place from box to box. Finally,

I'll add retrieves with a tennis ball and have the dog retrieve from box to box," he describes. This box drill can be made as simple or complex as needed for an individual dog and as indoor space allows.

2 Slow & Steady

Practicing the "place" command reinforces steadiness and control and can be done anytime, anywhere, whether it's in the garage while changing the oil in the car or in the living room while watching the game. "Have your dog sit or stand (place) on a dog bed or platform and remain there until you give him or her the appropriate command to release," explains Miller. "The beauty of this drill is it doesn't require your undivided attention – just be sure your dog stays in your peripheral vision so you can make a correction if needed."

3 Follow the Leader

To ensure a quiet, controlled bird dog, Vetter recommends advanced heeling drills, which can be done simply as you walk around the house. "I train a dog to heel in a tight figure-eight motion, shift into reverse and back up with me, and make small left and right clicks as if I were positioning him or her on a lining drill, Vetter says. "I also teach that when I lead with my left foot, the dog is to heel. When I sidestep with my right foot, he or she is to 'whoa.' I overlay a command to an action, then wean the dog off the command as he or she becomes accustomed to my body language and actions."

4 Hold, Carry & Release

If your dog developed a bad retrieving habit this past season, now is a good time to fix it so you can hit the ground running again once the weather is nice. "No matter how old or young your dog, it never hurts to get back to the basics," Vetter advises. "Work on trained retrieves by running

your dog up and down the training table. Use several different objects to reinforce what's already been taught or to get a correction in as needed."

5 At Your Command

Before you assume obedience 1010 drills – such as "here," "sit," "kennel," "down" and "no" – sound boring, think again. "Consider the next season and the areas you'd like to polish with your dog before then," says Miller. "More than likely, any of those skills will begin with rock-solid obedience." Vetter agrees, "Lay or sharpen the foundation when the weather isn't cooperating so that when you can get outside, the groundwork's already covered."

If you do take your dog outdoors for a training session in less-than-ideal weather, it's important to be vigilant about keep your dog safe in these conditions. Check your dog's footpads regularly after outdoor exercise. Constant exposure to moisture caused by rain, snow, ice or mud can irritate a dog's footpads, causing skin damage, cuts and infection from bacteria or fungi. If a dog has cracked or bleeding paws, consult your veterinarian.

You should also pay attention to your dog's tolerance of plummeting or soaring temperatures. Keep a close eye on puppies and senior dogs, as they cannot withstand weather extremes as well as a dog in his or her prime. A good rule of thumb for limiting outdoor exercise during high or low temperatures is that if it's too hot or cold for you, it's too hot or cold for your dog.

The bottom line is to use common sense in caring for your dog in weather extremes. Although you can't change the weather, you can be sure your dog is healthy and comfortable.

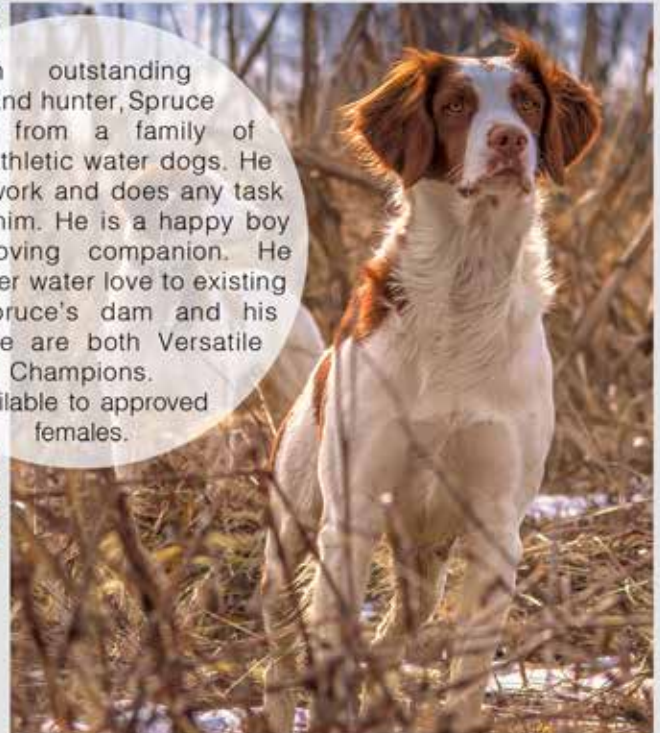

CONDITIONS AND RULES FOR FUTURITY ELIGIBILITY



- The 2022 American Brittany Futurity shall be open to every Brittany bitch and her progeny whelped during the calendar year of **January 1 - December 31, 2020**, who is owned or leased by a member of The American Brittany Club, and whose litters have been Futurity nominated with The American Brittany Club. Sires do not necessarily have to be owned/leased by an American Brittany Club member. All dams nominated and all sires bred to must be registered with AKC, CKC, or FDSB.
- The **nominating breeder** needs to be a current full member in Good Standing of the ABC when the litter is nominated and the closing dates of the of the Sectional Futurities in which puppies from their nominated litter compete. They must sign the Litter Nomination form, and any breeder purse checks will be paid to this designated nominated breeder. If their membership has lapsed at the time of the Sectional Futurity, the purse will revert back to the ABC Futurity Administrative Fees.
- Nominations of dams must be made within 60 days after a bitch has whelped, and a Nomination Fee of \$40.00 ("First Forfeit") must be paid at this time.** This payment will entitle each puppy of the nominated litter to be entered in the ABC Futurities (Field and/or Show) after the puppy has been properly registered with AKC or FDSB. Nomination Fees are set by the ABC Board of Directors.
- Late litter nominations will be accepted with the following current fee schedule:** In addition to the Nomination Fee of \$40.00, late fees are \$60.00 for 61-90 days, and \$100.00 for 91-180 days. Nominations after 180 days will be accepted at the discretion and decision of the ABC Futurity Committee. The postmark will determine the fee for late nominations. The ABC Board of Directors may impose additional late fees from time to time.
- A Final Forfeit Fee, to be eligible to compete in the Sectional Futurities (Western/Central/Eastern), is due by October 1, 2021, and is submitted by the owner of the eligible puppy. Futurity Entry Fees will also be paid prior to 2022 Sectional Futurity events** by the owner of the eligible puppy for each Sectional Futurity event in which the eligible puppy is entered. Final Forfeit Fees as well as Sectional Futurity Entry Fees are set by the ABC Board of Directors and subject to change.

The *Brittany Bites* Recipe Collection

Here are our monthly recipes tried by you, our Brittany enthusiasts.

Pheasant Primavera

- 6 Pheasant breasts
- 1 teaspoon Ground Cumin
- 1 teaspoon Ground Paprika
- Salt and Pepper
- 2 tablespoon Grapeseed Oil
- 2 cups Snap peas
- 1 cup Frozen Corn
- 1 cup Frozen Spinach
- 2 cups Tomato Sauce

Season the pheasant breasts with cumin, paprika, salt and pepper.

Place the pheasant between two sheets of plastic wrap, pound with a mallet

In a heavy bottom pot, heat the grapeseed oil and brown the pheasants on all side, about 5 minutes. Remove pheasant from pot and slice.

Add peas, corn, and spinach to pot. Season the vegetables with salt and pepper. Cover partially and let cook for about 10 minutes. Add the sliced pheasant back to pot. Stir in tomato sauce.

Cook until all ingredients are tender, about 10 more minutes. Serve over prepared pasta, enjoy!

Pheasant Piccata

- 4 to 8 pheasant, partridge or grouse breasts, skinless and boneless
- Salt and black pepper
- 1/2 cup flour
- 2 tablespoons olive oil
- 1/4 cup unsalted butter, divided
- 1/2 cup white wine
- 2 tablespoons lemon juice
- 2 tablespoons small capers
- 2 tablespoons chopped parsley

Put each breast between two sheets of plastic wrap and pound them flat with a rubber mallet, empty wine bottle or meat mallet. You want them about 1/4 inch thin if you can. Better to err on being too thick than thin. Salt and pepper the cutlets well and dust with the flour.

Get the oil and 2 tablespoons of butter hot over medium high heat, and saute to the floured breasts for 3 minutes on one side, 2 minutes on the other. You may need to do this in batches. Move to a plate and tent with foil.

Pour in the lemon juice and white wine and scrape any brown bits off the bottom of the pan with a wooden spoon. Add the capers and boil this down by half over high heat, maybe 2 minutes. Turn off the heat and put the pheasant breasts on serving plates. Put the remaining butter in the saute

pan and swirl it around until it melts. The sauce should be emulsified and smooth. Pour over the pheasant and garnish with the parsley.

March AKC Delegate Meeting

The AKC delegate meeting was held in Newark, NJ March 9 and 10, 2020. This is the meeting that the members of the Board of Directors are voted on by the delegates. The Class of 2021 is Dr. Thomas, Davies, Class of 2024 are Jeffrey Ball, Dr. Michael Knight and Dr. Carmen Battaglia.

Along with the voting for the new BOD, Mr. Sprung presented the State of the AKC report. I will only highlight some of the more important facts. You can view the entire report on the AKC Gazette on the website. Increase in litter registrations are up 3% from 2018. Dog registrations are up by 1%. The number of breeders are up 5% and aggregate entries are the highest at 3,310,000, which is an increase of 2% compared to 2018, having grown by more than 67,000. Agility and Obedience are trailing, however, Hunt Tests are up 14,000 entries, Rally is up 18,000 entries and FAST CAT grew by 28,000 entries with scent work increased by 52,000. Clubs produced over 22,700 sanctioned events which was an increase of 5%

The financial report was given by Peter Rohslau, Controller. The AKC showed an increased revenue by 4.4% while expenses only increased by 3.8% AKC made 2.9 million in charitable donations to AKC 501C3 affiliates.

Overall revenue increased 3.4 million which is a 4.5 % increase over 201 with registration being the biggest source. Sports and Events also showed a healthy growth of more than 4\$.

I attended the Parent Club meeting, Dog show rule changes as well as the Field Trail committee and Crop and Dock committee meetings on Monday. Crop and Dock has some movement in the New York area but otherwise things seemed quiet this quarter.

The Field Trail committee introduced the new members to the group. Discussion was held on safety during Hunt tests. Also Doug Lundgren came late to the meeting. He did tell the group that the American Brittany has presented a change to the Field Trial Rules that the 3 point Brittany major at a Brittany Trial should be dropped. Doug did indicate that he felt this was a good idea and said that it would be presented to the BOD at the next meeting for voting.

Again, I thank you for the opportunity to represent the ABC to the AKC as the delegate. Please do not hesitate to contact me if you have any concerns.

WW's Miss Wendy Peffercorn captured the 2019 ABC Quail Classic/Championship title for owner Burton Wice of Creve Coeur, MO. She was admirably handled by Tom Tracy, Jr. to a strong, attractive race with two nice finds. Wendee ran with youthful exuberance but her application and manners belied the fact that she was just four months past her second birthday.

Piney Run Jake was named Runner-up with a good, consistent race and four finds. Jake was handled by his owner, Kent Patterson of Franklin, TN.

ANJ Ohio Hellion placed third in this dual sanctioned AKC Grand Open Limited All Age Classic. Hank is owned by Mike Poehler of Hoffman Estates, IL and was handled by Bob Burchett.

In fourth place was Just Call Me Lucky Ned Pepper owned and handled by Frank Campbell of Oklahoma City, OK.

The Greater St. Louis Brittany Club hosts the ABC Quail Classic/Championship, an event sanctioned by AKC as a Grand Open Limited All Age Classic and by American Field's Field Dog Stud Book as an All Age Championship. They hold it on the Field Trial Sportsmen's grounds at Grovespring, MO. This fall's scheduled start was Monday November 11. An eleventh-hour judge cancellation by Jon Small, due to a family emergency delayed the start until Tuesday morning to allow the replacement judge, Justin Hess, time to travel. The delay proved doubly necessary when an ice storm hit the area on Monday, further delaying the start until noon Tuesday.

The Field Trial Sportsmen's grounds are in the upper echelon of field trial venues in the nation. The grounds are groomed for field trials with feed strips lining the edges and thoughtful mowing of the courses. The three one-hour courses have a natural flow and offer good cover for quail and for watching dogs. Pre-released and wild coveys of quail are plentiful here; supplemental birds planted during the trial are an added bonus and aid in bringing the

resident coveys back on course. During deer season trials are not permitted to run through Clymer's pastures because of landowner hunting plans nor to use the clubhouse loop due to its proximity to the state wildlife area. Missouri's rifle deer season started on the last day of this trial which put the hunting season rules into effect at the start of the event. This necessitated a horseshoe turn on the north end of the bull pasture and a return trip past the blue house, then turning south into the chute below the twin barns to resume course three's typical route.

The Drawing was held one week prior to the event on Monday November 4 at the Wice residence in Creve Coeur, MO. Trial Chair Sharon Wice and trial Secretary Burton Wice conducted the draw as advertised. Fifty-four dogs were entered in this prestigious stake, fifty-two of which were starters.

The weather on Monday was such that the running would have been delayed due to ice and snow if the judge change hadn't already necessitated it. The sharply falling temperatures that came with clearing skies ensured icy conditions for Tuesday morning. Keeping safety as the first concern it was decided to wait until Tuesday morning to make the decision as to starting time. Overnight lows during the course of this trial ranged from 14 to 26 with daily highs between 36 and 54. The start of Wednesday's running was delayed until 9 am and the start on the remaining days of running was set at 8:30 am. This allowed the sun to soften the frozen ground making footing better for dogs and horses.

Purina donated small pouches of Pro Plan Sport dog food for all entrants as well as large bags for the winners. Garmin donated a Pro 550 advanced training system for the winner. The Greater St. Louis Brittany Club and the American Brittany Club Quail Classic/Championship participants are very appreciative of the support received from these fine companies.

The American Brittany Club's Purina All Age Dog of the Year winner is often determined at this trial. This year was no exception; prior to this trial Ru-Jem's Last Penny was leading by twenty points. Although she turned in a pleasing performance here, it was not quite enough to place. Jake's points for Runner-up were enough to defeat her. They are worthy adversaries and their respective owner's Kent Patterson and Jerry McGee have a right to be proud of them.

This club worked well together and put on a smooth-running event. Burton Wice was the glue that held it all together. He handled all of the paperwork and coordinated with the others as to who would take care of each day's duties. Bird planters were Dave Capstick, Joe Williams, Tommy Thomas, Tim Self and Tommy Tracy. Manning the dog wagon during the trial were Tim Self, Jerry McGee, and Mitch Sims. Sandwich makings were set out for lunch each day by various crew members. Meals were cooked each evening in the clubhouse by a different volunteer. This made feeding judges, work crew and participants simple. The Greater St. Louis club picked up the tab for groceries and everyone was invited to eat, compliments of the club. Sunday night's meal of creamed pork tenderloin and rice was prepared by Burton Wice; on Monday night, Mitch Sims cooked ham and potatoes. Kathy and Ron Galeumbo served lasagna on Tuesday night and Kathy did the lion's share of kitchen clean-up throughout the week. Tom Healey made jambalaya on Wednesday; a plethora of leftovers was served on Thursday and Friday evenings. Every meal was delicious! The trial concluded on Saturday afternoon, those that remained went out for steaks at Beaver Creek Pay Lake's restaurant. The effort taken to provide meals for everyone added to the congeniality that prevailed over the entire trial.

Judges for this event were Bonnie Hidalgo, Brighton, CO and Justin Hess of Exira, IA. When planning for this event began last March, Dennis and Bonnie Hidalgo were slated to judge. Dennis broke his hip in April and it became apparent in September that he would not be able to fulfill his assignment. At that time the Club secured the services of Jon Small. When Jon was forced to cancel, Justin was recruited to fill in the gap at the last minute.

Justin campaigns his Vizslas on the National Vizsla Association circuit and at local AKC sanctioned trials. He has enjoyed much success on the national and regional level. Justin has judged several championships and is a well-respected judge. Bonnie has been involved in trialing with pointers, setters and Irish setters for most of her life. She has judged several American Field Championships and also some AKC National Championships. Together they made a team that worked great together, both readily agreeing on evaluations of performance and order of placement following each brace.

Winners & Others

The newly crowned American Field Champion/AKC Grand Open Limited Classic winner, WW's Miss Wendy Peffercorn, handled by Tommy Tracy Jr., began her performance just beyond the Little Vine loop, the second brace on Wednesday afternoon. Her proud owner, Burton Wice was on horseback to witness her performance and was not disappointed. She made some big, attractive moves. Wendee scored a nice find in the Bull pasture at 35, her intensity and manners were superb. She ran well through the Bull pasture, making a reaching move up the hill to the corner pond. Wendee made a huge forward move from the blue house to the alley below the twin barns where she showed nicely forward. She pointed a big covey as time was called. She showed consistently forward for the hour, giving a performance that was exciting to watch. Wendee will turn three in July. She was sired by the multiple Champion, Glade Run Irish and her dam is Driving Miss Daisy II; both parents also competed in this stake.

Piney Run Jake, the Runner-up, owned and handled by Kent Patterson appeared on Tuesday afternoon in the second brace of the stake. His brace released heading up the hill into Little Vine loop on a frigid but sunny day. Jake took part in a divided find on a large covey at 5; he marked the flush. Off the hill and on toward Sycamore he ran hard. Jake took the left edge through Sycamore, looking good. He hit the cross line and made game but corrected

on. At the tip, Jake took the right edge and rimmed the east end before heading up the hill. Point was called on the hillside and then waved off by his scout and the dog continued forward to the twin barns. Point was called for Jake near the barns at 32; a single quail was flushed with all in good order. Jake scored his third find on the ridge in the bull pasture with a huge covey lifting for the staunch dog at 49. He scored his next find near the far end of the pasture at 54 on a feeding covey, he displayed perfect manners and intensity. Jake caught the front just as time was called. Jake is a result of the mating of Piney Run Art to Piney Run Gypsy. He will turn seven next May. Jake has always been a frequent visitor to the winner's circle.

ANJ's Ohio Hellion did a solid job on the ground for the hour to place third in the Classic. Hank was handled by Bob Burchett for owner Mike Poehler who was on hand for the performance. Hank was sired by Grand Junction Jake and out of High Hopes Little Ann. His first find occurred at the top of Sycamore at 7. Hank pointed again at the end of Sycamore after a nice move to get there; it was unproductive at 12. His second find was on the ridge before twin barns at 21; he had a covey nicely located. In the bull pasture he made an impressive move up the west side to the pond corner. Hank completed another pretty move from the blue house to the area south of the barns. Below the barns, he was working scent which took him into a heavy thicket filled ravine where he pointed at 54. His handler and Judge Hess worked their way down to him and his birds were produced with all in order. Hank finished the hour with a find at 59, also mannerly. Hank ran a consistent race with many good moves but his overall range was shorter than that of the two higher placing dogs.

Just Call Me Lucky Ned Pepper, handled to fourth place by his owner, Frank Campbell of Oklahoma City, OK was under strong consideration for a major portion of his hour. Ned ran a beautiful, consistently forward race for 50 minutes; he used the edges and made huge moves. Ned covered the right edge in Davis bottom like he owned it. He scored a very good find on Apple Tree at 45 with all in order. Ned was getting the job done. He was forward off Apple Tree and then out of sight by 51, catching up just before Little Vine hill. He was slow and short through the hill loop, killing his chances for an American Field placement but holding out for a piece of the AKC Classic. Ned was sired by the highly successful, Kinwashkly Dirty Ned Pepper and is out of Caney River TNT's Special Budget.

It is interesting to note that the first three placing dogs ran on course two; the top two on consecutive afternoons and the third on the final morning. The fourth place, Just Call Me Lucky Ned Pepper also appeared on the final morning, but ran on course one.

The Running:

JJ's Levi the Lionheart (Williams) was paired with Ace's One-Eyed Jack (Holman). The running was delayed until noon on Tuesday because of the ice and snowstorm that hit the area on Monday; an overnight low of 10 kept the ground hard and slippery so the delay was called for safety reasons. This pair castaway into Breakaway bottom; they were away to the front. Both had a brief interlude where they crossed the road into Sycamore but were returned in short order. Levi made a nice move down the right edge of Davis; Jackson went through on the left. Both were forward through Island field and up Horse Killer Hill. Point was called for Jackson on Apple Tree Hill at 49, he showed good intensity but no birds were produced. Levi stopped to flush on a feeding covey at 54 near the apple tree. Both dogs continued forward until the hour elapsed.

Gun Creek Gangster (Holman) and Piney Run Jake (Patterson) released heading up the hill into Little Vine. Jake's performance is described under Winners & Others. Doc was perfectly steady on a divided find of a covey at 5. Doc pointed staunchly in the cross row of Sycamore bottom but it was unproductive at 25. He continued forward along the ridge, past the twin barns to the blue house and into the bull pasture where he seemed to lose steam. Doc finished forward.

High Hope's Jack's Original Spice (Holman) and Driving Miss Daisy II (Tracy) began at the blue house, heading east and showing promise. Daisee

was under a bird and up at 11. Spice continued nicely forward through the alley and across the road. She made some nice moves but went the hour without bird contact.

Almaden's Under Lock and Key (Tillson) and Jac's Ray of Sunshine II (Holman) turned loose at 9 am Wednesday. Ray was under birds at 12. Oudi was lost before Davis bottom.

Hoochie Coochie Man (Tillson) and Roustabout Eustace (Capstick) started into Davis. "T" made some great moves through the bottom for Dave Capstick. They were forward into Island field and across Apple Tree hill. Point was called for "T" on the left line but was waved off. Both dogs did a nice job through Little Vine loop. They showed forward, heading into Sycamore bottom. "T" made a nice move down the left line; Karl took the right and scored a nice find at 56. "T" was rimming the end of Sycamore at time; Karl was forward on the left.

Black Creek Summit (Holman) was paired with Castaway Wilson (Tracy). Chip scored a find on the hillside at 4. On the ridge top at 9, Wilson pointed staunchly along a grass strip. He moved at the flush and was up. Chip was gone on deer at 12 and not recovered under judgment.

Wild Wild Willie (Tillson) and Shady Way's Joker's Hill Country Express (Tracy) were promising at the start. Stan was lost before the road crossing. Willie was forward on the right edge through Davis, crossing the front at the second cross row. In the Island field he liked the timber and there were a couple occasions where it caused him to get behind. Willie pointed before Horse Killer Hill at 36 but no birds were produced. He stayed forward nicely from there well into Little Vine loop. He was found forward on point at time but it proved barren.

Rev'n Gunrunner's Tilly (Tillson) and WW's Miss Wendy Peffercorn (Tracy) started just after the Little Vine loop. Wendee's performance is described above. Tilly showed well early with some big moves but was lost in the bull pasture.

Crescent City Girl (Tillson) and Sniksoh Hank's Hatch (Burchett) turned loose at the end of the alley. They were nicely forward into the tip of Sycamore. Hatch took the left side; Nola made a beautiful sweeping move along the ditch and swung forward on the far-right line. Unfortunately, she turned back before the corner and took the line out of sight. It ended with the pulling of her tracker. Meanwhile, across the road Hatch had run through a feeding covey and failed to stop. The afternoon's final brace ended at 11.

HEH's Slim Shipley (Burchett) and Jagoub's Spell Caster (Tracy) were Thursday's first brace. Slim pointed at 12 below Sycamore gates; Tabu came in for a nice back. Relocation was required and successful. Tabu was under a covey at 17 below the Davis cemetery and was up. Slim continued mainly forward for the remainder of the hour.

TJ's Brightest Jewel (Tillson) and Sniksoh Hank's Gypsy Cruise (Burchett) looked good through Sycamore bottom; Cruise scored a classy find there at 9. Jewell was picked up at 21. Cruise slowed his pace and was picked up at 38.

Tequila Scorcher (Tillson) and Maxwell's Prickly Pete (Tracy) were released on the hillside overlooking the former Rudy Lehar homeplace. They moved nicely down the hill and around the pond. Lincoln made the horseshoe turn but Pete did not. His tracker was pulled after a long absence. Tommy Tracy while searching for Pete, called point for Ed Tillson, near the barns at 14. Lincoln had completed a nice move to get there. A covey was spread out feeding and flew over the dog but he remained steady; the judges credited him with an excellent find. Lincoln scored a second find in the alley with all in perfect order. His third find came at 30 after the road crossing. He stood high and tight on a forward edge. His manners were faultless for the flush of a big covey. Lincoln was mostly forward on the way to the ridge loop where he had a lengthy absence but was found under judgment after time. Lincoln was a contender but his range being somewhat less than the top four combined with his absence caused his displacement.

R & H Dark Night (Burchett) and CVK's Spartan King (Tracy) were released in Breakaway bottom. These two were fast forward from the start, showing promise. Leo was lost and Tracy pulled the tracker at Davis bottom. Mac D continued forward through Davis and into the Island field where he shortened. At 38, his handler opted to pick him up.

Brendi Brooks Cowboy Up (Trimble) and Blazin E-Z Mac (Burchett) turned loose heading across Apple Tree hill. Mac was quickly lost on deer and not returned under judgment. Tuff ran the entire hour predominantly forward for his 93-year-old owner and handler, Ray Trimble. He stopped to flush before Sycamore at 29. Just beyond the twin barns, point was called for Tuff at 56, his scout called the flight of the bird but it was not officially seen. Tuff finished forward.

Sniksoh Windtuck Willy (Schaefer) and Roustabout All In (Tracy) headed into the bull pasture to start. They were attractive from the get-go. Willy was lost. Al pointed near the pond at 7 but no birds were produced. He continued at good range and speed through the bull pasture and made some big, beautiful moves from the blue house to the area south of the barns. He stopped to flush on a single just above the alley but didn't stay put.

Campbell's Razz-Ma-Tazz (Campbell) and Roustabout Blew By (Tracy) began Friday's running. Blew's tracker was out at 21. Razz ran in the cover all the way down the right side of Davis. He crossed in front near the creek crossing and was forward to the Island. He hung up in the island of trees and his handler opted to pick up.

Alleycats Drought (Williamson) and George (Tracy) George went the wrong way and had to be turned; when he caught the front at 5 his brace mate was being picked up for a breach of manners. George went up Horse Killer hill through the woods and was handling poorly; he was put on the wagon at 12.

Ru-Jem's Last Penny (Tracy) and Alar's Dirty Dancer (Tillson) released at the top of Don Fox hill. Penny was found pointing at 5, just off the hill. She had birds well located and was very mannerly. They continued forward through Little Vine loop. Penny pointed on the left side in Sycamore at 25 but only feathers were found. Dani was lost by 31. Penny ran an intelligent race, taking the edges forward consistently. Her pace and range could have been faster and bigger but her application was spot-on. Penny was the only dog to finish on Friday.

JWB Artic Cat (Tracy) and Wichita Wild Woman (Johnson) Tracy lost Kimber before the road crossing and earned a new nickname, "Without a Trace". Niki made some nice forward moves down the left side of Davis bottom and crossed at the centerline unseen by handler and judge. Judge Hess while catching the front spotted her on the right, pushing up birds.

Sparky's Prairie Wind Gypsy (Johnson) and Glade Run Irish (Tracy) turned loose in Davis bottom. In the Island field at 8 they were standing side by side in a feed strip. Irish dove in during the flush and was picked up. Gypsy stood tight but no birds were seen. Gypsy continued forward, doing a nice job making attractive moves over Apple Tree hill and around the Little Vine loop. She was last seen in judgment when she came out of the loop.

Kasmir (Tracy) and TNT's Raisin a Leprechaun (Burchett) broke away in the tip of Sycamore. Kash hung up near the road and was behind for several minutes. He caught the front just prior to the twin barns; Dexter was forward down the ridge, past the barns and on to the bull pasture. Kash pointed beyond the barns on the right edge; after relocation his birds were put up with all in order. He caught the front but was hard to manage and was up. Dexter was lost in the bull pasture.

A Trace of Bourbon with Diamonds (Johnson) and Just Call Me Lucky Ned Pepper (Campbell) were first up on Saturday. Trace scored a find at 15 before Davis, all in good order. He honored Ned on Apple Tree hill at 45. Trace pointed on the left at 49 but it was a rabbit. He scored his second find at 59 on Little Vine ridge; his manners and intensity were excellent. His race was at times, erratic.

Firestarter's Crossed the Line (Tillson) and ANJ's Ohio Hellion

(Burchett) Ty was lost to the front with Tillson pulling the tracker at the end of Sycamore bottom. Hank's hour is relayed under Winners and Others.

Arrow's Tequila Rustler (Beaver) and Osage Fork Slick (Burchett) began at the end of the alley. Slick was under a covey in the ridge loop at 17. Rusty made a nice move down the valley toward the ridge loop and handled well through the loop. He shortened on the trip back down the valley and was picked up with no birds pointed at 43.

Molly Mae Alexander (Tracy) and Turning Points Shenanigan's (Burchett) Shandi scored a dug up find on the hillside across from Daugherty's house at 13; her style and manners were perfect. Molly scored a beautiful covey find at 14. Tracy waited at the road crossing for Burchett; a covey got up and took Molly with them. Shandi went on to have another good find on the east edge before Horse Killer at 39 and a third in the bottom of Little Vine at 53, nicely done. Further down the right edge, she pointed again at 56, a deer went out, upon hearing people call out that something had left, Bob fired his pistol, only to learn that it had been a deer. In his defense, it was deer season! While her race was not strong enough to change things, she completed her hour up

the knoll in Little Vine with heart.

MKS My Little Ammo (Johnson) and SKF Willy's Miss Mollie (Burchett) were drawn in season. "BB" was powerful from the start, making big bold moves and was eventually lost. Mollie had a nice find at the beginning of Sycamore at 16. She scored a second find going up the hill out of Sycamore at 23. Mollie was under a covey on the ridge behind Daugherty's at 30.

AMERICAN BRITTANY CLUB 2019 HALL OF FAME

The ABC Board of Directors voted in Delmar Smith to the ABC Hall of Fame at the November 2019 BOD annual meeting. Delmar has been a fixture in the world of bird dogs, especially the Brittany, for over seventy years. He was a pioneer in the American Brittany Club starting in the 1950's and won the National Championship three times with Towsey. Delmar was instrumental in bringing horseback handling to the Brittany field trials and is recognized as one of the first trainers to develop the idea of dog training seminars which are designed to help people understand the training and handling of their own dogs.

In 1971 Delmar conceived the idea of establishing and running a three hour shooting dog event that was called the International Endurance Shooting Dog Championship. This event is still in existence today and is dominated by Pointers and Setters. There was only one Brittany that competed and won this event and that was Pacolet's Cheyenne Sam who was trained and run by Delmar and his son, Rick.

Delmar has been a huge supporter and promoter of the Brittany for many years and is very deserving of this honor.
