For those who have never organized a field trial, it is hard to appreciate everything that must be done in preparation for a regional field trial, much less the Nationals. Obtaining approvals from the sanctioning organizations; finding judges, a reporter and marshals; obtaining birds, trophies and ribbons; managing finances, entries, and the running; arranging for meals and snacks- and the list goes on. The COVID-19 pandemic further complicated this year's event with social distancing, hand sanitizers, and face masks playing essential roles for the safety of all concerned. Health problems and quarantines required many last minute judging changes including one on the night before the start of this year's Championship. Fortunately, Allison Bell, a well-qualified judge in her own right, had decided to accompany her husband Jarrett for his judging assignment in Booneville. Little did she know that instead of riding her young horses in the gallery for the week that she would be riding them up front with Jarrett to evaluate dogs competing in this year's Championship. Steve Ralph and Kent Patterson, this year's Field Trial

Secretary and ABC 1st Vice President, respectively, as well as their crew of helpers should be commended for putting on this year's event.

In addition to Steve and Kent, special thanks must also go to others who collectively, helped make this year's Championship a great success. Richard Beaver served as stakes manager (and happily no new landmarks were named in his honor), Dr. Robert Rankin was the course marshal and Bret Lindback served as gallery marshal coordinator. Of course, their job was easy again this year mainly because this reporter was granted special privileges to ride up front near the judges. Linda Thomas, Rocky Lindback and Judi Tipton made sure we had coffee, water, snacks and homemade treats. Most importantly, Joe Gower picked up the donuts for the dog wagon each morning. Bill Hancock served as auctioneer for the Calcutta and helped coordinate upkeep and repairs on the ABC property. Donna Janulis relieved Kent from his responsibility as hospitality host and Mary Jo Trimble guarded the roads to help ensure the safety of our dogs on course. Judi Tipton and her crew followed COVID-19 guidelines while preparing and serving 3 meals a day in the clubhouse which was greatly appreciated, especially by those who did not want to travel for meals or provide their own food.

Purina donated small pouches of Pro Plan Sport dog food for the entrants as well as large bags for the winners. Garmin donated a Pro 550 advanced training system for the Champion, and The Saddle Guy built an engraved saddle for the Champion. These fine sponsors manufacture quality products known throughout the field trial community as products that we all use in training our dogs. Additionally, Purina and Garmin sponsor the annual "Dog of the Year" awards for all age and shooting dogs.

The city of Booneville generously provides a military Humvee along with a driver to pull the dog wagon. Fortunately, Robert Smith was able to resume his driving duties this year. Ed Janulis, ABC President, filled in a few times when Robert was unavailable.

Since 1987, the ABC National All-Age Championships have been





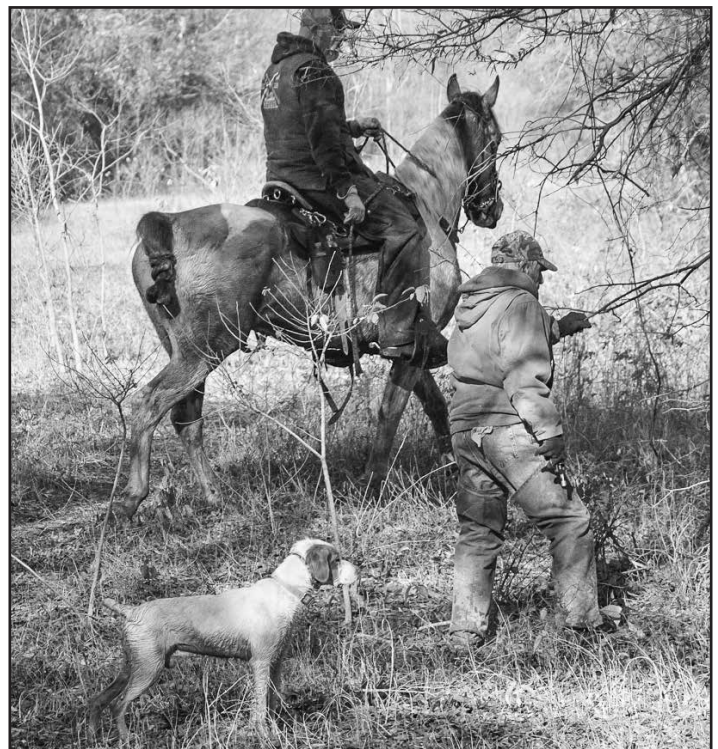
held at the J. Perry Mikles Blue Mountain Wildlife Demonstration Area in Booneville, Arkansas. Brian Enfield, Brad Wells, and Clyde "Red" Bailey had the facilities and grounds in excellent condition. There was enough mowing in the heavy cover on Courses 1 and 3 to allow an all-age dog to show to the front from time to time and to shine running the edges yet more than enough cover to also hold birds. Due to recent flooding, the cover was thinner than usual on course 2. More than 3500 birds had been pre-released by numerous field trial associations including the ABC before the start of this year's Open All-Age Championship and opportunities to find birds were abundant. Many coveys were pointed multiple times in the same location throughout the trial. As evidenced in "The Running", these grounds provide many challenges for both dogs and the handlers. Tree lines, feed strips, and old roads can take dogs in multiple directions and if the wrong path is chosen, the tracker is frequently returned to the handler. Water logged courses added to the challenges of running dogs this year.

Our judging panel was composed of the husband and wife team of Allison and Jarrett Bell from Troy, Missouri. Both have been actively involved in breeding, training and campaigning Vizsla field trial dogs for the last several years. Jarrett and Allison have judged many championships and regional field trials and were looking for a dog that ran far to the front, stayed on the edges, hunted hard, pointed with style, and finished strong. The judges refused to chase the handlers and kept a consistent pace for the entire trial. Sixty two dogs were entered and 61 went to the line in the 2020 ABC National Open All-Age Championship. Impressively, 10 different professional trainers/handlers had entered dogs. The judges were asked to post dogs that they would place and to keep only the top 4 dogs posted (in no specific order) as the Championship proceeded. It wasn't until the last brace of the Championship did the judges observe the All-Age performance they were hoping to see. Many dogs with otherwise solid performances paid a heavy price for a single flaw and many perennial winners came to the line but had difficult times handling these challenging grounds.

THE WINNERS

Champion

Routabout All In (Tommy Tracy, Jr.). The Champion ran in the only brace on the last day of the event. "Al" is a 6 year old white and orange male out of Maxwell's Outer Limit and Cedar Valley Lily and is owned Bo Ackerman of Clermont, GA. Al was released at the start of Course 1. Throughout the hour, Al exhibited excellent application, good range and handled well. Al's first find came at 8 minutes on the right side of an island of trees about halfway to the Barking Dog House. Tommy flushed a covey of quail with all in order. Al had a second find at 16 minutes to the right of the path as we approached Lick Creek. Al took the far left edge in the last section of the "S" fields leading to the chute toward the Double Gates. He was rewarded with another covey find at 30 minutes at the end of these fields and a single at 41 minutes in the chute just before the Double Gates confirming that Al can find birds and also point them with excellent style. There was some confusion among members of the gallery concerning Al's finish. After heading toward the bridge from the Double Gates, Al took the far left edge along the river and showed to the front at the bridge at the end of Course 1. With time remaining, handlers were instructed to take their dogs back toward the Doubles Gates. Al was then seen motoring fast and hard to the front in the trees on the right side of the fields along the edge the river. After time, Al was spotted by the judges far to the front in the trees along the road near the Double Gates. It took 31 braces to see





what they were looking for and this finish played a critical role in naming AI this year's National Champion.

Runner Up Champion

MK's Magnificent Bandito (Scott Johnson). Chico is an 11 year old male out of Tee-Bone and Chief's Nubbin's My Lil Lady and is owned by Bill and Mary Lynn Oliver from Eureka, Kansas. This dog is no stranger to the winners circle and ran in brace 14 along with RU-JEMs Last Penny (see below) which broke away at the beginning of Course 2. These 2 seniors were highly competitive. Although neither dog exhibited extreme range, both exhibited excellent application and each of their performances were enhanced by the other's. Chico didn't waste any time getting started. He took the left edge of the Bowling Alley and slammed on the brakes along the trees at the 8 minute mark. Scott flushed birds with all in order. At 23 minutes, Chico went on point in the trees at the end of the fields after the Old 109 Bridge and again in the trees just before we turned into the Fish Hook at 28 minutes. After completing the Fish Hook, Chico rimmed the right edge of Parrish Field where he had a divided find at 49 minutes and another at 54 minutes after completing the cast along Old 109. Chico also backed Penny at 32 minutes. The strong finish after entering Parrish Field played a large role in Chico's placement.

Third Place

RU-JEMs "Last" Penny (Tommy Tracy, Jr.). Penny was sired by Trademark's ATM out of Red Bud Zipper and owned by Jerry McGee of Steward, IL. Both the sire and dam were owned by the late Jim and late Janet Chase. Each of them would have been so proud to see the results of breeding this perennial winner. As mentioned above, Penny was braced with the Runner Up Champion. At 8 minutes, Penny was credited with a stop to flush in the trees on the right side of the Bowling Alley and backed Chico at 28 minutes just before we entered the Fish Hook. Penny then went on to show her bird finding talents where she had a find at 32 minutes in the trees just before turning right into the Fish Hook and another at 40 minutes in the island of trees on the left side of the

road in the Fish Hook. This later find required 2 relocations before Tommy could produce a bird. Like her bracemate, Penny rimmed the right edge of Parrish Field, had divided finds at 49 minutes and another at 54 minutes and finished strong after crossing Old 109.



Fourth Place

Piney Run Hilltop Blew (Kent Patterson). Blew is a 3 ½ year old male out of Piney Run Chalk and Piney Run Chicklet and is owned by Kent Patterson of Franklin, TN. Blew ran in brace 4, the first brace of the first afternoon. Blew didn't waste any time getting started when he was found standing with excellent style in the right edge 5 minutes after the breakaway. Birds were flushed with all in order. Blew showed several times to the front in the heavy cover at the start of Course 1 and had another find at 26 minutes in the fields after crossing Lick Creek. After a non-productive at 36 minutes, Blew went through the chute toward the Double Gates and had a nice limb find at 42 minutes in the tree line in the first field after the Double Gates. Blew finished strong to the front but a single come from behind during his hour factored into the judges' final evaluation.

Award of Merit

Arrow's Tequila Rustler (Richard Beaver). Rusty is a 7 old male out of Beaver's Straight Arrow and Runner's Tequila Rose and is owned by Sandy Becker of Billings, Montana. Rusty ran in the last brace of the Championship along with this year's winner. Rusty put on a strong forward race with nice application. After reaching the end of Course 1, Rusty was directed back toward the Double Gates to complete the remaining time of his hour. Rusty hugged the right edge along the river and had plenty left to finish his hour strong to the front. Rusty had 1 piece of solid bird work at 33 minutes.

THE RUNNING





Day 1

Brace 1: Piney Run Jake (Kent Patterson) and Turning Points Shenanigans (Bob Burchett). Jake fought through the heavy cover on the first part of Course 1 and had a divided find with Shandi at 12 minutes in thick briars about halfway to Lick Creek. Jake was next found standing in the tall grass in the far corner of the field as the course turned toward the Barking Dog House. Kent flushed and fired with all in order. Jake motored to the front after crossing Lick Creek. He took the right edge through the middle section of the "S" fields and was looking nice as he rimmed the large field below the building on top of the hill. Unfortunately, this perennial winner was not seen after this impressive cast. Shandi made a nice cast in the last section of the "S" fields and had another find at 45 minutes just before the Double Gates but overall, her run was not going to get it done.

Brace 2: MK's My Lil Ammo (Scott Johnson) and Brendi Brooks Cowboy Up (Ray Trimble). Dogs were released at the start of Course 2. BB was forward, handled well, but worked only at modest range. She had a find at 19 minutes in the trees near the Fish Hook. She was again found standing at 34 minutes in the trees at the end of the Fish Hook but Scott was unable to produce birds and BB was given a non-productive. BB looked nice rimming Parrish Field but put up birds after crossing Old 109 and her day was done. Another year for 94 year old Ray Trimble at Booneville- what more can I say. Tuff backed BB at 19 minutes and had a find at 34 minutes at the end of the Fish Hook. He had another find at 49 minutes to the right of the cut through in the first field after crossing Old 109. Although Tuff was posted on Day 1, his ground game was not sufficient to keep him on the board for the duration of this year's Championship.



Brace 3: Spanish Corral's Sonny Patch (Joe Gower) and Sniksh Little Diamond (Scott Johnson). Dogs were released at the start of Course 3. Patch went forward on the right side of the course and was found standing in the trees at 10 minutes. Joe flushed a small covey and all was well. However, Patch never made the turn toward Mario's Hill and Joe called for the tracker at 25 minutes. Kate was making some nice moves early on but shortened up and went into hunting mode as her hour went on. She had finds at 28, 37, and 51 minutes after crossing Lick Creek and the other 2 in tall grass between the trees and the road.

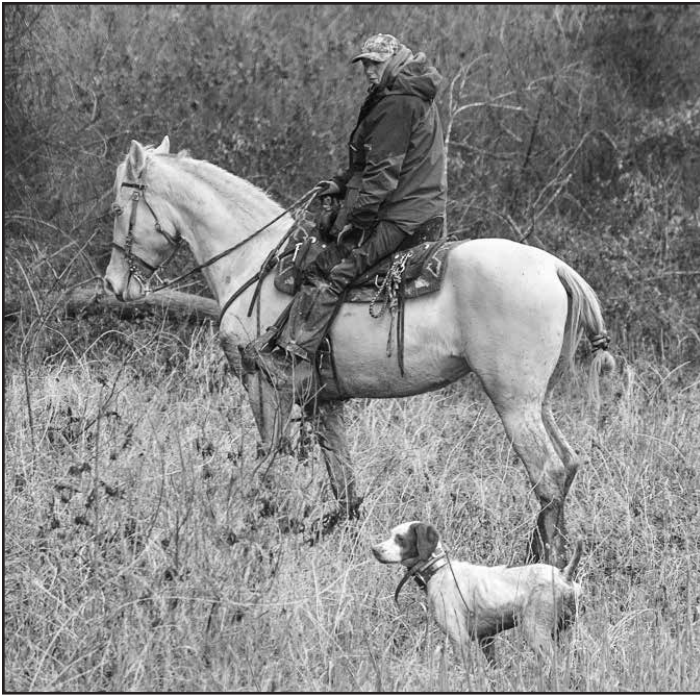
Brace 4: HEHI's Slim Chipley (Bob Burchett) and Piney Run Hilltop Blew (Kent Patterson). The first brace of the afternoon had the gallery watching. Blew's performance was described above. Slim was found standing at 21 minutes in the trees just before we turned toward the Barking Dog House. After crossing Lick Creek, Slim made some nice moves and had another find in the last tree line in the final section of the "S" fields. Slim took the left edge in fields after the Double Gates. However, he got to the "end" of Course 1 at 50 minutes and didn't have enough left for a strong finish as the handlers were told to take their dogs back toward the Double Gates.



Brace 5: Wild Wild Willie (Ed Tillson) and Farm Girl Pearl (Bob Burchett). Dogs were released at the start of Course 2. Willie, the defending Champion, got off to a great start when he rimmed the breakaway fields on the right side of the road and was rewarded with a find at the 6 minute mark. Willie continued with a strong forward race but put up birds on the right edge of Parrish Field to bring an early end to his day. Pearl was not in her usual form today. Although she had 2 finds and finished her hour, her ground race was disappointing and she was not going to challenge any of the competitors.

Brace 6: JJ's Levi the Lionheart (Tommy Tracy, Jr.) and Son Yoti's Master Of Illusions (Paul Doiron). Dogs broke away at the start of Course 3. Levi went on point at the 14 minute mark just before we got to Mario's Hill. Tommy flushed and fired with all in order. However, Levi ran into problems at 25 minutes and his day was done. Magic was seen from time to time in the heavy cover at the beginning of Course 3. He was credited with a stop to flush on a covey of birds at 31 minutes but thereafter, he shortened up, went into hunting mode, and was picked up early.

Day 1 Dogs on the Board: HEHI's Slim Chipley (Bob Burchett), Piney Run Hilltop Blew (Kent Patterson), Brendi Brooks Cowboy Up (Ray Trimble)



Day 2

Brace 7: Sigbrit's Not In Kansas Anymore (Scott Johnson) and Sundance Kid's Rule Breaker (Frank Campbell). The temperature turned cold after raining all night long. Bud was scratched so Doti ran as a bye in place. This 3 year old had a difficult time establishing a forward pattern with her ground race. She had a find at 16 minutes in the last field before turning toward the Barking Dog House and another in the last section of the "S" fields.

Brace 8: Sligo Sam (Ben Lorenson) and Godfather's F.N. Rockstar (Steve Chang). Sam made some nice moves, especially to the island of trees before the Fish Hook and in Parrish Field, but overall his run was inconsistent. He ended his hour without any birds. Rocky was impressing the judges. He rimmed the last field in the Fish Hook and had first class style on his finds at 8, 32 and 42 minutes. However, he pooped out at the end of his hour which moved him off the leader board as the competition continued on.

Brace 9: ANJ's Ohio Hellion (Bob Burchett) and T Copper Buckaroo (Paul Doiron). Dogs were turned loose at the start of Course 3. Hank never made the turn toward Mario's Hill but eventually showed up to the front, without his handler, where his day ended when he failed to back his bracemate. Buck hunted at short range, had a find at 19 minutes,



but non-productives at 13, 24, and 30 minutes brought an early end to his day.

Brace 10: Shailorville's Gunner (Ben Lorenson) and High Hopes Jac's Original Spice (Chad Holman). The entire afternoon was tough on the dogs. Gunner was found standing with a limb find at 30 minutes. Ben flushed a covey of birds with all in order. Gunner had another covey find at 38 minutes but disappeared shortly thereafter. Spice made some nice moves but had a difficult time connecting them together. She had finds at 33 and 48 minutes.

Brace 11: Highpoint Spike's Southern Gal (Ben Kuykendal) and Ace's One Eyed Jack (Chad Holman). Ellie had a difficult time establishing her ground race and was lost at 45 minutes without any birds. Jackson had a non-productive at 10 minutes and covey finds at the 25 and 29 minute marks. His run was not pleasing his handler and he was picked up at 48 minutes.

Brace 12: Hoochie Coochie Man (Ed Tillson) and JWB Arctic Cat (Tom Tracy). Karl was unable to stay to the front or establish a ground race and was picked up at 40 minutes. Kimber made a nice move to the front and was rewarded with a find at 12 minutes. However, she was lost shortly thereafter and her day was done early.

Day 2 Dogs on the Board: HEH's Slim Chipley (Bob Burchett), Piney Run Hilltop Blew (Kent Patterson), Godfather's F.N. Rockstar (Steve Chang), High Hopes Jac's Original Spice (Chad Holman).



Day 3

Brace 13: Just Call Me Lucky Ned Pepper (Frank Campbell) and Godfather's Red Feather Gunslinger (Steve Chang). Lucky Ned had a find at 27 minutes in an island of trees in the middle section of the "S" Fields and another at 35 minutes. His scout called point 2 other times but Lucky Ned was moving again before the judge and handler arrived. Lucky Ned usually has good application but his ground race was only fair this time around. The judge described Gunnar as directionally challenged.

Brace 14: RU-JEM's "Last" Penny (Tommy Tracy, Jr.) and MK's Magnificent Bandito (Scott Johnson). Performances were described above.

Brace 15: Carpe Diem (David Lincoln) and Black Creek Uhaul (Chad Holman). Carp was having a tough time today. He frequently came from behind and then went missing till we got to the Pavilion Field where Dave elected to pick him up at 25 minutes. Johnny came from behind several times and Chad elected to also pick him up at 25 minutes. Neither dog had bird work.

Brace 16: Sniksoh Hank's Gypsy Cruise (Bob Burchett) and Maxwell's Prickly Pete (Tommy Tracy, Jr.). Bob directed Cruise around the course with a tight handle. Cruise had a find at 35 minutes in the last tree line at the end of the "S" Fields but a self-relocation ended his day early. Pete was doing a really nice job. He had a find at 13 minutes just before the turn toward the Barking Dog House. After crossing Lick Creek,



Pete went to the far edge of the first field and at 18 minutes was rewarded with another find. Pete took the right edge of the middle section of the "S" fields and at 26 minutes had his third find in the trees in the far corner of the field. Unfortunately, Pete was not seen after this last find and Tommy called for the tracker at 35 minutes.

Brace 17: Blew Me Away (Paul Doiron) and Driving Miss Daisy II (Tommy Tracy, Jr.). Dogs were released at the Double Gates. After crossing the bridge onto course 2, both dogs turned left. Daisee never showed to the front but the scout reported that she was having a pretty good time just where she was and Daisee felt there was no need to get Tommy involved. Unlike Daisee, Bud showed to the front in the Bowling Alley. Later he had a nice covey find in the trees in the island in the Fish Hook at 38 minutes. However, this year's National Amateur All-Age Champion was not getting it done on the ground this time around.

Brace 18: Scout Upland Trailblazer (Ed Tillson) and Knine Finale's Way To Go (Paul Doiron). Dogs were released at the start of Course 3. Scout made some moves to the front but had a long absence near the turn toward Mario's Hill. After rejoining his handler, Scout was found standing on a limb find at 40 minutes where Tillson flushed a huge covey of birds. Allie went on point with excellent style in the island of trees in the breakaway field at the 1 minute mark. However, Paul was unable to produce birds and Allie was given a non-productive. At 42 minutes, a covey of quail flew out of the tall grass where Allie was last seen. Paul rode over, found Allie standing, and was able to flush a single with all in order. Allie had another covey find at 52 minutes. Overall, Allie's ground race was inconsistent and a second non-productive at 59 minute sealed her fate.

Day 3 Dogs on the Board: Piney Run Hilltop Blew (Kent Patterson), Godfather's F.N. Rockstar (Steve Chang), RU-JEM's "Last" Penny (Tommy Tracy, Jr.), MK's Magnificent Bandito (Scott Johnson).

Day 4

Brace 19: Treasure States Toby Mac Daddy (Ed Tillson) and WW's Miss Wendy Peffercorn (Tommy Tracy, Jr.). Wendee had a

difficult time establishing a consistent ground race. She had a find at 15 minutes in the cedar trees as we turned toward the Barking Dog House and another in the last tree line in the "S" Fields. Toby, Toby, Toodaloo Toby. This reporter was the scribe for the ABC 2020 Pheasant, Quail, and National Open All-Age Championships. You were lost after going over the first sand hill in the Pheasant. You took off like a bat out of hell in the Quail but were not seen thereafter. Finally, you were lost shortly after the breakaway this year in Booneville. Where do you go when Ed releases you at the breakaway?

Brace 20: Molly Mae Alexander (Tommy Tracy, Jr.) and Waypoint Chancey Big White Cooper (Kyle Merrill). Both dogs took the right edge in the first field after they were turned loose at the start of Course 2 and had a divided find at the 2 minute mark. After birds were flushed, Molly took a few steps and more birds took to the air and she took the walk of shame back to the dog wagon. Big White continued on but had a difficult time staying to the front. Kyle called point at the 33 minute mark. However, Big White put up birds before his handler arrived and he joined Molly in the dog wagon.

Brace 21: Rusty Ridge Where U Been (Paul Doiron) and Black Creek Whizki Skip (Chad Holman). Dogs were released just before Parrish Field. Skip didn't waste any time getting started when he went on point at the 30 second mark in the trees to the right of the path. As Chad flushed birds, Skip took a few small steps and was ordered up to end his day as fast as it started. Oh, what could have been for Been. He was doing a very nice job on the ground- he was forward on the correct side of the tree lines and edges and overall had beautiful application. Unfortunately, Been went missing as we approached the last field on Course 2. Paul continued across the bridge and onto Course 3 but Been never reappeared and the tracker was returned to the handler.

Brace 22: Dynamitemakeit (Paul Doiron) and Sniksoh Hanks Hatch (Bob Burchett). The weather was beautiful as we broke away on Course 1 first thing in the afternoon. This brought participants out of their trailers and onto their horses in the gallery. Unfortunately, dogs in this brace failed to impress the gallery or their handlers and Bob and Paul respectively picked up their dogs at 22 and 30 minutes.



Brace 23: Alar's Dirty Dancer (Ed Tillson) and Castaway Wilson (Tommy Tracy, Jr.). Dogs were turned loose in the third section of the "S" Fields. Dani was fast, forward, in the right places, hunting the outer limits of the course without help from her scout and was impressing the judges. She took the left edge of the field after the Double Gates and showed to front at the bridge. When we arrived at the Bowling Alley at 30 minutes, Mr. Tillson elected to pick her up. Wilson was having a hard time staying to the front and Tommy elected to pick him up when we got to the bridge at the end of Course 1.



Brace 24: I'm Your Man (Ben Lorenson) and Almaden's Under Lock and Key (Ed Tillson). Dogs were released in the Bowling Alley and worked at close range for the hour. Gus had a covey find at 19 minutes in the tall grass on the left side of the road in the Fish Hook, a non-productive in the right edge of Parrish Field, and a small covey at 50 minutes in the last tree line on Course 2. Oudi had a non-productive at 19 minutes on the right side of the road in the Fish Hook and a hawk kill at 39 minutes after completing Parrish Field and crossing Old 109. Oudi was not seen thereafter and Tillson called for his tracker at 55 minutes.

Day 4 Dogs on the Board (No New Dogs): Piney Run Hilltop Blew (Kent Patterson), Godfather's F.N. Rockstar (Steve Chang), RU-JEM's "Last" Penny (Tommy Tracy, Jr.), MK's Magnificent Bandito (Scott Johnson).

Day 5

Brace 25: Spanish Corral's Big Iron (Joe Gower) and Roustabout Lil Pumpkin (Paul Rosevear). Colt incurred a cut on his ear shortly after the breakaway. Colt seemed to be doing OK with his injury but we weren't sure about Joe. Colt and Joe continued on but Colt's run was inconsistent and Joe elected to pick him up before we got to the Double Gates. Pumpkin didn't get the memo that today she was running in the National All-Age Championship. Neither dog had bird work during their 40 minutes on the ground.

Brace 26: Willie Makeit (Scott Johnson) and CVK Spartan King (Tommy Tracy, Jr.). Dogs were released at the Double Gates. After crossing the bridge onto Course 2, Leo took the left edge of the first field and went on point with Willie backing. Tommy was unable to flush birds and Leo was given a non-productive. Willie made a nice cast around the right edge of the last field before entering the Bowling Alley while Leo continued forward rimming the left edge of the Bowling Alley where he was found standing at the 22 minute mark. As the handler arrived, Leo was then seen under birds and his day was done. As Leo was led back to the dog wagon, Willie was seen 100 yards ahead with Scott off his horse. The judges asked him if Willie put up Leo's birds and Scott replied that he's not pleading guilty but Willie is staying on the end of the check cord.

Brace 27: M&M's Grouse Gunning Gracie (Kyle Merrill) and Tequila Scorcher (Ed Tillson). A cold rain started to fall as dogs were released for the last brace of the day and this seemed to negatively affect their performances. Gracie was out of control the entire time she was on the ground. Lincoln made nice casts in Parrish Field and in the corn field at the end of Course 2 but overall he lacked his usual drive, speed and range that frequently takes him to the winner's circle. Tillson elected to pick him up at 48 minutes. Neither dog had bird contact during their time on the ground.

Brace 28: Sonny's Hot Summer Breeze (Paul Doiron) and Jac's Ray Of Sunshine (Chad Holman). Breezy was working at gun dog

range and was frequently behind. He had one find at 24 minutes but unfortunately it was to the rear. Paul elected to pick him up at 30 minutes. Ray was seen standing at 14 minutes by an island of trees on the left side of the path before the turn toward the Barking Dog House. Birds were seen in the air as Ray was in the area and his day was done.

Brace 29: Crescent City Girl (Ed Tillson) and Kashmir (Tommy Tracy, Jr.). Dogs were released in the middle section of the "S" Fields as a cold rain started to fall. Nola was making some nice moves and went on point at 11 minutes in the tree line at the end of the "S" Fields but the cold put a damper on her performance. Kashmir has been making a name for himself this fall but was not getting it done today. Both handlers elected to pick up at 30 minutes.

Brace 30: SR's Blew By Typhoon (Paul Doiron) and Gun Creek Gangster (Chad Holman). Dogs were released at the start of Course 2. Ty immediately went to work when he took the right edge of the first field and went on point at 2 minutes. Paul flushed a huge covey with birds exploding in all directions from around Ty. Ty never made it into the Bowling Alley but showed up 20 minutes later as we entered Parrish Field before going toward the Fish Hook. Paul's persistence paid off because Ty went on to finish strong with additional finds at 35 minutes in the Fish Hook, 43 minutes in the trees on the right just before entering Parrish Field, and at 57 minutes after crossing Old 109. Doc was not putting on an All-Age performance and had problems with birds to end his day at 25 minutes.

Day 5 Dogs on the Board: Piney Run Hilltop Blew (Kent Patterson), RU-JEM's "Last" Penny (Tommy Tracy, Jr.), MK's Magnificent Bandito (Scott Johnson), SR's Blew By Typhoon (Paul Doiron).

Minutes for the 2020 ABC Board of Directors Annual Meeting

New Judges Education Chair Amy Booth zoomed in to introduce herself and make a few comments about her new position. Amy got started her new position at the 2020 National Specialty Show where there were 4 judges in attendance. Amy stated she is impressed with the current ABC Judges education program and intends to keep it running the same with Diana Kubitz and other committee members continued input.

Before beginning other 2020 business President Ed Janulis took a few minutes to go over his recommended regulations for Covid-19 for all activities at the 2020 National Activities. Ed then moved into the reports and action items presented in the 2020 Agenda Book.

2020 ABC AGENDA BOOK REPORTS, TOPICS, ACTION ITEMS AND MOTIONS:

Motion 1: Move to officially approve the 2019 Board of Directors Meeting Minutes.

Motion by: Mary Karbiner Seconded by: Darlene Dow Motion Passed: 15 Yes

Topic: ABC Officers and Board of Directors need a better mode of communication, i.e., Yahoo, direct email blasts, wider use of ABC Facebook page or a dedicated spot on the ABC website to communicate with members directly.

Discussion: Ed Janulis commented he is currently sending out welcome letters to all new members and has had some very positive responses. Bernie Crain stated he had tried communicating via email and social media groups, and nothing has been able to reactivate the enthusiasm of the past. Bernie feels having club supported activities that would attract and interest young people is of paramount importance. Robin Tomasi agreed and stated the ABC members on the West Coast have been responding positively to email blasts on issues and events. She stated that many young people these days do not use Facebook but have gone to other groups such as Instagram and Tik Toc. Robin was not in favor of changing to another social media as she felt the ABC Facebook page is continuing to maintain its informational content practice.

Topic: Report from Bob Burchett – Note: Some of Bob's verbal report is missing due to technical difficulties during his presentation. Bob reported that the 2020 Walking Gun Dog Nationals in Ionia

had a strong entry and the budget shows a small profit for the event. A younger than normal crowd was in attendance. In regards to no Champion or RU Champion being awarded in the NOWGD this was due to dog performance; specifically, dogs running so far ahead they ended up putting up the large coveys of birds they were finding before the handlers were able to reach them. A question was asked if there were plans to move the Gun Dog Nationals back to the Spring and Bob stated there were no plans to do that at this time. Bob expressed his pleasure at serving two terms as the 4th Vice President and cautioned all Directors to look to the future but if necessary, dig in their heels, to protect the past.

Topic: Dawn Droel, 3rd Vice President, gave her report on the 2020 National Specialty Show. Dawn expressed her pleasure at serving as 3rd Vice President but stated she was eager to get back to showing her dogs at the Nationals. She stated her inability to show her dogs while serving in this capacity is only an ABC rule not an AKC rule. Covid-19 precautions were successfully implemented at the 2020 NSS. There was one incident involving an inebriated exhibitor who fell in the parking lot and then filed an accident report the next day. All necessary paperwork was completed by the show superintendent and will be filed with AKC and any other necessary organizations. Very successful fund raising this year in part due to a member run online raffle and also because ABR didn't attend so there was not another source of fundraising items for sale thus the NSS items received all the funds which were put back into the National Specialty Show. Dawn made the suggestion that in the future ABR be limited in the number of items they sell or raffle at the NSS.

Topic: Paige Giebel won her third ABC Best National Specialty Junior Handler so the traveling trophy given for this award was retired to her. Dawn requested permission for Teresa McNulty to establish a new traveling trophy for the ABC Best National Junior Handler winner. Teresa's replacement trophy would be at her cost.

Motion 2: Move to grant Teresa McNulty permission to replace the retired ABC Best National Specialty Junior Handler traveling trophy.

Motion by: Mary Karbiner Seconded by: Joe Droel Motion passed 15 Yes

Dawn expressed concern that the Agility entries were much smaller this year and for that reason she was concerned it would not pay for itself. Judy Graves explained Agility has its own budget for the NSS starting this year. Dawn felt that the new Judges Education Coordinator who started at this year's NSS was involved in an awkward situation that caused a few complaints from other exhibitors. Amy was mentoring 4 judges ringside on Friday then showed a dog on Saturday which won a high award. Dawn felt this was not only an awkward situation but that it was potentially a conflict of interest. Jessica Carlson requested permission to speak and took the floor. Jessica said this situation was a one-time occurrence due to the mid-season appointment of Amy Booth as the new Judges Education Coordinator. If the same situation is likely to occur in the future there would be time to make arrangements for a different Judges Education mentor. No further action was required on this item.

Report and Action Item from Jennifer Brooke Burlington,

Elected Secretary - Staying busy but feel the position is under-utilized and could include some other responsibilities. Having said that Brooke presented the following action item.

Action Item: Would like to request that Regional Clubs (especially in the West) make a list of resources (pointing dog clubs, hunting clubs, other Brittany organizations) and submit them to her so she can give out this information to people from different areas of the country inquiring about activities for their Brittany's.

Discussion: Mary Brown suggested that Brooke contact other Western Regional Club Officers in the area where the inquiries were coming from to get suggestions. Jim Hammett said the Western Regional Clubs have started offering Amateur Walking Stakes especially in the juvenile stakes as an incentive to bring in new Brittany owners. He also mentioned the ABC Futurities as being a good event for new Brittany owners. Burton Wice stated Walking Field Trials are posted on the ABC Field Trial Schedule which is posted on the ABC Website and published in the ABC Magazine. Burton suggested that the ABC think about offering a Hunt Test Schedule similar to this Field Trial Schedule that could be posted on the ABC Website and possibly published in the Magazine. He also mentioned there were Hunt Tests and Field Trials posted on the AKC Event Website. All of these suggestions should be taken under Brooke's consideration. No further action required.

Report from Gerilyn Sennott, ABC Treasurer – Will continue sending out quarterly reports which have been well received. Comparison from year to year have been difficult since 2019 items were entered incorrectly and it took several months work for Judy Graves and I to figure them out. Have a preliminary cost report on the 2020 National Walking Gun Dog events. The Amateur is showing a small profit and by moving the unawarded trophy costs for the Champion & RU Champion to next year should help with the Open budget as well.

Report from Jennifer Brooke Burlington, Agenda Book - Brooke reported she had fewer complaints this year but said there were fewer reports. Also mentioned that there was a total of 55 ABC committees many of which had never sent in reports. Ed Janulis stated he was working on this item.

Topic: Brooke felt she had time to take on the duties of the ABC Dog of the Year Award so Ed said he would enter her name for consideration of this position.

10 MINUTE BREAK

Report and Action Item from Mary Jo Trimble on AKC Legislative Liaison

Mary Jo reports that legislative issues were greatly reduced due to Covid-19 because of less meetings. She expects if things settle down action will begin again in Spring 2021.

Action Item: Continue financial support on a continuing basis to both the US Sportsmen's Alliance and the National Animal Interest Alliance (NAIA).

Discussion: No action required as both of these items are in the budget.

American Field Liaison – Ray Trimble sent in a report covering the current status of American Field. Ed Janulis makes the statement that American Field as an organizational expense is in question now due to the discontinuance of a printed magazine with the American Field charging the same price for Championship and regional trial sanctioning for digital advertising.

Book of the American Brittany from Jessica Carlson – Jessica

reported that the ABC Book of the 2010's (2010 – 2019) is still on track for publication in 2021.

Action Items from Ron Gulembo-East Central Director

Topic 1: Publish Standard Operating Procedures for Officers and Chairmen in Policy Book.

Motion 3: Move to form a one-time committee, comprised of Ron Gulembo and Darlene Dow, to create a simple guideline sheet outlining duties of the 1st VP, 4th VP and their respective Field Trial Secretaries.

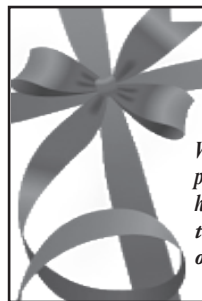

Kansas All Age Championship 2020

The one-hour stake, Kansas Championship, hosted by Southern Kansas Brittany along with Purina as a sponsor was held on the Oliver Ranch in the roaming Flint Hills of southeastern Kansas. We would like to thank the owners of the Oliver Ranch, Bill and Mary Lynn Oliver for allowing us to hold the championship on these prestigious grounds and Purina for their sponsorship. Judges Brooks Carmichael and Tommy Thomas honored us with their dedicated attention to the performance of the dogs.

The drawing was held live Sunday evening, October 16, 2020 at the grounds. At the closing of the entry date, there were a total of 39 dogs entered in the championship. With this number of dogs entered it should have taken us through Thursday morning to complete the Championship.

Day one of the Championship brought on cool damp temperatures, with brace one beginning at 8:31 a.m. sharp.

Brace 1: Godfather's F.N. Rockstar, Steve Chang and Ocaje, (Grace), Terry Gowin. Grace took the field with a wide cast to the left and Rocky was seen running forward. At fifteen minutes into the run, handler called point for Grace. Rocky came in from the west to honor. Unfortunately the point resulted in a non-productive. Deer were seen at the thirty-minute mark. At the forty-two minutes Rocky had not been seen and the tracker was pulled. Grace had a find at the forty-five-minute mark, and failed manners with a chase.

Brace 2: Ru-Jem's Last Penny, Tom Tracy and McChesney's All Down the Line (Ranger), Scott Johnson. At twenty-two minutes Penny had a find in the east side of the bowl along the creek just

past the wire gate; consisting 4 to 5 birds all was in order. Johnson had pulled the tracker at this time for Ranger. Penny went on with a total of three more finds. Penny slowed towards the end of the brace

Brace 3: SKF Miss Cheap Bourbon Whiskey (KD), Steven Foster and Willie Make It (Willie), Scott Johnson. Brace began at 10:42 a.m. Both dogs had an all-age ground run but unfortunately both were without birds.

Brace 4: Jowill's Daniel in the Lions Den (Daniel), Tom Tracy and Rev'n Gunrunner's Tilly, Ed Tillson. Daniel was seen to the right towards the fence row after the break away and moved across to the front, Tilly was seen at twelve o'clock. Eighteen minutes in Daniel was seen on point, handler flushing, Daniel broke with a chase. Moving on through the brace Tilly makes her way up front through the canyon. At the 30 minute mark Tilly has a stop to flush. Again she is found on point near the "beer can", handler Tillson relocates Tilly resulting in a non-productive. Tilly's race ends with a pick up at the forty-seven minute mark.

Brace 5: Kashmir (Kash), Tracy and Wild Willie (Willie), Tillson. The brace began mid-afternoon, starting at 2:26 p.m., Willie was found on point at 2:29 p.m. for his first find. Kash failed to back. With Willie moving on he is given a water break at the 25 minute mark. Making his way on further Willie has a clean find and travels on and is making a nice move through the east loop and using lines. All through the brace Willie makes enjoyable casts with excellent range, was in view by the judges at time.

Brace 6: MK's Magnificent Bandito (Chico), handler Scott Johnson and JWB's Artic Cat (Kimber), handler Tom Tracy. Chico bumped a bird at the 30-minute mark. The retrieval device was requested for Kimber 45 minutes into the brace. This concluded the first day of the Championship.

Day two: An unfortunate horse wreck during the weekend trial, causing Tom Tracy to withdraw his remaining dogs from the championship. This required the committee to redraw the running order.

Brace 7: Godfather's Red Feather Gunslinger (Gunnar), handler Chang and Almaden's Under Lock and Key (Oudi), handler Tillson. Brace began at 8:50 a.m. Oudi is seen out front ranging nicely and was seen on point near the pond with a covey find, holding his manners well. Another find at the top of the canyon with several birds flushed from the grassy area by the handler, nicely handled by Oudi. Operating his way on through the brace working hard to prove his ability Oudi is found on point at 55 minutes looking proud and mannerly. Gunnar finished out the brace without bird work.

Brace 8: Tequila Scorcher (Lincoln), handler Tillson, bye. On point at the 15 minutes along the hedge row just before the high post gate, another find at 22 minutes along the east draw from the hay meadow holding mannerly. Working his way forward with a nice cast to the left from the pond and up

through the draw. Lincoln had a find at the hour mark, finishing clean.

Brace 9: J&M Rodeo Romeo (Tuff), Tillson and Sniksoh Little Diamond (Kate), Johnson. Tuff went wide to the left and was not seen for the remainder of the brace. Kate had a total of three

ABC Quail Classic/Championship

Reported by Burton Wice

The Greater St. Louis Brittany Club hosted the ABC Quail Classic/Championship on the Sportsmen's Association Field Trial Grounds in Grovespring, MO. This fall's scheduled start was Saturday November 14th. An eleventh-hour judge cancellation delayed the start until Monday morning to allow the replacement judge, Ken Chenoweth of Fair Grove, MO, time to rearrange his schedule so that he could evaluate dogs along with John Hott of Hoopeston, IL. With 49 entries and 48 starters, the judges assessed dogs over a 4 day period. Together they made a team that worked great together, with both readily agreeing on evaluations of performance and order of placements.

As detailed below, ANJ's Ohio Hellion, handled by Bob Burchett captured the 2020 ABC Quail Classic/Championship title. Hank was sired by Grand Junction Jake out of High Hopes Little Ann. Owner Mike Poehler of Hoffman Estates, IL, was present to watch another winning performance for Hank. For the other braces, Mike sat tall in the saddle while comparing Hank's performance with those of the other dogs hoping that Hank would still be the winner after the last dogs had run. You can rest easy now Mike!

RU-JEMs Last Penny, handled by Tommy Tracy, Jr., was named Runner-Up Champion. Penny was sired by Trademark's ATM out of Red Bud Zipper. Both the sire and dam were owned by the late Jim and late Janet Chase. Each of them would have been so proud to see the results of this breeding. Owner Jerry McGee of Steward, IL was driving the dog wagon while Penny performed and those in the horseback gallery had to keep one eye on the dogs ahead and the other on the dog wagon behind as Jerry kept inching closer and closer to see the action. His driving during this brace reminded us of the late Phil Corlew, long-time dog wagon driver for the Greater Saint Louis Brittany Club, who always gave the dogs a ride

to remember.

Challenging the winners were Sniksoh Hank's Hatch (Third Place) handled by Bob Burchett for owner Adam Freeman of Marshfield, MO and perennial winner Piney Run Jake (Fourth Place) handled and owned by Kent Patterson of Franklin TN.

The Field Trial Sportsmen's grounds are in the upper echelon of field trial venues in the nation. The grounds are groomed for field trials with feed strips lining the edges and thoughtful mowing of the fields. The three one-hour courses have a natural flow and offer good cover for quail and for watching dogs. Pre-released and wild coveys of quail are plentiful here; supplemental birds planted during the trial are an added bonus and aid in bringing the resident coveys back on course. Missouri's rifle deer season started during the Classic/Championship which put the hunting season rules into effect at the start of the event. During deer season trials are not permitted to run through Clymer's pastures because of landowner hunting plans and The Missouri Department of Conservation does not allow us to use the clubhouse loop which is adjacent to a state wildlife area. This necessitated a horseshoe turn on the north end of the bull pasture and a return trip past the Blue House, then turning south into the chute below the twin barns to resume the typical route on course three.

Secretary Burton Wice conducted the draw as advertised on Sunday evening November 8 in his horse trailer on the field trial grounds. Forty nine dogs were entered in this prestigious stake and only 1 was unable to make it to the starting line. Overnight lows during the course of this trial ranged from 26 to 50 degrees with daily highs typically reaching into the 60s or low 70s.

Purina donated small pouches of Pro Plan Sport dog food for all entrants as well as large bags for the winners. Garmin donated a Pro

550 advanced training system for the Champion. The Greater St. Louis Brittany Club and the American Brittany Club Quail Championship participants are very appreciative of the support received from these fine companies.

The American Brittany Club's Purina Open All Age Dog of the Year is often determined at this Classic/Championship plus The Greater Saint Louis Brittany Club regional field trial that immediately preceded this event. This year was no exception where JWB's Arctic Cat held on to win the Purina 2020 Open All-Age award.

The Greater Saint Louis Brittany Club worked well together and put on a smooth-running event. Burton Wice, field trial secretary, handled all of the paperwork and coordinated with the others as to who would take care of each day's duties. This year the club hired Jim Lowery, the caretaker of the field trial grounds to plant birds each morning. Driving the dog wagon during the Championship were Tim Self and Jerry McGee. Because of the COVID-19 pandemic, the club was unable to host daily meals in the clubhouse for all participants. However, Burton prepared meals for the judges. Next year, the pandemic will hopefully be under control and the club will resume hosting 3 meals a day for all of the attendees.

Winners

The newly crowned Champion, ANJ's Ohio Hellion, handled by Bob Burchett began his performance just beyond Davis Bottom, the second brace on the first afternoon. Hank's proud owner, Mike Poehler was on horseback to witness his performance and was not disappointed. Hank made some attractive moves and scored a divided find with his brace mate at 35 minutes in the far tree line after exiting Little Vine Loop. Hank showed well in Sycamore Bottom and took the right edge in the field after the Double Barns and was rewarded with a find at 57 minutes. Hank finished his hour at the top of the hill by the Blue House.

RU-JEM's Last Penny, the Runner-up Champion, handled by Tommy Tracy, Jr. was turned loose at the breakaway in the first brace of the third afternoon. Penny is a perennial winner due to her excellent application and ability to find birds. Today was no exception. Penny's first find came at 11 minutes just before the second creek crossing. At 17 minutes, Penny pointed again after crossing the road and Tommy flushed birds with all in order. Taking the left edge through the Island Field, Judge Hott remarked that "this bitch can fly". After going up Horse Killer Hill and passing the gate from Don Fox Hill, Penny was found standing under the cedar trees on the left edge of Apple Tree Hill where Tommy flushed a nice covey of quail. Penny slowed down a little in the final minutes of her hour.

Challenging the winners were Sniksoh Hank's Hatch (Third Place) and Piney Run Jake (Fourth Place). Hatch was turned loose in the first brace of the trial in the Breakaway Field. Although the beginning of course 1 is known as a great place to show your dog, bird work is typically less than would be expected. This was not the case for Hatch who scored 3 finds in the first 12 minutes before reaching the second creek crossing. Hatch had additional finds at 25 minutes in the tree line at the end of Davis Bottom and at 42 minutes just below Horse Killer Hill. From Apple Tree Hill to the end of his hour, the handler steered Hatch down the milo strips on the left edge of the course and he was rewarded with a find at 55 minutes in the last field before the end of course 1.

Piney Run Jake was turned loose in the Island Field and got right to work with a find at 6 minutes on the right edge of the field before Horse Killer Hill. Jake proceeded unseen from Apple Tree Hill and showed at the base of the hill in Little Vine Loop. Jake was again seen at the far end of Sycamore Bottom and was rewarded with a find at 45 minutes by the pond by the Double Gates. The handler heeled Jake to catch the front but the judges did not like this 6 minutes loss of action. Jake, appearing tired, was watered at the Double Barns and then took the right edge toward the

Blue House and was rewarded with a small covey find at 57 minutes.

The Running:

Day 1

Brace 1: Snikosh Hank's Hatch (Burchett) and Castaway Wilson (Tracy). Hatch was described above. Wilson bumped a bird at 7 minutes and his day was done early.

Brace 2: Alar's Dirty Dancer (Tillson) and CVK's Ironman (Tracy). Dani took off from the start but forgot to tell Ed where she was going. Not a problem because Ed found her when he took out the tracker. Tony was having trouble with his ground race and bumped birds at 18 minutes on the left edge of Sycamore Bottom to end his day.

Brace 3: Molly Mae Alexander (Tracy) and Wild Wild Willie (Tillson). Dogs were turned loose in the middle of Sycamore Bottom. Molly wasted no time and went on point along the milo strip on the right edge below Sycamore Bottom and just before reaching the road. Tracy flushed a single and all was well. Molly had another solid find at 13 minutes along the fence by the Double Barns but ran into trouble at 21 minutes by the Blue House when she went with a covey that flushed wild. Willie, last year's National Champion and in the hunt for this year's Purina Award, went on point at 17 minutes on the left side of the field after the Double Barns and before the lake. Tillson was unable to flush birds but that wasn't a problem because Willie put them up for Ed during a relocation.

Brace 4: WW's Miss Wendy Peffercorn (Tracy) and J&M Rodeo Romeo (Tillson). The first brace of the afternoon was turned loose in the Breakaway Field. Wendee, owned by this reporter, won this event last year shortly after her second birthday. A repeat performance was not in the cards as Wendee took out birds at 7 minutes along the milo strip on the right edge before the first creek crossing. Tuff had a find at 13 minutes just before the second creek crossing. Tuff was missing in action twice after his find but looked nice taking the right edge in Davis Bottom- that is until he disappeared again this time requiring Tillson to call for the tracker at 31 minutes.

Brace 5: ANJ's Ohio Hellion (Burchett) and WW's Gin and Tonic (Wice). This brace was turned loose just beyond Davis Bottom. Hank's performance was described above. Ginee made some nice moves along the edges in the Island Field and the last field before Horse Killer Hill. She proceeded up Horse Killer Hill and showed again on top of the hill in Little Vine Loop. After completing Little Vine Loop, Ginee had a divided find with Hank at the far end of the first field. Ginee was released and enjoyed her independence and wasn't seen again until we reached the fields after the Double Barns. Ginee finished her hour headed toward the far end of the Bull Pasture.

Brace 6: I'm Your Man (Patterson) and Turning Points Shenanigans (Burchett). The last brace of the day started near the beginning of the Bull Pasture. Neither dog was found standing until 22 minutes when Gus went on point at the end of the chute that leads back into Sycamore Bottom on course 3. Gus had a quail find at 59 minutes when Kent flushed a nice covey of quail along the left edge of the Breakaway Field. Gus also demonstrated the versatility of the American Brittany with his Ozark Grand Slam which in addition to quail, included turkey, armadillo and deer finds during his hour. Shandi checked back frequently with her handler during her hour on the ground and had a small covey find at 59 minutes on the right side of the first tree line at the end of the Breakaway Fields.

Day 2

Brace 7: Tequila Scorcher (Tillson) and Roustabout Blew By (Tracy). Dogs in the first brace of the day were released in the Breakaway Field. The wind made it difficult for Lincoln to decide which side of Davis

Bottom to hunt. At 23 minutes, he went on point in the tree line at the end of Davis Bottom. After his find, Lincoln looked nice on the right edge of Davis Bottom. After crossing the creek into the Island Field, Lincoln was lost and Tillson called for his tracker. Blew had a find at 14 minutes in the last tree line before the second creek crossing but true to its name, Blew was not seen after he entered Vacuum Hollow.

Brace 8: JWB Arctic Cat (Tracy) and Piney Run Hilltop Blew (Patterson). Dogs were released on Apple Tree Hill. Blew was next seen on the hill in Little Vine Loop and then disappeared for good. Kimber had a find a 13 minutes on top of the hill in Little Vine Loop. Kimber took the right edge after Sycamore Bottom and went on point at 32 minutes. Tommy flushed birds and fired with all in order. Kimber had another find in the fence line by the Double Barns at 45 minutes immediately followed by one on the right edge after passing the Double Barns. The judges were impressed with her style on this last find. Kimber finished forward near the far end of the Bull Pasture approaching Clymer's.

Brace 9: Arrow's Tequila Rustler (Beaver) and Roustabout All In (Tracy). Rusty made some nice moves on the edges but finished without birds. Al got off to a quick start with a find at 5 minutes in the tree line by the Blue House. This was followed by a stop to flush and a non-productive. Overall, Al was not pleasing his handler and Tommy elected to pick him up.

Brace 10: Treasure States Toby Mac Daddy (Tillson) and JJ's Levi The Lionheart (Tracy). Toby took off like a bat out of hell but was not seen thereafter. Levi took the left edge of the Breakaway Field and was rewarded with a find at 4 minutes. He had a second find in the creek bed just before crossing the road into Davis Bottom. Overall however, Levi's run was inconsistent and not up to par and Tommy elected to pick him up at 30 minutes just before the Island Field.

Brace 11: Roustabout Lil Pumpkin (Rosevear) and Sundance Kid's Rule Breaker (Campbell). Roustabout Lil Pumpkin was scratched and Sundance Kid's Rule Breaker was moved to Brace 25.

Brace 12: Piney Run Jake (Patterson) and Kashmir (Tracy). Dogs were released in the Island Field. Jake's performance was described above. Kash had trouble getting started and came from behind in the Island Field but still had a find at 6 minutes. Overall, Kash's run was inconsistent but he did go on point again at 57 minutes on the right edge near the end of the field after the Double Barns. However, birds were never flushed and he was given a non-productive.

Brace 13: Hoochie Coochie Man (Tillson) and CVK's Spartan King (Tracy). Dogs were released near the Blue House. Leo, a perennial winner, did not receive the memo that we were not going to go through Clymer's and was lost after the 10 minute mark. Karl worked at short range and had a difficult time staying forward. Tillson elected to pick him up early.

Day 3

Brace 14: Big Mac XIV (Tracy) and Sniksoh Windtuck Willy (Burchett). The first brace of day 3 pitted a youngster against a senior citizen- neither won out. Willy took off fast and furious but was not seen after the breakaway whereas Big Mac put up birds at 4 minutes on the left side of the Breakaway Field.

Brace 15: Scout Upland Trailblazer (Tillson) and Maxwell's Prickly Pete (Tracy). Dogs were released at the second tree line in Davis Bottom. After crossing the creek, Pete went up the hill just before Vacuum Hollow and was not seen again. Scout proceeded through the Island Field and had a find on the right edge just before the creek crossing opposite Horse Killer Hill. After his find, Scout went up Horse Killer Field, took the edge to the right, and was not seen again.

Brace 16: Rev'n Gunrunner's Tilly (Tillson) and JJ's Sir Walter

Raleigh (Tracy). Dogs were released at the start of Sycamore Bottom. Unfortunately, that was the last we saw of Tilly. Raleigh was doing a nice job on the ground. He hunted the right edge of Sycamore Bottom and then took the chute to the left that leads up to the Double Barns. Unfortunately, at 17 minutes Raleigh took out birds at the Double Barn and his day was done.

Brace 17: Just Call Me Lucky Ned Pepper (Campbell) and Ru-Jem's "Last" Penny (Tracy). The first brace of the afternoon was released in the Breakaway Field. Penny's performance was detailed above. After crossing the creek at the end of Davis Bottom, Lucky Ned was found on point in the milo on the left side of the field. Frank was unable to produce birds and was given a non-productive. Lucky Ned continued on through the Island Field, up Horse Killer Hill, and was found standing in the woods on the right side of the field. Frank flushed a large covey of birds with all in order. Judge Chenoweth commented that Lucky Ned did a phenomenal job on the ground- he was forward, on the edges, and made some huge moves. Unfortunately, Lucky Ned sat down during Frank's extensive flushing attempt on his non-productive and could not be used.

Brace 18: Osage Fork Slick (Burchett) and Georgia's White Lightning (Tracy). This brace was turned loose at the end of Little Vine Loop. Slick had a tough time keeping up with his handler but finally caught up with him at the Double Barns. He then went down the chute on course 3 and was not seen again. George's ground race was pretty erratic and Tommy elected to pick him up at the Double Barns.

Brace 19: HEH's Slim Shipley (Burchett) and JoWill's Daniel in the Lions Den (Tracy). Dogs were released by the large pond after the Double Barns. Slim had a find at 6 minutes in the Bull Pasture and then went forward on the left edge along the road. Slim continued forward on the course but failed to make the U-turn at the end of Bull Pasture and was last seen heading toward Clymer's. Bob called for the tracker at 26 minutes when we, but not Slim, got to the chute below the Double Barns. Raleigh went on point 45 seconds after the dogs were released but Tommy was unable to produce birds. At 6 minutes, Raleigh caught the front where his brace mate was standing. Unfortunately, he failed to back and his day was done.

Day 4

Brace 20: Crescent City Girl (Tillson) and Brendi Brooks Cowboy Up (Trimble). Nola was not in true form today. She had a stop to flush at 6 minutes on the right edge before the first creek crossing. Unfortunately, she released herself before the handler arrived and her day was over early. Tuff had a tuff day. His run was erratic and he seemed to be having a pretty good time doing his own thing. Ray elected to pick him up at the end of Davis Bottom.

Brace 21: JB's Full Speed Ahead (Tracy) and R&H Dark Night (Burchett). Dogs were released in the Island Field and Mac D was not seen thereafter. At 14 minutes, Captain had a covey find in the left edge of Apple Tree Hill and another at 21 minutes in the left edge of the last field in Course 1. Unfortunately, her run was a little erratic and she was picked up at 25 minutes.

Brace 22: Almaden's Under Lock And Key (Tillson) and Jagoub's Spell Caster (Tracy). Dogs were released at the start of Course 2. Oudi had a find at 18 minutes in the right edge of the last field in Sycamore Bottom and a back at 35 minutes. Unfortunately, Oudi also had a non-productive at 26 minutes just before the Double Barns and another in the tall grass as we entered the Bull Pasture and was picked up at 45 minutes. Tabu hit a hot spot in the course with finds at 35 minutes just before the Blue House, 37 minutes just before the Bull Pasture and at 40 minutes with a huge covey on the left side of the Bull Pasture. Tabu made

some nice casts but overall he hunted at modest range and had a difficult time staying to the front.

Brace 23: Prairie Wind Pistol Pete (Tracy) and Sniksoh Hank Gypsy Cruise (Burchett). The first brace of the afternoon was a short one for PD where he had trouble with birds shortly after breaking away. Cruise had a covey find at 13 minutes at the end of the field after the second creek crossing. Although he had a difficult time navigating the first part of Davis Bottom, he looked nice sticking to edge of the last field after the second tree line and went on point just before the creek crossing at the end of Davis Bottom. Unfortunately, Bob was unable to flush birds and Cruise was given a non-productive. Overall, Cruise worked at short range and his run was erratic and Bob elected to pick him up when we got to the gate at the top of Don Fox Hill.

Brace 24: Rebel's Fly Me To The Moon (Tillson) and Driving Miss Daisy II (Tracy). Moon is a little new to the game, had a hard time deciding what to do, and was picked up by Tillson at 24 minutes. With her brace mate chasing her, Daisee got off to a slow start but started to get going when she took an edge to the far right corner of the tree line near the end of Sycamore Bottom. Daisee continued forward on the right edge toward the road where we have been having finds throughout the week. Daisee then had the find of the stake at 29 minutes when she was found standing in the trees 60 feet up a near vertical hillside. To everyone's amazement, Tommy climbed the hillside, flushed birds, fired, and got back to Daisee with all in order. However, Daisee's slow start was too much to overcome and Tommy elected to pick her up.

Brace 25: Roustabout Eustace (Capstick) and Sundance Kid's Rule Breaker (Campbell). The last brace of the stake started on the right edge where Daisee finished. "T" looked nice continuing on the right edge and completed rimming the last field before turning toward the Double Barns. At 2 minutes, "T" was found standing by the pond near the Double Gates. Dave walked into the thick briars and flushed a huge covey of quail in which birds exploded in 3 separate waves. Dave took "T" forward and caught up with Bud near the Double Barns. Both dogs took the left edge

toward the Blue House where birds are typically found. Unfortunately, neither was able to handle the trusty birds that reside in this location. And the 2020 ABC Quail Classic/Championship was concluded.

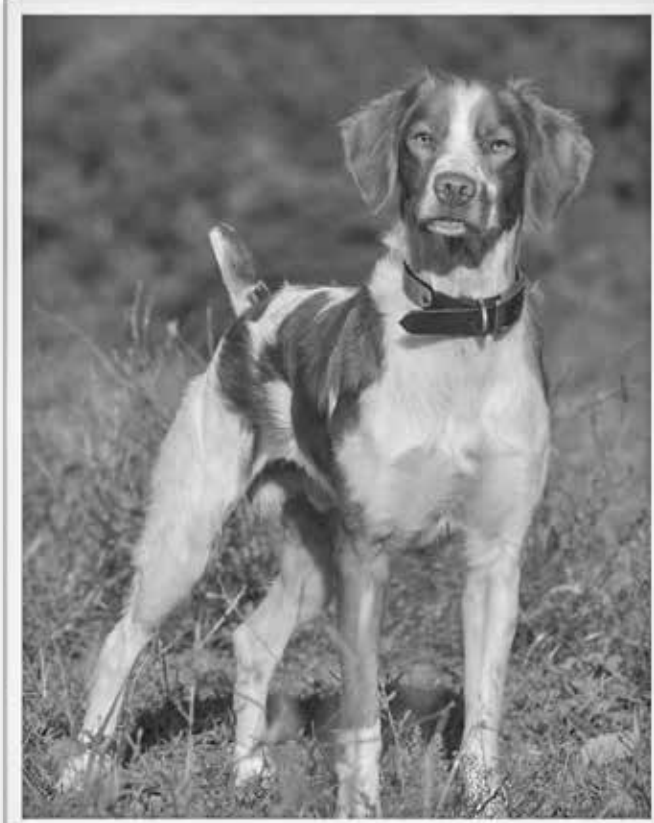
