The very first funny from Judge Will Smith after our introduction on the first day, first brace of the 2020 American Brittany Club National Amateur Championship. There were more Will jokes interspersed throughout this Championship, delivered unexpectedly and always when I needed a good laugh. Weather for the four-day event was pretty consistent on a daily basis and included coldish mornings, mild afternoons and gusty variable winds. In spite of Covid-19, entries in both the Amateur and Open All Age Championships were only slightly below the 2019 entries. 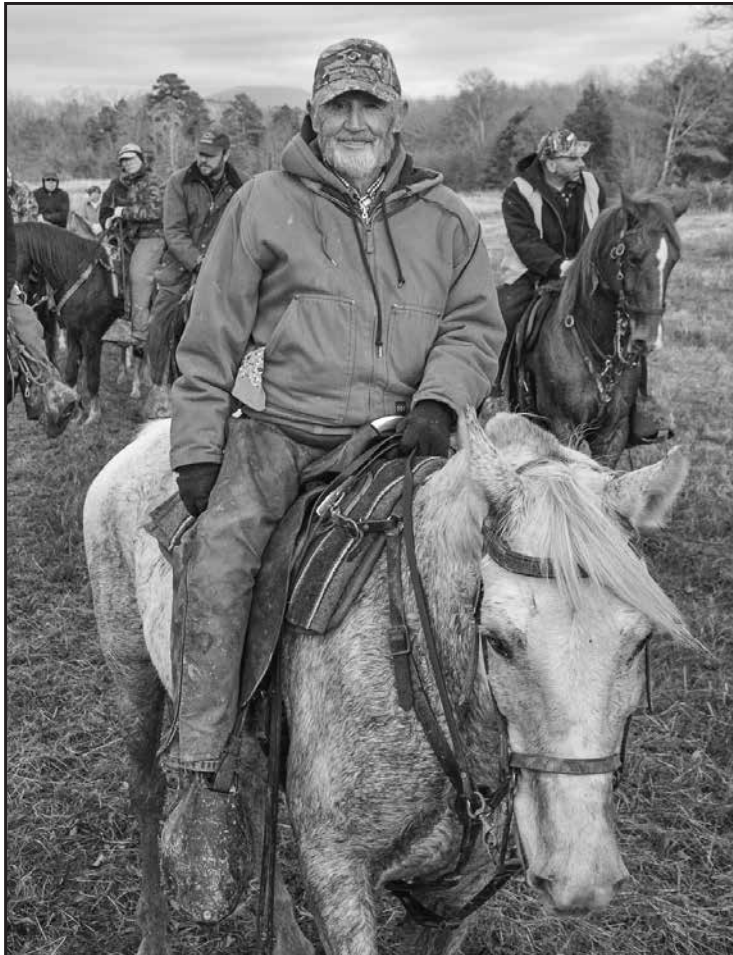

Sunday evening Judi Button provided a welcoming dinner which was followed by the lively Amateur All Age Championship Calcutta where the charismatic Joe Gower served as Auctioneer and used humor and dog/handler/owner stories to keep the crowd entertained and drive the bidding. A big thanks to Joe. Tuesday evening, we gathered at the Clubhouse to celebrate the 2019 National



Amateur Champion NAFC/GFC/ FC/GAFC/AFC Ru-Jem's Last Penny. Jerry McGee was a delightful host with lots of Penny stories. The tables were decorated with seasonal-colored flowers, ceramic pheasants and of course, gold wrapped chocolate pennies. The generous hosted bar and a fried chicken dinner with all the fixings were enjoyed by all and we gave thanks to Jerry and crew for a most enjoyable evening. On Wednesday, the All-Age National Silent Auction began after dinner and continued until all the donated items were rehomed. Thursday was Thanksgiving Day and after running the final brace, placements announced and awards presented, a mouth-watering Thanksgiving feast was served up followed by the annual membership meeting. On Friday the ABC All Age Derby Invitational was run and will be reported separately. Saturday FC/AFC Cvk's Spartan King "Leo" handled by Jack Alexander and owned by Jack Alexander & Bob Rankin received the coveted Purina Amateur All Age Dog of the Year Award. Winner of the Purina Open All Age Dog of the Year Award was FC/AFC Jwb Arctic Cat "Kimber" handled by Jack Alexander and owned by Jack & Crystal Alexander. Crystal made an insightful acceptance speech outlining life on the road while chasing those Championship points and thanking everyone for all their help and encouragement throughout this 2020 field trial season. What a special night for the owners of these two amazing dogs.

Judges for the National Amateur this year were Bonnie Hidalgo of Brighton, CO and William Smith of Moscow, TN. Both are well respected for their knowledge of bird dogs and field trialing. We thank them for their many hours in the saddle and the positive learned consideration they afforded each and every dog. Their attention and focus never wavered over the course of the trial and we thank them for their professionalism and commitment. Both expressed their desire to see dogs with a robust



distant race as well as one that exhibited intensity, high style and good manners on their birds. Those dogs chosen who best represented their ideals are listed below:

The Recognized:

Champion: Top Dog Brace 17 FC BLEW ME AWAY "BUD", Handler: Joe Gower; Owners, Norm and Terry Ahl. Bud is a 5-year-old white and orange male out of NAFC/GFC/FC/AFC Spanish Corral's Sundance Kid and FC Blew By Yet? After a short-lived loop-de-do during the first 5 minutes of his hour Bud started showing the judges what they were looking for as he straightened out and surged to the front making long fast casts down the edges and hunting all objectives near and far. Bud looked like a million bucks on his 2 covey finds, the first at 30 and another at 50 both of which he handled with intense style and perfect manners. Bud finished as strong as he started, moving rapidly to the front rightfully earning himself the coveted title of 2020 National Amateur Champion.

RU Champion: Bottom Dog Brace 17b GFC/FC/AFC/DC TEQUILA SCORCHER "LINCOLN", Handler: Richard Beaver; Owner, Charles "Bernie" Crain. Lincoln is a 10-year-old orange & white male out of DC Almaden's River of Shadows and DC/AFC Tequila With A Twist. Lincoln is no stranger to the winner's podium at these Nationals having been there in 2018 with a 4th place in the National Open Championship. Lincoln, a real field trial veteran, ran an intelligent forward race reaching for all objectives in his search for birds. His one bird find occurred at 45 where he was observed standing tall and tight along the tall grassy outside edge of Parish Field. Lincoln maintained stately manners through a prolonged flush and shot. As he moved forward Lincoln finished his hour moving at a practical range and speed still hunting hard.

3rd: Bottom Dog Brace 3b: FC/AFC Jwb Arctic Cat "Kimber", Handler: Jack Alexander, Owners: Jack and Crystal Alexander. Kimber is





a 4-year-old orange and white female out of Maxwell's Outer Limits and Chancey's Frozen Asset. Kimber had a successful 2020 field trial season and was awarded the 2020 Purina All Age Dog of the Year for all her solid consistent efforts. Kimber's winning style was displayed at this event with snappy far-reaching casts and intense style on her two covey finds, one at 25 and the other at 30. A non-productive was logged at 43 when birds could not be located in a heavily snarled tree line but Kimber exhibited perfect manners through the search and relocation. Kimber finished her hour moving forward fast with enthusiasm and energy to spare.

4th: Bottom Dog Brace 2: NAFC/GFC/GAFC/FC/AFC Spanish Corral's Sonny "Patch", Handler/Owner: Joe Gower. Patch is a 9-year-old white and orange out of NAFC, GFC, FC, AFC Spanish Corral's Sundance Kid and CH/AFC Midas Blazin Amber Skies. Patch was the 2015 NAFC Champion and has returned every year since, placing 3rd in 2018. Patch was hunting hard from the get go and scored his first find at 15 which he handled with style and manners. Patch locked up at 32 while traversing the river's edge where a large covey took flight as the handler made his way into the area with Patch standing tall and tight through the flush and shot. At 50 Patch pointed into some heavy, hard to penetrate undergrowth at the road edge and it didn't take long for handler to decide to move him on down the road. Patch finished to the front moving at a judicious rate and range.

The Running

First Day, Monday November 23, 2020, 2-hour fog delay; Temp range 40 to 58, light variable winds.

Brace 1: Cvk's Spartan King "Leo", Jack Alexander & Spanish Dancer "Sassy", Robbie Myers. Both dogs loaded with a full head of steam had handlers dispatching their scouts in both directions of Course 1. In the vicinity of the big oak a call of point was heard deep from the right side of the road and as we approached Leo was observed standing staunchly into some tall grass off a narrow game trail. Handler flushed a small covey and Leo whirled around taking a few steps to follow their flight and was picked up for this indiscretion. There had been no sighting of Sassy since the breakaway and judges called time-out for her at 10:15.

Brace 2: Maxwell's Heavy Hitter "Gabe ", Kevin Rogers & Spanish Corral's Sunny "Patch", Joe Gower. Gabe and Patch start working hard from the get go in search of birds. Patch's run is described in the Recognized section above. In spite of Gabe's determined and strong hunting pattern throughout his hour he never had any bird contact.

Brace 3: Crescent City Girl "Nola", Barry Steinmetz & Jwb Arctic Cat, "Kimber" Jack Alexander. Nola and Kimber are two remarkable female athletics that are always gallery pleasers when they run. Kimber's run is described in the Recognized section above. Unfortunately, Nola, though patterning the cover like a pro never had bird contact during her hour.

Brace 4: Chiefs Cross Plains "Copper" Breeze, Craig Rucker & Jagoub's Spell Caster, "Tabu", Tom Jagielski. First brace of the afternoon was cut short when Copper was seen under a large covey on the left side of the road at 20. These birds flew in every direction and Tabu who had been diligently hunting the right side of the road ran over a quail and failed to stop thus ending her run at 21. The dogs were gathered up and we crossed Lick Creek for the breakaway of Brace 5.

Brace 5: ANJ's Ohio Hellion "Hank", Mike Poehler & Piney Run Hilltop "Blew", Kent Patterson. Hank and Blew broke away after the Lick Creek crossing, Hank casting to the left and Blew the right. At 5 point was called for Blew deep down the right side treeline but handler was unable to produce any birds so Blew was moved on. At 15 Hank was observed on point in a heavily wooded treeline down the left side of the road. Handler disturbed the running birds enough for the judge to see them then fired the shot with all in order. After rejoining the front forward judge advised

Blew had an orderly find at 23 in the vicinity of the double gates. Hank moved forward hunting hard but had no further bird contact. Blew had another point at 58 but no birds could be located and time was called.

Brace 6: Driving Miss Daisy II "Daisee", Burton Wice & Marjo's Fille De La Bretagne "Brie", John Perry. Daisee and Brie shared a find at 5 with all in order. Brie pointed at

40 just after crossing the Horse Bridge in the center mott at the start of Course 3. A bird was flushed, shot fired with all in order. At 30 Daisee was found leashed and enjoying a mud bath so obviously her time on the ground was finished. Brie pointed at 55 in a wooded gully adjacent to the road and after much searching, running birds were observed by the judge and Brie given credit for another nice find just before time was called.

Day 2, Tuesday, November 24, Temp range 36 to 58, with light variable winds.

Brace 7: Wild Wild "Willie", Steve Cosgriff & Sniksoh Little Diamond "Kate", Bruce Heiter. Kate went flying to the opened gate on the right and was not seen for an extended time. Willie got right to work pointing a big covey at 5 where he spun around on the flush but made no forward motion so was moved on. Just in the nick of time, she showed up, checked in and continued her run. At 37 Kate and Willie shared a find with both dogs exhibiting good manners. Willie pointed again at 55 but self-relocated on the extended search and was ordered up. Kate finished her hour showing signs of fatigue.

Brace 8: Rusty Ridge Where U "Been", Joe Gower & MK's My Lil Ammo, "BB", Nick Blasi. Been and BB had their running shoes on this brace. Been's first cast put him well out of the gallery view but he rejoined up at the old bridge and proceeded to run the big loop in Olympic time. Instead of making a right turn onto the course road Been went straight ahead into the man-eating tangles where he encountered a huge covey which led to his demise. BB ran an animated forward race not letting a single objective go unsearched. BB exhibited all the traits these judges were looking for in an all-age performance but was not rewarded with any bird work. Because of her superior ground effort, the judges awarded her a "Judges Award of Merit."

Brace 9: Piney Run "Jake", Kent Patterson & Diamond Hill Ain't My Fault "Scout", Lisa Pollack. Jake ran a big race, perhaps too big and stealthy, as the retrieval device was called for at 50 after an extended absence. Scout was running a moderate race and had a nice find at 38 with all in order but at 50 he was observed under a covey thus ending his run.

Brace 10: Tnt's Raise A Leprechaun, "Dex", Tommy Thomas & TJ's Black Diamond "Coal", John Perry. Both dogs hunted hard over Course 1 with Coal having a clean covey find at 30. Both dogs were observed pointing in separate areas of an overgrown feed strip just off the road. Dex took too many steps on the flush at 40 thus ending his hour. Birds could not be located for Coal so handler moved him out of the area. Coal continued hunting hard but slowed down towards the end of his hour.

Brace 11: Spanish Corral's Big Iron "Colt", Joe Gower & B & T's Sonndance Kid Rock "Rocky", Trasa Fowler. Rocky was a bit growly on the breakaway but Colt paid him no mind just turned on the afterburners leaving him to resolve his own aggravation which he did by chasing birds at 10. Colt continued forward, running the lines and going to all objectives in a pleasing all age application but encountered no birds.

Brace 12: Brigadoon's Hi Proof Moonshine "Hooch", John Perry & Ru Jems "Last" "Penny", Steve Ralph. Penny was a bird finding machine this brace. Her first find came at 3 in the center mott just minutes from the breakaway. Hooch came through running right past her and was

picked up for failure to honor. Penny worked the birds with impeccable manners and was moved on. Penny's snappy fast casts took her to all the right places as she continued her bird finding ways, posting clean finds at 20, 30, 32 and 35 all handled with impeccable style and manners. Penny was found standing again at 45 but as the handler approached, she took a few steps which pushed the birds up thus ending her hour.

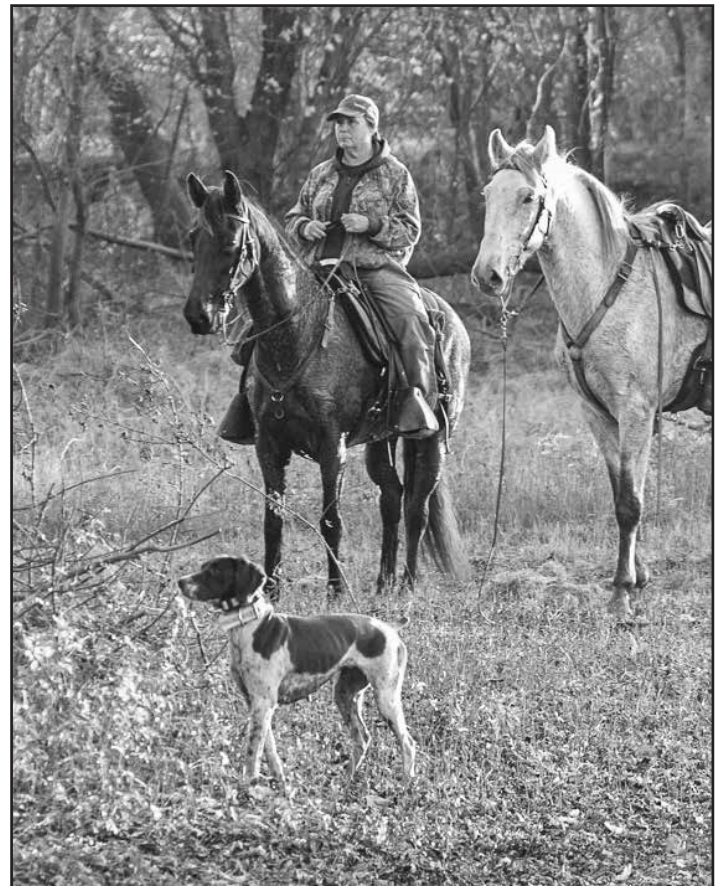
Day 3, Wednesday, Nov 25, Temp range 36 to 58, light variable winds.

Brace 13: Turning Points Shenanigans "Shandi", Julie Nelson & Just Call Me Lucky "Ned" Pepper, Frank Campbell. Just after the Lick Creek Crossing Shandi was found on point at 18 under a big cedar. After an exhaustive search and relocation Shandi stepped on a bird out in the open which flew out of the area. Shandi received a stop to flush for her effort and was moved forward. Ned's one bird find came at 38 and after an thorough search and relocation the running birds were spotted, the shot fired with all in order. Both dogs finished the hour hunting hard to the front.

Brace 14: Carpe Diem "Carp", David Lincoln & Lambachs Blew By You "Blue", Kevin Rogers. Carp took off fast, was briefly seen at 18 then disappeared for good. Blue took off with purpose and had his first covey find at 15 where he showed intensity and style through the flush and shot. At 18 Blue stood majestically, surrounded by a large covey in a heavily tangled meadow in Parrish Field. Handler flushed a large covey with Blue exhibiting perfect manners through the shot. Blue was released and headed for an unknown destination and was never returned to judgment.

Brace 15: Gun Creek Gangster "Doc", Donna Janulis & Farm Girl "Pearl", Bruce Heiter. Pearl pointed briefly at 10 but pushed the birds up before handler flushed so she was through for the day. Doc handled pleasantly and had a nice covey find at 30. He then made a big move and was observed under a covey by the handler who picked him up at 38.

Brace 16: Hurricane "Banjo", Rodger Fiorito. Running as a solo





Banjo found birds at 15 and 35 which he handled with intensity, style and good manners but his overall run fell short of what the judges were looking for in an all-age performance.

Brace 17: Blew Me Away “Bud”, Joe Gower & Tequila Scorcher “Lincoln”, Richard Beaver. Champion and RU Champion runs are described in The Recognized section above.

Brace 18: El Grande “Truman”, Robbie Myers & Sr’s Blew By Typhoon “TY”, Joe Gower. Ty made short work of his time by pushing birds up at 2 in the center mott just after breakaway. Truman was unable to get his mojo going so handler elected to pick him up at 40.

Day 4: Thanksgiving Day, Nov 26, Temp range 36 to 58, light variable winds.

Brace 19: Mk’s Magnificent Bandito “Chico”, Dave Lincoln & Brendi Brooks Cowboy Up “Tuff”, Ray Trimble. Chico broke away fast and forward. At 30 the retrieval device was handed over. Tuff ran his



heart out for Ray. There is a distinct visible bond between this dog and his handler. Tuff had two nice covey finds; one at 10 and another at 20, both being handled with style and manners. Tuff had a remarkable finish that had me and most of the gallery mesmerized. It wasn’t a powerful cast but the fluidity and length of it made it easy on the eyes. Tuff and Ray worked in synch as Tuff crossed over from the river’s edge to the far tree line which runs parallel to the lane then crossed the road to the far treeline which he ran to the end just as time was called. At the request of the judges, I rode over to tell Ray time was up and congratulated him and Tuff for a finish well done. I then lifted Tuff up onto his Scout’s saddle for a much-deserved ride to the dog wagon.

Brace 20: Alleycat’s “Drought”, Stan Williamson & Skf Miss Cheap Bourbon Whiskey “KD”, Steven Foster. Drought and KD shared a divided find on a big covey at 20 with all in order. Drought pushed a covey at 55 to end his hour. KD finished her hour but her application had become erratic.

Brace 21: High Hopes Jac’s Original “Spice”, Ron Gulembo

& Arrow’s Tequila Rustler “Rusty”, Richard Beaver. Spice had an inconsistent run with a back at 50. Rusty started out slowly but began making some excellent moves over the woody, winding Course 3 terrain. Rusty logged a nonproductive at 50 but had no bird contact during his hour.

Breed Standard for the Brittany

General Appearance: A compact, closely knit dog of medium size, a leggy dog having the appearance, as well as the agility, of a great ground coverer. Strong, vigorous, energetic and quick of movement. Ruggedness, without clumsiness, is a characteristic of the breed. He can be tailless or has a tail docked to approximately four inches.

Size, Proportion, Substance: Height: 17 1/2 to 20 1/2 inches, measured from the ground to the highest point of the shoulders. Any Brittany measuring under 17 1/2 inches or over 20 1/2 inches shall be disqualified from dog show competition.

Weight: Should weigh between 30 and 40 pounds.

Proportion: So leggy is he that his height at the shoulders is the same as the length of his body.

Body Length: Approximately the same as the height when measured at the shoulders. Body length is measured from the point of the forechest to the rear of the rump. A long body should be heavily penalized.

Substance: Not too light in bone, yet never heavy-boned and cumbersome.

Head

Expression: Alert and eager, but with the soft expression of a bird dog.

Eyes: Well set in head. Well protected from briars by a heavy, expressive eyebrow. A prominent, full or pop eye should be heavily penalized. It is a serious fault in a dog that must face briars. Skull well chiseled under the eyes, so that the lower lid is not pulled back to form a pocket or haw that would catch seeds, dirt and weed dust. Preference should be for the darker colored eyes, though lighter shades of amber should not be penalized. Light and mean-looking eyes should be heavily penalized.

Ears: Set high, above the level of the eyes. Short and triangular, rather than pendulous, reaching about half the length of the muzzle. Should lie flat and close to the head, with the tip rounded very slightly. Ears well covered with dense, but relatively short hair, and with little fringe.

Skull: Medium length, rounded, very slightly wedge-shaped, but evenly made. Width, not quite as wide as the length and never so broad as to appear coarse, or so narrow as to appear racy. Well defined but gently sloping stop. Median line rather indistinct. The occiput only apparent to the touch. Lateral walls well rounded. The Brittany should never be "apple-headed" and he should never have an indented stop.

Muzzle: Medium length, about two-thirds the length of the skull, measuring the muzzle from the tip to the stop, and the skull from the occiput to the stop. Muzzle should taper gradually in both horizontal and vertical dimensions as it approaches the nostrils. Neither a Roman nose nor a dish-face is desirable. Never broad, heavy or snipy.

Nose: Nostrils well open to permit deep breathing of air and adequate scenting. Tight nostrils should be penalized. Never shiny. Color: fawn, tan, shades of brown or deep pink. A black nose is a disqualification. A two-tone or butterfly nose should be penalized.

Lips: Tight, the upper lip overlapping the lower jaw just to cover the lower lip. Lips dry, so that feathers will not stick. Drooling to be heavily penalized. Flews to be penalized.

Bite: A true scissors bite. Overshot or undershot jaw to be heavily penalized.

Neck, Topline, Body

Neck: Medium length. Free from throatiness, though not a serious fault unless accompanied by dewlaps, strong without giving the impression of being over-muscled. Well set into sloping shoulders. Never concave or ewe-necked.

Topline: Slight slope from the highest point of the shoulders to the root of the tail.

Chest: Deep, reaching the level of the elbow. Neither so wide nor so rounded as to disturb the placement of the shoulders and elbows. Ribs well sprung. Adequate heart room provided by depth as well as width. Narrow or slab-sided chests area fault.

Back: Short and straight. Never hollow, saddle, sway or roach backed. Slight drop from the hips to the root of the tail.

Flanks: Rounded. Fairly full. Not extremely tucked up, or flabby and falling. Loins short and strong. Distance from last rib to upper thigh short, about three to four fingers widths. Narrow and weak loins are a fault. In motion, the loin should not sway sideways, giving a zig-zag motion to the back, wasting energy.

Tail: Tailless to approximately four inches, natural or docked. The tail not to be so long as to affect the over-all balance of the dog. Set on high, actually an extension of the spine at about the same level. Any tail substantially more than four inches shall be severely penalized.

Forequarters

Shoulders: Shoulder blades should not protrude too much, not too wide apart, with perhaps two thumbs' width between. Sloping and muscular. Blade and upper arm should form nearly a ninety degree angle. Straight shoulders are a fault. At the shoulders the Brittany is slightly higher than at the rump.

Front Legs: Viewed from the front, perpendicular, but not set too wide. Elbows and feet turning neither in nor out. Pasterns slightly sloped. Down

in pasterns is a serious fault. Leg bones clean, graceful, but not too fine. Extremely heavy bone is as much a fault as spindly legs. One must look for substance and suppleness. Height at elbows should approximately equal distance from elbow to withers.

Feet: Should be strong, proportionately smaller than the spaniels', with close fitting, well arched toes and thick pads. The Brittany is "not up on his toes." Toes not heavily feathered. Flat feet, splayed feet, paper feet, etc., are to be heavily penalized. An ideal foot is halfway between the hare and the cat foot. Dewclaws may be removed.

Hindquarters: Broad strong and muscular, with powerful thighs and well bent stifles, giving the angulation necessary for powerful drive.

Hind Legs: Stifles well bent. The stifle should not be so angulated as to place the hock joint far out

Feet: Same as front feet.

Coat: Dense, flat or wavy, never curly. Texture neither wiry nor silky. Ears should carry little fringe. The front and hind legs should have some feathering, but too little is definitely preferable to too much. Dogs with long or profuse feathering or furnishings shall be so severely penalized as to effectively eliminate them from competition.

Skin: Fine and fairly loose. A loose skin rolls with briars and sticks, thus diminishing punctures or tearing. A skin so loose as to form pouches is undesirable.

Color: Orange and white or liver and white in either clear or roan patterns. Some ticking is desirable. The orange or liver is found in the standard parti-color or piebald patterns. Washed out colors are not desirable. Tri-colors are allowed but not preferred. A tri-color is a liver and white dog with classic orange markings on eyebrows, muzzle and cheeks, inside the ears and under the tail, freckles on the lower legs are orange. Anything exceeding the limits of these marking shall be severely penalized. Black is a disqualification.

Gait: When at a trot the Brittany's hind foot should step into or beyond the print left by the front foot. Clean movement, coming and going, is very important, but most important is side gait, which is smooth, efficient and ground covering.

Temperament: A happy, alert dog, neither mean nor shy.

Disqualifications :Any Brittany measuring under 17 1/2 inches or over 20 1/2 inches. Black in the coat. A black nose.

The above Standard was approved by the AKC on April 9, 1990 and went into effect May 29, 1990.

3rd: Top Dog Brace 2: CVK's Jungle Land 'Clarence', Handler: Tom Tracy, Owners: Raus Tracy, Nebraska & Bo Ackerman, Georgia. Clarence, white/orange male out of GFC FC Maxwell's Prickly Pete and Dakota Sage

The Running:

Brace 1a Urban American Legend, Handler Steve Chang Owner: Alan Morrison

2b 'Sugar' Sweet Whizki, Handler: Bob Burchett, Owner: Phil Witter

Sugar pointed at 10 handling the flush and shot with acceptable derby manners. Sugar appeared to lose her focus and began exhibiting an

erratic application so handler picked her up at 25. Legend began his run a bird finding machine posting three nice finds at 13, 23 and 30. He handled these birds with stylish points and almost broke derby manners. After this point Legend began a series of short stops pointing into likely objectives along the road just a short distance from the double gates. This incident produced nonproductives at 34 & 40. Handler finally got him to leave this area but he continued this sticky behavior down the road so handler picked him up at 50.

Brace 2a CVK's Jungle Land 'Clarence', Handler: Tom Tracy, Owners: Raus Tracy/Bo Ackerman

2b Perro Pajaro 'Uno', Handler: Scott Johnson, Owner: Justin Hagedorn

Decision was made to breakaway Brace 2 at the Double Gates and they were away at 9. Clarence and Uno broke away making big fast casts towards the River's edge when both suddenly veered back toward the double gates. After a lot of loud whistling and hard scouting both came back in, with Clarence shooting towards the rivers edge and Uno staying in the treeline on the right side of the course. Clarence made it to the horse bridge in short order, crossed over and began working Course 2 in a fast efficient manner. Uno disappeared before the bridge so handler moved on across calling loudly while the scout intensified his search. At 20 Clarence pointed briefly then put up a good size covey which he chased but regained the front when he heard the shot and his handler's whistle. It was reported that Uno found his way to Course 2 and had a find at 20 while trying to catch the front. Clarence had another covey find at 23 pointing briefly and exhibiting acceptable derby manners on the flush and fire. Clarence then had a near broke find at 35 standing staunchly and allowed the handler to move in front of him to flush and fire. At this same time Uno was picked up since his compass was not functioning in a forward direction. Clarence pointed for the last time at 45 in a thick overgrown mott, self-released several times but couldn't find any birds so handler whistled him forward and he finished his hour still hunting hard. For his efforts he was awarded a well-earned 3rd place finish.

Brace 3a JB's Cajun Hot Pepper 'Spice', Handler: Tom Tracy, Owner: Jennifer & Chezney Pollman

3b Anj's 'Georgia' Hellion, Handler: Bob Burchett; Owner:
Spice and Georgia took off together at a good clip but stayed in touch with their handlers. They pointed simultaneously but in separate areas of a long treeline at 15. Spice put some birds up so handler fired and moved her out of the area. Georgia kept searching but never made bird contact so was moved on to rejoin the front. Spice pointed again at 35 but no birds were found so she was moved on. Both dogs pointed a small covey at 45 and after flushing and chasing both got back to the front finishing their hour showing signs of weariness.

Brace 4a Jagoub's Whodatsay 'Whodat' When I Say Whodat? Handler/Owners: Tom & Debra Jagielski

4b TNT's Handsome 'Harry', Handler: Bob Burchett; Owner: Tommy & Linda Thomas

Whodat pointed at 5 but no birds were found so he was moved on. Both dogs pointed the same birds at 35 and gave chase before the flush and shot. After shots were fired and all was in order the dogs were moved on down the road. At 50 Harry was picked up for not pleasing his handler. Whodat finished his hour slower than he started but still hunting hard.

Brace 5a Frosty Meadows Ramblin' Man 'Bo', Handler/Owners: Amy & Nathan Hopper

5b Been There 'Tip', Handler: Tom Tracy; Owners: Bob Rankin/

Tom Milam & Linda Milam

These two speed demons caught everyone's attention with an exploding independent breakaway. Bo took off into the horseshoe and it took awhile for the scout to round him up. Meanwhile Tip made a long cast down the right treeline when he locked up at 15 pointing staunchly before flushing the birds. Handler called him back to the front and he was off like a rocket. About this time Bo's scout had Bo back on course and to the front and he immediately started finding birds. Bo was making all the right moves down both sides of the course and was rewarded with covey finds at 20, 30 and 35 which he pointed staunchly and handled with acceptable derby manners. Meanwhile Tip was covering the course in and out of the woods hunting hard. He scored another find at 43 when he pointed a flighty single at the base of a tall pine tree who took to flight straight up the tree trunk and landed on an overhanging branch. Tip locked up even tighter with his head slightly inclined and handler moved in, gave the tree a little bump and off flew the bird with Tip turning to mark but remaining in place until handler took him by the collar and moved him forward. Tip continued working the course in winning form and finished his hour to the front stronger than when he started. The last 20 minutes of Bo's race took a lot of loud handling to keep him straight and forward on the course. Bo had his 4th find @ time and handler expressed relief that his hour was up. For their efforts Tip earned the Champion title and Bo Runner Up Champion.

Brace 6a Dogwood's Fireball 'Whiski', Handler: Bob Burchett; Owner: Todd Parmenter

6b Rusty Ridge Busting Loose 'Buster', Handler/Owners: Claude & Jan Kilpatrick

Whiski had a long absence after the breakaway and rejoined at 20 where he stopped to point a bird which he handled with acceptable manners. Whiski was brought to the front for a few minutes but he was last seen making a huge cast towards Course 1 and never returned to judgment. Buster wasn't running his usual bold race this day nonetheless he had a smooth, effortless way of moving across the course never letting up but his casts were short which kept him way too handy to be considered in spite of 4 nice bird finds at 4, 8, 20 and 45.

With the 2020 ABC Derby Invitational completed we head towards camp to hear the placements.

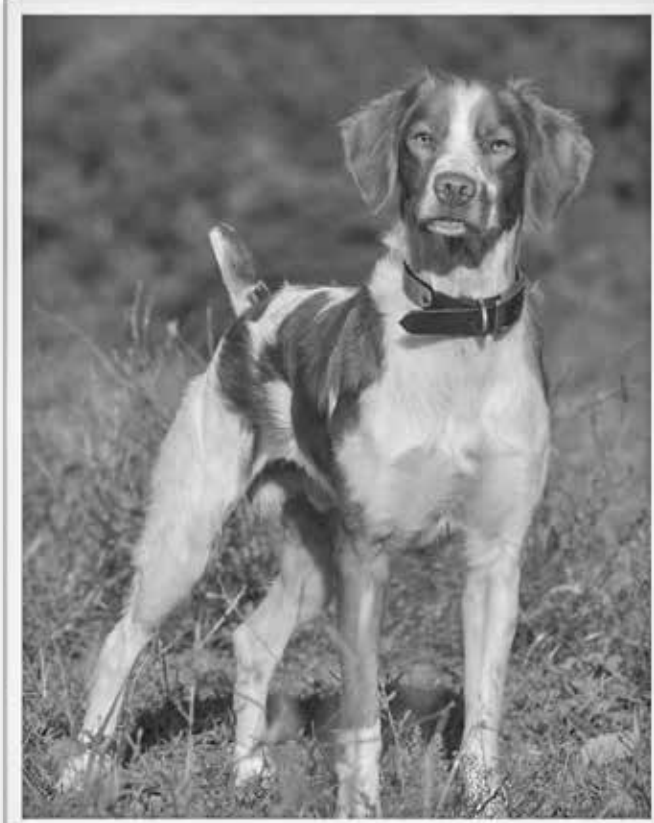

ABC Grouse & Woodcock Classic/Championship



PURINA

This year's Classic was originally scheduled to be run this spring in Rhode Island, hosted by The New England Brittany Championship Assoc. Due to COVID-19 restrictions they were unable to run the Classic as scheduled. Badger Brittany Club was asked to host the Classic and scheduled the trial for an October 9th start in Augusta, WI. Jim Brigham a long-time grouse trial enthusiast accepted the leadership role. A team of Badger Brittany Club members came up this summer to help clear trails in preparation for the fall Classic.

A wet heavy Easter Sunday snow storm broke off trees, snapped limbs and flattened brush leaving our trail system in a mess. It took eight work days and some extra last-minute effort to restore our trails to Championship standards. Birds were relatively plentiful Grouse recovered from last years low with good breeding and nesting weather. Woodcock did well and small groups of flight birds had dropped in for the Championship. Three other Championships were run on these grounds prior to the ABC. All had ample birds giving plenty of opportunity for class bird work on wild birds. COVID-19 did have a significant impact on entries this year with numerous handlers electing to "sit this one out."

Our two judges are both well-seasoned grouse hunters, field trailers and no strangers to the winner's circle. Brent Sittlow of

Hudson, WI – President of the Chippewa Valley Grouse Dog Association sponsor along with Badger Brittany for this trial partnered with Neil Boos of Chippewa Falls, WI. Neil has been training dogs as a profession for many years and has experience with multiple pointing breeds. He is very involved with neighboring club to the north "Moose" which sponsors numerous native bird continuous course events. Needless to say, both Neil and Brent have a vast amount of experience and both did an outstanding job of adjudicating all braces. The placements were well received.

We always appreciate the support of our sponsors Purina & Garmin. Their support adds greatly to the overall success of the trial. It's very evident that the owners and handlers believe in their products as most the dogs were collared with Garmin GPS units and many owners feed Purina to fuel healthy and winning dogs. The Winner received a Garmin Pro 550 Plus/TT15 system and all winners received multiple bags of Purina Pro Plan Performance. A huge thank you goes to Eau Claire County without our partnership with them we would not be able to host these trials. The collaborative cooperation relationship we have with Eau Claire County Parks Director Josh Peterson and his staff Jody Gindt, Jake Tumm and others is outstanding and much appreciated. Eau Claire County has over 50,000 acres of

public forest and we are very fortunate to be able to be one of the many groups utilizing this fine resource.

The Winners

Rib River Tough Enough Two wins the 2020 ABC Grouse & Woodcock Classic. Tuffy a 5-year-old male clearly dominated this year's championship with a strong, forward race in promising cover. Tuffy carded two mixed finds (grouse and woodcock) and two woodcock finds. Tuffy is owned and handled by Roger King of Wausau, WI. Runner up was awarded to MJ's Sweet Sugar Magnolia a 12-year-old female owned and handled by Mike Dally of Appleton, WI. Maggie is no stranger to the winner's platform. Last year she won the Classic. This year she earned her 4th runner up. She is a prolific bird finder, pointing a woodcock at 6 and a stop to flush on a woodcock at time. Her race was strong more like a dog half her age. 3rd place was earned by Bark River Fresh Water Pearl (Pearl) handled by Jeff Stanton She hunted hard at a nice pace for the full hour.

The Running

The first brace broke away at 7:30 AM. The starting temperature was 49 warming up to 70 for the last brace and light winds prevailed throughout the day. **MJ's Box of Rain (Rainy) – Mike Dally and Biscuits Buddha Banshee (Buddha) – Tom Jagielski** on the Highline Course both marking one big cast after the other. Mike called point for Rainy at 11 but waved it off as he approached. Both dogs stayed in good cover with no let down at 30 the gallery moved a woodcock along the river.

The second brace broke away on the Horse Creek Course with Red Granite's I am a Rock (Rocky) – Julie Asmus and Bark River Fresh Water Pearl (Pearl) – Jeff Stanton. This is a "loop" course along the Horse Creek and Eau Claire River. Five woodcock and one grouse were moved on this brace. The gallery moved a grouse to the right of the course shortly after break away. Pearl had woodcock funds at 8 and at 12 in the full view of the gallery. At 18 the gallery moved a woodcock in dense hazel brush. At 37 Jeff put a woodcock to flight after an extended flushing effort Pearl steady and stanch. Jeff called point at 41, flushed then sent Pearl on without bird contact. With minutes left Pearl pointed again not knowing the woodcock had already departed prior to her arrival. Pearl ran well at a hunting dog pace. Rocky was the stronger of the two, making many big forwards casts. Unfortunately, he had no bird contacts.

The third brace was the "H" course which is a "figure 8" course mostly in good river bottom cover along the Eau Claire River. Rib River Tough Enough II (Tuffy) – Roger King, Wausau, WI and Repeat's Little 501 Blues (Levi) - Julie Asmus took off like a shot and mostly kept it up for the balance of the brace at 8 Tuffy stopped to point into tag alder cover with a slight tail flag, indicating he was a bit unsure. Roger made a brief flushing effort and sent him on. Seconds later, first a woodcock, then a grouse erupted from the tags with Tuffy making a mannerly stop to flush. Roger fired, all in order. At 18 both dogs made big back casts and were bullish about returning to the front. At 22 in

the river bottom, Tuffy pointed, Roger flushed, no bird produced. At 33 Tuffy pointed again, 40 yards to the right of the trail. As Roger went in a big brown phase grouse blew out from under an oak deadfall. Roger shot, Tuffy stayed steady only for Roger to find a woodcock in front of the dog that flushed out at his approach. All in order. At 35 Tuffy nailed another woodcock. At 42 both dogs were out on a limb in hazel brush cover on the right. Tuffy's bell stopped at 45 it took eight minutes to find him, Roger found him standing tall on a really nice woodcock find Levi stayed ahead, hunting hard. Both dogs finished fast and forward.

The fourth brace was run on the "Diablo Jake Course" with MJ's Sweet Sugar Magnolia (Maggie) – Mike Dally and Biscuits Me Wearing the Pants (Paddy) – Tom Jagielski This course runs along the Eau Claire River, past Roger Kings cabin and ends up by the bridge on Knights Pool. Maggie showed off her skills early by pointing a woodcock at 6. She pointed again at 11 with Paddy backing-no bird produced. The gallery flushed a grouse at 51. With seconds left a woodcock was flushed by Mike and Maggie hit the brakes for a "stop to flush." Both dogs ran hard with no let up for the full hour.

The 2020 American Brittany Club Grouse and Woodcock Classic is in the books and all enjoyed this successful trial. Hopefully next year will get us past the COVID-19 dark shadow and we can resume a more normal trial schedule and social activities that go with it. See you next year!

CONDITIONS AND RULES FOR FUTURITY ELIGIBILITY



- The 2022 American Brittany Futurity shall be open to every Brittany bitch and her progeny whelped during the calendar year of **January 1 - December 31, 2020**, who is owned or leased by a member of The American Brittany Club, and whose litters have been Futurity nominated with The American Brittany Club. Sires do not necessarily have to be owned/leased by an American Brittany Club member. All dams nominated and all sires bred to must be registered with AKC, CKC, or FDSB.
- The **nominating breeder** needs to be a current full member in Good Standing of the ABC when the litter is nominated and the closing dates of the of the Sectional Futurities in which puppies from their nominated litter compete. They must sign the Litter Nomination form, and any breeder purse checks will be paid to this designated nominated breeder. If their membership has lapsed at the time of the Sectional Futurity, the purse will revert back to the ABC Futurity Administrative Fees.
- Nominations of dams must be made within 60 days after a bitch has whelped, and a Nomination Fee of \$40.00 ("First Forfeit") must be paid at this time.** This payment will entitle each puppy of the nominated litter to be entered in the ABC Futurities (Field and/or Show) after the puppy has been properly registered with AKC or FDSB. Nomination Fees are set by the ABC Board of Directors.
- Late litter nominations will be accepted with the following current fee schedule:** In addition to the Nomination Fee of \$40.00, late fees are \$60.00 for 61-90 days, and \$100.00 for 91-180 days. Nominations after 180 days will be accepted at the discretion and decision of the ABC Futurity Committee. The postmark will determine the fee for late nominations. The ABC Board of Directors may impose additional late fees from time to time.
- A Final Forfeit Fee, to be eligible to compete in the Sectional Futurities (Western/Central/Eastern), is due by October 1, 2021, and is submitted by the owner of the eligible puppy.** Futurity Entry Fees will also be paid prior to 2022 Sectional Futurity events by the owner of the eligible puppy for each Sectional Futurity event in which the eligible puppy is entered. Final Forfeit Fees as well as Sectional Futurity Entry Fees are set by the ABC Board of Directors and subject to change.

Hope's Chief Of Crosscreek was named the winner of the 2020 edition of the American Brittany Club's Gun Dog Classic/Championship. No stranger to the winner's circle, Chief put down a strong race, consistently to the front and requiring little direction from his handler throughout his hour. He scored 7 very stylish finds and 1 back, with only a single non-productive to mar an otherwise immaculate race. Runner-up went to Atos, who also ran a strong race, with 4 solid finds and 2 stops-to-flush on a very windy day. Both the winner and runner-up were ably handled by Bob Burchett. Almaden's Under Lock And Key, handled by Ed Tillson, took third. Fourth place went to Starlight's Callisto Moon, handled by Bob Burchett.

Since its inception in 1974, the Gun Dog Classic has been hosted by regional clubs from all over the country. The only Classic not to be based on a single game bird, it is intended to showcase gun dogs on quarry native to a given region, be it quail, pheasant, chukar, grouse, prairie chicken, etc. A dog is not required to point a specific game bird to qualify for the championship, but must handle whatever game bird it encounters. The venue for this year's event returned to the Midwest, being held at Bird Dog Ranch, near Thayer, Iowa. Owned by Linda and Tommy Thomas, these grounds have undergone constant improvement over the years toward making this a quality place to showcase bird dogs. Native quail and pheasant were augmented with released quail to ensure sufficient opportunities for bird contact. Host club for this year was the Hawkeye Brittany Club. Club members Bruce Heiter and Bill Cockrum handled most of the duties of putting on the trial, assisted by Steve Ralph, Linda Thomas, and Val and Hyatt Burchett.

Judicial duties were handled by Justin Hess, well known Vizsla handler from Exira, Iowa, and this Scribe.

Field trial aficionados are well aware that events of this magnitude do not simply happen, but are dependent on financial support from corporate sponsors. The American Brittany Club is very grateful to Purina for its long-standing sponsorship of the classics and championships, as well as other events.

Brace 1: Starlight's Callisto Moon/Burchett – St. Clair's Prince Rocco Vulcano Leo/Johnson. The dogs broke away north of camp under clear skies, temperature in the high 40s, and a steady wind of 10-12 mph from the south. Both dogs broke away at good range, Cal being the bigger runner. Both were found standing at 10 past the double crossing. Birds were flushed, with all in order. At 12, Rocco was credited with a find with Cal backing. At 15, Cal was very intense on point at the second finger feeder, turning his head only to mark flight of bird. Meanwhile, Rocco scored a separate find about 30 yards away, all in order. Cal scored in the feed strip east of the old barn site at 18, exhibiting very intense style throughout the flush and shot. Rocco had a find at 19 on west side of old barn site. After crossing onto the south course, Cal made a very nice cast along feed strip, ending at the crossing into the next field. At 49, Rocco had a find by the feeder north of the hedge row, with Cal backing. Cal pointed at 51 along a mowed strip a few hundred yards further on. A bird was produced with all in order. Rocco pointed at 57, with Cal backing, on pond dam at old horse corral, but no bird was produced and both dogs were sent on. They finished the hour before reaching the east-west fence line. Cal made some very nice casts during his hour, whereas Rocco was handier.

Brace 2: Detroit Rascal's Son Of A Gun/Burchett – Hoochie Coochie Man/Tillson. The dogs were loosed from the west gate by the corn field, heading south into a steady wind. Karl had a mannerly find

at 2 along the east-west fence line. He pointed again at 8 at the feeder southwest of the hedge row. A small covey was produced, again handled with good manners. At 10, a pair of quail lifted in front of Karl from the mowed strip along the hedge row and he went with the birds. Meanwhile, Cobo was pointing at the east end of the hedge row. A bird was flushed, with all in order. After crossing over to north course, Cobo pointed at 30 in horse path north of Ed's Motte. A lengthy flushing attempt and relocation resulted in no bird being produced and dog was taken on. He was credited with a find at 36 east of the old barn site and again at 41 on south edge of alfalfa field, but his run was not consistent and handler elected to pick up at 57 when we got to the road crossing to the south course.

Brace 3: Sniksoh Evolution/Hoskins – Over Under's Kick It Out/Johnson. Dogs broke away south of the road crossing, heading southeast. Eve made a big move in the east field before the crossing. Upon exiting the crossing, she headed to the hedge row and scout was dispatched. He called point at 7. Handler rode to dog and attempted to flush before asking dog to relocate. She worked along the hedge row about 70 yards, then locked up on point again showing excellent style. Handler produced a pair of quail, with all in order. Eve pointed at 14 near dogwood bushes. Handler reported finding the remains of a hawk kill and dog was taken on. Handler attempted to catch the front, but scout found Eve locked up on point again at 19 at end of feed strip east of the horse corral. A bird was produced, with all in order. Meanwhile, Holly had pointed along the east-west fence line, but self released and was picked up at 16. Eve suffered a non-productive at 26 along the south property line prior to the creek crossing. After the creek crossing, Eve made a big cast around the field, but disappeared, not to be returned to judgement and handler called for the tracker at 42.

Brace 4: Hope's Chief Of Crosscreek/Burchett – A Trace Of Bourbon With Diamonds/Hastings. The last brace of the morning left from the hedge row heading north. Both dogs broke away well to the front. Chief pointed intensely at 2 by the feeder north of the hedge row. Birds were produced with all in order. He scored again at 4 just prior to the road crossing. After crossing onto the north course, Trace shortened considerably, whereas Chief maintained a strong, forward race. Chief carded another find at 17 along the feed strip past the double crossing, looking very intense and with great style on point. He had a covey find at 18 near the feeder in the first finger. Trace was credited with a stop-to-flush at 20. Chief pointed again at 21 at the feeder in the second finger and handled the flushing birds with excellent manners. He was found on point at 24 east of the old barn site. Birds were flushed with all in order. Trace's run had shortened considerably, but he did score on a pair of quail at 26, with Chief backing, at the old barn site. Chief suffered a non-productive at 30 in a heavy weed patch west of the old barn site. Trace pointed at 32 in the corner of the alfalfa field, but handler found only a pile of feathers. During the latter half of his race, Chief made several huge casts at the edges of the course, always to the front. He was finishing his hour going away when he scored yet another impeccable find at 59 by the lone tree north of the willows.

Brace 5: Lightem Up Louie/Chang – Hurricane Banjo/Friorito. The first brace of the afternoon left from camp at 1:30. Temperatures had climbed into the low 70s, and the wind had intensified. At 12, at first finger past Ed's Motte, both dogs stopped. Banjo was loose and Louie looked more intense. Friorito dismounted and fired, claiming a stop to flush. Chang then flushed a bird in front of his dog and fired. Both dogs were taken on and scored a divided find at 14 on a large covey by the second feeder. Banjo pointed at 17 at end of feed strip on east side of barn. He exhibited good style and manners as a bird was flushed. At 25, Banjo pointed along feed strip by johnny house. Bird flew and dog turned to mark at the flush and shot. On the south course, at 41, Louie had a stop

to flush on a wild pheasant in feed strip. At 47, Louie found by scout along mowed strip in heavy cover. Bird was produced with all in order. Louie pointed at 53 along the edge of the corn field. A single quail was flushed as dog stood mannerly through the shot. Birds lifted in front of Louie at 59 as we approached the south creek crossing. Both dogs were stopped and a shot fired as time expired.

Brace 6: Sundance Kid's Rocky Mountain Renegade/Burchett – Scout Upland Trailblazer/Tillson. Dogs were turned loose at the bottom of the hill east of the creek crossing. Scout had a find at 3 in the hedge row with all in order. After being sent on, Scout exhibited great ground speed. Both dogs crossed onto the north course, and through the fields north of camp. Scout had disappeared to the front, but was found at 20 standing along the tree line past Ed's Motte. Rocky came in and backed, whereupon Scout scooped up the bird and was up. At 22, Rocky stopped at first feeder, then released himself before relieving himself, then pointed again. Handler flushed a small covey, but dog suffered a breach of style and was picked up.

Brace 7: Atos/Burchett – DanDe Tyghten Up/Chang. The final brace of day one left from the old barn site headed west. Cinch scored a find in the field south of the johnny house at 7. Atos made a big move around the field to the west crossing. He continued running to the front past the road crossing onto the south field and pointed at 25 by the lone hedge tree north of the willows. An extensive flushing attempt ensued, with handler asking dog to relocate several times, but Atos barely moved from where he originally stopped. After multiple attempts to try to get the dog to move, handler finally found the bird buried in the grass and flushed it. Atos handled all this with great style. He was found standing by scout at 30 along draw north of the hedge. Bird was produced with all in order. As handler was attempting to regain the front, Atos had a stop to flush at 34, then pointed at 36 along east-west fence line. He remained mannerly during the flight of a small covey and subsequent shot. Meanwhile, Cinch pointed a pair of quail by the covert near the south creek crossing at 35. Atos was credited with another stop to flush by the hedge row at 43, then scored again on a find at 45. He finished strong to the front north of camp. Cinch finished his hour with no further bird contact.

Brace 8: Sniksoh Little Diamond/Johnson – Pretty Boy Floyd/Chang. The first brace Tuesday morning broke away under cloudless skies, with temperatures in the low 50s and a calm wind. Kate made a big opening cast, but apparently did not make the turn into the north field. Floyd had an unfortunate encounter at 12 with a bird in a mowed strip past the double crossing. Kate was not to be seen, and handler called for the tracker at 20.

Brace 9: Windsong's Honky Tonkin Hank/Johnson – Blaze Away Bonita/Burchett. Dogs were loosed from the old barn site, heading west. Hank went through the crossing and rimmed the south side of the alfalfa field. Boo was snappy and quick but ran a much closer race than Hank. Hank was found standing at 7 near the feeder south of the johnny house. He had good manners as a small covey was flushed, only turning his head to mark the flight of the birds. Unfortunately, he was seen under a bird at 13 at the south side of the orchard. Boo continued on to south course but came out after a bird by the feeder north of the hedge row at 27.

Brace 10: Kid's Royal Casey/Heiter – Turning Points Shenanigan/Burchett. This brace started where the last brace finished. Casey had a quality find at 4 along feed strip east of the old horse corral. Shandy suffered a bump and chase at 9, along the fence line near the creek crossing. Casey made a nice forward move along the hedge row. Birds were seen leaving from the keyhole as we approached. Dog was found standing on the other side of the hedge, so handler dismounted and fired, then took the dog on. Casey pointed at 17 by feeder north of hedge row.

He moved up slightly before reestablishing point, then locked on the birds. Handler flushed and fired, as dog stood mannerly. After crossing onto north course, Casey pointed at 34 at first feeder past Ed's Motte. He crept forward several feet before settling in on point. Initial flushing attempt was not successful, and dog was asked to relocate, after which a pair of quail was produced. After being sent on, he had an absence for several minutes, but was returned to judgement within the allotted time. He pointed at 42 along the feed strip by the old barn but took too many steps toward the birds at the flush, ending his bid.

Brace 11: Sovereign's Legendary Cowboy/Burchett – Simon's Standing Stone/Tillson. The final brace of the morning was turned loose at the old barn. Temperatures had warmed up noticeably, but the wind remained very calm. Both dogs went through the alfalfa field, Duke being the wider of the two, and through the next fields to the west crossing. Duke suffered a bump and chase on a covey along the south end of the orchard at 14. Gus continued on, at short range, and handler elected to pick up at 20 as we rode past camp.

Brace 12: Godfather FN Rockstar/Chang – Starlight's Mercury Out Ryder/Burchett. Rocky was scratched, so Ryder ran as a bye dog, leaving from camp at 1:30. Temperature was in the mid-70s, and wind remained very light. He had a covey find at 13 in feed strip near feeder east of old barn site. He was found standing at 22 in the dead-ash motte and birds were flushed, with all in order. He made several good moves as he traversed the fields but would double back and return many times. He was credited with a stop-to-flush at 45 near the feeder north of the hedge row. At 50, he spun around as he was running up the hill to the old horse corral and locked on point. A bird was flushed about 2 feet in front of the dog, who handled the flush and shot in a very mannerly fashion. He pointed again at 56 along the feed strip near the south creek crossing, exhibiting good style and manners at the flush and shot.

Brace 13: DP's Little Bit Of Mayhem/Burchett – Godfather Redfeather Gunslinger/Chang. This brace left from the hedge row, heading north. A breeze was blowing from the WSW about 5-8 mph, with temperatures in the low 80s. Mila made nice opening cast and pointed at 2 by the feeder north of the hedge row, with all in order. Both dogs continued onto the north course, with Gunner being absent for a time after handlers went through the double crossing. Mila was seen under a bird at 20 near the old barn site. Gunner was eventually returned to judgement by scout and pointed at 24 in feed strip west of the old barn. A good-sized covey was flushed, which was handled in a mannerly fashion. After a dip in the water tank, Gunner was sent on and pointed at 31 in multiflora rose bushes along the south side of the alfalfa. Handler attempted to flush, but the thorn bushes were too thick and he elected to take a non-productive. Gunner was found standing at 42 in the dead-ash motte. Birds were produced, with all in order. Gunner finished his hour shortly after crossing onto the south course.

Brace 14: Romence's Life Of Riley/Burchett – My Little Touch Of Diamond/Johnson. Dogs broke away into the east field, heading southeast. Bling pointed at 6 at a hedge tree far north of the hedge row. All was in order as a pair of quail flushed. At 10, both dogs were standing in the crossing leading to the horse corral. No bird was produced, but Bling had a lapse in style and was picked up. Riley continued alone and pointed at 15 along edge of the corn field. Handler was unable to produce a bird and picked up the dog after her second non-productive.

Brace 15: Cross Creek Sovereign Pop-A-Top/Burchett – JB's Hankering For A Bird/Johnson. First brace Wednesday morning broke away with temperature in the high 50s-low 60s, no wind and no clouds. At 13, Jackson scooped a bird at first feeder and was up. Hank had a find at 15 east of old barn, with all in order. After being released, Hank disappeared and was not seen again until he was returned by scout as

handler approached the west creek crossing. He shortened considerably and handler elected to pick up at 36 as we approached camp.

Brace 16: Almaden's Under Lock And Key/Tillson – Sniksoh Hank's Hatch/Burchett. Broke away on the south course. Oudi found standing at 15 along feed strip near south creek crossing. He maintained good style as a small covey was flushed. Hatch had an unfortunate encounter at 20 with a bird in the hedge row. Oudi pointed at 21 along a mowed strip north of hedge row. No bird was produced, although they could be heard calling a short distance away. Oudi crossed to the north course and disappeared to the front but was found standing at 40 at first feeder past Ed's Motte. A single bird was produced, with all in order. Oudi pointed at 41 near old barn site. Handler found recent roosts where dog had pointed and elected to go on. He was credited with a stop-to-flush along feed strip in the orchard at 57. He finished strong to the front.

Brace 17: J&M Rodeo Romeo/Tillson – Stellar Fifty One/Burchett. Breakaway was south of road crossing. Stella was found standing at 14 at cut in east-west fence line. Birds produced, with all in order. Tuff disappeared south of the old horse corral and handler called for the tracker at 22. Stella also suffered an absence but was returned to the front by scout at the hedge row. She scored a find at 42 at Ed's Motte, with all in order. She pointed at 44 by the finger feeder, taking a small hop as the bird was flushed. She pointed at 58 at feeder south of the johnny house, with all in order. She finished at short range.

AMERICAN BRITTANY BREEDERS CLUB CODE OF ETHICS

Adopted November 30, 1996

The following principles are to be used as an educational guide and a tool for Brittany breeders for the purpose to develop more genetic and disease free dogs, while being ethical in all matters with the public and with our peers.

Objective and Purpose

To promote cooperation and friendship among the breeders and owners of Brittany and to encourage higher standards in breeding, training and showing of Brittany in the field and in the show ring; to discourage the breed from becoming split into groups of "field dogs" and "show dogs" and to strive to keep it forever a "dual dog".

Ethical breeders should:

1. Comply with all ABC and AKC rules and regulations.
2. Maintain a high standard of health, care, and cleanliness for dogs under one's care.
3. Truthfully and realistically represent the Brittany being bred and/or sold in terms of quality, health, and genetic history.
Refrain from breeding a bitch or using a stud until they are two (2) years old.
4. Consult with your breeder and with knowledgeable, experienced members of the ABC, regional clubs, or local kennel clubs to broaden your understanding and knowledge of the history of the breed BEFORE breeding your Brittany.
5. Breed only stock which are physically and temperamentally sound and in good health. No dog or bitch should be bred that is known to have serious inheritable defects or genetic diseases, such as:
 - canine hip/elbow dysplasia, primary epilepsy, a seizure disorder,
 - eye disorders - retinal atrophy, undescended testicles,
 - heart defects, extreme shyness, viciousness, other inheritable diseases or defects
6. Not attempt breeding without the ability to distinguish between correct and incorrect physical attributes. This ability requires a careful study of the breed standard, principles of genetics, and a study of both the sire and the dam's pedigrees. Breeders should study and learn the good points within our dogs, looking to both field ability and conformation.
 - 7. Have their breeding stock OFA (Orthopedic Foundation for Animals), GDC (Genetic Disease Control) or PennHip certification numbers for hips on, at least, both the sire and the dam; preferably for three (3) generations on both sides of the pedigree. In addition, other tests (brucellosis, eyes, elbows, and other unspecified tests) should be declared in agreement between owners of the sire and the dam prior to breeding.
8. Refuse to sell to commercial wholesalers, retail brokers, or research laboratories.
9. Have tails docked and dew claws removed soon after birth. Prior to the sale of the puppies, initial shots for known infectious diseases should be given and worming administered. A buyer should be supplied with a four- (4) generation pedigree, registration certificate, information on all veterinary care, and instructions for the care, feeding, and training of the Brittany.
10. Remember your responsibility, as a breeder does not end with the sale of the puppy. A breeder should have contact with the buyer of a pup throughout the life of the dog. This information will enhance breeding knowledge and improve the foundation for a good long-term breeding program. This will also help your regional club to grow with new members and possible participants and workers.
11. Use spay/neuter agreements and/or consider limited registration if it is known or believed to manifest hereditary defects detrimental to the breed. THE LONG TERM INTEREST OF THE BRITTANY SHOULD BE THE GOAL OF EVERY BREEDER.
12. Consider DNA finger printing for all dogs in your breeding programs.
