# The Brittany Gazette



## Along the Line

by Dave Webb

Those of you who read this Brittany column, which appears four times each year in the AKC Gazette, recall that in the January issue a piece titled "Sunday Morning" appeared. The piece was somewhat of a reflection about the early days of this author learning about the Brittany breed. In addition as noted Richard and Ester Keenan were a focus in that piece; however the discussion was limited.

For this reason it was decided to put together more information about the Keenans. About Twenty-Five years ago I wrote an article about the Keenans and their Flying Feather line of Brittanys, which was published in the Ruffed Grouse Society magazine – November/December 1997 issue; what follows is an edited version, which will provide insight as to the importance the Keenans were to development of the breed.

The dogs of Flying Feather Brittanys, Guys Mills, Pennsylvania, have an excellent reputation as outstanding hunting dogs - for both pointing and retrieving birds. In addition, the Brittanys have made their mark at field trials and in the show ring. The Club House walls are lined with ribbons obtained by their Brittanys from both show and field trial events.

Dual field and show champions are a part of the generations of Flying Feather Brittanys. The Keenans are undoubtedly proudest of the direct line back to their dual and amateur field champion Beau'Pere, who, besides winning those honors in both the show ring and in field trials, was the reason the Keenans established their Flying Feather Kennel and Hunting Preserve.

The Keenans' trained Beau'Pere to his dual championship in 1970. And when Dick Keenan takes a break from his training schedule and caring for the dogs - mostly Brittanys - at Flying Feather, he talks of Beau to those who will have coffee with him. In addition, he's more than willing to explain Flying Feather's breeding philosophy that has evolved over the past 30 years. "You see, it's like this," he says. "You breed good bird dogs to get good ones. By that I mean both the sire and dam have to have shown to be good dogs in the field. The dog will find birds, point and retrieve. He'll have the desire to work and find birds all day long. He just doesn't want to quit. That's what makes a good gun dog." When Dick defines the word "good" the emphasis falls on several specific traits of a pointing dog - ability to find birds, point those birds with style and find and retrieve the downed bird.

With all of his accomplishments, perhaps one of his most significant was helping to dispel the assumption that a field and show champion can't be a gun dog that "puts meat on the table." In

Dick Keenan's log book there's enough information to estimate that 4,500 birds were shot over Beau'Pere.

In the early 1970s Dick Keenan decided to retire as a construction engineer from the Pennsylvania Department of Transportation and then raise and train Brittanys full time. In 1972, Dick and Esther purchased acreage for a hunting preserve, which became Flying Feather, and the move was made.

Over some 30 years Esther Keenan has bred and raised an estimated some 70 litters of orange and white or liver and white Brittany pups. Several years ago during an antelope/mule deer hunt in Montana, Dick was visiting with a local rancher and talking about upland bird hunting and pointing dogs. The rancher made mention

of his Brittany and the dog's bird-finding abilities. As the conservation continued, it developed that the dog's lineage could be traced back to Beau'Pere. The rancher's bird-finding Brit was a second-generation pup sired by Beau.

Esther Keenan's records indicate that pups have been placed with new owners in Alaska and California, Texas and the New England States. Also as expected, largest number of Flying Feather Brittanys are in Maryland, Michigan, New York, Ohio, Virginia, and, Pennsylvania.

It has been the second retirement for the Keenans. But puppies from Flying Feather are still in constant demand. There's a waiting list; Esther raises one or two litters a year. Dick still trains a few dogs and cultivates, plants, and

manages 265 acres for bird hunting from September to the end of February.

Dick estimates the Flying Feather Brittany pups placed in new homes, the majority of them go with owners, who train and hunt their bird dogs. Very few are purchased just as family pets. Further as Dick indicates only a small number of the pups become competitors in field trials and perform in the show ring.

Both of the Keenans have past and their grandson now maintains the Flying Feather bird hunting preserve. They both had influence on my own experience with showing and field trialing Brittanys. The line of Flying Feather Brittanys is one that we plan to continue along with some breeding to "improve" the breed – as Dick Keenan stated, "You breed good bird dogs to get good ones." It is worth noting, Glade Run Irish was the 2016 Purina Brittany All-Age Champion; also the Brittany National Amateur All-Age Champion for 2016. Irish's damn was strictly bred from the Flying Feather line.

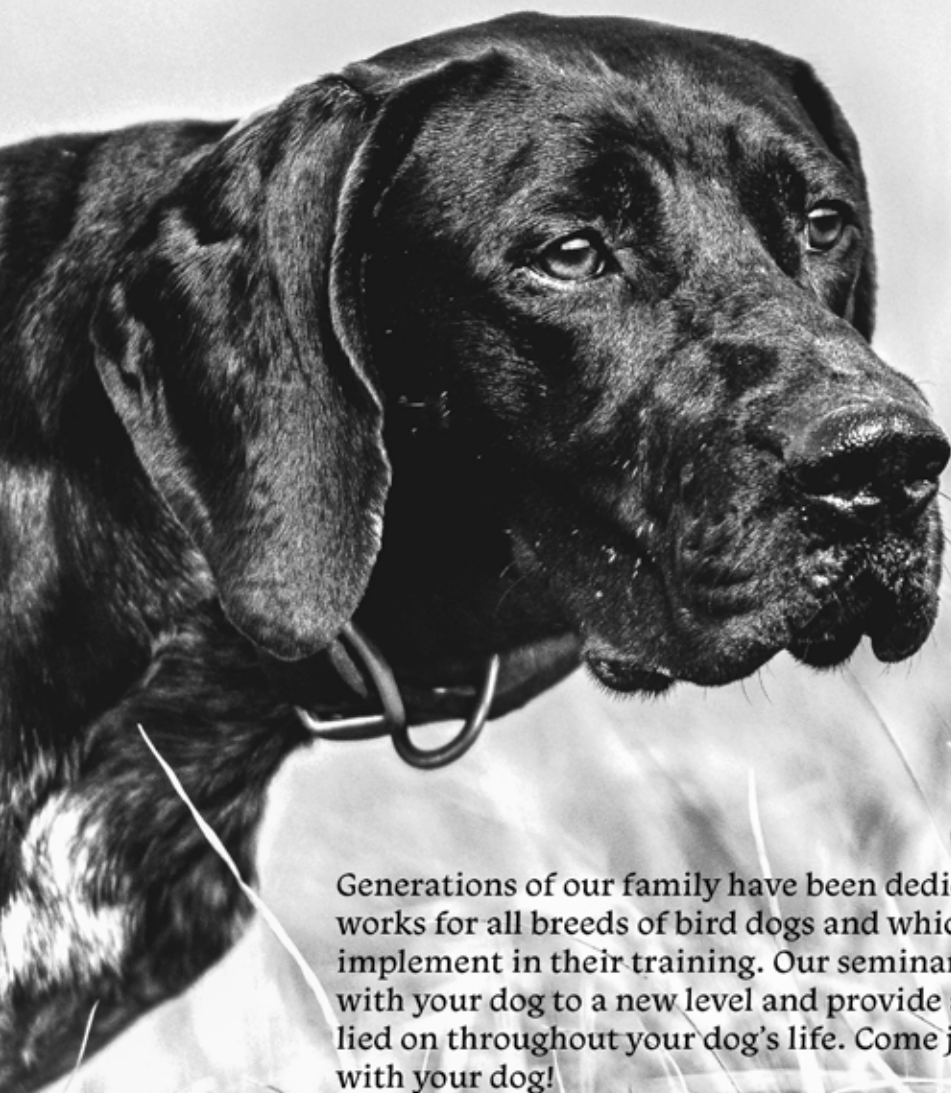

### CONDITIONS AND RULES FOR FUTURITY ELIGIBILITY



- The 2023 American Brittany Futurity shall be open to every Brittany bitch and her progeny whelped during the calendar year of **January 1 - December 31, 2021**, who is owned or leased by a member of The American Brittany Club, and whose litters have been Futurity nominated with The American Brittany Club. Sires do not necessarily have to be owned/leased by an American Brittany Club member. All dams nominated and all sires bred to must be registered with AKC, CKC, or FDSB.
- The **nominating breeder** needs to be a current full member in Good Standing of the ABC when the litter is nominated and the closing dates of the of the Sectional Futurities in which puppies from their nominated litter compete. They must sign the Litter Nomination form, and any breeder purse checks will be paid to this designated nominated breeder. If their membership has lapsed at the time of the Sectional Futurity, the purse will revert back to the ABC Futurity Administrative Fees.
- Nominations of dams must be made within 60 days after a bitch has whelped, and a Nomination Fee of \$40.00 ("First Forfeit") must be paid at this time.** This payment will entitle each puppy of the nominated litter to be entered in the ABC Futurities (Field and/or Show) after the puppy has been properly registered with AKC or FDSB. Nomination Fees are set by the ABC Board of Directors.
- Late litter nominations will be accepted with the following current fee schedule:** In addition to the Nomination Fee of \$40.00, late fees are \$60.00 (total of \$100) for 61-90 days, and \$100.00 (total of \$140) for 91-180 days. Nominations after 180 days will be accepted at the discretion and decision of the ABC Futurity Committee. The postmark will determine the fee for late nominations. The ABC Board of Directors may impose additional late fees from time to time.
- A Final Forfeit Fee, to be eligible to compete in the Sectional Futurities (Western/Central/Eastern), is due by October 1, 2022, and is submitted by the owner of the eligible puppy.** Futurity Entry Fees will also be paid prior to 2023 Sectional Futurity events by the owner of the eligible puppy for each Sectional Futurity event in which the eligible puppy is entered. Final Forfeit Fees as well as Sectional Futurity Entry Fees are set by the ABC Board of Directors and subject to change.
- Beginning 1/1/2020, all litter nominations will be acknowledged via both email and written notification sent**
