

2021 National Open Gun Dog

Championship

The 2021 American Brittany Club National Open Gun Dog Championship was held in Booneville, Arkansas at the Blue Mountain Wildlife Demonstration Area, located in the Arkansas River Valley between the Ouachita and Ozark Mountains. For 2021-22, alligator season was closed, but crow hunting is allowed year-round in the area. The Blue Mountain Wildlife Area stretches over 8,200 acres owned by the Army Corp of Engineers. Rolling topography with great tree lines, edges, and well-groomed fields with good cover, all in good shape. A great venue for our Nationals again this year. We were blessed with very mild weather. Brisk cold nights and sunny days. The grounds are great quail country and there were plenty to go around for the Open. Singles and huge coveys both to give the dogs a lot to show their skills and prowess.

The Committee was headed up by Chair Lisa Pollack and Secretary Darlene Dow, an energetic and efficient team. The amiable Ed Kostka was the Stakes Manager. With a huge continuous course through 8,000+ acres, it takes a man who knows the grounds to reliably deliver the dogs for each brace and to keep the brandy wagon chugging along. Ed showed up at all the right places and did it every day for the entire trial. He kept everyone on time and showed up in just the right spots to pick up dogs. The committee of John Perry, Vince Anderson, Jon St Clair, Teresa Richmond rounded out the workers and helpers and all worked selflessly to provide a well-organized and well-run event. Their nonstop energy and worker bee attitude kept things rolling along smoothly. Dennis Sullivan rode all day every day to serve as Course Marshal. Thank you for the saddle time Dennis.

Many thanks to our judges Jim House and John Hott. Both men have



been competing and judging for decades and have a keen eye for a really good dog. Between them they have nearly a century of experience with dogs. Jim has been training and trialing for 45 years, with 21 Brittany Champions to his credit and many Championship judging assignments. John had an auspicious start as a teen fishing at Wehle's pond and is a well-respected pointer man with experience judging many Championships.

Huge thanks to Purina for their continued generous financial support and providing Pro Plan Sport dog food for all the placing dogs and to Garmin who generously supported this event. Thank you to all who attended and especially those who competed.

The 2021 National Gun Dog Champion was found on the 5th day in the 30th Brace.

Congratulations to Copely's Sheltany Echo of Angels, known as Zoie. Ably handled by Scott Johnson and scouted by Richard Beaver. Zoie is owned by Julio & Connie Rodriguez. Runner Up was Hoochie Coochie Man- Karl, handled by Ed Tillson and scouted by Jessica Carlson. Karl is owned by Pam Baird. Third was Sniksoh Worthy Expense-Spense, handled by Bob Burchett and scouted by Tommy Thomas. Spense is owned by Jeff Hoskins. Fourth place was Magnum High Velocity-Gauge, handled by Vince Anderson and scouted by Denise Anderson. Gauge is owned by Vince Anderson.



Day 1, Dec 4. The committee decided on an early release in the mornings and the start times were adjusted by 15 minutes in an attempt to beat the sun going down on the tail end of the day. There was a big crowd of 30 or so in the gallery to watch the inaugural brace. The horses were lively and stomping and the dogs in the dog wagon were yelling for their turn before we even cast off. We had warm, dry weather with a light breeze. It had rained overnight so there was some water in puddles and pooled up along the course.

Brace 1, Day 1: Saradac's Dangerous Diamond Caper- Caper, handled by Lisa Pollack and Hurricane Banjo- Banjo handled by Roger Fiorito. Turned loose at 7:50, Banjo and Caper made a lively kick-off from the starting line, foot racing it down the hill. Caper had her first point at 5 minutes pointing into a grass patch with beautiful style, high tail and rock-solid performance through the flush. Caper was seen pointing into a mowed waist deep feed patch at 13 minutes. She had a small move up to lock it in. Banjo, seeing the activity moved in to take a look-see but was ushered on by the scout. Caper continued her stylish ways with a lovely point and feet anchored into the ground during the flush of 3 or 4 birds. Banjo had a point at 7 minutes. He was looking for Roger, waiting

for the action to begin. Unable to find the bird Roger relocated. Banjo moved up about 6 feet. Roger called a bird and fired. Moving on, Banjo bumped a bird ending his race. That left Caper to finish on her own going away on the curve of a field, looking good at time.



Brace 2, Day 1: Starlight's Mercury Outrider- Rider, handled by Bob Burchett and High Hopes Jac's Original Spice- Spice handled by Chad Holman. Break away had both dogs moving smartly. Rider has an attention-grabbing ground speed. 5 minutes in, Spice had a nice covey of 20 birds. Both dogs had a nice ground covering race. Spice covering the edges with direction from her handler had a point on a nice covey at 22. Both dogs moving powerfully forward on the right-hand edges. Spice on point again, Rider honoring. Spice took two steps. Rider stayed anchored. Another point at 42 for Spice. Rider honored with his good style. Chad flushed 2 birds, Spice made some forward movement. Rider stayed anchored. At 43 minutes Rider had a point. His handler did a relocate. He moved up about 20 yards doing a thorough search, no bird. Both dogs did another nice rim of a giant field. At 59 Rider pointed, nice and steady and was rewarded with 2 or 3 birds.



Brace 3, Day 1: Leona Valley's Sunny Red Side Up -Red handled by Paul Dorion and Just Call Me Lucky Ned Pepper-Lucky Ned handled by Frank Campbell. Both dogs dug in at the take off. Ned took a nice edge and stuck a point at 9 minutes on an edge. A nice covey of 10+ birds flushed all around him. Flat footed, steady, looked great. At 18 minutes they had simultaneous finds. Red with great style on his point, Ned pointing in higher cover, about 30 yards apart. Paul flushed for Red- 5 or 6 quail and fired, Red was all in order. Some flew toward Ned. Ned stayed steady. Frank flushed Ned's birds, another dozen, Ned looked good. The judge rode up another bird. Both dogs held. At 23 minutes both dogs were moving along at a great clip. Ned pointed, Red did a stylish honor. Ned got a rabbit for his trouble. Both dogs off nicely, making hay. Red checked back in with Paul and caught an edge which pulled him off to

the right down a road in the wrong direction. At 37 Ned slowed to a stop, birds in the air, he's up. Red on point, very stylish. Head high and tail. Nice size covey at time.



Brace 4, Day 1: Turning Points Shenanigans-Shandy handled by Mark Claypool and Bama Jama Willy's Sassie Sadie-Sadie handled by Bob Burchett. Both dogs moved forward nicely, well out from the judges. Both handlers urged their dogs around the Fish Hook. It took a bit of work. Bob worked hard to get Sadie back. Shandy had point at 43. A nice single. Shandy had a 2nd point on the edge of the cover at 50 minutes, very nice style, a small covey of 6 or 8 handled perfectly. Shandy snapped into another point on an edge, moved up one, two lengths, then came up empty handed for her effort. Sadie worked hard in the thicker cover, but came up empty handed for her hour.

Brace 5, Day 1: Lapat's Cody -Cody handled by Al Cropek and Romence's Life of Riley- Riley handled by Bob Burchett. The start was a bit bumpy with a loose horse- Handlers paused to let dogs soak in the puddle and get back in the game. Cody went off to the left and had a find at 28 minutes in the edge of deep grass. Looked steady for his 4 or 5 birds with a small mark to watch them fly. Cody in the cover, birds seen coming out ahead of him. Chased about 50'- he's up. Riley doing a nice smooth handle for Bob cruising the edges, working hard. She went on point, high head, high tail. Went around the corner and she went on point again into thick head high cover. Nice style, staunch on a single. One more find with 5 or 6 quail. Riley was a bird finding machine.



Brace 6, Day 1: Just Call Me Eli -Eli handled by Kyle Merrill and Marjo's Fille DeLa Bretagne-Brie handled by Robert Goldman. The handlers took off with purpose and worked well ahead of the judges. Brie stood tall on the edge of a thicket, 10 o'clock tail, high head. 4 quail. Nice and staunch. Both dogs gone a while. Eli appeared to the front. Brie coming up. Brie hit a point. High head, high tail, looking sharp. Took the handler a while to work the thick cover, dog looked steady, relocates. Brie goes into another thicket row, disappears but pops out ahead of the handler and keeps moving. No bird. NP At 44. Brie on point in a shallow

ravine with great style; 3 or 4 quail, rock solid. Eli had bird work at the same time. Bob got Brie around Eli's work smoothly. At 56 Brie had another point, nice style, handled a relocate on a single.



BRIE POSTED

Brace 7, Day 2: High Velocity Copper Magnum-Colt handled by Vince Anderson and TNT's Nymph in Harlem Pants-Jazz handled by Bob Burchett. Temps in the 70's today. Both dogs had a snappy start off the line, a foot race to the front. Colt's scout & handler swap horses. Jazz on point at 12 minutes with a 10'oclock tail. Colt moved in and tried to take credit for the find. He was retired for the day. Bob flushed 6+ quail and Jazz handled all the fuss with aplomb. At 22 minutes another nice stylish find, staunch on the flush. Jazz was gone a bit and Bob back tracked to find her buried. Bob waded in, shot and birds flew. Jazz too deep to see. Judge waded in behind the handler to watch the action. Jazz narrowed her run and was leashed at 49.

Brace 8, Day 2: Gun Creek Gangster-Doc handled by Chad Holman and Sniksoh Worthy Expense-Spencer handled by Bob Burchett. Attractive start, but Doc narrowed his race early. Spense leading the way. Worked them around the Fish Hook. Doc on the road. At 27 Doc was on point in tall grass, was relocated, moved up and pointed at 20 yards; 10 o'clock tail, staunch. Still came up empty for his effort. Spense made a nice cast in heavy cover and came out front. At 50 minutes a point for Spense. Nice covey of 10, he was handsome and staunch. 55 minutes Doc on point in a tree line. Relocated twice. This time he had birds, one step. At 57 both dogs on point. Both handlers working it, both fired and rewarded by a small covey. Nice cruise around the fields. Spense pointing with nice style, Doc honoring. Bob cannot locate a bird and had a barren point at time.

Brace 9, Day 2: Pretty Blue Eyes a Sweet Touch of Charlie B-Charlie handled by Bob Bakas and Beech River's Light Em Up Lulu-Lulu handled by Travis Shuler. Handlers well out front of the judges off the line. Both dogs animated, speedy. Lulu on point at 20. Very pretty style, looked good. Charlie zoomed by and neglected to honor. It was the end of Charlie's day. Lulu had two birds, all in order. At 30 minutes Lulu on point. Handler flushed; birds flew. Handler walked back to dog and kicked up more birds, she handled it well. Lulu's race narrowed and at 45 she was on a rope.

Brace 10, Day 2: Atos handled by Jackie Hutwagner and I'm Your Man-Gus handled by Ben Lorenson. Strong start off the line, both forward with good speed. Handlers well out in front of the judges. Both dogs gone a while. At 6 minutes Gus was found on point with a 10 o'clock tail. He had one bird and a small move to mark. Atos moving forward with great ground speed. A bird popped out of the grass, Atos stopped, handler fired. STF, all in order. Atos moved on, working the fields, speedy and animated, tearing along on the right, Gus rimming the fields with a nice

forward race on the left. Both dogs working hard. Atos on point into a little feed patch. Staunch, relocate, Atos wouldn't move. After the 2nd attempt, he moved up about 50' and pointed a nice covey, looked good. Gus on point, small turn to mark. At 59 Gus on point, a relocate turned up nothing at time.

Brace 11, Day 2: Trio's I'm Finn-Tastic at Campbell's- Finn handled by Bob Burchett and Jazz Em Up Arrow-Arrow handled by Rick Hastings. With a nice take off, Arrow and Finn rimmed the field, laying em down with nice speed going flat out. Both dogs forward and easily handled around Fish Hook with no problem. A brief chase in the trees and Arrow was up. At 45 Finn was seen pointing into heavy cover with high head. Finn faded after a prolonged flushing attempt and was up.

Brace 12, Day 2: Sigbrit's Not a Trace of Rust-Rusty handled by Kyle Merrill and Nalko des Sentiers du Ramier II- Nalko handled by Jackie Hutwagner. Great start off the line. Nalko is a pocket rocket. Both dogs moving well. At 33 Nalko on point just inside the edge of cover. He is very staunch. Relocated. He looked hard but didn't turn up anything. Handler moved him on. He covers ground at amazing speed. At 33 Nalko on point. It was a large covey moving on the ground in front of him. He handled it well. At 37 Rusty had a point, but it was barren. Both dogs were not to their handlers liking and they were retired for the day.

SPENSE, ATOS AND GUS POSTED

Brace 13, Day 3: York County Cruizer-Cody handled by Ben Lorenson and Urban American Legend-Urbi handled by Steve Chang. Urbi is short and busy. Cody to the front across the field. Gone a minute, popped out in front then gone for a while. At Urbi is on point with a 10 o'clock tail. There was an extended search. On relocate the dog went up an edge and kept going. He spotted Cody and left his own work to honor Cody. Cody is on point now at 43. Cody relocates a couple of times. He keeps his fine style, but hard work in heavy cover brings no reward. Cody was finally rewarded with a find at 57, all in order to finish his day.

Brace 14, Day 3: Miss Behavin'-Ivy handled by Al Cropak and B&T's Sundance Kid Rock-Rocky handled by Scott Johnson. Rocky tore on out of there, hitting the first field rim and smok'n it. Ivy is liking the pace too. At 11 Ivy on point with a 12 o'clock tail in a small grove. Her reward is a half dozen quail. Rocky had his own find at 21, handled well. Both dogs moving forward nicely. Rock and Ivy point at 31. There was a breach of manners that ended the day for both.



Brace 15, Day 3 Hoochie Coochie Man-Karl handled by Ed Tilson and Kid's Royal Casey-Casey handled by Bruce Heiter. Karl and Casey had a strong and aggressive forward start off the line. 9 minutes in Karl snapped into point; 11 o'clock tail. Casey honoring nicely. 10 birds right under Karl's nose. Ed fired with Karl staunch as a rock. Casey made a 180 and was ordered up by the judges for his error. Working steady and hard Karl moved forward. At 27 Karl was on point with a 10 o'clock

tail. 3 birds, he didn't move a whisker. Continuing, Karl had bold moves to the front and worked all the cover. He covered a lot of ground and was consistently forward and always going where you wanted to see him. He ended going away.

Brace 16, Day 3: Cross Creek Sovereign Pop-A-Top-Top, Jackson handled by Bob Burchett and Supernova-Nova handled by Scott Johnson. It was sunny & breezy. Nova off the line around the corner and on point in the middle of the field at 2 minutes- armadillo! Off to look for the real thing at good speed. At 15 Jackson had a nice find on a large covey. Very fine style and staunch through his work. At 15 Nova on point, handled well, all in order. At 22 minutes both dogs in the trees looking uncertain- maybe a deer bed? Saw deer cross the field a minute ago. At 24 Nova had an empty point. Both dogs up at 27 as they weren't pleasing their handlers



Brace 17, Day 3: M&M's Grouse Gunning Gracie-Gracie handled by Kyle Merrell and Ramblin Gamblin Willie-Willie, handled by Al Cropek. Off the line Gracie rimmed the first field just laying them down. She had a mission and then she was gone. At 19 minutes Willie was on point. Al relocated several times in a tough clump of trees with thick under brush. He worked it hard and so did Willie but, in the end, could not produce a bird. Willie had a little chase and he was up.

Brace 18, Day 3: Diamond Hill Sunshine & Whiskey-Dani, handled by Lisa Pollack and Sovereign's Judge and Jury-JJ, handled by Bob Burchett. At 4 JJ was on point on the edge. Birds boiling out and running on the ground. Dani honored about 30 yards back. JJ staunch. Handled flawlessly. 7 min JJ on point again, 10 o'clock tail, high head. Relocate, JJ softened a bit, relocate again, 2 steps on flush. Dani's handler elected to pick her up at 11. JJ hunting hard. He had a long dry spell with no birds even though he was going everywhere he should. At 50, 1 bird popped up from the cover, then the covey boiled out. A breach in manners forced the end of his race.

KARL POSTED

Brace 19, Day 4: Simon Standing Stone-Gus handled by Ed Tillson and Dogwood's Bennelli- Benny handled by Bob Burchett. The morning started at 32 degrees with ice on the puddles. Shortly into the course there are deer seen moving across the field; 2 big does. Gus looked but thought the better of it. Both dogs moving forward with good ground speed. Benny hitting it hard. Gus gone a bit. At 28 Benny pointed at a feeder under a fir tree. The birds started running and so did Benny. He's up. We see Gus at 34. He's off to hunt and Ed pulls the tracker at 49.

Brace 20, Day 4: Magnum High Velocity-Gauge handled by Vince Anderson and Coos Triple Six-Boomer handled by Scott Johnson. Boomer is off to the right with good speed off the takeaway. He looked like a million bucks rimming the field. Gauge checked out some likely cover and both dogs moved on in very nice fashion. At 11 Gauge scores the first

point. All in order. Both dogs rim another field. Another point for Gauge at 20, Boomer honoring. Both dogs look good. Vince relocated. Gauge is rewarded with a covey of 20 or so which he stood with fine style. Both dogs off smartly again. At 42 Gauge is buried in heavy thicket and Boomer is pointing as well. 10 quail boiled out. Only Vince fires. Gauge on point at 51, all in order and again at time around the corner from his previous find. Always a staunch manner. Boomer continues his attractive ways along the edges. Gauge tapering off. Both dogs going away at time.

Brace 21, Day 4: Pursuit's Little Phoenix-Phoebe handled by Bob Burchett and TJ's Black Diamond-Coal handled by John Perry .After a nice take off both dogs did a nice job on running the edges. At 10 minutes Phoebe pointed with fancy style. Bob dismounted and fired. Phoebe softened her style and was not pleasing to his handler. She was up. Coal on point in hedge row; 10 o'clock style. Handled well, staunch. Coal was reaching for distant cover. He was not visible for an extended period. At 42 his handler pulled the tracker.

Brace 22, Day 4: Scout Upland Trailblazer-Scout handled by Ed Tilson and Shailorville's Gunner- Gunner handled by Ben Lorenzon. It was a power start off the line, great speed and animation from both dogs. Gunner working hard, hauling mail, using all the course. Scout did a nice job of rimming the fields, covering all the likely hideouts. Gunner on point at a feeder under a pine. 11 o'clock tail, great style and 6 birds handled perfectly. Gunner on point again in a blanket of quail. The ground was alive with birds. Ben had to run to get them to lift. At least 30 boiled out in every direction. Gunner was frozen on point. Another, just a single, to wrap it up for Gunner. Gunner pushed the edges of the course and worked it near and far. Scout was still missing at time with no birds on the books.

Brace 23, Day 4: Woodsong's Honky Tonkin Hank-Hank handled by Scott Johnson and Knine's Finale's Way To Go-Allie handled by Paul Dorion Hank was laying it down, moving forward well and Allie was keeping up and working the edges. Both dogs had attractive ground speed. Hank on point at 11 minutes. Looked nice, out in an open field. He stayed steady for the long ride to him; 10 o'clock tail. He had a nice little covey. Allie ordered up on judges' opinion she blinked a back on Hank. Rounding the Fish Hook with Hank, the scout really earned his pay. Heavy cover coming around the side of the Fish Hook took its toll. At 44 Hank slowed and was up.

Brace 24, Day 4: Sniksoh's Hank's Hatch-Hatch handled by Bob Burchett and Almaden's Under Lock & Key- Oudi, handled by Ed Tillson. Great ground speed on takeoff, both dogs running hard. Oudi made a bold move to the front intent on finding birds. Hatch more to the left and working another line. At 3 minutes Hatch on point; 11 o'clock tail. Great intensity. He was a in a grove of trees and heavy cover. Bob started to flush, and Hatch helped. The ground was blanketed with birds. Not sure how Hatch got in the middle of them without making them lift. He was good till he wasn't. At 8 minutes Oudi was on point with nice style. 8 flew out and still more moving around on the ground. He was staunch and anchored. Oudi continued working the lines and field hard with impressive work ethic. He tapered off in the last 10 minutes, going well, but shorter.

GAUGE and OUDIE POSTED

Brace 25, Day 5: Dream Catcher's Windstorm-Windy, handled by Kyle Merrill and Kinwashkly Speed Racer-Reese handled by Paul Dorion. 30 degrees and sunny this morning. Both dogs were off with good ground covering speed, staying busy. At 5 minutes, Paul's dog was pointing in the tree line at a feeder with 10 o'clock style. Kyle's dog honored then changed her mind and came off honor. She was up. Paul's dog was, but the point was barren. At 30 minutes Paul picked him up, as he was animated, but not forward going.

Burchett and Godfather's F.N. Rockstar-Rocky-handled by Steve Chang. Animated start, going forward, one on each side. Good speed. They both got around Fish Hook smoothly. At 23 Breezy went on point with beautiful style. High head and tail. She did a relocate taking a line into deeper cover. Searching. No bird. Sam working a bit ahead of Breezy now. Paul called point for Breezy at 51. A lengthy flush attempt came up empty. Both dogs ended their day birdless.

Brace 28, Day 5: Diamond Hill Ain't My Fault- Scout handled by Lisa Pollack and Blaze Away Bonita-Boo handled by Bob Burchett. Scout laid down a race with impressive speed. Boo worked more cover. At 12 minutes Scout was on point in thick, high cover. High head, nice style. Lisa flushed two quail for her. At 27 Lisa pulled the tracker as Scout had an extended absence. Boo too had been working out of sight and wasn't seen. Bob worked his vocals and Boo came in at 37. At 41 Boo is up.

Brace 29, Day 5: Wingra's Indy-Go-Indy-Indy handled by Kyle Merrill and Spanish Ranch's Full Blown Gale-Gale handled by Paul Doiron. Great start off the line. Gale rimmed her second field, Indy

working further in the trees. At 12 Gale on point, uncertain, staunched up, relocate. No bird here. At 13 Indy is on point, but the find was barren. Both got around the Fish Hook in good order. At 38 Indy was on point, looking great in shoulder high cover. Gale honoring with good style. Kyle working hard but came up empty. At 45 Indy on point again and finally rewarded with a single. All in order. At 50 minutes Indy on point and Gale honoring. Kyle relocates and comes up empty once again. He picks up Indy. Gale ends her day birdless.

Brace 30, Day 5: Copley Sheltany Echo of Angels-Zoie

handled by Scott Johnson and Sniksoh Evolution-Eve handled by Jeff Hoskins. An exciting start with both dogs fast off the line. Both dogs on point simultaneously. At 3 min Zoie looks like a million bucks, high head, high tail. Her bird handled well. Eve looks great, relocates, long search, but comes up empty handed. At 25 Eve is gone on a relocate. Her day was ended early. At 29 Zoie swapped ends into a point that produced 10 birds. Steady as a rock and pretty as a picture. Taking off she is still snappy, running a narrow forward course. At 45 on point with a small covey as her reward. At 52 she is on point in an edge, the birds came out 2 then 6. She stayed staunch and steady. At 56 minutes she got in the water and was going away at time.

Brace 31, Day 6: Red Granite's Henry Will Be a Star-Henry handled by Bob Bakas and Dan-De Tyghten Up-Cinch handled by

Steve Chang. Nice weather at 52 degrees. Both dogs off the line straight away, lots of enthusiasm, moving out smartly. Cinch a nice rim of the first field, stretching out. Henry on point working a hot spot, but nothing there. He is working to keep forward, working those side objectives. Cinch is working cautiously. At 35 minutes the Judges ended their day.

Brace 32, Day 6: Sniksoh Little Diamond-Kate handled by Scott Johnson and Dynamitemakeit-Dyna handled by Paul Dorion. Off nicely, Dyna tight to the edge. Nice rim of a field by Kate, running hard. Headed for Fish Hook Kate needs a little encouragement to make the sharp turn. Dyna comes along more easily. Both dogs really putting it down. Both dogs together. Handlers are smok'n the pace. At 28 Kate points with nice style. Birds flew and she was staunch. She moved forward smartly, getting back to business. Dyna working the field edges left and right with good speed. Dyna found a hot spot, but nothing to work. At 49 Kate is pointed in heavy cover. Scott dismounted and 30 birds boiled out. Kate handled it perfectly. Kate slowed at the end. Dyna's still moving diligently but ended her day with no bird.

Brace 33, Day 6: DP's's Little Bit of Mahem Mila-Mila handled by Bob Burchett and a Bye. Last brace- last day, gorgeous weather with blue skies and wispy white clouds. Mila is all business and heads off to the right. At 3 minutes she is on point with a 10 o'clock tail. A whole covey rises round her. She stands it beautifully. Very classy. She is moving along with nice speed digging into the tree lines looking for more. Found a hot spot but moved on. At the Pavilion field she was deep in the cover with the scout looking for her. Working the feed patches hard, but close. At 26 her handler elected to retire her for the day.

His FC/AFC Mr. Buddy Boy was Runner-Up Champion in both the Open and Amateur Championships in 1994 and earned the Purina Dog of the Year Award. Ed has served as ABC Central Dates Coordinator and put countless hours of physical work into the Rend Lake grounds and the Pyramid field trial grounds in Illinois, making trips back and forth from his Missouri home.

Judy served as field trial secretary for decades for the Southern Illinois Brittany Club, the Illinois Brittany Club, the Mid-South Brittany Championship and currently the Illinois Brittany Championship. She also cooks most of the meals for those field trials along with scouting for Ed and their dogs. She serves on the ABC Magazine Committee, served as Final Futurity Forfeit Secretary from 2007 to 2014 and continues to work with the Futurity Committee.

Judy is best known for her knowledge of finance and Not for Profit rules and regulations. She was instrumental in creating a 501c3, NFP Foundation for the ABC and has served as ABC Financial Committee Chair since its inception. She established the first ever budget process for the ABC. Judy served as Executor of the Estate of Janet & Jim Chase, directing thousands of dollars for the Pyramid field trial grounds and to the Bird Dog Foundation.

ABC 2021 Quail Classic/ Championship <mark>∺purina</mark> ProPlan

The Greater St. Louis Brittany Club hosted the 2021 ABC Quail Classic/ Championship on the Sportsmen's Association Field Trial Grounds in Grovespring, MO. The competition started on Monday November 15th. With 39 entries and 38 starters, Judges Howard Burbach of Pleasant Hill, Missouri and Chad Chadwell from Springfield, Illinois assessed dogs over a 4 day period. Hunting application and bird work were critical factors in the final decision of these judges. Their time in the saddle was greatly appreciated.

First Place: As detailed below, GFC, FC Sniksoh Hank's Hatch (Hatch), handled by Bob Burchett captured the 2021 ABC Quail Championship title. Hatch was sired by GFC, FC, AFC Sniksoh Spank's Hank out of Sniksoh Boomer Babe and is owned by Adam Freeman of Marshfield, MO. Hatch was a frequent winner over the past year and finished a close second to RU-JEMs Last Penny for this year's ABC Purina All-Age Dog of the Year. As detailed below, Hatch ran a forward race, handled kindly, and had multiple stylish finds.

Second Place: GFC, GAFC, FC, AFC JJ's Levi The Lionheart, handled by owner Joe Williams, was named Runner-Up Champion. Levi, sired by NAFC, GFC, FC, AFC Spanish Corral's Sundance Kid out of Sandbank Rose, has been a perennial winner on the American Brittany Club All-Age field trial circuit for several years. As detailed below, Levi handled well and ran a forward race with 3 nice finds.

Third Place: WW's Gin and Tonic (Ginee) placed third. Ginee was sired by NFC, NAFC, GFC, GAFC, FC, AFC Glade Run Irish out of GFC, FC Driving Miss Daisy II. Ginee was handled by owner Burton Wice of Saint Louis, Missouri. Ginee ran a strong All-Age race with 3 finds. A few inconsistencies in her application kept her from placing higher.

Fourth Place: B & T's Sundance Kid Rock (Rocky) took fourth place. Rocky, sired by NAFC, GFC, FC, AFC Spanish Corral's Sundance Kid out of Janee's Dirty Dancer, is owned by Trasa Fowler of Stillwater, Oklahoma. Rocky had an inconsistent run but 4 incredibly stylish finds.

The Field Trial Sportsmen's grounds are in the upper echelon of field trial venues in the nation. The grounds are groomed solely for field trials with feed strips lining the edges and thoughtful mowing of the fields. The three one-hour courses have a natural flow and offer good cover for quail and for watching dogs. Pre-released and wild coveys of quail are plentiful here; supplemental birds planted during the trial are an added bonus and aid in bringing the resident coveys back on course. As a result, multiple large coveys of quail were pointed (or not!) each brace. This year, the feed strips were extremely dense. Although this provided heavy cover for the quail, it also challenged handlers and scouts to locate dogs standing in the edges. As usual, three braces were run each morning and another three each afternoon.

Missouri's rifle deer season started during the Championship which put the hunting season rules into effect at the start of the event. During deer season trials are not permitted to run through Clymer's pastures because of landowner hunting plans and The Missouri Department of Conservation does not allow us to use the clubhouse loop which is adjacent to a state wildlife area. This necessitated a horseshoe turn on the north end of the Bull Pasture and a return trip past the Blue House, then turning south into the chute below the Twin Barns to resume the typical route on course three. Unfortunately, this 2-hour course was usually sufficient to complete three "1-hour" braces.

Secretary Burton Wice conducted the draw as advertised on Sunday evening November 7 in his horse trailer on the field trial grounds. Thirty-nine dogs were entered in this prestigious stake and only 1 was unable to make it to the starting line. Overnight lows during the course of this trial ranged from 25 to 40 degrees with daily highs typically reaching into the 60s.

Purina donated small pouches of Pro Plan Sport dog food for all entrants as well as large bags for the winners. Garmin donated a Pro 550 advanced training system for the Champion. The Greater St. Louis Brittany Club and the American Brittany Club Quail Championship participants are very appreciative of the support received from these fine companies.

The members of the Greater Saint Louis Brittany Club worked well together and put on a smooth-running event. Burton Wice, field trial secretary, handled all of the paperwork and coordinated with the others as to who would take care of each day's duties. The club hired Jim Lowery, the caretaker of the field trial grounds to plant birds each morning. Burton Wice, Joe Williams, and Mitch Sims prepared limited meals while Stan Williamson made sure we had plenty of supplies for the dog wagon. Jerry McGee, of Steward, Illinois drove the dog wagon for the entire stake. While 3 other dogs still in the running for this year's Purina All-Age Dog of the Year were challenging his RU-JEMs Last Penny for this year's award, those in the horseback gallery had to keep one eye on the dogs ahead and the other on the dog wagon behind as Jerry kept inching closer and closer to see the action. His driving during these braces reminded us of the late Phil Corlew, long-time dog wagon driver for the Greater Saint Louis Brittany Club, who always gave the dogs a ride to remember. You can rest easy now Jerry- no one caught Penny.

Winners

The newly crowned Champion, GFC, FC Sniksoh Hank's Hatch (Hatch), handled by Bob Burchett began his performance at the end of Little Vine Loop. Hatch stuck to his lines although he was not the biggest running dog. In Sycamore Bottom, Hatch and his bracemate had a divided find at 17 minutes. After turning left and uphill from Sycamore Bottom toward the Twin Barns, Hatch had his second find at 23 minutes on the left edge halfway to the Twin Barns. Following a non-productive, Hatch was found standing again at 36 minutes at the start of the Bull Pasture. After another find in the Bull Pasture, Hatch had his 5th find at 58 minutes just before entering the chute at the beginning of course 3.

After 2 short braces, GFC, GAFC, FC, AFC JJ's/JBW's Levi the Lionheart, the Runner-up Champion, handled by Joe Williams, was turned loose in the Island Field. Levi is a perennial winner due to his excellent application, handling and ability to find birds and today was no exception. Levi handled well and had a good forward race at adequate range. He was rewarded with finds at 19 minutes just before entering Little Vine Loop, at 50 minutes in the heavy cover on the left edge on the way from Sycamore Bottom to the Twin Barns, and at 58 minutes near the large pond after continuing past the Twin Barns.

WW's Gin and Tonic (Ginee), the third-place winner, was turned loose at the far end of the Bull Pasture and worked her way to the chute where it enters course 3. Ginee took the left edge and was not seen when we arrived at the double gates at the end of Sycamore Bottom. After searching, Ginee's scout found her standing in the heavy cover where she was last spotted. Following a relocation, a bird was flushed with all in order. After a refreshing swim in the pond at the end of the chute, Ginee took the right edge and was rimming the last field at the end of Sycamore Bottom before she went on point heading toward the road- birds were flushed with all in order. Burton took Ginee across the road and waited for the judges before sending her down the right edge. Rimming the feed strip and heading back toward the second Creek Crossing on course 1, Ginee went on point and was rewarded with her third find. Ginee took the far right edge forward on course 3 back toward the clubhouse, went up, over and down the mountain at the end of course 3, and finished her hour running strong to the front as she re-entered the Breakaway Field.

B & T's Sundance Kid Rock (Rocky), fourth place winner, was turned loose at the end of Little Vine Loop and hunted his way toward the front for the entire hour. Rocky was found standing at 23 minutes by the pond near the double gates and Scott flushed birds and fired with all in order. Rocky then had finds at 27 and 29 minutes on the left edge heading toward the Twin Barns and another at 32 minutes at the gate by the Twin Barns. Of particular note, Rocky's style on point was excellent- he stood staunch with

his head and tail up high on all four finds. Following non-productives at 43 and 55 minutes, Rocky finished the hour at the far end of the Bull Pasture. The Running:

Day 1. Brace 1: TMR's Lucky Betts (Betts; Tommy Tracy, Jr.) and Tequila Chica Bonita (Chica; Richard Beaver). Shortly after the breakaway, Chica was found standing on the left edge before the first Creek Crossing. Richard was unable to flush birds and Chica was given a non-productive. Betts then had a nice covey find at 13 minutes on the left edge just before the second Creek Crossing. After crossing the road into Davis Bottoms, Chica was found standing with excellent style in the feed strip along the road. Betts failed to back and was ordered up. Richard then flushed a large covey, fired, and collared Chica with all in order. Continuing through Davis Bottoms, Chica was confused by the difficult and changing wind directions in this part of the course. He went on point at 39 minutes near the Creek Crossing into the Island Field but unfortunately had problems handling the birds and his day was done.

Brace 2: R&H Dark Night (Mac D; Bob Burchett) and CVK's Jungle Land (Clarence; Tommy Tracy, Jr.). Dogs were released in the Island Field. Clarence was enamored with this bracemate before he took out birds at the 4-minute mark below Horse Killer Hill. Mac D had trouble keeping up with his handler before taking out birds below Apple Tree Hill.

Brace 3: McChesney's All Down the Line (Ranger; Scott Johnson) and Dogwood's Fireball Whiski (Whiski; Bob Burchett). The dog wagon had a flat tire at the bottom of Don Fox Hill which required a short delay in the running. Fear not because Joe Williams came to the rescue and returned from camp with a spare. After the tire change, dogs were released at the gate at the top of Don Fox Hill. Ranger's performance was described above. Whiski did an excellent job on the ground- he handled well and was constantly forward. At 22 minutes, the scout found him buried in a feed strip in the first field after Little Vine Loop. Unfortunately, the birds that were also buried in the feed strip were too tempting for Whiski and his day was done.

Brace 4: Big Mac XIV (Big Mac; Tommy Tracy, Jr.) and Alder Grand Hopes Penny Ante (Penny R; Bob Burchett). Dogs were turned loose in the Breakaway Field. Big Mac went on point at 13 minutes on the right edge before the second Creek Crossing. Tommy flushed birds and fired with all in order. Tommy called point again for Big Mac at 50 minutes and fired his gun but the judges had not seen a bird. Penny R put up birds at 50 minutes in the left edge of the first field in Little Vine Loop. Both dogs were pretty tired before the end of their time on the ground.

Brace 5: GFC, FC Sniksoh Hank's Hatch (Hatch; Bob Burchett) and GFC, FC, AFC MK's My Lil Ammo (BB; Scott Johnson). Hatch's performance was described above. BB and Hatch had a divided find at 17 minutes at the pond at the end of Sycamore Bottom. BB then took the left edge toward the Twin Barns and was rewarded with a find at 22 minutes. BB struggled on the ground for the last 15 minutes of his hour but had a third find at 55 minutes.

Brace 6: DC, AFC Arrow's Tequila Rustler (Rusty; Richard Beaver) and GFC, AFC Maxwell's Prickly Pete (Pete; Tommy Tracy, Jr.). Dogs were released at the chute re-entering course 3. This section of the course is known to hold several coveys of birds and this day was no exception. Rusty went on point at the 2 minute mark. Richard flushed birds, fired and moved him on with all in order. Unfortunately, Rusty put up birds just before the chute enters Sycamore Bottom and his day was done at the 5 minute mark. Pete also went on point at 2 minutes at a different location in the breakaway chute. Tommy was unable to produce birds and Pete was given a non-productive. Exiting the chute, Pete was rimming the right edge at the end of Sycamore Bottom and heading toward Parks Creek Road when he put up birds at 10 minutes to end his day.

Day 2. Brace 7: Prairie Wind Pistol Pete (PD; Tommy Tracy, Jr.) and TNT's Handsome Harry (Harry; Bob Burchett). Dogs were released in

the Breakaway Field. PD wasn't seen thereafter and Tommy called for the tracker at the second Creek Crossing. Harry went on point at 27 minutes on the left edge at the end of Davis Bottoms. Birds were flushed with all in order. Harry continued through the Island Field, Up Horse Killer Hill and down Apple Tree Hill. Unfortunately, Harry put up birds at the entrance to Little Vine Loop to end his day at 50 minutes. Harry made some nice moves on the ground but overall, his run was a little erratic.

Brace 8: B&T's Sundance Kid Rock (Rocky; Scott Johnson) and Georgia's White Lightening (George; Tommy Tracy, Jr). Rocky's performance was described above. George wasn't pleasing his handler and was picked up at 23 minutes.

Brace 9: WW's Gin and Tonic (Ginee; Burton Wice) and NGDC, GFC, FC, AFC Sniksoh Little Diamond (Katy; Scott Johnson). Ginee's performance was described above. Katy does a lot of winning but a breach of manners at 12 minutes ended today's performance early.

Brace 10: Jagoub's Spell Caster (Tabu; Tommy Tracy, Jr.) and Sniksoh Hank Gypsy Cruise (Cruise; Bob Burchett). Tabu's run was a little erratic, wasn't pleasing his handler and he was picked up at 20 minutes. Cruise proceeded through Davis Bottoms and went on point with nice style at 23 minutes at the cut in the trees near the end of Davis Bottoms. However, birds were not produced and Cruise was given a non-productive. Cruise continued on through the Island Field and took out birds at 40 minutes on the right edge of the field below Horse Killer Hill.

Brace 11: FC Sniksoh Worthy Expense (Spense; Bob Burchett) and NFC, GFC, FC Roustabout All In (AI; Tommy Tracy, Jr.). Dogs were released at the top of Don Fox Hill and motored across Apple Tree Hill. Spense went on point, with Al backing, at the entrance to Little Vine Loop. Birds were not produced and Spense was given a non-productive. Both dogs continued through Little Vine Loop. Bob called point at 33 minutes in the field after Little Vine Loop but it turned out to be Tommy's dog standing. Al was looking great as Tommy flushed a covey of birds. Unfortunately, a second wave of the same huge covey was too tempting for Al and his day was done. Spense continued through Sycamore Bottom and went up the hill toward the Twin Barns. Taking the left edge, Spense had a find at 44 minutes. After going through the gate at the Twin Barns, Spense went on point with nice style at 51 minutes on the left edge just after the pond. Bob flushed a huge covey of quail with all in order.

Brace 12: Piney Run Hilltop Blew (Blew; Kent Patterson) and FC, AFC JWB Arctic Cat (Kimber; Tommy Tracy, Jr). Dogs were released at the Blue House. Blew had a non-productive at 4 minutes. Both dogs were putting on nice ground races when they disappeared heading back toward the Twin Barns and the chute on course 3. Tommy called for the tracker at 27 minutes and Kimber's day was done. After a 12 minute absence, Blew reappeared from the rear and Kent then sent him down the chute. Blew went on point at 37 minutes at the end of the chute and Kent flushed a small covey with all in order. Blew put on an all age performance as he rimmed the fields at the end of Sycamore Bottom and proceeded on the far right edge of course 1 as we turned to head back toward the clubhouse. Some inconsistencies in his run and the long absence kept Blew off the leaderboard.

Day 3. Brace 13: Trio's I'm Finn-Tastic at Campbell's (Finn C; Bob Burchett) and FC WW's Miss Wendy Peffercorn (Wendee; Tommy Tracy, Jr). Dogs were released in the Breakaway Field. Finn C was making some nice moves when he went on point with excellent style at 12 minutes in the tree line just before the first Creek Crossing. Unfortunately, Finn C went with birds and his day was done. Wendee didn't last much longer. She disappeared up the mountain just before the first Creek Crossing. Tommy called for the tracker at 16 minutes and after a long search, found her before she got to Jake's Diner for breakfast in Grovespring.

Brace 14: SKF Willy's Miss Mollie (Mollie; Mitch Sims) and Jagoub's

WhoDat Say WhoDat When I Say WhoDat (WhoDat; Tommy Tracy, Jr.). Dogs were released at the road crossing into Davis Bottoms. Mollie took the left edge and went on point at 5 minutes. She took some steps as the birds were flushed and her day was done. Who Dat didn't last much longer. He chased birds at 9 minutes and the morning coffee break started earlier than usual.

Brace 15: GFC, GAFC, FC, AFC JJ's Levi The Lionheart (Levi; Joe Williams) and NAFC, GFC, FC, AFC ANJ's Ohio Hellion (Hank; Bob Burchett). Levi's performance was described above. Hank is a frequent winner at Grovespring. Bird work was scarce this morning but Hank was found standing at time on the left edge just before the Blue House. Bob flushed birds with all in order. However, the judges were disappointed in his ground race today.

Brace 16: GFC, GAFC, FC, AFC Piney Run Jake (Jake; Kent Patterson) and Willie Make It (Willie; Scott Johnson). Dogs were released in the Breakaway Field. Willie disappeared shortly thereafter and Scott called for the tracker. Jake has been a perennial winner on the All-Age circuit but today was not his day. Jake went on point at 52 minutes in the field just before Little Vine Loop. After a relocation, he returned and stopped again in the same location. This time a bird was flushed but a very hard mark ended his day.

Brace 17: Osage Fork Slick (Slick; Bob Burchett) ran as a BYE. Slick was released at the entrance to Little Vine Loop. His run was erratic and he put up birds on the right edge at the end of Sycamore Bottom just before reaching the road.

Brace 18: Sundance Kid's Rule Breaker (Bud; Frank Campbell) and GFC, GAFC, FC, AFC CVK's Spartan King (Leo; Tommy Tracy, Jr.). Dogs were released heading up the hill from Sycamore Bottom toward the Twin Barns. Leo immediately went on point but was given a non-productive when Tommy was unable to flush birds. Leo had a find on the left edge at 7 minutes halfway to the Twin Barns and another at 12 minutes at the Twin Barns. Unfortunately, a second non-productive at 16 minutes ended Leo's day. At 14 minutes, Bud was seen under birds by the large pond after the Twin Barns and his day was also done.

Day 4. Brace 19: Bamajama Willy's Sassie Sadie (Sadie; Bob Burchett) and Kashmir (Kash; Tommy Tracy, Jr.). Sadie got off to a good start with a find at 6 minutes in the right edge by the first tree line in the Breakaway Field. Kash then had a find at 10 minutes just after the first Creek Crossing. However, Sadie failed to back and her day was done. Kash crossed the road into Davis Bottoms and went on point in the first tree line. Tommy flushed birds but a hard mark and poor manners ended Kash's day.

Brace 20: DC, AFC Just Call Me Lucky Ned Pepper (Lucky Ned; Franck Campbell) as a BYE. Lucky Ned was released at the first tree line in Davis Bottoms and had an inconsistent run. He had finds at 32 minutes at the entrance to Little Vine Loop and at 44 minutes at the pond on top of the hill in Little Vine Loop.



Jim loved running dogs and I never saw him when he wasn't upbeat regardless of what may have happened during a brace — he's certainly missed!

We'd like to thank our judges, Sam and Kim Thompson, a father/daughter duo from

Wisconsin who are long-time Brittany people and a pleasure to be around. We greatly appreciate their time in the saddle and attention to each dog's performance in selecting the winner and placing dogs. Thanks to Bruce Heiter and Bill Cockrum for all their time and effort in the planning and the execution of those plans necessary to make this a quality event they do it all without missing a beat and a smile on their faces. We'd also like to thank our hosts, Linda Thomas and her son Tommy who've done remarkable things in improving this venue - it just keeps getting better! Linda, along with Valeria and Hyatt Burchett kept the dog wagon and road guard duties rolling along; Chuck Schaefer assisted as well, though I suspect that he was primarily guarding the donuts.

Our winner, Sniksoh Little Diamond ran in the 8th brace and was handled by Scott Johnson. Kate had 5 finds, coming at 4, 10, 17, 22 and 35 mins. with some very nice moves during her hour. She closed the hour with a stop to flush at 52 min. and time expiring as we went downhill headed west, just south of camp.

Second place went to Starlight's Callisto Moon who ran in the 6th brace and was handled by Bob Burchett. Cal backed his bracemate nicely at 3 min. and he carded 8 stylish finds, with 5 of those finds occurring within a 14 min. span: his last at the 60 min. mark. His run grew over the hour with a very nice string of moves over the last 45 mins. culminating with a sizable covey on his last find.

Third place honors went to Saradac's Dangerous Diamond Caper who ran in the 2nd brace and was handled by Lisa Pollock. Caper carded 5 well placed finds with beautiful style and covered the ground with a snappy gait and an attractive manner of going; a fun dog to watch!

Pushing the winners, in fourth place was Copley-Shelttany Echo of Angels handled by Scott Johnson in the 3rd brace. Zoie carded evenly space finds looking very nice on point for each one. At the 56 min. mark, she had a stop to flush on a Pheasant along the fence line at the NE corner of Charlies place.

The Running:

Brace 1: Sovereign's Legendary Cowboy (Duke) – Bob Burchett and Supernova (Nova) – Scott Johnson. Duke had a big, forward pattern with 5 stylish finds; a large absence from judgement took him out of the placements. Nova backed Duke nicely at 18 & 28 mins. with 3 solid finds of her own on coveys at 13, 15 and 35 mins. respectively. She had a nice run overall that slowed nearing time.

Brace 2: Romence's Life of Riley (Riley)

Diamond Caper (Caper) – Lisa Pollock. Caper's 3rd place run is covered above; Riley backed her nicely at the 7 & 15 min. marks. She carded 3 nice finds of her own: coveys at 19 and 24 mins. with nice style and intensity. A non-productive at 38 mins. and a stand on a single at 48 mins. Both dogs pointed again, directly after time was called for the hour.

Brace 3: Copley-Shelttany Echo of Angels (Zoie) – Scott Johnson and A Trace of Bourbon With Diamonds (Trace) – Rick Hastings. Zoie's 4th place run is detailed above. Trace had 2 finds coming at 8 min. & 40 min. marks with nice style; he backed his bracemate at 32 min. directly upon being released from a non-productive at 28 min. His recovery from an injury effected his performance and Rick elected to pick him up at the 50 min. mark.

Brace 4: Sanbar's Legendary Black
Tie Affair (Jackson) – Bob Burchett and
Woodsong's Honky Tonkin' Hank (Hank)
– Scott Johnson. Jackson was slow to start,
carded a non-productive at 5 mins. and Bob
elected to pick him up as we neared camp as
he was clearly off his game. Hank made some
nice moves initially carding a beautiful find at
5 mins. He carded his 2nd find at 43 mins. and
a stop to flush at 52 mins. Hank's pattern and
speed suffered towards the end of the hour.

Arrow was away fast at the start, disappearing near the 1st crossing; Rick called for the tracker at 14 min. & later finding him near the NW corner of the property. Jackson's pattern grew over time, making some nice moves with finds at 10, 14 and 18 mins. He also carded 3 stop-to-flushes over the hour.

Brace 6: Starlight's Callisto Moon (Cal) – Bob Burchett and MK's My Lil Classic (Nova) – Scott Johnson. Cal's 2nd place performance was covered previously. Nova carded nice finds at 3 & 7 mins., a back at 15 mins. and a non-productive at 20 mins. She made some nice moves with a snappy and fluid gait, catching your eye as she ran. Nova got headstrong at times with Scott electing to end her bid at the 41 min. mark near the old barn site on the North edge of the property.

Brace 7: Dogwood's Benelli (Benny) – Bob Burchett and Windfall's I Put U Under My Luv Spell (Freya) – Ben Campbell. Benny ran forward though difficult at times, with his speed and application growing as the hour progressed. He had a stop-to-flush at 26 mins.; non-productives at 47 & 55 mins. ended his bid. Freya was away quickly on a feed strip where she suffered an indiscretion at the 3 min. mark,

ending her day.

This pair broke away with speed to find Rocky standing and Cobo backing nicely at 2 mins.; Cobo exhibited great poise with Rocky going with the bird. Cobo went on to have a stylish find at 9 mins. and a non-productive at 15 mins. to stand again at 38 mins. where he bumped the birds on his 3rd relocation to end his day.

Brace 10: Starlight's Mercury Out Ryder (Ryder) – Bob Burchett and Almaden's Under Lock And Key (Oudi) – Ed Tillson. Ryder was running fast and making moves early, a bit headstrong at times late in the hour; overall a nice performance with 2 finds with lofty style. Ryder made almost an entire lap of the property during his hour. Oudi likewise was running hard and making moves with a stop-to-flush at 28 mins. and a quality find at 35 mins. with all in order. At the 44 min. mark, he stood again, but succumbed to temptation ending his bid early.

Brace 11: Sniksoh Hank's Hatch (Hatch) – Bob Burchett and Kid's Royal Casey (Casey) – Bruce Heiter. Both dogs ran hard and made nice moves during their time on the ground. Casey had finds at 7, 9 and 26 mins. with the spring winding tighter with each one, then at the 32 min. mark it came unwound ending Casey's bid. Hatch had finds at 33, 40 and 43 mins.; shortly after release from the 3rd find, Hatch decided to flush some birds of his own to end his bid early.

Temperatures were cold mornings and coolish afternoons with low humidity and light inconsistent variable winds. Scenting conditions were tenuous due to extremely dry ground conditions.

Richard walked into the trees and finally found the running birds and put one to flight with Judge Rohner standing close by. Rusty stayed staunch through the search and flush as time expired to the delight of all watching. A wellearned first place performance by dog and handler alike.

Bits About Brittanys by Clarence Goering

The following stories and cartoons have been reprinted from a manuscript that was intended to become a published book. This work was titled "BITS ABOUT BRITTANIES" and was written by Clarence Goering from Newton, Kansas. Clarence bought his first Brittany in 1942 it was a male he named Marquette Allamuchy. He was very active with Brittanies from that point until the 1960's. Being an active, well-known breeder during that era his kennel "TRIUMPH BRITTANIES" was nationally sponsored by Ralston Purina feed company. A copy of this manuscript was assembled into book form and is on display at the Brittany Field Trial Hall of Fame museum in Grand Junction, TN.

HUNTING STORIES South Dakota Hunts

When my dog Roc was a little over a year old, I took him with three of my older dogs to South Dakota for pheasant hunting. One day while we were there, we decided to work a weed patch along a fence row. The path was long and narrow, so three of us started at one end and the other fellow drove the car to the other end. He parked the car about a block beyond the end of the weed patch and walked back to block the end. We shot several birds before we go to the end of the patch. So we thought we had put up all the birds and started to walk along the fence row to the car. When we were about halfway to the car, Roc went on point in the fence row. We were sure he didn't have a bird pointed, but when we walked up to him a big cock pheasant boiled out of the cover in front of him. We were real surprised but did manage to recover in time to drop the cock.

After the retrieve, we again started to the car. But I looked back and there he was again, standing on point on the spot where the bird we had just shot had been. Of course, we all thought he was pointing the scent of the bird we had just shot, so I walked back and took him off point and we again started for the car. As we were almost to the car and looked back, there he was again pointing at the same spot. Well, we all knew there was no bird there, but we walked back so I could prove to Roc he was wrong. As I kicked the grass in the fence row ahead of him, believe it or not, another big cock flushed. This surprised us so much that all four of us shot at the bird. You guessed it, we all missed. This incident caused me to make the following remark, "Usually when you think the dog is false pointing and you call him a liar, he ends up making a liar out of you

because he really has a bird pointed."

The Following Day

The next day when we were out hunting, we were working a shelter belt that ended along a road ditch. As we came to the ditch we thought we had flushed all the birds, so we decided to take a little rest before walking back to the car.

We sat around for a while talking about our hunt. After we had rested, we started to walk to the car. However, I looked around to see where the dogs were and there at the fence row stood Rock and Tammy on point in the heavy grass in the ditch. So, I jokingly said to the other fellows, "You guys go on, but I'll go back and shoot the bird the dogs are pointing." They stopped walking but didn't really believe the dogs were actually pointing a bird since we had been sitting only a few feet from the spot where they were pointing.

As I stepped in front of the dogs, a big clock flushed. I was ready and dropped him. Tammy picked up the bird and Roc followed her to bring it to me. As I was taking the bird from Tammy, Roc went on point again, pointing right where the bird I had shot had flushed. I was a bit skeptical but was ready in case there was another bird there. Again, as I kicked the grass in front of Roc, a cock boiled out so I dropped him and Roc made the retrieve. As I took the bird from, believe it or not, Tammy again pointed at the same spot. "Well," I said, "this is ridiculous, there just can't be another bird there." But to my surprise a third cock flushed. I knocked him down and the dogs made the retrieve.

To Judge

According to the new edition of Merriam-Webster, to judge is "to form an authoritative opinion; or to form an estimate or evaluation about something". It is thus within our world of pointing dogs, a person qualified to pass critical judgment over competition events, which include although not limited to field trials, hunt tests, show, obedience, and agility. However, for the most part, the remaining discussion will pertain to all events with exception of those remarks concerning weather.

The individual who judges must:

- Know the breed; in this case the Brittany,
- Significant experience handling and working with the breed,
- Understand the importance of placements and long-term factor on progress to improve the breed,
- Recognize judging is a "thankless", never-easy job in the face of disagreeable weather rain, snow, extreme heat and humidity,
- Consider to the sport be brought judgment of values, honesty of purpose, and integrity.

It's important for a judge to know the "rules of the game/competition".

The American Kennel Club (AKC) has specific guideline to become a judge. There are educational and testing programs along with seminars that must be attended in order to become a judge. Plus consider there are separate rules and regulations for each type of competition.

As previously mentioned, judges, besides having a significant degree of experience with pointing dogs, there must be never any politics involved with placements in the events.

Personally, it has happened to this author; once in a show event and once following a field trial:

Lot of training at home with many months attendance at obedience classes with our Brittany; upon entering show ring, observe dog immediately behind actup as judge evaluates him. He went onto receive the blue, which gave a championship; our Brittany — nothing. Was told "you're just a "newby"; wait your turn".

The second AKC field trial attended; our Brittany receives a yellow. Later, one of the judges apologized, indicating our Brittany should have been placed higher. Dog that won got his field championship and should have not even placed. Handler/owner friend of the other judge.

In researching to write this article, a primary focus was on field trials; although many of the statements and or opinions can be applicable to other competitive dog sports. Many years ago quotes were made by the American Field Magazine editor, Albert F. Hochwalt. The subject was judging!

"Judges are major factors in the progress of breeds. It is an accepted fact that field trial placements influence the selection of breeders and so the thought should ever be uppermost that dogs of quality, of high character—dogs which can contribute to breed advancement—should be given prime consideration."

Mr. Hochwalt then went onto cite a well-known judge of the time, Clarence Aldrich, who would put/paste in his personal judge's book, before each assignment, the following reminder:

Do not measure a dog's greatness by the distance he goes from his handler to find birds.

Do not give preference to quantity, if brilliancy is lacking. Do not be carried away by a temporary display of brilliancy remember one swallow does not make a summer. Do not make a dog win twice.

It is better to condone the slight mistake of a genius than to reward mediocrity.

Mr. Hochwalt also continued by stating: "In these five precepts lie the essence of the entire law of field trial judging." As this author contemplates some of the above statements, it is perceived and acknowledged that my understanding of some of the wording is not easily understood. My own field judging experience was and is very limited; it was decided to get the opinion of several well-known judges. The word that just "jumps-out" from Mr. Aldrich's and Mr. Hochwalt's point-of-view on Judging is "brilliancy".

Dictionary definition—several as follow: intelligent, outstanding, exceptional, or magnificent.

With respect to dogs, the word "brilliancy" probably should be considered for performances in the show ring to be a dog that is a near perfect specimen conforming to the breed standard. In addition the dog must respond to handler regarding instructions for performance in the ring. Further other competitive sports both field – hunt tests and NAVDA – and other ring competition such as agility and obedience; these dog competitions can focus on the term "brilliancy".

With regard to the term "brilliancy" and field trial events, a Judge will observe the dog's (a Brittany) performance, such as

- the cast on breakaway,
- making casts and hunting during the run,
- when on-point as the dog gathers in scent with intensity of the point with head high and tail set,
- never circles back coming through the gallery, also to the front,
- manners during stop-to-flush,
- manners as dog honors brace mate's point or stop-to-flush,
- attitude toward handler respecting commands and direction.

As the judge observes and considers all the above and with his experience and knowledge a rating for the dog will be made.

As this writer comes to a conclusion for this piece, we all should and I will give thanks to all who are willing to take on this "thankless" job of being a judge for a dog sporting event.


