

# 2021 ABC National Championship November 27 to December 1, 2021

The 2021 running of the American Brittany Club National Championship boasted an entry of 59 dogs with all 59 coming to the line starting Saturday, November 27 at the Blue Mountain Wildlife Demonstration Area near Booneville, Arkansas. The weather was mostly clear skies with coolish mornings and mild to very warm afternoons. Light variable winds prevailed but the dry conditions and low humidity made for challenging scenting conditions. The grounds were pristine making for excellent viewing of those dogs who stayed on task and wanted to be seen.

A smooth execution of this event would not be possible without the dedicated people who work tirelessly to ensure success. Kent Patterson managed the multiple tasks associated with his position as Field Trial Chairman in an organized and efficient manner. Members of the Field Trial Committee consisting of Joe Gower, Bret Lindback, Steve Ralph, Bob Rankin, Richard Beaver and Burton Wice, dedicated hours assisting Kent with the scheduling and coordination of all the national activities. Tom Milam served as Stakes Manager and Bob Rankin managed the Judges Marshall duties. Bret Lindback served as Course Marshall and he and his crew of volunteer Marshalls kept the gallery flowing in an orderly fashion.

Judi Tipton and crew worked hard to provide us with excellent food and beverages throughout the running. The grounds were in tip top shape due to the efforts of Red Bailey and Brad Wells. A special thanks to Red for the extra days he spent grooming after his retirement. We will certainly miss Red and wish him all the best. Kudos to Tom White

for coordinating the multiple tasks associated with the management of the dog wagon throughout both the Amateur and Open Championship. Thanks always to Road Guard Mary Jo Trimble for driving her vehicle down Hwy 109 during the running, keeping an eye out for dogs that wander off course and onto the highway.

Purina has been a consistent sponsor of the American Brittany Club National Championship events for many years. Purina again donated small bags of Pro Plan to each dog entered and full bags were distributed to the Winner and placers. Performance Purina jackets were





presented to the Judges and Reporter and were most appreciatively received. Huge thanks also go to Kevin Parrish, The Saddle Guy and to Garmin for their donation. Thank you seems too little to say when all these guys do so much for not only our National events but all field trials.

This year public drawings were held for both National All Age Championships. Both draws were held on Saturday November 20 at 2 PM in the Clubhouse on the Blue Mountain Field Trial Grounds in Booneville, AR. Kent Patterson came prepared with all the right equipment and officiated these draws flawlessly with the technical support of National Field Trial Secretary Steve Ralph who ran the computer program being viewed on the large projection screen throughout the process. Mary Karbiner and Bob Rankin manually wrote down the info in case of a device malfunction. Competitors were mesmerized as the spinning numbered balls were drawn for each dog to establish brace mates. The paired brace mates were then drawn for a brace number to complete the bracing sheet. Fascinating; with the few conflicts being resolved immediately and effortlessly. As each stake was completed a handwritten bracing sheet was placed upon the bulletin board for those who wanted to photo them before the hard copies were printed.

Events held during the week of the National Championship began with the National Championship Calcutta on Friday, the All Age Purina Awards on Saturday and Lordy, Lordy no one will ever forget the spectacular 2020 National Championship Winner ABC NFC Roustabout All In Banquet on Sunday night. The Clubhouse resembled an exclusive Las Vegas casino offering Raffles, Gambling and Dancing following the five-star buffet feast. We all thank Al's owners Dr. William "Bo" and



Renae Ackerman; Party Planner extraordinary Carla Tracy and Judi Tipton and crew for all their hard work preparing the fabulous food and lively presentations.

This year's judging panel included Jon Humphrey of Claremont, OK and Chris Weatherly of Grand Junction, TN. Both adjudicated with integrity, knowledge and a deep understanding of field trials and field trial bird dogs. Both were looking for qualities such as speed, range, style, stamina, good manners and a consistently forward race. The dogs best exhibiting those qualities are listed below.



The Recognized:

Champion: Top Dog Brace 12 FC/AFC CVK'S SPARTAN KING "LEO", handler Tom Tracy; owners, Jack Alexander & Dr. Bob Rankin. Leo is a 7-year-old white and orange male out of Maxwell's Outer Limits and Cedar Valley Lilly. Leo ran in the final brace on Sunday breaking away on Course 1 through the Cotton Fields fast and forward. At 10 Leo was observed standing tall and tight at the start of the river strip with his brace mate Karl honoring. A large covey was put to flight with all in order and both dogs were sent on. Leo ran the river until he angled right at the first tree line and pointed sharply at 13. Just as handler Tracy arrived, Karl ran past the pointing Leo who was picked up for failure to honor. Judges and handler Tracy discussed this incident and Judges decided as far as Leo was concerned the situation was a non-event and he would be moved on. Leo covered the remaining area on Course 1 in fine form and after crossing the horse bridge onto Course 2 Leo was found





standing at 25. Leo stood staunchly through the flush and shot and sent on his way. Glimpses of Leo were seen as he ran down the strips then headed around the left turn at the old bridge and made an Olympic cast to the far tree line coming out hanging to the right side of the course. At 41 Leo put on the brakes pointing intensely into a circular tall grass area known to hold large but very stealthy coveys. After stomping around for a while handler relocated Leo but was still unable to locate any birds so he took the nonproductive and moved Leo on down the road. Leo had a great forward finish with his last cast blowing down a tree line just below the course road which put him arriving right at time in front of the handler, judges and gallery. A very fine performance deserving of the National Championship title.

RU Champion: top Dog Brace 3 GFC/FC/AFC JJ'S LEVI THE LIONHEART "LEVI", handler/owner, Joe Williams. Levi is a 8-year-old white & orange male out of NAFC/GFC/GAFC/FC/AFC Spanish Corral's Sundance Kid and Sandbank Rose. Levi ran over Course 3 where his incredible speed and power came in handy. He worked all the objectives offered by this sometimes-challenging course near and far. His first find came at 26 where he was found standing tall into a clump of tall grass. Handler dismounted and finally put a few birds to flight in a clump several feet away. Levi held tight and mannerly through the search and eventual flush and shot and was sent forward to continue his search for more birds. Levi was all business as he worked his way over the course and was rewarded with a big covey find at 52 which was handled head and tail high. With only 5 minutes left to go Levi broke through the brush going away to the front as strong as he had started.

Third: Top Dog Brace 15 GFC/GAFC/FC/AFC PINEY RUN "JAKE",





handler/owner Kent Patterson. Jake is a 9-year-old white and orange male out of NFC/FC/AFC Piney Run Art & Piney Run Gypsy. Jake, a veteran to these grounds, broke away quickly, a dog on a mission, aiming for those remembered objectives. At 10 Jake was found buried up in tall cover, head and tail high. A small covey was flushed with all in order. Jake was watered then turned loose and began randomly hitting objectives near and far. Jake hit the jackpot at 50 pointing regally into a plot of tall dense cover. A large covey was put to flight with the mannerly Jake standing tall through the loud wing beats. Jake finished his hour with a strong forward cast to cinch the 3rd place finish.

Fourth: Top Dog Brace 30 FC DYNAMITEMAKEIT, "DYNA", handler Paul Doiron; owner Peggy Doiron. Dyna is a 4-year-old white and orange female out of NAFC/GFC/FC/AFC Spanish Corral's Sundance Kid and FC Blew By Yet?. Dyna ran last as a solo girl-on-fire in the final brace. Start to finish Dyna traversed Course 2 displaying a strong forward race making eye catching moves to likely bird hideaways with grace and ease. Her single dramatic find came at 50. Handler was observed looking intensely into a small stand of trees surrounded by short thick brush. This was the exact spot where a large covey had been moved the day before. Handler dismounted and slowly raised his hat as he approached the objective. As handler moved into the cover several birds took flight in rapid order. Dyna who was buried up in the brush remained calm and composed through their flight and the shot. She was then watered up and turned loose to continue her intelligent eyepleasing race finishing forward and as strong as she had started. It was a well-earned 4th place performance. In addition, Dyna was awarded the Christy Feather Duster "Best Bitch" Award for being the highest placing bitch in the National All Age Championships.

The Running: First Day, Saturday Morning, Nov 27, 2021, Temp range 35 to 56, 31% humidity, light NE winds.

Brace 1: Gun Creek Gangster, "Doc", Chad Holman and Godfather's F.N. Rockstar, "Rocky" Steve Chang. First find of the Championship went to the stylish Rocky at 10. All was in order through the flush and shot and he was sent on. At 30 Rocky pointed had a pile of feathers but he moved a short distance onto the high bank at the little pond and locked up again. Handler stomped all around and relocated the dog. The dog took one step and bam he's not gonna move anymore. Handler took one step and up came 2 birds. The shot was fired, all in order and Rocky moved on. Both dogs ran the left treeline with Rocky taking the lead making a beautiful cast that ended near the double gates in the large cane field. Rocky proceeded cautiously through the area but didn't stop when a single bird took flight in front of him thus ending his



time at 50. Doc moved efficiently and intelligently over Course 1 but was not rewarded with any birds.

Brace 2: Jac's "Ray" of Sunshine II, Chad Holman and Supernova, Scott Johnson. Both dogs took off in a foot race but soon separated started hunting for the elusive birds. Supernova scored with a nice covey find at 36 with all in order but had an erratic application throughout her hour. Ray stayed on task, hunting hard but went birdless in his hour.



Brace 3: JJ's "Levi" the Lionheart, Joe Williams and Blazin E-Z "Mac", Ray Trimble. Levi's race is described in the Recognized section. Ray rode at a steady pace across Course 3 singing loudly for Mac who was seldom seen but when he did show it was always to the front. Mac made his last appearance at 52 near the end of Course 3 but was missing at time and not returned to judgment.

Saturday Afternoon Temp Range 59 to 62, 31% humidity with SW winds 8-10 mph.

Brace 4: Almaden's Under Lock and Key, "Oudi", Ed Tillson and Jwb Arctic Cat, "Kimber", Tom Tracy. Oudi had a non-productive at 14 and was picked up by handler at 30. Kimber went missing early and tracking device was requested at 40.

Brace 5: Tequila Scorcher, "Lincoln", Ed Tillson and Spanish Corral's Big Iron, "Colt", Joe Gower. Both dogs had impressive first casts making strong forward moves to objectives near and far. At 43 Lincoln pushed a bird and was up. Colt ran a solid all age race showing speed, stamina and intelligence but went birdless.

Brace 6: Ss Rig's Colorado Gun Runner, "Rig's", Tom Milam

and Skf Jr's Straight Shooter, Steven Foster. The action started early for these two with a divided find at 8 on a large covey. Shooter couldn't contain himself and chased the birds on the flush. Rig's stayed clean through the ruckus and was sent on his way. At 15 Rig's scored another find which he handled with style and manners. Rig's continued his impressive forward race through the rigors of Course 3 with the expert guidance of his handler. Unfortunately, after his second find Rig's posted a nonproductive at 24, a rabbit find at 43 and another nonproductive at 56 which ended his effort.

#### Posted: Levi the Lionheart, Joe Williams

Day 2, Sunday Morning, November 28, 2021m Temp range 42 to 59, 37% humidity with 5 mph north wind.

Brace 7: Just Call Me Lucky "Ned" Pepper, Frank Campbell and WW's Gin And Tonic, "Ginny", Burton Wice. Ned made some good moves but went birdless. Ginny was fun to watch with an energetic fast forward race. She had a stop to flush at 5 but no other bird work during her spirited hour on the ground.

Brace 9: Knine Finale's Way To Go, "Allie", Paul Doiron and TMR's Lucky Betts, Tom Tracy. These two girls ran around like tiny tornadoes until both handlers grew weary of all their excess activity so both were picked up at 27.

Sunday Afternoon, Temp Range 60-63, 41% Humidity and 8 mph North Wind.

Brace 10: Skf Miss Cheap Bourbon Whiskey, "KD", Steven Foster and Snikson Hank's Gypsy "Cruise", Bob Burchett. Cruise pointed at 8 but self-relocated at 10 and was up. Just wasn't KD's day so she was picked up by handler at 25.



Day 3, Monday Morning, Nov 29, Temp range 43 to 64, 54% humidity, light variable winds.





Brace 13: High Hopes Jac's Original "Spice", Chad Holman and Sniksoh Worthy Expense, Bob Burchett. Spice scored a find on running birds at 15 with all in order. She continued but her race and application became erratic. Expense made a valiant effort in the bird search department but never connected with them during her hour.

Brace 14: Black Creek Uhaul, "Johnny", Chad Holman and Godfather's Red Feather Gunslinger, "Gunnar", Steve Chang. Johnny was picked up by his handler at 12. Gunnar was pinging every which way but was missing at time and not returned to judgment.

Brace 15: Piney Run "Jake", Kent Patterson and Hvk's Kid "Chance", Paul Doiron. Jake's run is described in the Recognized section. Chance broke away fast and forward and continued hunting hard and was rewarded with a single at 48. Chance did an excellent job pinning that single and showed immense intensity as he took in its glorious scent. Upon release Chase ran by Jake on point and was ordered up for failure to honor at 51.

Monday Afternoon, Temp Range 65-68, 37% Humidity.

Brace 16: B & T's Sonndance Kid "Rock", Scott Johnson and Rusty Ridge Where U "Been", Claude Kilpatrick. Rocky and Been took off over Course 1 both on a bird finding mission. Rocky got on the bird board with a huge covey find at 11 under the big cedar on the right side of the road. He was staunch through the flush and shot and moved forward to continue his quest. Where he moved to was the question and handler requested the tracker at 40. Meanwhile Been was making big fluid moves showing to the front just enough to keep it interesting. At 32 a call of point came from Been's scout, and we all went the distance in rapid order to find Been standing on the back side of a faraway tree line.





After a quick caution handler moved in and put up a single then moved Been out of the area to continue his run. Been continued across the course at an eye pleasing pace hitting objectives to the front then hit the water trough before taking off down the river run. Been was in sight at 59 but one minute later when the call to pick up resounded he was a dog gone and not returned to judgment.

Brace 17: Mtb Louree's Lets Have A Fee-"Esta", Paul Doiron and Alder Grand Hopes Penny Ante, Bob Burchett. Esta and Penny attacked Course 2 on a mission to find some birds. Penny was a gone girl at 40 but Esta stayed in touch though her moves were at times somewhat unconventional. She was rewarded with a nice covey find at 45 where she stood tall and tight while the birds were located and flushed. Esta finished her hour strongly moving forward.

Brace 18: Jagoub's Spell Caster, "Tabu", Tom Tracy and I'm Your Man, "Gus", Ben Lorenson. It was almost like Tabu put some sort of spell on Gus as they cruised the course together but also went down together after a bird indiscretion at 13.

Day 4 Tuesday Morning, November 30, Temp Range 43-64, 89% Humidity with light variable winds.


Brace 19: Piney Run Patch, Ben Lorenson and Black Creek Whizki Skip, Chad Holman. Both dogs went missing early on with trackers being distributed at 53.

Brace 20: Sr's Blew By Typhon, "Ty" Paul Doiron and Sigbrit's Not In Kansas Anymore, "Doti" Scott Johnson. Ty and Doti broke away swiftly and started hunting hard. Point was called at 18 for Ty in a grassy mound just off the left side of the road. At 20 Doti entered the area and slammed to an impressive honor. She stood staunchly as Ty was relocated. Paul decided to take the non-productive, so Doti was moved forward by an accommodating spectator to rejoin her handler and Ty was turned loose to look for birds elsewhere. Doti scored a clean find at 36 but lost her zest through the rest of her hour. Ty finished his hour strong but never connected with birds.

Brace 21: M&M's Grouse Gunning "Gracie", Kyle Merrill and ANJ's Ohio Hellion, "Hank", Bob Burchett. Gracie decided to run another course, so her tracker was requested at 25. Hank had birds with all in order at 30 but disappeared shortly thereafter and not returned to judgment.

Tuesday Afternoon, Temp Range 68-73, 37% Humidity with 8 mph westerly winds.

Brace 22: Sniksoh Hanks "Hatch", Bob Burchett and Kashmir, "Kash", Tom Tracy. Kash lost no time finding birds, pointing staunchly at 8 with all in order through the flush and shot as a big covey took flight.



Hatch ran in and gave merry chase to the fleeing birds thus ending his time at 10. After Hatch was rounded up Kash continued slowly down the course. At 20 handler decided Kash was just too tired to continue.

Brace 23: MK's My Lil Ammo, "BB", Scott Johnson and Bamajama Willy's Sassy Sadie, Bob Burchett. Sassy was not pleasing her handler so was picked up early. BB exhibited all the traits these judges were looking for in an all-age performance but was not rewarded with any bird work. The judges gave BB a well-earned special recognition for her superior ground effort.

Brace 24: Georgia's White Lightening, Tom Tracy and Shailorville's "Gunner", Ben Lorenson. The scenting conditions this day really sucked, and these two dogs decided to look elsewhere for birds both going astray early. Lightening was up at 10 and Gunner at 20.

Wednesday Morning, Temp Range 46-65, 72% Humidity and 8 mph west wind.

Brace 25: WWW Miss "Wendy" Peffercorn, Tom Tracy and Piney Run Hilltop "Blew", Kent Patterson.

Wendy and Blew took off to the left and at 12 point was called for both. As the judges and gallery arrived birds were observed in the air but both dogs were pointing into the deep treeline about 10 feet apart. Handlers dismounted and put more birds to flight with all in order, so both were credited with a divided find and sent on their way. At 53 Wendy was pointing along the river run but no birds could be produced so she was sent on to finish at a moderate range and speed. Blew went missing after the divided find and was never returned to judgment.

Brace 26: Maxwell's Prickly "Pete", Tom Tracy and Sligo "Sam", Ben Lorenson. Pete set out on his own private mission and was gone



early. Sam hunted hard from the start and was rewarded with a big covey find at 46 with all in order. He continued his quest at a moderate rate and range but encountered no more birds.



Brace 27: Blew Me Away, "Bud", Paul Doiron and Ace's One Eyed Jack, "Jackson", Chad Holman. Jackson scored at 14 when he pointed a single silly bird just sitting in front of the big cedar close to the road. Jack was clean on his bird but just couldn't quite get it all together as was the case with his brace mate Bud so both dogs were picked up by their handlers at 25.

Wednesday Afternoon, Temp Range 68-70, 62% Humidity and light westerly winds.

Brace 28: Roustabout All In, "Al", Tom Tracy and Tequila "Chica" Bonita, Richard Beaver. Quickly after the breakaway these two both got into trouble. Al was seen kinda stopping at 8 but when the birds took off Al was right behind them. At 10 Chica was seen running down an adjacent tree line, bumped a bird which ending her run.

Brace 29: Wild Wild "Willie", Ed Tillson and McChesneys All Down the Line, Scott Johnson. McChestney was lost from the breakaway and tracker was requested at 20. Willie had two nonproductive, one at 14 and the other at 25 so handler picked him up.

**Brace 30: Dynamitemakeit, "Dyna" Paul Doiron and Bye.** Dyna's run is described in the Recognized section.



Of course, it goes without saying, but we'll repeat it again, thank you to Purina for sponsoring our event both monetarily and with the donation of food to help fuel our champions! The International Classics kicked off 3 weeks of running at the Bird Dog Ranch. Followed by the ABC Central Futurity, the Iowa Brittany Club trial, Ed Powell Gun Dog Championship, Hawkeye Brittany Club trial, and finally the ABC Gun Dog Classic, the grounds became soaked with not only mud, but also huge coveys of birds. Wild pheasants were also seen during many of the braces. Mother Nature could have been a little kinder to us, but we managed to get all the stakes completed without any hold ups for weather.

The International Open All Age Classic began on Tuesday morning. Temperatures were chilly, with light rain and even some snow showers mixed in. #### Texas Amateur All Age Brittany Championship

From 1996 through 2009 the Texas Amateur All Age Brittany Championship was hosted by the West Texas Brittany Club at the Nancy Lee Ranch in Brownwood, TX. Nancy Lee was a rancher, educator and an extraordinary steward of the Lee Ranch which was founded by her parents. Nancy loved sharing the ranch with family, friends, and field trailers so they too could enjoy the beauty and game bird abundance of the ranch. After Nancy Lee passed in late 2009 the West Texas Brittany Club moved their field trial events which included the Texas Amateur All Age Brittany Championship to the LBJ National Grasslands near Decatur, Texas from 2010 to 2016. The Texas Amateur All Age Brittany Championship, now designated as a Grand Amateur Limited All Age, GALAA has been hosted by the Sooner Brittany Club since 2017 every Spring at the Lake Murray Field Trial Grounds in Ardmore, Oklahoma. Most competitors agree the Sooner Brittany Club Spring Field Trial is a great tune up for the US Open Brittany Championship and the Victorie Nationale Derby Championships which run immediately following.

Eighteen enthusiastic competitors were brought to the line for this 26th renewal of the Texas Amateur All Age Brittany competition. This year's judges were Alex Jacock of Edmond, OK and Ben Kuykendall of Ferris, TX. Both these gentlemen have years of experience running and watching bird dogs compete. Both were studious in their observations, paying close attention as the dogs navigated these rolling hilly grasslands. They wanted to see dogs with an intelligent frontal application at an extended range who exhibited intense style and manners on their birds.

#### The Running of the Recognized:

First Place went to top dog in Brace 3 FC/AFC Arrow's Tequila Rustler "Rusty", handled by Richard Beaver and owned by Sandy Becker of Billings, Montana. Rusty is an 8-year-old male out of Beaver's Straight Arrow and Runner's Tequila Rose. Rusty has been a consistent winner this season and this event proved no exception. Rusty ran a mostly forward energetic race with a single find at 42 which he handled in a mannerly fashion. Rusty was responsive to his handler and hit all the objectives the course had to offer. Rusty completed his hour still hunting hard.

Second Place was top dog in Brace 9 FC/

AFC Sigbritt's Not In Kansas Anymore, "Dotie" handled/owned by Nick Blasi of Wichita, KS. Dotie is the 4-year-old daughter of GFC/GAFC/FC/AFC MK's My Lil Ammo. Dotie earned second place by running an energetic intelligent forward race with two stylish and mannerly finds. Dotie finished her hour to the front as strong as she started.

In third position was top dog in Brace GFC/GAFC/FC/AFC JJ's "Levi" the Lion Heart" handled/owned by Joe Williams, Hilliard, Ohio. Levi is an 8-year-old male out of NAFC/GFC/ GAFC/FC/AFC Spanish Corral's Sundance Kid and Sandbank Rose. Levi exhibited great power and intelligence moving always to the front across these grounds. Levi had an impressive limb find mid-way through his hour just after crossing Pond Dam 2 in a lone tree strip very close to the lake. Levi stood tall and tight as a small covey was observed running around in the heavy cover so shot was fired with all in order and Levi was moved on. Levi continued hunting hard and intelligently to the front the entire hour.

In fourth place was top dog in Brace 7 GFC/ GAFC/FC/AFC MK's My Lil Ammo, "BB", handled/ owned by Nick Blasi, Wichita, KS. BB is a 10-yearold female out of Sniksoh Free Boy and Chief's Nubbin's My Lil Lady. BB knows these grounds well and made smart use of her knowledge of all the usual bird spots, running steadily to the front scoring six bird finds throughout her hour which she pointed stylishly, head and tail high. BB finished her hour searching diligently for more birds.

#### Region 17 Amateur All Age Championship

22 dogs came to the line for this year's running, with judges Bruce Bryant and Ken Sanderson in the saddle to adjudicate their performances. We thank them for their time and their attention to each performance. Many members of the Southern Kansas Brittany Club were on hand to make the running of this event possible - Herb Rea, Terry Gowin, Matt Harris, Trasa Fowler, Nathan Hopper, Rick Wheeler, and Scott Johnson worked hard all week to keep things rolling along; we thank them all for their efforts!

We could not begin to have a competition of this quality, without the generous hospitality of our hosts, Mary Lynn & Bill Oliver. Their beautiful ranch is a combination of wide-open fields, wooded draws and rocky mesas, presenting challenging courses for the dogs to search for game under challenging atmospheric conditions. Blowing winds and varied humidity, made finding and pointing game difficult and caused the birds to be jumpy at times. Multiple covey finds on released and wild quail provided regular excitement as handlers went to flush for their charges.

These events would not be possible without the support of our sponsor Purina for providing their Sport Formula Dog Food for each placing dog as well as continued financial support to make this sport that we love possible. We are truly grateful to this fine company for their continued support of our events.

This year's winner was Arrow's Teguila Rustler, handled by Richard Beaver. Rusty ran in the 3rd brace carding one spectacular find. He laid down a smooth, forward run with an efficient and pleasing flow to his pattern. His punch to the front into the wind caught the judges' eyes as did his most memorable move; a big forward sweep of the Hay Meadow Bowl along the entire base of the Mesa towards the High Post Gate area, then dropping down into a wooded draw taking it deep to the south and found standing at 50 mins. on a find where few others had ventured, which sealed the Championship.

Runner-up honors went to El Grande, handled by Robby Myer. Truman broke away into a stout wind yet stayed forward and running well despite the conditions. He made a western reaching move to drop into the Windmill Canyon section, then ran the fence line of the Hay Meadow area to card a baren stand at 23 in some scrub nearing the pond. Moving on, Truman worked the draw area past the High Post Gate with a pleasing flow and pattern, hunting hard the rest of the brace to stand at 50 mins. past the fence corner in a deep draw of the Eastern Bowl as we headed towards camp. His hour expired near the weekend breakaway location.

A Montana Silversmith Trophy Buckle was presented to the handlers of our Champion and Runner-up.

Third place was awarded to B&T's Sonndance Kid Rock, handled by Trasa Fowler. Rocky broke away into a strong headwind which messed with his pattern early. His pattern grew and improved approaching the Windmill Canyon area, through the Flat Rock Crossing. He was standing for his 1st find at 24 mins. with nice style and intensity, prior to the crossing above the Watershed. He worked nicely for the remainder of his hour, carding a stop to flush at 48 mins. and his final find coming in a deep draw of the Bowl Section nearest camp at 53 mins. with time expiring approaching the weekend break away.

Fourth place went to Just Call Me Lucky Ned Pepper, handled by Frank Campbell. Ned was running hard early with a nice application that was mostly forward. As noted by the judges, he was pushed through the section after the Flat Rock Crossing to the entrance of the Hay Meadow Bowl, then worked nicely there to stand his 1st find at 31 mins. Ned carded his 2nd at 38 mins. near the exit toward the High Post Gate, working the field below nicely. Ned had a stop to flush at 48

mins. at the entrance to the Bowl Section nearest camp, slowing some towards the end of the hour.

#### The running:

Brace 1:Sassy – Robbie Myers and BB – Nick Blasi. Sassy was fun to watch and had 4 evenly spaced finds with nice range and pattern throughout her hour; she displayed solid bird work. Had she not slowed some towards the end, she'd have most likely changed up the placements. BB had a nice, forward run that flowed well with eye catching moves, carding solid finds at 13 mins. and 29 mins. A third find at 30 mins. requiring a relocation was the undoing to her solid bid.

Brace 2: Chica – Richard Beaver and Timber – Rick Hastings. Chica displayed nice range and ground speed moving nicely through the Watershed and Hay Meadow areas, with a back at 27 mins., a find at 36 mins. and stood again at 40 mins. where she succumbed to temptation. Timber's run was one that thoroughly covered the likely places and produced lots of bird work. He carded finds at 16 mins., 27 mins., 42 mins., 46 mins. and 49 mins. with a nice back at 36 mins.

Brace 3: Rusty – Richard Beaver and Bud – Frank Campbell. Rusty's winning performance is detailed above. Bud ran well, had an attractive way of going and initiated several nice moves over the hour, but he was birdless for his efforts.

Brace 4: KD – Steven Foster and Hatch – Adam Freeman. This pair broke away greeting each other with enthusiasm due to their recent breeding. Love 'em and leave 'em Hatch then flew to the front with a powerful, far flung run, that explored the boundaries of the course. KD worked well through the flat top field and dropped down into the Windmill Canyon with speed and purpose when a failed stop to flush ended her day at 12 mins. prior to the Flat Rock Crossing. Hatch ran hard, eating up ground and hunting diligently, with no bird for his efforts, a performance worthy of a placement for sure.

Brace 5: Coal – John Perry and Colt – Vince Anderson. Coal was consistently forward, making many nice moves, hunting hard and searching the likely places throughout his hour with no creditable find for his efforts; a bird probably would have pushed the placing dogs. Colt had some difficulty getting lined out early, then did some nice work into the Windmill Canyon and really stretched in the Hay Meadow Bowl along the base of the Mesa to drop into the next to last draw there. He too finished his hour without a bird for his efforts.

Brace 6: Remi – Rick Hastings and Dottie – Nick Blasi. Remi took a while to get lined out with her run and application growing over time. She laid down a very nice middle part of the hour, with a find at 19 mins., a back at 53 mins. and a

baren stand with relocation coming at 59 mins. Dotti put down a nice run with some big moves reaching forward, using the wind accurately and hunting the right places. She had a nice find with style at 35 mins., a baren stand at 40 mins., a stop to flush at 50 mins. and a final find at 53 mins. with a breach of manners ending her bid there.

Brace 7: Rey – Joanne Perry and Rascal – Rick Hastings. Rey was wide early and grew in pattern and application with nice moves through the Windmill Canyon. She carried a reaching line past the Watershed area, into the Hay Meadow Bowl along the base of the Mesa there to be found standing at 27 mins. with nice style. After the field below the High Post Gate, the string broke with the Tracker being called for at 57 mins. Rascal put it all together past the Windmill Canyon, growing past the Watershed Area and into the East Bowl after the High Post Gate. He carded finds at 33 mins., 39 mins. and lastly at 51 mins. with a nice back and a stop to flush during the hour.

Brace 8: Rocky – Trasa Fowler and Bo – Amy Hopper. This pair broke away with purpose into a stiff wind. Rocky's 3rd place run was detailed previously. Bo ran hard, fast, and

across the Flat Rock Crossing to stand in the trees on the left at 14 mins. Upon the shot, another bird popped into a tree with Hank ending his bid to better see it!

Brace 10: Truman – Robbie Myers and Arrow – Rick Hastings. Truman's 2nd place performance was detailed previously. Arrow had difficulty with the strong wind effecting his run and pattern. He carded nice finds at 28 mins., 29 mins. and 32 mins. with a baren stand at 40 mins. He did a very nice job in the Windmill Canyon and hunted well along the base of the Mesa of the Hay Meadow Bowl where he carded all his finds.

Brace 11: Annie – Terry Gowin and Jessie – Harlan Gerardy. This pair broke away into what was likely the stiffest wind of the stake. They did much better upon reaching the Windmill Canyon and worked well from there, past the Flat Rock Crossing to find Annie pointed at 18 mins. with Jessie backing nicely. A breach of manners ended Annie's bid; Jessie moved on into the Hay Meadow Bowl. Below the Mesa and trees there, Jessie was judged under a bird at 24 mins. to end her day early.

#### **Western Brittany Shooting Dog Championship**

The 2022 Western Brittany Shooting Dog Championship followed the Oregon Brittany Club's Spring trial and was held April 4-5. The historic Madras trial grounds are a beautiful setting. With clear skies each day, Mt. Jefferson, Mt Hood, and several other Northwest volcanoes dominated the horizon.

Judges for the event were Rick Axtell, of Eugene, Oregon, and Mark Shearman, from Sandy, Oregon. Both judges are seasoned judges with both AF and AKC experience.

Purina supported this championship as they have in the past. That support is always appreciated and highly valued! Likewise, the US Forest Service provides us with a permit to use public land for these trials. Without their support, there would be no trials.

The unpredictable spring weather turned out a bit rough for this two-day event. With rain, snow, and high wind on the morning of April 4, we delayed the start until noon. The rain stopped midmorning, but the wind continued all day, at times gusting to 50 mph. It did not seem to affect the dogs so much as the handlers, judges, and this reporter. The windchill atop a horse was brutal!

#### April 4 Day 1

Brace 1: Dynamitemakeit (Dyna) handled by Paul Doiron was braced with CL Spanish Whiskey Bender (Ben) handled by Casey Precht. Both dogs ran a nice initial race, staying forward and hunting into the strong headwind. Dyna was running a bit bigger than Ben, but both were working the wind and applying themselves nicely. At 8, Dyna was standing a bird at the first rise and Ben arrived shortly thereafter. The judges ruled this a divided find. All was in order with the subsequent flush. At 14, Dyna had a second find just before the gate. A bird was produced, and all was in order. At 25, Ben ran over a bird and gave chase, ending his run. Dyna continued with a third find at 49 and ended forward.

Brace 2: Redlines Trace of Smoke (Trace) handled by Paul Doiron was braced with Christe's Im a Jakester (Jake) handled by Larry Sandusky. Both these dogs ran forward nicely and were birdless until 42 when Trace had a find in a lone juniper near the last water barrel. Subsequently, both dogs were found standing at 53 on the same bird. The judges ruled this a divided find. At 58, a bird flushed in front of

Trace and a chase occurred, ending his run. Jake finished well, strong and forward.

Brace 3: HVK Turn Back Time (Mick) handled by Paul Doiron was braced with Zips Moon Dance Kid (Skeeter) handled by Larry Sandusky. At 21, Mick pointed on the bitterbrush sidehill after the first gate. Mick took a couple steps on the flush but remained down. Skeeter was seen under a bird at 32 and was picked up. Mick finished the stake with a moderate run but did not find another bird.

Brace 4: HVK Little Man Tate (Tate) handled by Paul Doiron was braced with MTB Calpatch Idaho Gem-A (Gemma) handled by Tom White. This was a very nice gun dog race. Both dogs were snappy and forward and obviously having a good time in the gusty conditions. Both dogs ran the bowl nicely, with Gemma standing at the top of the bowl near the tire at 29. This turned out to be a non-productive. At 30. Tate was found on point before the second gate, a bird was produced, and all was in order. At 32, Tate pointed the same bird that had flown down-course, but all was in order with this flush. At 44. Gemma pointed near the water barrel, a bird was produced, and all was in order. Both dogs finished forward.

#### April 5 Day 2

Brace 5: This brace broke away the following morning at 8:30, April 5, with slightly better weather conditions. The wind was still a factor but was lighter and more westerly. MVP Game On (Joe) handled by Paul Doiron was braced with Mr. Staley (Doc) handled by Dan Campbell. At 7, Doc had a find at the rock pile but handled it poorly and chased at the flush. Simultaneously, Joe had a find to the west which he handled well and moved on. At 25, Joe had a find on top of the bitterbrush hill with all in order. At 32, Joe made a big move south and began to look

more like the all age dog he is. At 50, he'd been out of pocket for an extended period and Paul picked him up.

Brace 6: Sonny's Hot Summer Breeze (Breezy) handled by Paul Doiron ran as a bye. Breezy started by quartering into the northwest wind but began to stretch out after the turn near the first gate. At 17, Breezy was found standing on the south hillside opposite the bitter brush hill. A bird was produced, and all was in order. At 20, Breezy had a second hillside find at south end of the bitterbrush hill, but it turned out non-productive. At 39, Breezy had a find with all in order under the powerline. At 46, Breezy had a find before the second water barrel, but this also turned out to be a second nonproductive. At the end, she shortened up running into the headwind, but finished with a very nice, controlled, gundog

Brace 7: K Nine Finale's Way to Go (Allie) handled by Paul Doiron was braced with Jalos Rangle (Rangle) handled by Jim House. Both dogs ran a big race with multiple finds. At 6, both dogs had separate finds, Allie's to the west and Rangel's at the rockpile. All was order with both finds, but Rangle got very low as he anticipating the flush. Both dogs continued forward, with Allie having a second find at 12, and Rangle at 15. All was in order with both finds. At 19, Allie was standing pointing into a bitterbrush and Rangle came in from the west and pointed the same bird, initially flagging vigorously. Paul flushed and all was in order. Rangle followed with finds at 23 and 34. At 30, both dogs took a major back cast and headed to the top of the ridge near camp. Allie stuck a bird near the top of the hill with all in order. At 43, Rangle had a 4th find before the second gate. Again, Rangle got very low, but Jim elected to take a non-productive and move on. At 50, Allie began to get a bit erratic and headed toward the road, but Paul got Allie back under control and

#### **Open All Age Championship**

The 2022 Western Brittany All Age Championship ran March 30-31 before the Oregon Brittany Club's Spring horseback trial on our regular trial grounds on the Crooked River National Grasslands, near Madras Oregon. This is the second year the Oregon Brittany Club has sponsored this championship.

Morning temperatures on the grounds at the Crooked River National Grasslands, near Madras, Oregon were well below freezing, but daytime high temperatures were in the mid-50s. Winds were moderate to light both days. Scenting conditions were exceptional, with most dogs finding birds.

Judges for this year's championship were a husband/wife team of Angela and Tim Schillereff, pro trainers who have a large training facility on Sauvie Island, north of Portland, Oregon. Both are very familiar with western all age dogs, having judged many all age stakes in and around the Northwest.

Generous and valued support came from Purina. This support can mean the difference between losing money on a trial and breaking even. We are very grateful for their generous assistance. Additional support came from the U.S. Forest Service who provided the permit to use public lands for this purpose.

#### March 30, Day 1

Brace 1: We kicked off Wednesday morning at 8:00 AM. MVP Game On (Joe) handled by Paul Doiron was braced with Mr. Staley (Doc) handled by Dan Campbell. Both dogs ran forward at moderate distance. At 20, just after the water barrel, Doc was standing in heavy sage. A bird was produced, refusing to fly, but was blanked by Dan as it ran off and all was in order. At 25, Joe was standing near the thicker junipers. A bird was flushed, and Joe was steady to wing and shot. At 30, Joe was standing near Chukar Hill, Paul relocated Joe four times, produced a bird and all was in order. At 55, Joe had a final find in the big flat at the end, but Joe laid down under the pressure of a running bird, ending what had been a very nice run. Doc, meanwhile, continued to run at moderate range and finished forward.

Brace 2: MTB Louree's V-O-2 Max (Max) handled by Tom White was braced with HVK's Kid Chance (Chance) handled by Joe Gower. Both dogs took off strongly to the front, with Max taking a right at the gate and exploring the country south of the gravel road and north of the course. Chance stayed forward nicely and handled well to the front. At 47, near the second gate, Max was found standing near Chukar Hill, but took out the bird as his handler approached, ending his run. At 55, Chance was standing on the flat, a bird was produced, and all was in order. He finished

forward with a very nice, controlled all-age run.

Brace 3: Spanish Corral's Big Iron (Colt) handled by Joe Gower was braced with High Lonesome Bowden Hills (Bo) handled by Jim Hammett. Both dogs broke to the front, Bo heading southeast through the thicker sage, Colt due south, on course. At 27, Bo was found standing, but his handler could not produce a bird and they continued on. At 40, Colt had a nice find near Chukar Hill and second find at 55. At 56, Bo was standing near the flat, a bird was produced, and Bo stood firm. Both dogs had nice forward casts but returned to their handlers several times during the Brace.

Brace 4:. SR's Blew By Typhoon (Ty) handled by Paul Doiron was braced with Wild Wild Willie, (Willie) handled by Steve Cosgriff. Both dogs broke away strong, Ty running a bit bigger than Willie, but both dogs stayed forward. At 35, Willie was standing in front of a dead juniper, but this turned out to be non-productive. Willie continued with a big run across the bowl. At 48, Willie was standing near the rock pile, but took out the bird as handler and judge approached, ending his run. Ty slowed and shortened up a bit in a moderate headwind as the course turned north, but his was an outstanding run. Unfortunately, he finished birdless.

Brace 5: Blew Me Away (Bud) handled by Paul Doiron was braced with High Lonesome Owyhee Storm (Storm) handled by Jim Hammett. Both dogs ran strongly to the south, showing at the first gate. Storm made a nice cast up the south hillside, but was reported to have put up a bird, and was picked up at 25. Bud ended with three finds at 29, 35, 55 with all in order and one non-productive at 40. He also slowed considerably when he turned into the north breeze.

#### March 31 Day 2

Brace 6: This pair broke away at 8 AM on March 31. Dynamitemakeit (Dyna) handled by Paul Doiron was braced with High Lonesome Sage (Sage) handled by Jim Hammett. Both dogs did a very nice job staying forward. After the water barrel, Sage was out 600 yards or more to the front and was seen on the ridge before the north turn. As handler and judges topped that ridge, he was found standing to the front on the sidehill near a juniper. A bird was produced, and all was in order at 35. Sage continued to run big with finds at 45 and 56. On his second find, he selfrelocated a couple steps on a walking bird as his handler approached on the horse. Dyna continued with a shorter run, but ended with two finds at 46, and 50.


Brace 7: MTB Louree's Let's Have a FEE-ESTA (Esta) handled by Tom White ran as a bye in the last brace. Esta ran very strong and forward race with a big loop toward Chukar Hill at the midpoint of the course. Her finish was the best of the stake. She was spotted at 58 by the judge running the crest of the hill. From here she turned north into the bowl and continued to search for a find, but unfortunately finished birdless.





The Mingo Extravaganza started March 17 with Region 4, followed with the Ohio Brittany Club events over the weekend, with Dixieland two events during the week of March 21st. The Pennsylvania Brittany Championship began March 25th. Weather conditions were extreme with rain showers, snow, sunshine and temperatures ranging from below freezing to highs in the mid-60's.

Special thanks to all judges – Pennsylvania's events Amateur and Open Gun Dog Classic for Shooting Dogs – to ride and maintain their attention to the performance of all the dogs competing. The judges were Charles Brown and Rod Clagg, Amateur Stake and for the Open Stake, Bill Haynes and Joe Williams. Also thanks to Tom Tracy for use of his

truck as the Dog Wagon; Gene Stewart driving the Dog Wagon and planting for every brace quail; Ray Rush and Geoff Webb for their assistance with many other duties. A continuous course, which was developed by Tom Tracy couple of years ago, was used again this year. It shortened time between braces. This event would not have taken place without the help of these folks. A Derby event was not held this year due to lack of entries.


