# ABC Policy Book, page 20 (old) RECORDING FEES

All regional Field Trial Clubs shall pay ABC a recording fee for each dog started in their field trials (both horseback and walking). The price is as approved by the Board of Directors. See Appendix 1(2013) each time the dog is started. The field trial results shall be sent to ABC within ten (10) days after the trial or there will be a fine, as approved by the Board of Directors. See Appendix 1(2013), levied with a daily charge, as approved by the Board of Directors. See Appendix 1(2013), thereafter until results are received along with the recording fee, as approved by the Board of Directors. See Appendix 1(2013), per dog started (March 1, 1994) (2001) (2013)

Specialty Shows held by Regional Clubs shall pay a per dog recording fee, as approved by the Board of Directors. See Appendix 1(2013), to the ABC. The show results must be sent to ABC within ten (10) days after the show or there will be a fine levied, as approved by the Board of Directors. See Appendix 1(2013), with a daily charge, as approved by the Board of Directors. See Appendix 1(2013), thereafter until results are received. (1995) (2001) (2013)

Clubs holding Hunting Tests will also pay the per-dog recording fee, as approved by the Board of Directors. See Appendix 1(2013), to the ABC if they want the results published in the magazine. (1995) (2001) (2013)

Clubs holding Agility Trials will also pay the per-dog recording fee, as approved by the Board of Directors. See Appendix 1(2013).

The signed judging sheets and Secretary's page shall be sent to AKC so as to reach AKC no later than seven (7) days after the closing date of the trial. Penalty for non-compliance is a fee, as approved by the Board of Directors. See Appendix 1(2013), and a daily fee, as approved by the Board of Directors. See Appendix 1(2013), for each day's delay beyond the deadline, and other such penalties as may be imposed by the Board of Directors of the AKC. A recording fee, as approved by AKC. See Appendix 1(2013), for each first entry of a dog and a fee, as approved by the AKC. See Appendix 1(2013), for additional entry of the same dog shall also be sent to AKC within seven (7) days. Any American Field organization desiring a maximum two (2) page write-up in "The American Brittany" magazine must pay a recording fee, as approved by the Board of Directors. See Appendix 1(2013) per dog. (1978) (2001) (2013)

<u>Field Trials</u> held by Regional Clubs shall pay ABC an event fee (see Appendix 1) per-dog started (competitor) in each stake in their event. The event results must be sent to ABC within ten (10) days after the event, or there will be a fine levied, with an additional per day fee (see Appendix 1), thereafter until results and event fees (see Appendix 1) are received. No parent permission shall be granted a club for any future events until this event fee is paid. (2001) (2013) (2014)

<u>Hunt Tests</u> held by Regional Clubs shall pay ABC an event fee (see Appendix 1) per-dog started (competitor) in each stake in their event. The event results must be sent to ABC within ten (10) days after the event, or there will be a fine levied, with an additional per day fee (see Appendix 1), thereafter until results and event fees (see Appendix 1) are received. No parent permission shall be granted a club for any future events until this event fee is paid. (1995) (2001) (2013) (2014)

Specialty Shows held by Regional Clubs shall pay ABC an event fee (see Appendix 1) per-dog started (competitor) in each regular class in their event. The event results must be sent to ABC within ten (10) days after the event, or there will be a fine levied, with an additional per day fee (see Appendix 1), thereafter until results and event fees (see Appendix 1) are received. No parent permission shall be granted a club for any future events until this event fee is paid. (1995) (2001) (2013) (2014)

Obedience Trials held by Regional Clubs shall pay ABC an event fee (see Appendix 1) per-dog started (competitor) in each regular class in their event. The event results must be sent to ABC within ten (10) days after the event, or there will be a fine levied, with an additional per day fee (see Appendix 1), thereafter until results and event fees (see Appendix 1) are received. No parent permission shall be granted a club for any future events until this event fee is paid. (2014)

<u>Agility Trials</u> held by Regional Clubs shall pay ABC an event fee (see Appendix 1) per-dog started (competitor) in each regular class in their event. The event results must be sent to ABC within ten (10) days after the event, or there will be a fine levied, with an additional per day fee (see Appendix 1), thereafter until results and event fees (see Appendix 1) are received. No parent permission shall be granted a club for any future events until this event fee is paid. (2013) (2014)

<u>Rally Trials</u> held by Regional Clubs shall pay ABC an event fee (see Appendix 1) per-dog started (competitor) in each regular class in their event. The event results must be sent to ABC within ten (10) days after the event, or there will be a fine levied, with an additional per day fee (see Appendix 1), thereafter until results and event fees (see Appendix 1) are received. No parent permission shall be granted a club for any future events until this event fee is paid. (2014)

#### Additional fees:

The signed judging sheets, Secretary's page, and event fee (see Appendix 1) for each dog **entered** shall be sent to AKC so as to reach AKC no later than seven (7) days after the closing date of the trial. Penalty for non-compliance is a fee (see Appendix 1), and a daily fee (see Appendix 1) for each day's delay beyond the deadline, and other such penalties as may be imposed by the AKC. (2001) (2013) (2014)

Any American Field organization desiring a maximum two (2) page write-up in "The American Brittany" magazine must pay an event fee (see Appendix 1) per-dog started (competitor) in each stake in their event. (2001) (2013) (2014)

### ABC Policy Book, page 60 (old)

All Field Trials, all Specialty Shows, all Agility Trials (2013) and all Hunt Tests shall pay a fee, as approved by the Board of Directors. See Appendix 1(2013) for each dog started in each stake recording fee. No parent permission shall be granted a club until this per dog started fee is paid for the previous event, starting January 1, 1987.

### ABC Policy Book, page 60 (new)

All Field Trials, Hunt Tests, Specialty Shows, Obedience, Agility (2013) & Rally events pay ABC an event fee (see Appendix 1) per-dog started (competitor) in each stake/regular class in their event. No parent permission shall be granted a club for any future events until this event fee is paid, starting January 1, 1987. (2014)
