

2014 American Brittany Club Board of Directors Meeting Minutes (Unofficial until approved by the BOD) November 29, 2014 Fort Smith, Arkansas at the Show Site

The meeting was called to order at 8:00 A.M. by the President Robert Rankin. The Executive Secretary, Mary Jo Trimble, called the roll. Directors present were:

L. Pollock, D. Dow, K. Hanson, D. Riedl, K. Patterson, B. Hendrickson, T. Jagielski, J. Brigham, S. Ralph, M. Karbiner, T. Milam, A. Christensen, R. Wire, J. Henderson, J. Gower. All Directors were present. New Board Members Christensen, Hendrickson, and Gower were seated.

Motion # 1, 2013 Minutes: Motion by Ralph, Seconded by Brigham. I move to approve the 2013 minutes. 15 Yes, 0 No: Motion Passed.

President Rankin began with his Action Items. The first action item concerned a proposal from the Texas Coastal Club to remove all references in the Policy Book regarding event starter fees that did not require ABC approval to AKC. **Motion # 2, Event Fees:** Motion by Ralph, Seconded by Brigham. I move to strike obedience, rally, and agility from the starter/recording fee structure in the policy book. If clubs holding obedience, rally and agility events want results published in the ABC magazine, they will pay the advertising display rate as published on the masthead page of the magazine. 14 Yes, 1 No (Milam) Motion Passed. (Other starter/recording fees for field trials and shows will remain at \$2 per starter. Hunt tests remain as currently stated at \$2 per starter only if they want results published in the magazine.)

 2^{nd} Vice President Bryce Novotny addressed the BOD with his report and three (3) action items. He outlined the work of the ad hoc membership committee since its formation last year.

Motion # 3, Membership Promotion: Motion by Henderson, seconded by Dow. I move to add the current ad hoc Membership Promotion Committee to fall under the duties and responsibilities of the 2nd Vice President. 15 Yes, 0 No, Motion Passed.

Motion # 4, Membership Data Base Software: Motion by Ralph, Seconded by Karbiner. I move to allow Linda Langford, on a volunteer basis, to work in cooperation with the 2nd Vice President to develop new membership data base software for the ABC. 15 Yes, 0 No, Motion Passed. Bryce indicated he would also include input from anyone who needs to work with the membership list.

Motion # 5, NBRAN (National Brittany Rescue): Motion by Ralph, Seconded by Hendrickson. I move to recognize the NBRAN Rescue organization on the website and in the policy book. 15 Yes, 0 No, Motion passed. Terry Hilliard, 3rd Vice President addressed the Board. She indicated she had been contacted by several people and received comments on recent surveys about moving the National Specialty Show before the National Amateur All Age Championship instead of between the Amateur and Open Championships. The Fairgrounds has indicated the grounds would be available that weekend.

Motion # 6, Date of National Specialty Show: Motion by Hendrickson, Seconded by Milam. I move to allow the 3rd Vice President, Terry Hilliard, to move the National Specialty Show events to be held the Friday, Saturday, and Sunday prior to the running of the National Amateur Championship with the Board of Directors' meeting to be held on Sunday of that weekend at a location to be determined.

13 Yes, 2 No (Jagielski & Brigham), Motion Passed. (The National Specialty will be held on Friday and Saturday with Rally to be held on Sunday.)

Motion # 7, Nat. Specialty items: Motion by Riedl, Seconded by Milam. I move that the first six (6) items of the 3rd Vice President's report on page 15 of the agenda book be adopted. 15 Yes, 0 No, Motion Passed. Those items are as follows:

Page 38- typo in 2-D- should read: NSS will announce their judging assignment in the magazine and on (not one) the web site.

Page 39- J. the superintendent does not supply catalogs. We use the Yearbook. Take out catalogs.

Page 40- #7- If possible, the NSS is given its own day. The NSS/Obedience and Rally is now 3 days (and we would like more).

Page 40 the last paragraph, should read at the discretion of the show chairman, the NSS Qualifier class can be added and then continue on with the qualifications.

Page 41- #19 is redundant. That was already discussed on page 38, #5. Page 41- #21 should also include Rally

The Board did discuss whether or not to leave Agility on Page 42 - #27. It was suggested that since we do not currently have Agility at the National Specialty Show that it be removed. However, the Non Field Performance Committee in their report indicated that they would like to see an Agility event added to the National Specialty. Rather than remove and have to add back later on, this proposal was not adopted.

The next topic of discussion was the Secretary/Executive Secretary's action items.

Motion # 8, ABC Business/Facebook: Motion by Ralph, Seconded by Jagielski, I move that ABC business and/or motions may be announced on Facebook with a link to the ABC Website, but no discussion is to be allowed on these items on the ABC Facebook page. 15 Yes, 0 no, Motion Passed.

Motion # 9, Garmin Collar orders: Motion by Milam, Seconded by Hendrickson. I move to adopt #2 and #5 items on page page 17 of the agenda book regarding the Secretary's report. 15 Yes, 0 No, Motion Passed. Those items are as follows:

Item #2: Policy Book page 35, #28 and #5 page 75. Delete these sections and any other place they many appear as Garmin has requested that all request for Collars come through the Executive Secretary to avoid multiple requests. Add to duties of the Executive Secretary in the policy book. (Also see Trophy Chair Section page 75 of Policy Book)

Item # 5: Change and add to page 55 of policy book, Championship Pins section; Deep Blue, Field Championship (CHAMPION); Light Blue Amateur Field Championship (CHAMPION), Red, Show Championship (CHAMPION); Yellow, Dual Championship (CHAMPION); Dark Green; Obedience (CHAMPION); Light Green, Obedience (CD) & (CDX), (UD), Rally Advance Excellence (RAE), Beige, Master Agility Champion (MACH); Beige, Preferred Agility Champion (PACH); Purple, Grand Field Champion (GFC); Purple, Grand Champion (show) (GCH); Orange, Master Hunter (MH)

The Board reviewed the Treasurer Gerilyn Sennott's report and action items.

Motion # 10, ABC Donation Policy: Motion by Ralph, Seconded by Riedl. I move to adopt Treasurer Sennott's proposal on page 18 of the agenda book. 15 Yes, 0 No, Motion Passed.

This proposal is as follows: Page 51 of the policy book – Line items # 22 and # 23 should be deleted. Page 52 of the policy book – Line item # 24 should be deleted. New Proposal: The American Brittany Club, Inc. shall donate to the following organizations based on the finances of the Club on a yearly basis: Bird Dog Foundation Brittany Endowment, Sportsmen's Alliance, National Animal Interest Alliance, National Animal Interest Alliance Trust. These donations should be reviewed each year by the Finance Committee and approved by the Board of Directors at the November meeting.

The Treasurer asked Finance Committee Chair Judy Graves to point out to the Board that we currently have **seventy five outstanding membership refund checks from numerous clubs.** Checks range in amount from \$2 to \$140 with an average of \$40. A list of those clubs was read to the Board and Judy asked them to contact clubs in their region. Judy was asked to provide an email list to the BOD so this could be accomplished. If not cashed soon, those checks will be declared null and void by the Treasurer.

The AKC Delegate Judy Tighe asked in her report for donations for the AKC Disaster Relief Fund and the AKC Legislative Fund. This was tabled until the budget discussion.

(No funds were allotted during the budget discussion.)

4th **Vice President John Perry** distributed his report to the Board concerning the Gun Dog Nationals. The Gun Dog Banner brought in over \$3,100 for trophy donations this year. In 2013 it was \$200. This was a huge success for the Gun Dog Nationals. He said the Nationals needed better communication as to who has the equipment such as bird bags, coffee thermos, etc. to be passed on to the next committee. He presented three action items.

Motion # 11, Woman Handler Award: Motion by Karbiner, Seconded by Henderson. I move to discontinue the Woman Handler's Award at the National All Age and National Gun Dog due to a change in the times. The trophies should be retired to the Brittany Wing of the Bird Dog Foundation with a history of the award to be included. 14 Yes, 1 No (Dow), Motion Passed.

Motion #12, Best Dog Awards: Motion by Milam, Seconded by Patterson. I move to discontinue the female dog of the year award in both the All Age and Gun Dog Nationals. 2 Yes (Patterson & Milam), 12 NO, Motion Failed. No motion was necessary for the Field Trial Committee to change the award for the Runner-Up. VP Perry also presented an item that necessitated Executive Session.

Executive Session lasted from 10:00 A.M. until 10:20 A.M. No action taken following the Executive Session.

Motion # 13, Judges' Education Policy: Diana Kubitz, Judges' Ed Committee Chair, submitted an updated version of their policy to be changed/included in the Policy Book. Motion by Riedl, Seconded by Wire. I move to adopt the Judges' Education Policy on page 32 of the Agenda Book with items # 6 and the commentary in # 13 deleted. 15 Yes, 0 No. Motion passed.

Policy is as follows with original # 6 & #13 deleted and renumbered with changes in red:

- 1. The Judge's Education Coordinator (JEC) is the chairman of this committee and maintains and updates the judges' printed handout materials and the computer presentation used in the seminars.
- 2. The JEC maintains materials to be disseminated to judges and makes sure this information is available on the ABC website.
- 3. The JEC makes available all information needed to hold seminars to people who will be presenting the judge's education program. (A side note: Brochures are no longer sent.)
- 4. All judges education seminars are to be channeled through the JEC. The ABC computer presentation and printed handout materials are to be used as educational materials at all seminars.
- 5. The Judges' education budget is as approved by the Board of Directors. See Appendix 1 (2013)
- 6. The Judges' Education Committee shall determine the materials to be used in the presentations. The presentations will be updated as new materials and photos are obtained.
- 7. The JEC will maintain a record of individuals having taken judge's education and make that list available to clubs, the Summer Specialty and National Specialty Chairs.
- 8. ABC Mentors shall be approved by the following method:

Note: The ABC Mentor requirements are meant to be a guide in selecting members. The following is the criteria for being an ABC mentor.

- 1. A full member in good standing of the American Brittany Club For the past 12 years.
- 2. A full member of a regional Brittany Club for the past 12 years.
- 3. Having bred, whelped and raised Brittany litters would be considered helpful.
- 4. Having attended the ABC National Events that include both conformation and performance field trials.
- 5. The applicant, to be effective, should:
 - a. Be well versed in the history of the Brittany.
 - b.Understand the Brittany Performance Standard.
 - c. Have Experience with the process of judging in conformation and performance.
 - d. Be willing to have prospective judges come to their home or kennel to observe and discuss Brittany's
 - e. Attend any classes or meeting for mentors when possible.
 - f. Realize that their conduct reflects on the ABC at all times.
 - g. Should be unbiased.
 - h. Adhere to Brittany standard and its quest to keep the breed "forever dual" in keeping with the ABC Mission Statement.
- 9. Effective 2009, the Board of Directors voted to give the Judges' Education Committee the ability to determine if a candidate for an ABC Mentor/Presenter meets the qualifications as outlined in the ABC Policy Book. The JEC will take a written vote by email, U.S. mail, or fax approving or disapproving of candidates with a majority vote of committee members. If a committee member casts a NO vote, they shall indicate on the ballot which of the ABC Mentor's Criteria (i.e. item #6, number and/or letter) listed on the American Brittany Judges' Education section of the Policy Book that the candidate failed to meet. While individual ballots will remain confidential as though the committee is meeting in Executive Session to discuss personnel, ballots will be sent to the ABC President, an ex-officio member of all committee, the candidate shall be notified by the JEC and advised of the reason(s) for the negative vote. (2009) In 2010 the board of Directors voted to allow the committee to add categories that a rejection might fall into: (1) insufficient information and (2) Does not meet qualifications at this time. The Board also voted to revise the application to add information about field trials, hunt tests and attitudes regarding the Dual Dog. (2010)
- 10. ABC has asked AKC to require judges to take judges' education in Brittanys every five years.
- 11. ABC recommends that regional clubs hire judges who meet the five year criteria whenever possible.

Director Milam represents the ABC on the **Blue Mt. Field Trial Association**. He reported on proposed changes at both Conway and Blue Mountain field trial grounds regarding dog wagon & driver, burning rather than mowing, fees to be charged by the day and by the dogs run, pre-release bird cost and pay for someone to feed the birds.

Discussions are currently taking place between the Association and Fish and Game.

At this point, no vote has been taken by the Fish and Game BOD. That vote may take place this summer to be effective during the 2015-2016 field trial season.

Jim Brigham, Chairman of the **Brittany Foundation BOD**, gave an update on the progress of the Foundation during the last year. He thanked Bob Rankin and Ed and Judy Graves for their generous donations to help get their funding started. The Foundation will have a presence (page) on the ABC website. Insurance has been piggy-backed on the ABC Liability Policy. Brigham announced that Karen Hanson's one year term had expired. He asked for a BOD vote to fill the new five year term.

Motion # 14, Foundation 5 yr term: Motion by Dow, Seconded by Hendrickson.

I move to appoint Karen Hanson to the five (5) year term on the Foundation BOD.

15 Yes, 0 No, Motion Passed.

Motion # 15, Auction/Raffle Report: Karbiner reported on Auction/Raffle financials that had been submitted to her up to this date. Motion by Karbiner, Seconded by Hendrickson. I move to change the name of the Auction Raffle Committee to National Fundraising Committee. 15 Yes, 0 no, Motion Passed.

Facebook Committee Chair, Robin Tomasi requested the BOD to allow her committee to create a U-Tube Channel. The committee can restrict the channel to no comments. These can also be put on the ABC Website. Content would be approved by the committee as to what is appropriate material.

Motion # 16, U-Tube Channel: Motion by Christensen, Seconded by Dow. I move to create a U-Tube Channel with comments disabled. Site to be monitored by the ABC Facebook Committee. 15 Yes, 0 No, Motion Passed. Dow brought up a discussion of an Oversight Committee to work with all media outlets of the ABC. (Magazine, Website, Facebook). She wanted more coordination between the venues. Others agreed that more communication should take place without a formal committee trying to direct all groups. Committee Chairs should drive what needs to be shared with and/or on other venues. Dow also asked who receives the various ABC emails. The Webmaster Ralph explained that the only multi-faceted business address is the one to ABC Membership because several people/committees deal with membership issues.

Bobbie Sigmund, Chair of the Futurity Committee, discussed her Committee's Policy Book revision. She alluded to her discussion with Bernie Matthy's about futurity dogs not being FDSB registered. They are now including FDSB registration forms in the final forfeit mailing as well as the initial papers.

The **Purina and Garmin programs** were discussed and explained how they are handled. The Futurity currently has its own **website domain** which is not under the auspices of the ABC. The question was asked, "Does ABC need multiple domains for every committee that wants one?" Webmaster and other directors felt we only needed one URL which shows more of what the ABC does. Sigmund felt her domain was easier to use. It was decided that ABC needs to control all domains using the ABC name. The webmaster and Facebook Chair agreed to work together to solve this problem and consider format changes on the Website Futurity Page.

The Futurity Committee requested that **Pay Pal** be used to collect Futurity forfeits.

Pros and cons of its use were discussed. The Treasurer has asked that this not be approved. It was suggested that this issue be tabled until the Futurity Chair could discuss the issue with the Treasurer and that the discussion be done as soon as possible. Litter nominations for 2015 start January 1. Steve asked for 90 days. President said 60 days or sooner. Since there was no motion on the table there was no need for a motion to table but discussion should take place.

The discussion then moved on to multiple awards in the case of a **tie for the Dual Award**. Number of dogs defeated in the show exceeds number of dogs in the field in several instances. No motion concerning this was made but Karbiner withdrew her objections.

Protests at the futurity were discussed. Futurity Committee asked that they handle any protests. Directors felt that the committee on the grounds of the host club should handle protests as that follows ABC protocol as used in our ABC National Events. ABC should develop its own policy similar to AKC's protest policies. Host clubs will be told they will deal with the issue. No motion was made and Henderson said these were discussions on line items and then we vote on the total package after it is revised.

The Futurity Committee asked that the **Dual Dogs pictures appear on the cover** of the magazine as they have been sometimes in the past. Current policy outlines what dogs/events will be used on the cover of the magazine. This was rejected by the BOD last year but could be changed this year. This is the only "national" event where participants must be a member. Some preferred leaving off the older Hall of Fame dogs and using the Dual Futurity winners.

Motion # 17, Dual Futurities on cover of magazine: Motion by Dow, Seconded by Hanson. I move to put the Dual Futurity Award winners on the cover of the magazine.

13 Yes, 1 No (Karbiner), 1 Not Voting (Brigham). Motion passed.

Karbiner asked if we should include purebred in front of the word dogs where applicable. Directors felt this was assumed if the dogs were registered and this was redundant. The BOD moved on.

Page 65 #5, dealing with where **futurity money is deposited**. A lengthy discussion on ABC Banking procedures and accounts was conducted. Currently, all money is deposited as directed by the treasurer. Futurity Committee would like for Futurity Secretaries to handle this bank account. Judy Graves explained that the Commerce account was created so that she could relieve the Treasurer of some of the accounting issues as she is herself an accountant. Last year's motion created the Commerce Account near the Graves home. Graves who is chairman of the Finance Committee currently explained the reasons why ABC needs multiple accounts. Graves suggested that Sigmund discuss this with the Treasurer when they discussed Pay Pal. No wording change or motion was put forward on this issue.

Page 68, #14. Mary asked why "It is recommended but NOT REQUIRED "Nothing came of this discussion.

Page 70, #3, strike out the Pay Pal tabled for now. Agreed.

Page 74, #21, deals with number of days to send sectional **futurity reports** to Nat Futurity Secretary. 20 days rather than 30 would be better when results are sent to 2^{nd} Futurity Secretary and that they are to be verified that be sent on the regular field trial form to the ABC Secretary as soon as possible. Agreed but no motion.

Reporters should confer with judges if needed should be added. Agreed but no motion.

Page 77, under Dates: Futurities should be held before/after....: change Sectional trial to Regional trial. (incorrect term correction) Sectional Futurities are subject to approval of the Regional Dates Coordinator and then the National Dates Coordinator. No argument on this change but no motion.

Page 79, strike **AKC and put ABC** approved tracking collars. Can be same as AKC or American Field but make it ABC policy. Agreed but no motion. Futurity is not run under the AKC.

Page 84, paragraph 4, Strike AKC and put ABC. No argument. Last line acceptable.

Page 88, Administration Fee: additional expenses must be pre-approved by Chair.

Change Futurity Auction to Futurity Fundraiser: agreed but no motion.

Page 87: **Purse changes** are already made according to R. Tomasi, member of the Futurity Committee, but was not in agenda report book. Ratio, 2nd paragraph under proposed. Leave show out on purse ratio for all age & gun dog. Cross out if applicable on Dual Dog. Add line regarding show purse minus 5%. 10 % for ABC then take out 5 % for dual dog. If no dual dog, then ABC retains that. Agreed but no motion.

Page 89: Milam would like to see finding birds should be a primary objective. 4 lines up from bottom paragraph. Current wording acceptable.

Page 47 dealing with **nomination allowed 60 days after whelp**. Straw Vote left at 60 days. No problem with increasing fees. Bullet point entry fees discussed. Litter fee \$40, Show final \$30, Field entry goes to \$60. Litter nomination starts Jan 1 everything else 2016.

Motion # 18: Futurity Proposals: Motion by Hendrickson, Seconded by Wire. I move to accept the Futurity proposal with modifications. 15 Yes, 0 No, Motion Passed.

Bobbie then asked that the Futurity form be a full page alternating with the half page each month. Rankin suggested a full page every other month with no half page which would keep the magazine costs the same.

Motion # 19, Futurity Ad: Motion by Dow, Seconded by Pollock. I move that the litter nomination form be a full page run every other month in the magazine.

15 Yes, 0 No, Motion Passed.

Motion # 20, Classics Committee, Ray Trimble, Chair: The policy book needs to be corrected by not calling all the Classics Grand Championship Stakes. They are American Field Championships and AKC Classics that carry Grand Champion points. Motion by Karbiner, Seconded by Jagielski. I move that the verbiage on page 89 – 92 of the policy book should have Grand removed where appropriate and add Chair's Statement in Agenda Book. 15 yes, 0 No, Motion Passed.

Statement on Classics and rationale follow: The Policy book needs to update the title of this section changing the title of the first Classics Section to read: "Original ABC Game Bird/Gun Dog Classic/Championships" to further distinguish between the original Classics and the second section dealing with Championship Association Championship trials which are also ABC/AKC Classics. After the BOD Meeting in December, the following motion was passed: I move that the ABC (Chukar, Grouse/Woodcock, Gun Dog, Pheasant, Prairie Chicken, Quail) Classics and the ABC National (All Age & Gun Dog) Championships be designated as AKC Grand Champion Limited stakes.

While this motion is correct, the Grand designation has nothing to do with American Field sponsored championships. This is an AKC designation referring to points given to the above mentioned events that are also ABC Classics. The policy book currently refers in every mention of the "Original" Classics as GRAND CHAMPIONSHIPS which is incorrect. These references need to be removed and a statement added that all of these stakes will be AKC Open Limited stakes offering Grand Championship points. The title of this section of the policy book should be ABC ORIGINAL GAME BIRD/GUN DOG CLASSIC/CHAMPIONSHIPS.

Brigham discussed the progress on the Ethics Committee's upcoming proposal. Some work is yet to be done and proposal will likely come out during the time parameters for mailing out election ballots in order to include them as it will entail a by-law change.

Motion #21, Code of Ethics Name: Motion by Brigham, Seconded by Hendrickson.

I move to change the title of the Code of Ethics section of the Policy Book to Breeders' Code of Ethics. 15 Yes, 0 No, Motion Passed.

Judy Graves presented the report of the Finance Committee and discussed her committee's action items regarding the financial outlook for the future and what needed to be done to keep the ABC in good financial status. Background on these motions can be read in a previous issue of the American Brittany Magazine in the Agenda Book Action Items. While no formal motion was put forth, the BOD accepted the report of the Finance Committee and moved on to specific action items the committee had to be presented.

Motion # 22, Appointments to the Finance Committee: Motion by Karbiner, Seconded by Ralph. I move that Joe Gower and Kent Patterson be appointed to the Finance Committee to replace Dan Riedl whose term is expiring and John Henderson who asked to be replaced. 15 Yes, 0 No, Motion Passed.

Motion # 23, Recording Fees, Motion by Ralph, Seconded by Brigham. I move that Action Item #1, page 44 of the Finance Committee Agenda Report be adopted. That Action Item reads as follows: Effective immediately all recording fees collected shall remain in the general operating fund. This shall be retroactive to January 1, 2014. 14 Yes, 1 No (Hanson), Motion Passed. (Background: Currently in the Magazine Policy Section, page 60 describes the recording fee policy. The entire four paragraphs should be moved to be added to the Recording Fee Section on page 20 with the last paragraph being deleted.)

Motion # 24, Future Grounds Fund. Motion by Milam, Seconded by Brigham. I move to adopt Action Item # 2, page 44 of the Finance Committee's report in the Agenda Book. 7 Yes (Patterson, Jagielski, Brigham, Ralph, Karbiner, Milam, Gower), 8 No (Pollock, Dow, Hanson, Riedl, Hendrickson, Christensen, Wire, Henderson) Motion Failed. Action Item # 2 reads as follows: The \$94,265 balance currently held in the board designated Future Grounds Fund be transferred to the Undesignated Fund Balance (reserve account) (No Policy Book revision is necessary for this motion.)

After the motion failed, Judy Graves was asked to rename the Future Grounds Fund to more accurately reflect the special purpose of those monies. Agreed.

The Finance Committee's Action Item # 4 dealing with Regional Club's current share of dues had a great deal of discussion with little BOD support. The Chair withdrew that Action Item from consideration.

Motion # 25, Dues Amount (action item #3): Motion by Hanson, Seconded by Brigham. I move to increase dues January 1, 2016 to fifty (\$50). 15 Yes, 0 No, Motion Passed.

Motion # 26, Associate Dues: Motion by Ralph, Seconded by Gower. I move to raise the associate dues to \$5 with \$3 going to the ABC and Regional Clubs getting \$2. (effective January 1, 2016). 15 Yes, 0 No, Motion Passed.

The Board was given a revised Budget for 2015. They went over the line items and changed some of the entries as will appear in the BOD revised budget. Donations to outside organizations were reduced. These will be announced when the 2015 Budget is published. Removing color coverage of the national events would cut magazine costs over \$7,000. Motion # 27, 2015 Budget. Motion by Milam, Seconded by Patterson. I move to adopt the 2015 ABC Budget as amended. 15 Yes, 0 No, Motion passed.

At this point in the meeting, various misc. topics printed as action items in the Agenda Book were discussed and motions followed.

Motion # 28, Membership Lists: Motion by Hendrickson, Seconded by Pollock. I move to change the policy book to allow every director to receive full membership lists. 9 Yes, (Pollock, Dow, Hanson, Riedl, Hendrickson, Christensen, Wire, Henderson, Gower, 6 No (Patterson, Jagielski, Brigham, Ralph, Karbiner, Milam) Motion Passed.

Motion # 29, National Patches: Motion by Riedl, Seconded by Pollock. I move to adopt Steve Ralph's proposal #1 on page 102. (Page 69 of the Policy Book, Remove the following statement from #6 as we no longer order or sell a yearly national patch, "Order patches, approximately 100 National Patches per year. (Order them early in event of error). (i.e. 2004/2006) 15 Yes, 0 No, Motion Passed.

Motion # 30, Reporter Expenses: Motion by Karbiner, Seconded by Milam. I move that National Reporters shall be paid the field report fee (see appendix) once their report is received for publication. Reporters may also request to be paid travel expenses to and from the trial and/or paid for their horse usage on the days they ride as the official reporter. Total paid to reporter is not to exceed \$1,000.

15 Yes, 0 No, Motion Passed.

(Suggested amounts: \$250 on completion of report, \$400 for travel which could be discounted if reporter has dogs entered in field or show, \$250 (Based on five (5) days running) Horse usage on days that they officially report. Not to exceed a total of \$50 per day or \$25 half day for horse. Total paid to reporter is not to exceed \$1, 000.) Karbiner will make a form for policy book.

The Board went into Executive Session to discuss election of Officers and People and Dog Hall of Fame. Results were announced as follows:

Motion # 31 (Done in Executive Session and Announced in Open Meeting):People Hall of Fame: Ron Harling. Dog Hall of Fame: DC/AFC Masked Shoshoni War Chief and NFC R-U/NAFC/DC/AFC Shady's Tia Maria. Officers Elected: lst VP: Tom Milam, Sec. Mary Jo Trimble, 3rd VP Terry Hilliard. 4th VP. John Perry. Motion # 32, Remote Access at BOD Meetings: Motion by Hendrickson, Seconded by Christensen. I move that digital or telephonic remote access can be made available to officers and committee chairs in case they are unable to attend. This is extended to directors in extenuating circumstances. 13 Yes, 2 No (Karbiner, Milam), Motion Passed.

Bob Fleury, Magazine Committee Chair, presented his report in booklet form to the BOD outlining what duties our publisher Webster County Printing does for us in addition to actually printing the magazine. He also reviewed possible costs if we were to add an online version of the magazine.

Motion # 33, Webmaster Duties: Motion by Riedl, Seconded by Jagielski. I move to accept items 5-6-7 on page 112. 15 Yes, 0 No, Motion passed. Items are as follows:

#5: The ABC Webmaster shall be responsible for all ABC Domains and Email (Forwarding) accounts. The yearly Domain registration and other website expenses must be submitted to the treasurer for approval and reimbursement.

#6: The ABC Webmaster shall be responsible for the ABC Pay Pal and Email (PayPal Filters)

#7: The ABC Webmaster shall work with the ABC Secretary regarding new website content before posting. Motion # 34, Email Votes: Motion by Ralph, Seconded by Brigham. I move to approve Board of Director email votes taken since the last Annual BOD meeting.

15 Yes, 0 No, Motion Passed.

Motion # 35, Versatile Dog Program: Motion by Hanson, Seconded by Christensen.

I move to adopt the proposed Versatile Dog Program outlined on page 140 and 141 of the Agenda Book and create a position of Versatile Dog Coordinator. 14 Yes, 1 No, (Karbiner), Motion Passed. Hanson said this proposal did not incur financial obligation for ABC as the only expense would be printing the certificates which she would do. Proposal is as follows:

VERSATILE DOG AWARDS

- Awards will begin in 2015 and dogs that have previously qualified will be eligible for the VD and VDE titles if both they and their owners meet the qualifications.
- The Versatile Dog committee will consist of a Chair and committee members with expertise in each of the categories (field, show, & performance.)
- All owners of a dog must be current members (full or associates) of the American Brittany Club by March

1st of the current calendar year for the dog to be eligible for Versatile Dog and Versatile Dog Excellent Title Awards for that year. - The Versatile Dog Coordinator shall keep a listing of all Versatile Dog Title recipients and the list shall be published on the American Brittany Club website.
- Dogs who have been awarded a Versatile Dog (VD) or Versatile Dog Excellent title may include this information as a suffix to their dogs registered name. This title is an American Brittany Club title and not an American Kennel Club title.
- Costs associated with this award will be minimal for printing and mailing of title certificates.

I move to accept the Dog of the Year as written but striking the sections for All Age, Amateur All Age, Gun Dog, Amateur Gun Dog sections. Change Puppy and Derby to Juvenile Dog of the Year. Strike the funding sections. 12 Yes, 3 No (Pollock, Karbiner, Dow) Motion Passed. Since the BOD did not approve any funding for this program, Karen Hanson volunteered to donate \$1,000 for the first year, and Robin Tomasi agreed to seek outside funding for future years. Field Dog of the Year categories were considered already being awarded with the Purina All Age Dog of the Year and Masked Magnum Award and The Garmin Gun Dog Award. Proposal as modified is as follows:

American Brittany Club National Dog of the Year Awards

- Awards will run from January 1st to December 31st, and start in 2015.
- The National DOY committee will consist of a Chair and a committee members with expertise in each of the DOY categories (field, show, obedience, agility, juniors, NSTRA, and NAVDHA)
- All owners of a dog must be current members (full or associates) of the American Brittany Club by March 1st of the current calendar year for the dog to be eligible for the National Dog of the Year Awards. (Please note: the associate membership is only available to individuals who reside in the same household as a current full member. Also, Associate Memberships do not include voting privileges in club matters.)
- If an individual obtains ownership of an eligible dog during the calendar year they have 30 days to join the American Brittany Club, and the previous owner(s) must have met the membership requirements for the dog to be eligible for the DOY award.
- If an owner's membership lapses during the year, they have a 30 day grace period to bring their membership current or their dog will be dropped from the eligibility list. Example: If an individual's membership expires on June 1st, they have until July 1st to renew.

- If there are no eligible dogs in a category, no award will be given for that year.
- DOY Committee will provide form to be filled out for awards that require owners to submit information.
- The Dog of the Year program will be evaluated in 2016 for changes to the program starting the 2017.
- DOY award presentation will be held with an ABC event (ABC Summer Specialty, Gun Dog Nationals, National Specialty, or All-Age Nationals) Individuals unable to attend will be mailed their certificates and any trophies. All owners will receive a certificate, but only 1 trophy will be provided per dog. Co-owners of dogs can purchase duplicates of trophies for the price of the trophy, and trophies will need to be ordered ahead of time with DOY Awards Committee.

Field Dog of the Year Awards: Field DOY awards will be awarded in the following categories based on the following rules:

Juvenile Dog of the Year - based on dogs defeated in Puppy & Derby stakes at any AKC Field Trial. Dogs defeated points from AKC trials hosted by clubs other than regional Brittany Clubs must be sent into the DOY committee with an attached copy of AKC win record report. In the case of a tie, the dog with the most 1st place wins will be awarded DOY. If a tie still exists then multiple awards will be presented.

For all Junior Awards, in the case of a tie multiple awards will be presented.

Show Junior Handler: The Show Junior Handler points will be tabulated on the number of handlers defeated in AKC Junior Handler events. This is based on the AKC Junior Handler Rankings.

Field Junior Handler: The Field junior will get 5 points for every event in which they participate per dog. This includes AKC Field Trials, Hunt Tests, NVDHA, and NSTRA. A form must be signed by judges or event secretary indicating their participation in the event and the name of the dog they competed with. The Junior must compete in at least 4 events during the calendar year to be eligible for this award.

Performance Junior Handler: The Performance Junior will get 5 points for every event in which they participate per dog. This includes all AKC performance events that Brittanys are eligible to compete in (obedience, rally, agility, fly-ball, barn hunt, etc.). A form must be signed by judge(s) or event secretary indicating their participation in the event and the name of the dog they competed with. The Junior must compete in at least 4 events during the calendar year to be eligible for this award.

Change the word recording to starter. 14 Yes, 0 No, 1 Abstained (Brigham) Proposal as modified reads as follows: Designated Specialty Shows held by Regional Clubs in conjunction (not concurrent) with All Breed Kennel Club Shows shall be exempt from the starter fee unless they want their results printed in the American Brittany Magazine. Motion # 38, Director Vacancies: Motion by Gower, Seconded by Darlene.

I move that in case of a Director vacancy the BOD will go back to the last previous election ballot vote and appoint the 2nd place candidate if they garnered 33% of the votes cast. 15 Yes, 0 No, Motion Passed. (Vote totals will be kept by each year's nominating committee chair.)

Due to the drop in entries in recent years, the BOD looked at how we can work with the qualifications to help increase entries, particularly in the Amateur Stakes.

Motion # 39, Qualifications: Motion by Ralph, Seconded by Brigham. I move to strike the line from the qualifications in all national stakes that "No dog may run in both the National All Age Championships and the National Gun Dog Championships in the same calendar year." 10 Yes, 4 No, (Patterson, Dow, Hendrickson, Pollock) 1 abstained (Karbiner).

Motion # 40, Qualifications: Motion by Ralph, Seconded by Brigham. I move to qualify a dog who has "qualified in any previous year and during the period from the previous years close of entries to the current year closing of entries has a placement in an (name of stakes) 13 or more dog stake in an AKC licensed trial held by a Brittany Club." 14 Yes, 0 No, 1 abstained (Dow).

Motion # 41, Directors' Ballots: Motion by Henderson, Seconded by Dow. I move that all ballots for the BOD election shall be consecutively numbered for each region based on eligible voters for that region. President declared motion passed on a voice vote.

2015 REPORT OF THE ABC PRESIDENT

Well, we got through another year, but it wasn't easy. The BOD has dealt with a number of issues, some of which were related to the length of our last meeting.

Costs are slowly increasing with revenue slowly decreasing. The peak of field trailing has passed and has slowly declined since. The same is occurring in almost all pointing breeds with few exceptions. Since the main sources of income come from dues and field trials, income has decreased as these two things have declined. The increase in dues was warranted but with a number of 3 year renewals, it will take a while to see the final results.

Other sources of income could be sought such as increasing the field trial starter fees or requiring an ad in the magazine to get approval to run a trial, etc.

Or, we could try to limit expenses like donations to other organizations and the scholarship program. These were all started when we had lots of money.

Money problems are facing most pointing breed clubs and are being dealt with in different ways.

Being President of the ABC is much different than the other organizations I've been President of. Most of the calls or emails I get are along the lines of "you need to tell so and so not to do that" and things of that nature. In the past (I was on the BOD for about 23 years) everything was taken care of at the annual meeting. Now, with the advent of emails, it seems that everything has to be done "right now." Our new way of discussing things before a motion is made should be the new standard of how we conduct business. Otherwise we become somewhat dysfunctional. Somehow the president should be allowed to make more of the day to day decisions on his or her own about things he or she knows would meet with BOD approval. So, anyway, I'm going to drift off into retirement and enjoy my dogs and horses, helping with field trials, and judging quite a bit. I'll still be around.

There has also been mention of NBRAN putting an AKC P.A.L.S. number on all Brittanys adopted out to maybe encourage Brittany adopters to do an activity and train their dogs – leading to less returned to rescue for behavior/energy issues, but this has not been decided on yet.

Overall it's been a good year and there are numerous positive things going on throughout the club. I have no action items at this time.

2015 REPORT OF THE 4th VICE PRESIDENT

Report will be presented at the Board meeting regarding the running of the Gun Dog Nationals in October 2015.

Action Items:

Policy Book Changes Page 46 #15—"Submit a report of your activities and recommendation to the Agenda Chairman in advance of the annual Board meeting. This must be done far enough in advance so the agenda chairman can have the agenda in the hands of the directors six (6) weeks prior to the annual Board meeting."

The Gun Dog Nationals run approximately 5 weeks prior to the Board meeting and a report on the running cannot meet these deadlines. Without having the information in the agenda book any issue cannot be discussed. This should be changed so any items that need to be addressed from the current years running can be brought to the board for action.

A couple topics that do need to be addressed are:

- 1. Location of the Gun Dog Nationals
- 2. ADA handlers, use of quads, bracing information/guidelines

Page 46 # 19—"Site selection for the National Open and Amateur Gun Dog Championships must be approved by the Board of Directors."

Many members have asked for a more neutral location and/or rotating grounds more centralized.

Page 47 #20—"Money made from the raffle and/or auction for the Gun Dog Championship shall be donated to the Ionia grounds as long as the ABC runs the Gun Dog Championships there. Before a donation to the grounds funs from the raffle and/or auction, each of the Gun Dog Nationals must break even."

Discussion was held as to keeping any money made, if break even status is achieved, in an account to offset and deficit in future running of the Gun Dog Championships. Many people are interested in working on fund raisers but not if the money will be sent to Ionia grounds.

Why is this a different arrangement that the All Age Nationals?

Page 157 #7—"The statistician is to compile the list of qualified dogs for the National Open, National Amateur and National Gun Dog Championships and send to the editor and Executive Secretary."

Over the past few years, that I am aware of, the Gun Dog Field Trial Secretary has kept the stats. I just need clarification of who is to do it and the policy book should reflect the same.

2015 REPORT OF THE EXECUTIVE SECRETARY/ SECRETARY Mary Jo Trimble September 8, 2015



Two main changes have dominated activities of the Executive Secretary/Secretary position during the last year. Activities outlined by the ABC Finance Committee have increased additional reporting of results and budgeting by the Executive Committee and the various ABC committees. This is a good thing to verify trends in income and expenditures which helps with planning for the future. Since this has never been enforced in years past, it has required great diligence on the part of the Finance Committee to work with all phases of the ABC Officer and Committee Chairs to develop a working plan for creating realistic budgets and accounting for each of their assigned duties. I know many members are upset with the lack of color in current issues of the magazine, but the Magazine Committee was charged with reducing their budget by several thousand dollars and this was a major way that could be accomplished. Hopefully with the new dues increase, some of the cut backs can be re-adjusted in the future as the club gets on a more long term solvency.

The second change has been adding someone to shadow my jobs as the BOD has decided after decades of the Executive Secretary (an ongoing BOD appointed position and ABC Secretary (an ABC BOD two year elected position) being held by one person to be divided. The Policy Book currently assigns very few duties to the elected Secretary position. When these two offices are once again divided, I anticipate some transfer of duties of the Executive Secretary to the Elected Secretary position. I was very pleased that Leslie Andreas was selected to shadow me for the Secretary position. Leslie is an ABC Life Member and has been actively involved with the ABC since her youth. She has a great understanding of the history and processes of the ABC, its dogs' pedigrees, as well as a great knowledge of the people in the ABC membership. All of this will serve her well if she later assumes the Secretary position.

Due to some confusion as to who was to do what in overhauling the way Membership Data is stored and distributed, nothing was accomplished on last year's BOD Motion to create a new database system for membership. One of my action items will address this and ask that the process be started during 2016.

I do feel the ABC is at a crossroads with different factions of the club pulling in different directions. I would hope that Directors, Officers, and Members would dedicate their efforts to keeping the Mission Statement foremost in their minds to remember that *the objective and purpose of the Club shall be: to promote cooperation and friendship among the breeders and owners of Brittany and to encourage high standards in breeding, training and showing of Brittanys in the field and in the show ring: to discourage the breed from becoming split into groups of "field dogs" and "bench dogs" and to strive to keep it forever a "dual dog".* Sometimes we get so wrapped up in pleasing everyone and promoting our own particular interests and worrying about the number of members in the ABC and forget that our goals should be directed toward protecting the high standards of the Brittany as a sporting dog with dual capabilities rather than how to please everyone and make everyone a winner. I would encourage Members to work through their Regional Club Directors and specific Committee Chairs when they wish to present new ideas or complaints to the Board of Directors. I would also encourage Regional Directors so they are not lost in the shuffle leaving the members to think they are not being heard. I would also encourage all to read the Policy Book so that you are aware of the rules and procedures that ABC Directors, Officers, and Committees are required to abide by.

EXECUTIVE SECRETARY/ SECRETARY Mary Jo Trimble

ACTION ITEMS

- Add to the duties of the Hall of Fame Chairs (both dog and people) to furnish the Magazine Chair a biography to be published in the ABC Magazine of those people and dogs elected each year to the ABC Halls of Fame. Since the ABC Secretary is to take minutes of the annual ABC Membership Meeting, I would add to the Policy Book Section for the ABC Secretary to receive nominations, conduct the election for Life Members at the Membership Meeting, and also present a biography to the Magazine Chair for publication of those members elected to Life Membership.
- 2. Reaffirm that the Membership Database should be overhauled by Linda Langford with input from an Ad Hoc Committee headed by the 2nd Vice President, and consisting of The Executive Secretary, Secretary, Membership Data Chair, Magazine Committee Chair, and Membership Promotion Committee Chair with others to be consulted or added as deemed necessary or beneficial to the project to assist Linda Langford in covering all bases regarding this program proposal.
- 3. I would like to propose that the ABC open an official ABC Yahoo Group for posting to member's notices, AKC actions, BOD actions, and referrals to the ABC Website and/or AKC website for more details to keep the membership more informed. This group would be for posting only with no discussion which has always been discouraged by AKC as internet fights do not encourage or promote new people to join our clubs and often create discord among the membership. The BOD has directed Facebook to only post notices to the ABC Website where no discussion takes place, but members are not in the habit of regularly checking the website, and we as officers are often criticized for posting to public discussion groups and/or Facebook. Signup and change of email addresses would be up to the individual members. I would be happy to add this to the duties of the Ex. Secretary as I serve pretty much in that capacity for the BOD anyway.
- 4. We need to add to the duties of the Ex. Secretary, Section # 5, page 53 of the policy book the following: Members who belong to Regional Clubs in more than one region or a region different from their residence shall notify the ABC Executive Secretary prior to August 1 each year in which region they wish to cast their ballot. This notice shall be published in the Magazine, on the Website, and Facebook (and ABC Yahoo Group if that proposal is accepted) prior to July 1 each year. If no notice from the member is received, then a ballot will be sent based on the member's state of residence. Members who belong to only one Regional Club will receive a ballot based on that Regional Club's Region. It is very time consuming to have to deal with this issue after the August 1st date and should be the members' responsibility rather than ABC trying to find in the membership list all these overlaps and trying to contact the members each year to determine their primary region. We do have members who live in one region and belong to only one club in a different region and ballots have ALWAYS been sent based on that Club's Region so that will not change.

2015 REPORT OF THE TREASURER Gerilyn Sennott September 12, 2015

As my term as Treasurer of The American Brittany Club is drawing to a close, the financial statements will be completed for year ending 12/31/15 before turning over all records to the new treasurer.

The Finance Committee has completed their internal audit on the 2014 Financials and found it was balanced and complete with the exception of the recording of membership unearned dues as members are paying for multi years. The pay pal reports do not reflect the expiration year. This has been addressed by the Finance Committee and I have forwarded all membership packets to the Executive Secretary for review. This will continue as I receive the packets from the Membership Data Chair.

After the 2014 National Events concluded, it was very difficult obtaining the money collected for deposit and expenditure receipts/reports of the events. This has been discussed with the Event Chairs and the Finance Committee where all recordings of the events be submitted to The Treasurer no later than 30 days after the end of the event. (This is an action item on the Finance Committee's report). It is imperative that this reporting is prompt as it effects the year end statements.

Each year the Finance Committee will advise The Board of Directors as to the donations made to the following organizations:

Bird Dog Foundation: Brittany Endowment Sportsmen's Alliance National Animal Interest Alliance National Animal Interest Alliance Trust

The bank account located at 1st Western Bank in Booneville, which was used for the disbursement of membership reimbursements, was closed to consolidate the checking accounts into one.

ACTION ITEMS

- 1. Currently we are reimbursing the clubs on a quarterly basis. Any club reimbursement which is less than \$20.00 will be carried forward to the next quarter until their check reimbursement exceeds the \$20.00 limit. Reasoning is that a check written for \$2.00, mailed and then usually misplaced as it is not deposited promptly then needs to be replaced at a later date. The cost is much more than the check written.
- 2. All club reimbursement checks must be deposited in a timely manner. After one (1) year after issuance date, the check will be voided and no replacement check will be issued.

2015 AKC DELEGATE'S REPORT

Judy Tighe September 15, 2015

The year has been busy with several changes to the AKC website. Unfortunately, the person in charge resigned midstream and the IT people had to work hard to make appropriate changes and updates. It is still a work in progress while problems are being worked out.

The Parent Club Committee has a number of projects: Parent Club of Excellence Project which has had poor response. Of those responding regarding the "Breeder of Merit", only 10 of the 27 clubs responding encouraged this program but 13 of the clubs encouraged full litter registration. Some of the clubs increased their membership while less than half report any Junior recognition or Junior Scholarship program.

AKC Classifieds needs to be able to verify if a person states they are a Parent Club member and Breeder of Merit.

The "Bred With Heart Program" has grown. It is geared to larger volume breeders that have 7+ litters/year. The breeder must comply with Parent Club recommended health tests, verification through the AKC inspection program and comply with the Breeder Education component. AKC is developing an on-line test and if you pass, you will receive certificate indicating you have completed the course.

Disaster Trailers – The program began in September of 2013. To date, \$1,031,000 has been raised. 30 Disaster Trailers have been delivered across the country with many more in the process of being built. I recommend ABC begin a 501c3 fund and contribute \$500 to start and request members make donations. If we donate \$1,000 or more to the Disaster Trailer program, the ABC logo can be put on a trailer.

The Certificate of Merit proposal for 4-6 month puppy class at shows has gone back to the Board to be reworked.

The Field Trial and Hunting Test Committee and Parent Club Committee are working together to update the Sporting and Hound breed fliers that go out to new puppy registrations. I have used the ABC flier and Irish Setter flier as examples. Many have old information that needs to be updated. Thank you to ABC for doing a great job on ours. **I have made the recommendation that this flier be sent to all people that breed a litter so they can copy and give to their new puppy buyers.** This way, we should get to those that are not members of ABC and encouraging them to join.

Also, the FT & HT Committee will be sending out a questionnaire to all the field trial clubs to see what we can do to help promote field events. A suggestion was made to invite veterinarian students to our field events.

With Legislation, AKC is supporting a Federal PAWS 2015 bill, Pets and Woman's Safety Act which helps women that are abused that have pets get to a safe place with their animal. Also they are supporting legislation that retail pet stores cannot sell pets from shelters. There are many bills throughout the country going after breeders. Any pets being brought into the USA MUST be vaccinated for Rabies. A one year vaccine may now be administered at 3 months but must be boosted at 4 months.

Election time is coming up and we need to assist in electing "dog friendly" candidates. You can sign up on line to make monthly donations of at least \$5 or more at akc.org/pac/. Or your club can sponsor a fund raiser. If there is a candidate you wish to support, get in touch with the AKC PAC. Of those the PAC donated to, there has been a 90% success rate. This is good for local and state elections. It gives us an edge whenever bad legislation is introduced.

One of the highlights this year of positive legislation happened in Illinois. The Illinois Federation of Dog Clubs and Owners sponsored a bill in the Illinois General Assembly to require shelters and rescue organizations to do multiple scans on dogs in their care to try and locate the owners before selling or placing any dogs with new owners. Governor Bruce Rauner recently signed the bill into law. Previously the Federation had sponsored a bill which required Animal Control to scan a minimum of two times before releasing a dog. This was an extension of that legislation. Currently there is a petition on line started by an East Coast lady who has spent over \$130,000 to try and get her dog back that had been placed into a new home even though the placing organization knew who the rightful owner actually was. She has established an online petition to try and get Federal Legislators to enact a federal law impacting all 50 states which would require these scans. I have included a summary of this and would encourage all clubs and ABC Rescue groups to work with your state AKC or other Dog Federations to promote similar legislation.

AKC'S ILLINOIS FEDERATION HELPS PASS LAW TO BENEFIT LOST DOGS By: AKC Government Relations Department

AKC's Illinois Federation Helps Pass Law to Benefit Lost Dogs

Thousands of Illinois pet owners will now have a better chance of being reunited with their beloved pets thanks to House Bill 4029, which was signed into law recently by Governor Bruce Rauner. The Illinois Federation of Dog Clubs and Owners (IFDCO), AKC's official Illinois state federation, worked with key sponsor Senator Thomas Cullerton to initiate the legislation, which requires animal shelters and rescue groups to scan intake animals for a microchip multiple times before releasing the animal. This extends the provisions of SB1632, which required the same procedure of animal control facilities. The American Kennel Club was proud to support both of these measures, which help reunite lost dogs with their owners.

"The Illinois Federation of Dog Clubs and Owners is committed to responsible dog ownership, and this new law is a win-win for all dog owners in the State of Illinois," said Michele Kasten, Vice President of IFDCO. "It will help get lost animals home more quickly by ensuring that shelters and rescues who take in stray animals follow the same requirements as animal control facilities -- scanning the animal for a microchip multiple times so it can be identified and returned to its rightful owners. Prior to this law there were no requirements for shelters or rescues to scan for a microchip and contact the owner..."

House Bill 4029 defines shelters as facilities operated by a humane society, animal welfare society, or other non-profit organization "promoting the welfare, protection and humane treatment of animals", as well as veterinary hospitals and clinics if they also provide these services.

Among other requirements, shelters would have to check for identification within 24 hours after the initial intake of a dog or cat. An additional scan for a microchip and other forms of identification would also be required prior to transferring an animal to another shelter or rescue group, or euthanization.

HB 4029 also states that if the first person listed on the microchip cannot be reached, the shelter must notify the second contact if one is listed. Also, shelters must notify the owner when they are identified and transfer dogs with identified owners to a local animal control or law enforcement agency for redemption. If they cannot transfer the animal, they must hold the animal for at least 7 days prior to removing the animal.

The AKC congratulates IFDCO on their significant efforts in bringing this important law that will help reunite lost pets with their owners as soon as possible.

ABC Regional Clubs and/or Rescue groups, feel free to contact Mary Jo for more information or questions.

Fortunately, due to the Presidential Election, dog legislation has taken a back seat. HSUS continues to fund political campaigns though. I stay in contact with the US Sportsmen's Alliance, AKC, National Animal Interest Alliance, and other legislative groups and along with Judy Tighe, our ABC/AKC Delegate, to try and notify members when their state has proposed legislation that they need to react to accordingly. We need all of you to stay focused on dog or animal legislation in your state and work to keep laws that don't kill the sport we love with bad laws.

The trend from Animal Rights folks this year seems to be establishing legislation affecting dogs kenneled outdoors. The emphasis is on Extreme Weather Conditions with severe penalties for dogs left outside. The problem with most of their legislation is EXTREME is not always defined and sometimes applies to all companion animals which in many states includes horses. Be on alert for this as they slipped in through during the last week of the Illinois Legislative Session and neither the Federation or IL Federation for Outdoor Resources nor our lobbyists got wind of it until it had been run through Committee and to the floor for a vote. It sounds good to legislators but could be dangerous to dogs that are permanently kenneled outdoors. WATCH FOR THIS!

The American Brittany Club has been trying to increase the number of regional trials that advertise their events in the American Field in order to make sure that dogs running in the ABC National Championships and Classics are qualified to receive the title of Champion or Runner-Up Champion if they would win one of our national stakes. A derby placement in an American Field sponsored event qualifies a dog for life as does an adult placement. Regional Clubs that are members of the AFTCA will have win certificates issued to their Amateur- handled winner which qualifies them to receive AFTCA Championship titles.

The ABC Secretary has asked clubs to indicate if their regional trials are also American Field sponsored on the ABC Field Trial application blank. The ABC trial reporting form has a place to check if results are also being sent to the AFTCA as well as the AF and AKC. Not as many clubs are members of AFTCA as are now running their trials under the American Field.

A larger proportion of the events NOT run under the AF are Walking trials which does hurt people trying to get win certificates or placements that would make the dog eligible to receive an AF/AFTCA Gun Dog National Champion Title. They still get the AKC National title but not the American Field or AFTCA ones.

For more information on running trials under both the American Field and AFTCA, contact Mary Jo Trimble, ABC Secretary.

Of special note is the new American Field Field Trial Ad Policy which is now in effect. The information shown below was pulled directly from the American Field Publication and is included for all participating clubs' information:

ABC REGIONAL AKC CLASSICS/ AF CHAMPIONSHIPS:

In addition to the regular ABC Original Classic/Championships, the ABC also sponsors Regional AKC Classic/AF Championships in conjunction with several Championship Associations. Clubs running these events need to follow the guidelines as posted on the ABC Website or contact the ABC Secretary for a copy. Please indicate on the result form that the trial is both an ABC Classic and an American Field Championship. There is a space provided on the ABC/AKC/AFTCA/AF result form. Please use this form to report results. Prior to the event, the current insurance certificate and completed AKC Field Trial application and the \$15 AKC fee should be sent to the ABC Secretary who will sign and send to AKC. Associations will be responsible for any AKC late filing fees as well. Please appoint a reporter to cover the trial and get reports and write-ups in promptly to the American Field and the ABC Secretary for publication. Please try and get photos of the winners as well.

2015 ETHICS COMMITTEE REPORT

Jim Brigham, Chair. September 11, 2015

The committee has been inactive this year. A misunderstanding of the procedures by me has caused a delay in Board action on these recommendations.

• Policy Book Article I deals with membership. We are proposing to amend Article I Section 2: Termination of membership and Section 3: Suspension of Membership to reflect the recommendations of the AKC Sample.

These amendments must follow Article IX Section1: Amendment of the Policy Book. The first step requires that an amendment be submitted to by a referendum vote by mail, (a) when authorized by the BOD or (b) by a written petition addressed to the Secretary and signed by at least 25 members in good standing, no more than 5 being members of the same regional member club. Section 2: Within thirty days after authorization, the Secretary shall mail to every member, entitled to vote, a copy of the proposed amendment or amendments together with an appropriate ballot, and shall specify on the ballot a day certain, not less than thirty days after such mailing, on which the polls shall close. Ballot must be signed. Must be voted on by 1/4th of members and must receive 2/3rds yes vote.

Authorization is by the BOD.

Action Items:

Motion 1: I move that the Board authorize a vote on the proposed amendment modifying the procedures for terminating memberships. To save on mailing costs, I further request that Secretary postpone the mailing until the fall mailing for directors.

Reasoning: It is more specific in dealing with any debts owed to ABC

Motion 2: I move that Section 3's title from Suspension of Membership to Discipline of Members. Further, that the Board adds C – it would describe how the Board would deal with a member preferring charges against another member. To save on mailing costs, I further request that Secretary postpone the mailing until the fall mailing for directors.

Reasoning: To better describe the process by which the Board would determine the appropriate disciplinary action against a member. This would give the Boar the same authority that its regional clubs are granted in B.

• Proposed Code of Ethics for the ABC Officers, Directors and Committee Chairs

Motion: I move that the Board adopt the following proposals for an Ethics Policy for Officers, Directors and Committee Chairs of the American Brittany Club.

1. Members of the Board, Officers and Committee Chairs will conduct the business of the ABC in good faith and with honesty, integrity, due diligence and reasonable competence.

- 2. No Board member or Officer shall share, copy, reproduce, transmit, divulge or otherwise disclose confidential information related to the affairs of the ABC. Each Board member will uphold the strict confidentiality of all executive sessions and other deliberations and communications of the Board deemed confidential.
- 3. Members of the Board, Officers and Committee Chairs will exercise proper authority, fairness and good judgment in their dealings with all parties.
- 4. Directors and Officers of ABC must at all times act in the best interests of the ABC and not for personal or third-party gains or financial enrichment. When encountering potential conflicts of interest Board members, Officers and Committee Chairs (refer to page 14 of the Policy Book ABC Policy on Conflicts of Interest) will identify the conflict and as required, remove themselves from all discussions and voting on the matter,
 - Avoid placing (and avoid the appearance of placing) one's own self-interest or any thirdparty interest above that of the ABC.
 - Do not abuse the position of authority given to you by the ABC by improperly using that authority for personal gain or third-party gain or pleasure.

Complaints of misconduct or conflict of interest may be made by any ABC member or a party dealing with the ABC or its regional clubs. Under most circumstances, the complaint will be received by the President or the Secretary of ABC.

Discipline procedures will be taken as set out in Robert's Rules of Order Newly Revised, 10th Edition Chapter XX Disciplinary Procedures Offenses Elsewhere Than in a Meeting; Trials or the most recent revised edition.

2015 ABC FACEBOOK COMMITTEE REPORT

At the time of this report there are 3,250 fans of the page. In the past year, we added 1,082 fans; a 50% increase. On any given week the ABC Facebook page is seen by up to 10,000 people.

Following are some insights into the demographics of our Facebook fans:

56% of our fans are women while 43% are men. The 55-64 age demographic is the most engaged (those who comment, like, or share content), followed closely by the 45-54 age group. The ages of our fans break down as follows (from largest to smallest):

- 45-54: 23%
- 35-44: 22%
- 55-64: 19%
- 25-34: 17%
- 65+: 11%
- 18-24:6%

Individual posts are viewed on average by 1,500 people. The most popular post to date was an AKC Gazette article shared from the AKC website written by David Webb on Brittany puppies. This article was shared from the ABC page almost 40 times, and reached more than 6,000 people. Health, hunting, personal stories, and training tips (across all venues) have been the most popular posts.

Periodic reminders were posted during the year encouraging FB fans to join the ABC, reminding current members to renew their membership, Futurity Nominate their litters, etc. Several promotional posts were made to support individual ABC events and items for sale.

Thank you to the members of the ABC Facebook Committee for all their hard work in providing a wide range of content for Brittany enthusiasts.

I also want to remind clubs to work with their Regional Date Coordinator concerning field trial date scheduling, as all date must first be approved by the Regional Date Coordinator before ABC can approve the field trial application.

2015 FINANCE COMMITTEE REPORT Judy Graves, Chair. September 2, 2015

Members: Judy Graves, Chair; Les Casselberry, East Coast; Kent Patterson, East Central; Jim Brigham, Central; Mary Karbiner, Mid-West; Joe Gower, West Coast

Having been formed in 2013, this committee continues to carry out its duties as outlined in the Policy Book. The first order of business for the committee is to oversee the audit function. Because of the ABC size and structure, an independent, certified audit would add unnecessary costs to the operating expenses, and provide nothing more than a certification that the financial statements were presented fairly. The committee members participated in an in-depth internal review and reported to the Board of Directors. One of our findings dealt with multiple people receiving cash receipts and event staff writing checks when the Treasurer was not available. Throughout the year, funds are collected by the Executive Secretary, Membership Data Chair, Webster Co. Printing staff, national event secretaries, volunteers for our publications, trophy donations, etc. etc. We noticed that the Policy Book does not address how often these funds should be forwarded to the Treasurer. In most cases, funds are sent to the Treasurer at least monthly. However, we did find that last year's gun dog nationals and the national specialty show took much too long to get their receipts and disbursement documentation to the Treasurer. We are proposing an action item to address this issue.

During 2015, we reviewed and recommended to the BOD the addition of a fifty cent mailing fee for all judges books & primers purchased. We found that in some instances, shipping costs exceeded the purchase price.

The outcome for 2014 was also sent to the BOD with an analysis of the actual vs. budget. Considering this was our first attempt at establishing a budget process, we feel the outcome was very positive.

The IRS group exemption continues to be in force with 45 clubs included in our umbrella. Two clubs were added in 2014. To date, no clubs have requested inclusion in 2015. Form 990-N was filled for each club and copies of the IRS e-postcard receipts were forwarded to each club's contact person. The ABC's 2014 IRS Form 990 was filed by the Treasurer May 12, 2015. Our 2015 CP 119 was filed Sept. 1, 2015 as required by the IRS.

Request for the 2016 Operating budgets along with the Futurity program will be due October 1st to the Finance Committee. National Gun Dog, All Age & Specialty events will be presented to the BOD in March of 2016. The dues increase approved two years ago will go into effect in 2016. Hopefully we will be able to submit a balanced budget with this increase. Costs continue to be monitored for any possible savings without sacrificing our program quality. We will continue to strive to establish a general operating fund reserve of at least twice our operating income.

ACTION ITEM #1

We request a motion be made to add to the duties of all event chairs that funds received for activity other than entry fees is turned over to the treasurer within 30 days of receipt.

ACTION ITEM #2

We request a motion be made to appoint Mary Karbiner to a full 5 year term as a member of the Finance Committee.

ACTION ITEM #3

After review of the 2016 budget submitted, we request a motion to approve the budget with any revisions made during board review.

The futurities committee graciously accepted as committee members "mid-stream" and is comprised of Leslie Andreas, Kristi Anglen, Darlene Dow, Linda Langford, Robin Tomasi, Sharon VanWieren and myself.

Sharon VanWieren is taking on the project of preparing an understandable description of why puppies should be registered with FDSB. Thank you Sharon.

After much pushing, prodding and threatening, we finally received information from all clubs regarding the futurities held this spring. Central and West made money (above budget) and East was extremely close to budget. East would have probably done somewhat better with a little more help and a lot better weather.

Not one of you will forget changing the futurity policy this late spring/early summer. Thank you for your tenacity in getting this approved. The correct policy is posted to the ABC website. Some of the changes noted are: litter nomination period was increased, dollar amounts for forfeits and entries were increased and there was modification of dual award rules to give multiple awards if there are ties. There are several small changes to be made, but I think it better if we wait another year. I'm sure you'll all agree.

There are definitely some major miles between the locations of the regional futurities for the 2014/2016, but we are hoping for good, hopefully better, numbers.

The first forfeits this year are somewhat higher than this time last year. Final forfeits for 2016 are due by October 1^{st} . At the time of this report, we have one application for hosting 2017. If you know of any club interested in hosting 2015/2017 regional futurities, please contact Kristi Anglen or me or ask interested club to complete application on ABC website and send to me. Action Items from Steve Ralph:

ABC Policy Book changes & additions

Futurity (Policy Book, Table of Contents & pg 100-114) - change all occurrences of "National Futurity" to "Futurity" **Per Steve Ralph:** Please add the following item to the 2015 ABC BOD Agenda.

Futurity improvement discussion (starting 2016/2018)

1. Change the Futurity format from running three sectional events (Central, East, West) to running three futurity events (All Age, Gun Dog, Show) with the corresponding National events.

a. The All Age Futurity would be run in conjunction with the National All Age Championships on the same grounds.

b. The Gun Dog Futurity would be run in conjunction with the National Gun Dog Championships on the same grounds.

c. The Show Futurity would be run in conjunction with the National Show at the same site.

2. Change length of field heats from 30 minutes to 45 minutes or 1 hour

Action Item from Karen Hanson: Discussion with the Futurity Committee and Futurity "Action Committee" on proposals for change in the futurity program.

Over the summer, members of the ABC Board sent in suggestions for improvement to the futurity program. The 2014/2016 futurity actually has 35% more litter nominations as compared to the 2013/2015 year. It would appear that futurity participation is on the upswing. The futurity program is one of the few programs where participation is limited to ABC members, and is one of the only programs that make money for the ABC year after year. The way the futurity program is currently run fits in with our mission, "**The purpose** of the American Brittany Club is to promote cooperation and friendship among the breeders and owners of a Brittany and to encourage the highest standards in breeding, training and showing of Brittanys in the field and in the show ring; to discourage the breed from becoming split into groups of "field dogs" and "bench dogs" and to strive to keep it forever a "dual dog".

I personally have competed in the futurity off and on for almost 30 years. I've seen highs and lows, but found that having a National futurity run off heightened the importance of the event. My personal feeling is that the futurity program is not broken, but can be improved if the National Club gives the program more importance and cache'. I also believe that as a breeders' stake, the breeders should be highlighted, which is something that up until now has been sorely lacking. With the last committee's pursuit of trophy donations, I think the program can and will be giving more emphasis to the actual breeders. I am especially happy to see the "showcase of dams" on Facebook. I think it really gives the program a lift and makes the membership want to participate.

I do think the clubs need support in putting on the futurity. Most clubs put on a futurity on an infrequent basis. They need to know what they are allowed to spend and they need a helping hand. I think it would be beneficial to have a member of the futurity committee be a liaison to the club putting on the futurity. That would hopefully help stop some of the Monday Morning micromanaging that has plagued the program in recent years. If we want to make the futurity a national event – I believe that the actual events will run better... in that you have a continuity of people running the events, and facilities in place to put on a quality event. That would lower the number of events and most likely would lower the actual number of participants, and most likely would lessen the appeal to "new" members who come to the events as their first real exposure to the field and show.

I also think it's time to look at why we are so afraid of "AKC" for the futurity program. AKC allows clubs to have special attraction events, and my understanding the charge to have a "special attraction" is \$15.00. The special attraction is considered to be a separate event. (See Beginner Puppy completion at dog shows, hunting dog stakes at field trials).

I think it would be an excellent idea to poll our futurity participants and breeders from the past two years to ask them what worked for them and what didn't. We are very concerned about the American Field registrations associated with the futurity or the lack there of. If the participants in the futurity do not want to register their litters or dogs with American Field, are we bringing any extra value to the participants by running the field events under American Field? What value to the participants does running the stake under American Field really bring?

Several members have suggested the following changes:

- If we move to one futurity, having the gun dog futurity with the gun dog nationals, the all age futurity with the all age nationals and the show futurity with the national specialty show. Other members have opined that this will make it harder to have a "real" dual dog, as many of the dogs that entered the gun dog stake would not want to make a second trip to the national specialty show, therefore giving the all age dogs a decided edge. A possible way to change this would be to have the futurity show with the summer specialty.
- Several members of the committee have recommending keeping the three- futurity set up, however, since the entries in the all age futurity have been steadily declining in years, combining the all age and gun dog futurities into one futurity field stake. They feel that this would highlight the "best" dogs, in a bigger pool of entries. Concern has been expressed that the gun dog futurity is currently a walking stake, and the resulting problems of bracing foot handled gun dogs with horseback handled all age dogs, perceived judging bias towards the "all age dog", and that many people who enter the gun dog futurity will not enter their dogs under this set up.
- Possibly change the stake from 30 minutes to 45-60 minutes.
- Explore the possibility of running futurities on the weekends or Friday or Monday to encourage more people who "work" to come.
- Explore ways to better reward the breeders of the futurity dogs as this is a breeders stake
- Have a show futurity run off or "maturity" at the National Specialty
- Steve Ralph has proposed that instead of having a field futurity run off, we instead have an ABC derbystyle invitational, which would include futurity field winners and placers from the regional futurities and dogs that have won or placed in significant derby stakes such as the Victoire Nationale, or dogs that have met a qualification standard based on numbers of wins or placements. This would be a single stake made up of gun dogs and all age dogs.

- 1. One thousand four hundred and twenty eight (1428) entries competed in Field and Show Events supported by Nestle-Purina Pet Care over the period of September 2014 through June 2015. This number included both show and field events with 395 show entries and 1033 field entries.
- 2. The Purina Coordinator at the end of the Spring and Fall session will submit to Purina a summary of events funded and the total amount of monetary funding to be paid in one check to the ABC Treasurer. I will then furnish the treasurer a list of events sponsored by Purina and the treasurer will issue the individual checks to the host clubs.
- **3.** Clubs, whose events are sponsored by Purina, must also furnish the Coordinator a signed copy of the judges' sheets. Ads, entry blanks or premiums, brace sheets, and write-ups should include the Purina Logo or otherwise give credit to them as a sponsor. Some reporters are not aware of this and the field trial committee should make sure they know to do so. We can add a Thank-You to the ABC Magazine reports if a club fails to acknowledge Purina, but we do not see the ones you send to the American Field before they are published.
- **4.** The current card system for applying for support and reporting results will continue. To receive the monetary support, you must return the cards and a copy of the official results to the Coordinator.
- 5. If you have a problem with the delivery of the dog food or the amount received, you must notify the coordinator immediately in order to possibly correct it.
- 6. In summation, the number of field events showed a decrease of 7% while the number of show entries, showed a decrease of 6%. Apparently inclement weather was a major factor in this decrease of entries overall. Many events had to be cancelled due to poor travel conditions and snow and ice on field trial grounds.



ELECTRONIC BALLOTING FOR AKC PARENT CLUBS

Effective: September 1, 2013

Unless the laws of your state prohibit the use of electronic balloting in general or for specific purposes, please be advised, effective September 1, 2013:

Parent clubs may conduct elections, votes on breed standard revisions, bylaw amendments and any other specific questions a club's board of directors shall determine, via electronic balloting. Such balloting must be conducted by an independent organization which specializes in electronic balloting.

A member must sign a written authorization agreeing to this method of balloting, which is revocable, which agrees to release the club from any liability should the ballot be received late or not received by the member, due to circumstances beyond the club's control. Members not providing written authorization will continue to receive all materials via USPS.

Clubs wishing to adopt this method of balloting must add the appropriate language to the applicable sections of their bylaws <u>the next time other</u> bylaw work is considered.

Electronic Balloting Q & As

How does my club see if this is permissible?

The club must check with the Office of the Secretary of State in the state where the club is incorporated or check the law governing not-for-profit organizations incorporated in that state.

Can my club do this now and make the Bylaws change later? The bylaws require that ballots be "sent" / "mailed" and that they be secret

The bylaws require that ballots be "sent" / "mailed" and that they be secret. As long as these components are met, the bylaws can be amended at a later date.

How does my club handle those members who want a paper ballot or who do not return a signed consent form?

Those members will continue to receive ballots via USPS.

Where does the club keep the signed consent forms?

The Secretary (or Recording Secretary) should keep the consent forms.

Is it necessary for the club to have the consent forms signed each year upon membership renewal or is the one consent form sufficient for as long as the member is in good standing? No, but the member has the right to "opt-out" provided the request is received by the club in advance of any election deadline.

How does the club combine the two voting methods - paper and balloting for the total? If the electronic balloting service does not include the counting of paper ballots the club must conduct the non-electronic balloting in any of the ways currently prescribed in the bylaws

Does the club have to report the votes separately to the membership or just the totals? The club should report just the totals but obviously the club's internal records should include both counts

How does the club ensure that a member did not vote both electronically and by paper? The club will have two lists of members: one sent to the e-balloting firm and the other maintained by the recipient of ballots received via USPS.

Action Item:

MEDIA & ARCHIVE COMMITTEE

Establish a committee with the objective of investigating the feasibility and practicality of effectively and economically archiving records of the ABC and the Brittany breed.

The archives committee assists and advises the American Brittany Club (ABC) on all archives and recordsrelated matters to ensure the preservation of and public access to information of historical value held by ABC.

Determine what needs to be archived, what to retain for a limited period of time and what to purge.

Develop a list of possible archive items and procedures/protocol.

Develop program and procedures to collect information valuable to the ABC Archives.

Create a list of pictures, and print items that we do not have record of and find catalog and archive these items.

Get rid of the antiquated idea that we need to be the purveyors of all Brittany records and that some places out there already have the information and we can search it. Also that we should be contributing to these sites and making sure they are correct.

Standardize templates, programs, and design so that all media productions have a format conducive to their respective audience and production (social, print, web)

Help regional Clubs to standardize and publish information in a timely manner and be able to transfer this information to National publications (social, print web). Explore digital submission of results in an attempt to establish database and decrease errors and omissions.

Create a single place, for patrons, to search for information about the breed.

Action Item:

I have been urged to explore a rotation or change of venue for the Gun Dog Nationals by many in the west coast constituency with consideration for the following rationale: Consider a more central and neutral site or, a rotating venue that allows for greater access to amateurs across the country that are a predominant participant base in gun dog stakes, and consideration for a late spring running rather than fall that is in close conflict with the All-Age National venue.

Motion: Update ABC Pay Pal account to remove Janet Chase's email from invoices. Recommended deadline of January 31, 2016

Motion: Add Quarterly BOD videoconference or teleconference to annual meeting schedule.

Motion: Change the distribution of the dues increase between the National and Regional Clubs. The \$50 shall be distributed \$35 to ABC and \$15 to the regional club.

Agenda Item: All memberships to run from July 1 through June 30th, and establish transition fees.

• Moving to this method would simplify the record keeping for ABC and Regional Clubs and provide an idea of the annual dues revenue in time for budgeting purposes for the annual November meeting.

Motion: Page 29 of policy book delete: "Each regional date's coordinator shall receive a stipend annually, subject to the approval to pay for printing and postage to send dates schedules to their regional clubs."

- Utilizing email delivery will be a cost savings of \$300 a year.
- The schedule is also printed monthly in the ABC magazine as well as being posted on the ABC website. The ABC Facebook periodically posts a link to the ABC calendar.

Motion: Page 91 of policy book: Any expenses incurred by ABC for the Classics/Summer Specialty are to be deducted from any corporate sponsor funds received by the host club.

- Cost savings
- This brings policy in line with the Futurity as all ABC incurred expenses are charged against the host club of the event prior to reimbursement.
- This policy change would not impact ABC providing a one page ad free of charge to host clubs, or the recording fees clubs for publishing of results in magazine. Host clubs are not charged recording fees for the events.

Motion: Provide digital version of the magazine to be available to club members. Members may opt out of receiving their magazine via USPS.
