Take right on Rte. 3 and go two miles to the light at intersection of Rte. 3 and Rte. 165. Take right on Rte. 165 and go approx. three miles. Headquarters will be on the left after crossing the bridge at Wood River.

FROM THE SOUTH – Interstate I-95 in Rhode Island to Exit #4. Take right at the bottom of ramp onto Rte. 3 East. Continue Rte. 3 three miles to light at intersection of Rte. 3 and Rte. 165. Take left and go approx. three miles. Headquarters will be on the left after crossing the bridge, at Wood River.

FROM THE NORTHWEST – Interstate I-395 to Exit 22, proceed East on Rte. 138 to Rte. 165. Two miles East of Voluntown the highway splits. Stay to the left on Rte. 165 and continue to the State line which is at the causeway crossing at Beach Pond. From the state line it is approx. three miles to headquarters which will be on the right before crossing the bridge at Wood River.
