Directions to Field Trial Grounds:

From the North- Get on State Highway 5 at Lebanon.

From Lebanon- Go South on Missouri Hwy 5 to Meadowlark Road. Turn Right onto Meadowlark Road. Follow it west until it swings south. The Sportsmen's Clubhouse and barns, etc. are a short distance south on the Right. The new camping area is a short distance further on the right. If you drove all the way into Grovespring on MO-5; you went too far.

From Grovespring- Go to Mo Rt M and turn West. Go to Parks Creek Road (look for wooden silhouette of a Pointer on the right – not far past MFA Feed Store); turn Right and follow gravel road to the Clubhouse. There is one “Y” in the road – go to the right. Go past Andy Daugherty's house and kennel and continue down the valley to the clubhouse and stables (on the left).

From the South- From I-44- Take Conway Exit, go to MO-5, turn right (south) and follow above directions. (There is no easy way from the South).

Food & Accommodations

Food- The Greater Saint Louis Brittany Club will provide meals for judges and participants.

Bunkhouse: Beds will be available for use on a first come first served basis. Use of the 2 bedrooms will be assigned by the field trial committee.
