All Stakes open to all registerable pointing breeds. All Stakes are non-retrieving. Horseback handling will be permitted in all stakes except amateur walking derby. Entries limited to number of stakes that can be run in daylight hours. IEBC reserves the right to cancel any stakes with fewer than 6 entries.

Bitches in season may compete in the last brace of the last stake on each course that day. AKC approved tracking collars will be permitted. Roading dogs behind the gallery will not be permitted. No discharging of firearms or blank pistols within the camp area.

This Trial is following the AKC flexible format option and the club reserves the right to rearrange the running order of the stakes and add/rearrange judges if the trail cannot be accommodated by the plan stated in the premium.

Bureau of Land Management (BLM) Requirements

- **ABSOLUTELY NO DUMPING or BURYING** of horse or dog manure is allowed on the grounds. Do not dump over the field barbed wire fence or the wood cliff fence. There will be a dump trailer on the grounds to take all the horse and dog manure offsite. Please keep your camping areas clean and load all organic material such as manure, straw, waste hay, etc. on the truck so it can be disposed of in accordance with BLM guidelines. Fill in holes and remove trash before you leave.
- **NO OPEN FIRES ALLOWED ON THE GROUNDS** and no smoking outside of your vehicles/RVs
- **ONLY CERTIFIED WEED FREE HAY ALLOWED ON BLM GROUNDS** IEBC has quality Alfalfa Hay available (90-100 lb. bales) for purchase onsite –see *Jason Sanko, Field Trial Secretary*, to purchase.
- **KEEP AREAS FREE OF LITER** BLM will inspect the grounds following the completion of the brittany trials. IEBC's continued use of these grounds depends on our *total* compliance with these rules.
- **KEEP GATES CLOSED**

Camping Overnight camping is permitted. Camping is confined to the designated parking area. Water will be available for animals. Please bring your own drinking water.

No Wrangler will be provided. No stallions allowed on trial grounds.

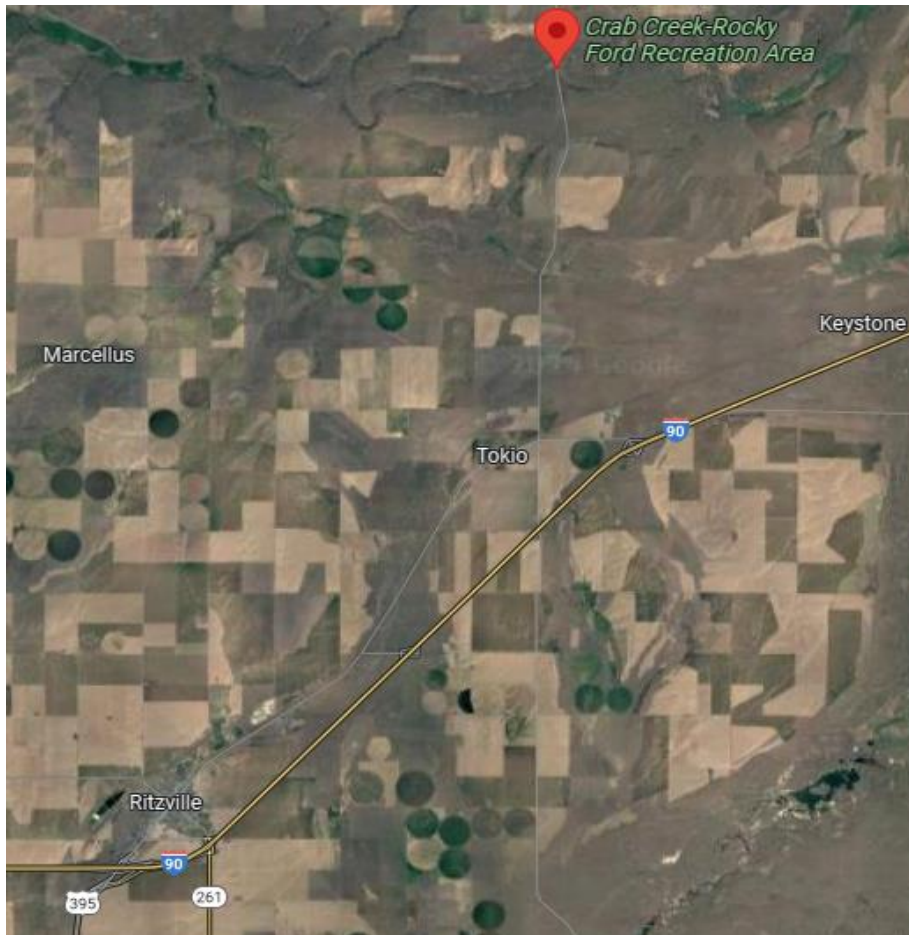

From East: Take I-90 Exit #231 toward Tokio Weigh Station onto Danekas Rd/N. Durry Rd. Turn right only N. Hills Rd. which becomes Harrington/Tokio Rd. Cross bridge over Crab Creek and turn left thru gate into camping area of Crab Creek-Rocky Ford Recreation Area Proceed through (and re-close) gate.

From West: Take I-90 Exit #226 and turn left on E. Schoessler Rd. over I-90 to T intersection. Turn right on Danekas Rd. to Harrington/Tokio Rd. then left to bridge over Crab Creek and left thru the gate into camping area of Crab Creek-Rocky Ford Recreation Area. Unit. Proceed through (and re-close) gate.
