All stakes are a single course without a bird field. Native and/or released Quail are used in all stakes except Open and Amateur Puppy. A blank cartridge will be fired in the Open and Amateur Puppy stake if bird contact occurs. The derby stakes will be 30 minute stakes. Horseback handling is only allowed in Open Limited Gun Dog, Open Gun Dog, Open and Amateur All Age, Open Puppy and Open Derby. AKC approved tracking collars are permitted for use, under AKC rules and regulations.

Fall 2022 Field Trial

The Michigan Brittany Club would like to welcome everyone to its Fall 2022 Field Trial. The trial will be held at the Ionia State Recreation Area, I-96 to Exit 67 (M66), North to David Hwy, West to Harwood, and North to Headquarters. Entries for the field trial will close on Monday, September 19, 2022, at the home of the Field Trial Secretary.

Placement in both Gun Dog Stakes will count toward the East Central Gun Dog of the Year Trophy.

All horses on the grounds need current Coggins and health certificates. The Michigan Brittany Club does not supply horses for handlers. Roading of dogs on the course behind the gallery will not be permitted during the trial.

Dogs need a current rabies vaccination certificate.

Saturday Evening - The club invites all participants to join us for dinner at the conclusion of the day's running. The club will not be serving lunches. Coffee and breakfast treats will be available each morning as well as cold beverages in the clubhouse. This information is all based on current Covid 19 guidelines and mandates.

State Park Permit- The Michigan DNR requires all vehicles on State grounds to display a Recreation Passport. These will be available for purchase at the grounds for \$17 (resident annual) or \$10/\$36 (daily/annual) for non-residents.

Parking /Camping- Camping is permitted on Headquarter grounds. Only campers desiring electricity should park in the area with electrical outlets. Camping fees (\$7 per day) are paid directly to the Michigan Brittany Club. Fees for an electrical hookup (\$5 per day) are also to be paid directly to the Michigan Brittany Club. There is no parking anywhere along the park service road or highway. Use designated parking lots only. Park perpendicular to posts in the Headquarters Parking Lot. There is no parking in the middle of the lot.
