

All horses on the grounds need current coggins and health certificates. Handler horses are not supplied by the Michigan Saginaw Valley Brittany Club. No wrangler will be available for horse rentals.

Dogs need a current rabies vaccination certificate.

STATE PARK PERMIT – The Michigan DNR requires all vehicles on State grounds to display a Recreation Passport. These will be available for purchase at the grounds for \$17 (resident annual) or \$9/\$34 (daily/annual) for non-residents.

PARKING/OVERNIGHT ATTENDANTS – Overnight attendants are permitted on Headquarter grounds. Only overnight attendants desiring electricity should park in the area with electrical outlets. Fees (\$7 per day) are paid directly to the club. Additional fees for an electrical hookup (\$5 per day) are also paid directly to the club. There is no parking anywhere along the park service road or highway. Use designated parking lots only. Park perpendicular to posts in the Headquarters Parking Lot. There is no parking in the middle of the lot.

**Bitches in season:** May compete in Amateur Gun Dog only.

Club and participants do not have exclusive use of the area. Any conflicts or concerns that may arise should be reported to the field trial committee.
