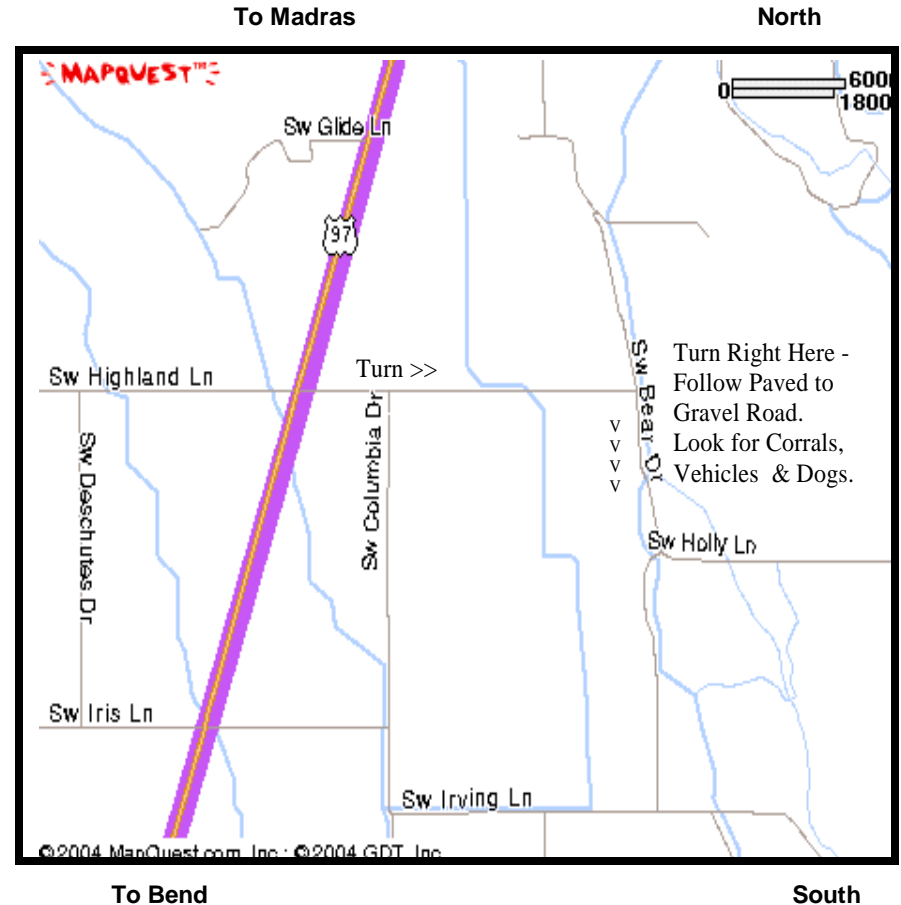
Please do not stake dogs out between the row of boulders and the fence adjacent to Holly Road. Use of corrals is prohibited. Please leave area near the corral loading ramps for vehicle and trailer access by the grazing permittee.
